

COMMISSIONERS OF THE SINKING FUND.

Abstract of the proceedings of the Commissioners of the Sinking Fund, at the meeting held July 8, 1878.

Present—Hon. Smith Ely, Jr., Mayor (Chairman); Hon. John Kelly, Comptroller; J. Nelson Tappan, Esq., Chamberlain; and Patrick Keenan, Esq., Chairman Finance Committee, Board of Aldermen.

The minutes of the last meeting were read and approved.

The Comptroller submitted the following resolution, which, on motion, was adopted, viz.: Resolved, That in accordance with the sale made on June 14, 1878, a lease of the franchise of the ferry, as now established, from the foot of Roosevelt street, in the City of New York, East river, to South Seventh street, Brooklyn, Eastern District, be awarded to the New York Ferry Company for the period of five years, from November 1, 1877, at an annual rent of five thousand and fifty dollars (\$5,050).

The Comptroller submitted the appraisement of the value of the yearly rent of the house and tot on the northeast corner of Eighty-fifth street and Third avenue, by S. C. Holmes; whereupon the following resolution was adopted, viz.:

Resolved, That the Commissioners of the Sinking Fund do hereby approve of the appraisal of the valuation of premises northeast corner of Third avenue and Eighty-fifth street, and fix the same made by S. C. Holmes, under date of July 5, 1878; and authorize the Comptroller to sell such premises for the term of two years, nine months, and fifteen days, from July 15, 1878.

Resolved, That the persons named in the first column of the following list be and they are hereby appointed Commissioners of Deeds in and for the City and County of New York, in the places, respectively, of the persons named in the second column:

The Comptroller submitted the application of F. M. Copeland, for return of the jury fee in the case of Copeland vs. Finn, paid to the Clerk of the Marine Court in June, 1874; whereupon the following resolution was adopted, viz.:

Resolved, That the sum of six dollars (\$6) be returned to W. S. Flippin, being the jury fee paid by him on June 20, 1874, to the Clerk of the Marine Court, on filing a note of issue in the action of Copeland against Finn, said action having been discontinued without any trial.

The Comptroller submitted the report of E. T. Fitzpatrick, Collector of City Revenue, in relation to the condition of the building known as Nos. 9 and 11 Franklin street, formerly occupied as a police station-house; when, on motion, the following resolution was adopted, viz.:

Resolved, That the Comptroller be authorized to sell, at public auction, the building known as Nos. 9 and 11 Franklin street, in accordance with the following terms of sale:

Cash to be paid to the Collector of the City Revenue, at the time and place of sale. The successful bidder to remove said building within twenty days from the date of sale, and to leave the ground on which the same stands free from all materials of the building, and smoothly and evenly

The Comptroller submitted the appraisement of the value of the material in the building Nos. 9 and 11 Franklin street, by E. T. Fitzpatrick; whereupon the following resolution was adopted, viz.: Resolved, That the Commissioners of the Sinking Fund do hereby approve of the valuation of the materials in building Nos. 9 and 11 Franklin street, as appraised by E. T. Fitzpatrick, under date of July 8, 1878, and do fix the value thereof in accordance therewith.

The Comptroller submitted the application of Francis Geis, for return of amount overpaid on account of street vault at 487 Second avenue; whereupon the following resolution was adopted, viz.:

Resolved, That the sum of forty dollars and fifty cents, (\$40.50), be returned to Francis Geis, being the excess paid by him for a vault in front of his premises known as No. 487, Second avenue, on June 10, 1878.

The Comptroller submitted the following resolution, which, on motion, was adopted, viz.:

Resolved, That a warrant be executed in favor of J. Nelson Tappan, Chamberlain, for the sum of five thousand dollars, (\$5,000) of the moneys deposited to the credit of "Croton Water Rents," to be paid into the City Treasury to the credit of "Croton Water Rent—Refunding Account," to be applied to the refunding of duplicate and erroneous payments of "Croton Water Rent."

A communication was received from John S. Ellis, Secretary of the Astoria Ferry Company, in relation to the financial condition of said company. Communication ordered on file.

The Comptroller submitted the appraisement of the value of the franchise of the ferry from Ninety-second street, East river, to Astoria, by Sigmund Wise; whereupon, the following resolution, submitted by the Comptroller, was, on motion, adopted, viz.:

Resolved, That the Commissioners of the Sinking Fund do hereby approve of the appraisal of the valuation of the franchise of the ferry from Ninety-second street, East river, to Astoria, Queens County, Long Island, as made by Sigmund Wise, under date of July 8, 1878, and authorize the Comptroller to sell such franchise for the term of five years, from November 1, 1877.

A communication was received from the clerk of the Commissioners of Police, transmitting copy

of preamble and resolution adopted by said Commissioners June 29, 1878, viz.: "Whereas, The portion of Barren Island owned by the City of New York cannot be made available as a dumping ground for street cleaning material, without incurring great expense to this Department in the construction of new water craft (especially adapted to those waters) for that pur-

"Resolved, That the right of use and occupation of the said premises by the Bureau of Street Cleaning of this Department, as a dumping ground, be and the same is hereby relinquished."

Whereupon the Comptroller submitted the appraisement by Sigmund Wise of the annual rent of that portion of Barren laland belonging to the City of New York, when, on motion, the following resolution was adopted, viz.:

Resolved, That the Comptroller be authorized to sell that portion of Barren Island belonging to the City of New York for the term of three years, and that the Commissioners of the Sinking Fund do hereby appraise and fix the value of such premises in accordance with the appraisement of Sig. Wise, made under date of July 8, 1878.

Application of College of Pharmacy, to be paid the amount of fines collected from Henry Eisen and Alexander Hudnut for violation of the act relative to the sale of poisons, was received; and, on motion, referred to the Comptroller.

A communication was received from the Commissioners of Emigration, "relating to the rent arged for the use of the Castle Garden Emigrant Landing Depot; which, on motion, was referred to the Comptroller.

A petition was received from Chester A. Arthur, Collector, Acting on behalf of the Secretary of the Treasury, for the conveyance of land (portion of the Battery for location for Barge Office) to the United States; which, together with accompanying documents, were referred to the Comptroller.
