BOARD OF ALDERMEN.

TUESDAY, January 18, 1881.

The Clerk called the members to order at 12 o'clock, M., and, upon a call of the roll, the following answered to their names:

Alderman Strack moved that Alderman Sauer be appointed Temporary Chairman. The Clerk put the question whether the Board would agree with said motion. Which was decided in the affirmative.

Alderman Sauer having taken the chair instructed the Clerk to call the roll of members, as provided in section 6 of chapter 335, Laws of 1873, when each one was to announce his choice for President of the Board.

Which proceeding resulted as follows:

For Bernard Kenney—Aldermen Autenreith, Power, Sauer, and Strack—4.

For Henry C. Perley—Aldermen Finck, Hawes, Hilliard, McClave, Seaman, Waite, and Wells—7.

For William Sauer—Aldermen B. Kenney, P. Kenney, Kirk, McAvoy, Murphy, and Sheils—6.

For John McClave—Alderman Perley—1.

The Temporary Chairman announced the vote, and declared that the Board had failed to elect a President.

Alderman McClave moved that the Board remain in session for one hour and ballot continuously for President, unless a presiding officer be sooner chosen.

As an amendment, Alderman Sheils moved that the Board do now take a recess until Thursday next, the 20th instant, at 12 o'clock, M.

The Temporary Chairman put the question whether the Board would agree with said amendment.

Which was decided in the affirmative by the following vote, on a division called by Alderman Hawes, as follows, viz.:

Affirmative—The Temporary Chairman, Aldermen Autenreith, Keenan, B. Kenney, P. Kenney, Kirk, McAvoy, Murphy, Power, Sheils, Slevin, and Strack—12.

Negative—Aldermen Finck, Hawes, Hilliard, McClave, Perley, Seaman, Waite, and Wells—8.

And the Temporary Chairman announced that the Board stood adjourned until Thursday next, the 20th instant, at 12 o'clock, M.

Report for the Quarter ending December 31, 1880.

DEPARTMENT OF TAXES AND ASSESSMENTS,
COMMISSIONERS' OFFICE,
NEW YORK, January 3, 1881.

Hon. W. R. GRACE, Mayor, etc.:

SIR—Pursuant to the requirements of section 27 of chapter 335 of the Laws of 1873, the Commissioners of Taxes and Assessments respectfully

REPORT:

That the requirements of the law, chapter 302, section 7, of the Laws of 1859, as follows:

"It shall be the duty of the Deputy Tax Commissioners, under the direction of the Commissioners of Taxes and Assessments, to assess all the taxable property in the several districts that may be assigned to them for that purpose by said Commissioners, and shall furnish to them, under oath, a detailed statement of all such property; that said deputies have personally examined each and every house, building, lot, pier, and other assessable property, giving the street and ward map number of such real estate embraced within said districts, together with the name of the owner or occupant, if known; also, in their judgment, the sum for which said property, under ordinary circumstances, would sell, with such other information, in detail, relative to personal property or otherwise, as the said Commissioners may, from time to time, require.

"Such deputies shall commence to assess real and personal estate on the first Monday in September in each and every year,"

—have been complied with, and that these assessments are substantially completed, and in such a state of forwardness that the books containing the same will be opened for public inspection on the second Monday (10th) of January, as prescribed by law.

The valuations upon real and personal estate in the county of New York, for the year 1880, amounted to \$1,143,765,727.09, made up as follows:

Real estate.....	\$942,571,690 00
Corporations.....	36,921,404 00
Bank shares.....	55,601,607 09
Resident personal.....	96,581,306 00
Non-resident personal.....	12,089,720 00

\$1,143,765,727 09

The rate having been fixed at 2.53 per cent., the amount required to be raised by tax was \$28,937,272.90, of which the amount collected for the year 1880, to December 31, 1880, inclusive, was \$21,737,167.13.

The defects in the laws for the taxation of property, to which the attention of thoughtful men has long been directed, have at length aroused a degree of public interest which, it is hoped, will result in practical measures of redress. The demand is for equality in taxation, not only as between private—including corporate—interests, but as between the several counties of the State. The laws for the assessment of the property of corporations are grossly defective, and operate unequally, and inequality in taxation is always oppressive, and becomes the occasion of just complaint.

The minutes of the meetings held the 3d and 8th instant were read and approved.

On motion of Commissioner Laimbeer, the certificate of his appointment was directed to be spread in full upon the minutes, as follows:

The following communications were received, read, and,

On motion, laid on the table to await action as stated, to wit:

From Moses Taylor and others, owners of each half of Pier 12, East river, agreeing to pay their proportion of the cost of repairing the pier under contract, conjointly with this Department.

From Providence and Stonington Steamship Company, asking that fender piles be driven on the south side of Pier, new 21, North river, in order to facilitate the berthing of their steamers at the south side of Pier, old 33, adjacent. Engineer-in-Chief directed to examine and report as to the cost of doing the work.

From Julius Jonson—For permission to build dock between One Hundred and Eighteenth and One Hundred and Nineteenth streets, Harlem river. Engineer-in-Chief directed to examine and report as to the condition of the water front in question.

From Central Railroad Company of New Jersey, with plans—To extend platform, etc., at Pier 8, North river, and erect shed upon said pier. Engineer-in-Chief directed to examine and report on the condition of the premises and the area to be covered by the proposed platform.

From Engineer-in-Chief—As to obstructions upon the water front between Twenty-third and Twenty-fifth streets, North river, which interfere with the free use of the premises for the construction of the bulkhead wall thereat. Secretary directed to address a communication to the Counsel to the Corporation, enclosing a copy of report of the Engineer-in-Chief of this Department and a tracing of the above-named premises, and requesting him to inform this Board what steps are necessary to be taken for the removal of the aforesaid obstructions, in order to enable this Department to proceed with its work of building the bulkhead wall and piers at that part of the water front in accordance with the new plan adopted.

The following communications were received, read, and,

On motion, placed on file, action being taken where necessary, as stated, to wit:

From Lidgerwood Manufacturing Company—Agreeing to hold this Department harmless for any damages which may be claimed for the use of certain patents upon engines, pile drivers to be furnished to this Department.

From Citizens Steamboat Company—For lease of Pier, new 43, North river. Secretary directed to advise in reply that the pier referred to is used by this Department for the accommodation of steamship companies, whose piers are being rebuilt under the new plans, and consequently this Department will not be enabled to grant them the use of the pier, as applied for.

From Platt, Gerard & Bowers, Attorneys—Requesting that this Department delay for a few days the work of removing the old platform between Forty-ninth and Fifty-first streets, East river, and constructing a new bulkhead thereat, until such time as they can complete the papers in the legal proceedings about to be commenced by them on behalf of Gerard, Beekman and others, to restrain the city from the prosecution of its proposed work. Secretary directed to state in reply that previous receipt of the communication from Gerard, Beekman and others, notifying this Department that legal proceedings would be taken to prevent the construction of the work above referred to, a contract to do the work had already been duly awarded, and that this Department has no power to delay the work as provided for in said contract, and furthermore considers that the interests of commerce and of the city imperatively demand that the prosecution of the proposed improvement shall be proceeded with as fast as possible.

From Engineer-in-Chief, as follows:

1st. Report, as to work performed during the week ending December 11, 1880.

2d. Reporting the completion of repairs made to dumping board at Seventieth street, East river.

3d. In reference to dredging the slip between Piers, new 37 and new 38, North river.

Application of Williams & Guion, lessees of Pier, new 18, North river, to have dredging done thereat by this Department, was taken from the table and placed on file, and applicants informed that whatever dredging may be necessary to be done at said premises, will have to be performed at their own cost and expense, in accordance with the provisions of their lease, and that a tracing showing the soundings taken in the slip adjacent to said pier, has been prepared by the Engineer-in-Chief of this Department, and can be examined by them upon application at this office.

From Superintendent Wm. McConkey—In reference to discharging stone ballast at Piers 45 and 46, East river.

A communication was received from the Comptroller advising substitution of Christian Zanger and Jennie E. Richardson as sureties on estimate of Holmes Brothers in place of Anthony Schwoerer and George Baecker; and, being read,

On motion, it was

Resolved, That in compliance with the requirements of section 27 of chapter 8 of the Revised Ordinances of the City of New York, consent is hereby given to the substitution of Christian Zanger and Jennie E. Richardson in place of Anthony Schwoerer and George Baecker, as sureties to the contract awarded under this estimate for removing part of old pier at foot of West Twenty-fifth street, and building Pier, new 55, North river.

A communication was received from John Kinsley asking that consent be given to the assignment of his contract to Forbes Holland for building platform, etc., between Forty-ninth and Fifty-first streets, East River, and being read,

On motion, it was

Resolved, In conformity with the provisions of paragraph 59 in the contract made by this Department with John Kinsley for building rubble wall and platform, between Forty-ninth street and Fifty-first street, East River, dated December 4, 1880, that consent be and is hereby given and directed to be indorsed on the said contract to the assignment or subletting of the contract, and of the work to be done thereunder, to Forbes Holland, of 117 East Eighteenth street, in this city, provided that the sureties to the bond for the faithful performance of the said contract shall agree in writing thereon to such assignment.

The Auditing Committee presented an audit of 19 bills or claims, amounting to the sum of \$7,311.28, and, being read,

On motion, accepted and adopted, and the Secretary directed to forward the said bills, together with proper requisitions for the amount, to the Finance Department for payment.

On motion, the Secretary was directed to notify the Hudson Tunnel Railroad Company, applicants for permission to occupy portion of water front between Morton and Leroy streets, North River, for constructing thereat a railroad tunnel, etc., to furnish for examination plans of the work proposed to be constructed; to specify the space to be permanently occupied by the company, as well as the space necessary for the prosecution of the work, the time during which the latter may be occupied, and such other details as will enable the Commissioners to act advisably upon the application of said company.

On motion, the Secretary was directed to notify the Old Dominion Steamship Company, lessees of Pier, new 26, North River, to at once proceed with the erection of the shed proposed to be built by them, at their own cost and expense, on the inner end of the pier, in order that this Department may not be delayed in its work to be carried on south of said Pier, the premises to be occupied by said shed having been completed and ready since the 27th of November last.

On motion, the Board adjourned.

APPLICATIONS FOR EXEMPTIONS WILL BE heard here, from 9 to 4 daily from all persons hitherto liable or recently serving who have become exempt, and all needed information will be given.

Those who have not answered as to their liability, or proved permanent exemption, will receive a "jury enrollment notice" requiring them to appear before me this year. Whether liable or not, such notices must be answered (in person, if possible, and at this office only) under severe penalties. If exempt, the party must bring proof of exemption; if liable, he must also answer in person, giving full and correct name, residence, etc., etc. No attention paid to letters.

Persons "enrolled" as liable must serve when called or pay their fines. No mere excuse will be allowed or interference permitted. The fines, received from those who, for business or other reasons, are unable to serve at the time selected, pay the expenses of this office, and if unpaid will be entered as judgments upon the property of the delinquents.

All good citizens will aid the course of justice, and secure reliable and respectable juries, and equalize their duty by serving promptly when summoned, allowing their clerks or subordinates to serve, reporting to me any attempt at bribery or evasion, and suggesting names for enrollment. Persons between sixty and seventy years of age, summer absentees, persons temporarily ill, and United States and District Court jurors are not exempt.

Every man must attend to his own notice. It is a misdemeanor to give any jury paper to another to answer. It is also punishable by fine or imprisonment to give or receive any present or bribe, directly or indirectly, in relation to a jury service, or to withhold any paper or make any false statement, and every case will be fully prosecuted.

ESTIMATES FOR REMOVING ALL OF THE old pier at the foot of West Twenty-fifth street, North River, which lies westerly of a line about forty feet westerly of the new bulkhead line, and for building a new wooden pier near the foot of West Twenty-fifth street, will be received by the Board of Commissioners at the head of the Department of Docks, at the office of said Department, Nos. 117 and 119 Duane street, in the City of New York, until 12 o'clock M. of

at which time and place the bids will be publicly opened by the head of said Department and read. The award of the contract, if awarded, will be made as soon as practicable after the opening of the bids.

Any person making an estimate for the work shall furnish the same in a sealed envelope to said Board, at said office, on or before the day and hour above named, which envelope shall be endorsed with the name or names of the person or persons presenting the same, the date of its presentation, and a statement of the work to which it relates.

The bidder to whom the award is made shall give security for the faithful performance of the contract, in the manner prescribed and required by ordinance, in the sum of Seventeen Thousand Dollars.

The Engineer's estimate of the nature, quantities, and extent of the work is as follows:

CHAPTER 123.

AN ACT in relation to arrears of taxes in the City of New York, and to provide for the reissuing of revenue bonds in anticipation of such taxes.

Passed April 15, 1880; three-fifths being present.

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. At any time after the passage of this act, and before the first day of October, eighteen hundred and eighty, any person may pay to the Comptroller of the City of New York the amount of any tax upon real property belonging to such person, heretofore laid or imposed and now remaining unpaid, together with interest thereon at the rate of seven per centum per annum, to be calculated from the time that such tax was imposed to the time of such payment, provided, also, that the time when such payment may be made on the amount of any such tax laid or imposed in the years eighteen hundred and seventy-seven, eighteen hundred and seventy-eight, and eighteen hundred and seventy-nine shall extend to the first day of April, eighteen hundred and eighty-one. The Comptroller shall make and deliver to the person making any such payment a receipt therefor, and shall forthwith cancel the record of any such tax on the books of the finance department; and upon such payment being made such tax shall cease to be a lien upon the property and shall be deemed fully paid, satisfied and discharged, and there shall be no right to any further interest or penalty by reason of such tax not having been paid within the time heretofore required by law, or by reason of any statute passed requiring the payment heretofore of any penalty or interest over seven per centum per annum upon any unpaid tax.

Sec. 2. Any revenue bond heretofore issued in anticipation of the taxes in the first section specified which may fall due and become payable before said taxes are collected, may be reissued by the Comptroller of said city, in whole or in part, for such period as he may determine, not exceeding one year.

Sec. 3. This act shall take effect immediately.
