Was the proposed rule included in HRA'S regulatory agenda? This rule was not contemplated when HRA issued its most recent regulatory agenda.

**What laws govern the rulemaking process?** HRA must meet the requirements of Section 1043 of the City Charter when creating or changing rules. This notice is made according to the requirements of Section 1043 of the City Charter.

#### Statement of Basis and Purpose of Proposed Rule

The Fair Fares NYC Program helps New York City residents with low incomes manage their transportation costs by providing them with a 50% discount on public transportation. The program has been launched in phases and a rule concerning the program was issued by the New York City Department of Social Services (DSS/HRA) late last year.

DSS/HRA will now be making the Fair Fares discount available on Access-A-Ride paratransit trips with the cooperation of New York City Transit. To that end, a letter was sent to all Access-A-Ride customers earlier this summer telling them how to apply for Fair Fares NYC and how to link their DSS/HRA Fair Fares NYC and Metropolitan Transportation Authority Access-A-Ride accounts. So far, approximately 700 Fair Fares customers have made that linkage. Although Access-A-Ride paratransit customers are not currently being charged a fare at all due to the COVID-19 pandemic, upon the resumption of fare collection customers will be able to take advantage of this discount. The current Fair Fares rule provides that the Fair Fares discount shall be available "on NYCT-operated subway and local bus lines, and such other transit options that DSS/HRA may designate in consultation with NYCT." Thus, although a rule change is not strictly necessary to expand Fair Fares to Access-A-Ride trips, DSS/HRA proposes amending the rule to reflect the inclusion of Access-A-Ride.

Additionally, the proposed rule:

(1) replaces references to the "Fair Fares MetroCard" with a more generic reference to the "Fair Fares discount" in light of the facts that MetroCards are not used on Access-A-Ride trips and that the One Metro New York (OMNY) system will likely eventually replace the MetroCard altogether,

(2) changes an erroneous reference to "federal gross income" to "gross income," and

(3) removes a definition of term that is not used in the rule.

Chapter 12 of Title 68 of the Rules of the City of New York is amended as follows:

Section 1. Subdivision(a) of Section 12-01 of Title 68 of the Rules of the City of New York is amended to read as follows:

(a) ["City agency" means a city agency as defined in section 1-112(1) of Title 1 of the New York City Administrative Code] <u>"Access-A-Ride"</u> means the paratransit program operated by the New York City Transit Authority NYCT for people whose disabilities prevent them from riding NYCT's fixed-route bus and subway systems.

\$ 2. Subdivisions (c) and (d) of Section 12-01 of Title 68 of the Rules of the City of New York are amended to read as follows:

(c) "Fair Fares NYC Conditions of Use" or "Conditions of Use" means the terms and conditions that an applicant must accept and agree to be bound by before receiving a [FFM] <u>FF discount</u>, pursuant to DSS/ HRA's Memorandum of Understanding with the New York City Transit Authority.

(d) "Fair Fares NYC [MetroCard] <u>discount</u>" or ["FFM"] <u>"FF discount"</u> means the [special MetroCard (or any successor to the MetroCard) that allows eligible individuals to receive a] discount <u>for eligible individuals</u> on designated travel options pursuant to the program established by this chapter.

 $\S$  3. Section 12-02 of Title 68 of the Rules of the City of New York is amended to read as follows:

#### § 12-02 In General.

[DSS/HRA will administer Fair Fares NYC and will make eligibility determinations in accordance with this chapter. Participants will be able to use the Fair Fares NYC MetroCard to travel on all NYCToperated subway and local bus lines, and such other transit options that DSS/HRA may designate in consultation with NYCT. Participants will be able to use the card to purchase, at half-price, pay per ride, 7-day or 30-day fares or such other fare types that DSS/HRA will designate as being available under the Program in the future. The program is subject to the availability of funding.]

(a) DSS/HRA will administer Fair Fares NYC and will make eligibility determinations in accordance with this chapter. Participants will be able to use the Fair Fares NYC discount to travel on all NYCT-operated subway and local bus lines, Access-A-Ride trips, and such other transit options that DSS/HRA may designate in consultation with NYCT, except that if a participant is already receiving a duplicative discount on one or more types of transportation, they shall only be able to use the discount on the type or types of transportation for which they are not receiving a duplicative discount.

(b) Other than Access-A-Ride users, who will pay their fare in the manner prescribed by NYCT, participants will be able to use the card discount to purchase, at half-price, pay per ride, 7-day or 30-day fares or such other fare types that DSS/HRA will designate as being available under the Program in the future.

(c) The program is subject to the availability of funding.

# § 4. Subdivision (a) of Section 12-03 of Title 68 of the Rules of the City of New York is amended to read as follows:

(a) To be eligible to receive a Fair Fares [NYC MetroCard] discount an applicant must:

(1) submit a completed application, including supporting documentation, in a format and manner established by the Program;

(2) submit a signed Fair Fares NYC Conditions of Use form pursuant to DSS/HRA's Memorandum with New York City Transit Authority; and

(3) meet the following eligibility requirements:

(A) The applicant must be a New York City resident;

 $\left(B\right)$  The applicant must be between 18 and 64 years of age;

(C) The applicant's [federal] gross income must not exceed 100 percent of FPL;

(D) Except as provided in section 12-02(a) of this chapter [The] <u>the</u> applicant must not currently be eligible for a duplicative discount or benefit from DSS/HRA, NYCT or any other entity or program;

(E) The applicant must not be currently suspended or permanently disqualified from the Program under section 12-05(b) of this chapter;

# \$ 5. Subdivisions (b) and (c) of Section 12-04 of Title 68 of the Rules of the City of New York are amended to read as follows:

(b) If the Program determines that a participant no longer meets the requirements of section 12-03(a)(3) of this chapter, or is no longer able to use the [card] <u>FF discount</u> due to a period of incarceration or other institutionalization of 30 days or more, the Program will provide a notice to the participant that will include the reason for the determination and the date their [FFM] <u>FF discount</u> will be deactivated.

(c) In order to re-enroll in the Program after their first or any subsequent year, or after having their [card] <u>discount</u> deactivated, pursuant to subdivision (b) of this section, an individual must satisfy the same eligibility requirements as a new applicant.

# 6. Subdivisions (a) and (b) of Section 12-05 of Title 68 of the Rules of the City of New York are amended to read as follows:

(a) The [FFM] <u>FF discount</u> can be used only by the participant to whom it is issued and only in accordance with the Fair Fares NYC Conditions of Use pursuant to DSS/HRA's Memorandum of Understanding with NYCT.

(b) A participant who misuses or abuses the [FFM] <u>FF discount</u> or commits fraud on the program, including but not limited to [giving the card to another person to use] <u>allowing another person to use</u> <u>the Fair Fares discount assigned to them</u> or deliberately providing misinformation to the Program, will be subject to the following penalties:

> (1) For the first offense, the participant will be suspended from the Program for 60 days. The individual will be allowed to reapply following the 60-day suspension and after signing an attestation in a form to be established by the Program.

(2) For the second offense, the participant will be permanently disqualified from the Program.

# $\S$ 7. Subdivision (a) of Section 12-06 of Title 68 of the Rules of the City of New York is amended to read as follows:

(a) In the event an individual is found ineligible for a [FFM] <u>Fair Fares</u> <u>discount</u> under section 12-03 or 12-04 of this chapter, or is determined to have misused or abused the [card] <u>discount</u> or committed fraud on the program, they may request administrative review of the decision by submitting a review request, in a form and manner established by the Program, within 14 days of the date of the decision.

# $\S$ 8. Subdivision (a) of Section 12-08 of Title 68 of the Rules of the City of New York is amended to read as follows:

(a) For so long as the program uses a card to facilitate the discount for some types of transportation, [The] the Program reserves the right to limit the number of replacement cards it will issue to an individual within a calendar year, in accordance with the Conditions of Use pursuant to DSS/HRA's Memorandum of Understanding with NYCT.

#### **NOTICE OF ADOPTION OF RULE**

NOTICE IS HEREBY GIVEN THAT, PURSUANT TO THE AUTHORITY VESTED IN THE COMMISSIONER OF THE NEW YORK CITY HUMAN RESOURCES ADMINISTRATION ("HRA") by section 141 of the New York Social Services Law and sections 603 and 1043 of the New York City Charter, HRA hereby adopts the following rule adding Chapter 13 to Title 68 of the Official Compilation of the Rules of the City of New York.

A similar rule was issued as an emergency rule on May 2, 2020, and a proposed permanent rule was published on June 23, 2020. A public hearing was held on July 23, 2020. No public comments were received.

#### **Statement of Basis and Purpose of Rule**

HRA issues this rule making certain changes to its burial allowance program.

In early May 2020, in order to address the unprecedented impact of the COVID-19 pandemic on New York City and the number of fatalities affecting the City's most vulnerable and low-income populations in dire need of financial assistance to provide for respectful and solemn final disposition of their loved ones, the Commissioner of the New York City Department of Social Services/ Human Resources Administration (DSS/HRA) issued an emergency rule concerning its burial allowance program, which is otherwise governed by State law and Chapter 2 of HRA's rules.

Currently, State law only provides for partial reimbursement of burial allowances up to \$900. In other words, burial allowances of \$900 or less are partially reimbursable by the State, but any amounts paid by local social services districts above \$900 come entirely out of local funds.

The emergency rule, which will expire on August 31, increased the available burial allowance from \$900 to \$1700. HRA is now extending the \$1700 allowance through December 31, 2020. The City will seek a legislative change that would provide for additional reimbursement from the State. Whether there is a legislative change may affect the amounts that the City determines to be practicable in the future.

Additionally, HRA is making the rest of the provisions of emergency rule permanent. Specifically, the HRA is making permanent the following changes to the burial allowance:

- (1) Increase the expense cap from \$1,700 to \$3,400 and adds the costs charged by a funeral director associated with the disinterment of decedent remains from Hart Island to the items that will not count towards the total expense cap.
- (2) Allow for applications to be made by email and other remote means, in addition to in-person.

- (3) Change the time within which a friend, relative or organizational friend of the decedent can file an application for a burial allowance, from 60 days from the date of death to 120 days from the date of death.
- (4) Allow anyone who may qualify for an allowance for burial expenses to apply for such an allowance either prior to or following burial or cremation and remove the requirement that DSS/HRA must respond to pre-burial or pre-cremation applications within two business days.
- (5) Provide that the value of any resources or income that are not liquid or available at the time of the decedent's death and not available at the time of application will not be deducted from the burial allowance in determining the amount that will be paid. However, DSS/HRA will reserve the right recover against such resource consistent with State law.
- (6) With respect to veteran burials in particular, remove the prohibition on providing burial expenses pursuant to Section 2-09 of Title 68 for the burial of veterans in private cemeteries other than Calverton Cemetery.

DSS/HRA's authority for this rule may be found in section 141 of the New York Social Services Law and sections 603 and 1043 of the New York City Charter.

Section one. Title 68 of the Rules of the City of New York is amended by adding a new chapter 13 to read as follows:

#### **Chapter 13: Changes to Burial Claims**

#### 13-01. Changes to Burial Claims Generally

Notwithstanding any provision of chapter 2 of this title to the contrary, the following provisions shall apply all applications for an HRA burial allowance:

(a) Notwithstanding the provisions of chapter 2 of these rules, the allowance provided for in section 13-02 of this chapter, or in Chapter 2, as applicable, shall not be available where the total burial expenses, as defined in section 2-02 of this title, exceed \$3,400. In determining whether such \$3,400 cap has been exceeded, the following costs will be disregarded:

(1) the cost of cremation or the burial plot and grave opening; and

(2) any costs charged by a funeral director that are related to the disinterment of a body that was buried on or after March 12, 2020 on Hart Island.

(b) The time within which any person may submit an application for a burial allowance is increased from sixty (60) days to one hundred and twenty (120) days from the date of death.

(c) Anyone who is eligible for an allowance for burial expenses or under this section or under Chapter 2, as applicable, may apply for such expenses either prior to or after burial or cremation. The requirement in section 2-09(d) of this tile that DSS/HRA must decide any applications made prior to burial or cremation within two business days is suspended. However, DSS/HRA will make decisions on all applications within a reasonable time.

(d) Applications under this section or under Chapter 2, as\_ applicable, need not be made in person and may be made online, by email, by fax and by any other remote means as DSS/HRA\_ may designate.

(e) In determining the amount of the allowance, the value of any resources or income that are not liquid or available at the time of the decedent's death and not available at the time of application shall not be deducted. However, DSS/HRA reserves the right to recover against any such resources consistent with State law.

(f) The provisions of section 2-09(b)(ii) of this title, prohibiting an allowance for veteran burials that occur in private cemeteries other than Calverton Cemetery, are suspended.

#### 13-02. Temporary Increase in Burial Allowance

Notwithstanding any provision of chapter 2 of this title to the contrary, for applications submitted on or before December 31, 2020, the allowance for burial expenses described in chapter 2 that are payable by DSS/HRA is \$1,700. This allowance can be used towards burial expenses, as defined in chapter 2, including the costs set forth in paragraphs (1) and (2) of subdivision (a) of section 13-01 of this chapter that are disregarded in determining the cap set forth in such subdivision.

#### ADJUSTMENT IN HUDSON YARDS DISTRICT IMPROVEMENT BONUS CONTRIBUTION AMOUNT

As provided in Section 93-31 of the Zoning Resolution of the City of New York, the required contribution amount per square foot of bonused floor area available through the District Improvement Fund Bonus in the Special Hudson Yards District has been increased from \$134.63 per square foot to \$135.44 per square foot as of August 1, 2020.

In accordance with Section 93-31, this increase is based on the change in the Consumer Price Index for all Urban Consumers (CPI), as published by the U.S. Department of Labor, Bureau of Labor Statistics. The CPI change for the period between July 1, 2019 and July 1, 2020 was an increase of 0.6 percent.

This increased contribution amount per square foot of bonused floor area applies to all contributions pursuant to Section 93-31 received on or after August 1, 2020, until such time as the amount is further modified to accordance with the Zoning Resolution.

#### Name, Description and Location of Proposal:

#### 343 Madison Avenue

BP 347 Madison Associates, LLC (BP) is seeking approval of a net lease from the Metropolitan Transportation Authority (MTA) and two "Vanderbilt Corridor Subarea" special permits, pursuant to Zoning Resolution § 81-633 633 (Grand Central public realm improvements) and 81-634 (modifications to bulk regulations and mandatory district plan elements), from the City Planning Commission (CPC) (collectively, the "Proposed Action") in order to redevelop the property owned by the MTA and located at 341-347 Madison Avenue, which is located within the "Vanderbilt Corridor" and "Grand Central Core Area" of the Special Midtown Subdistrict (the "Project Site"). MTA and BP are referred to, collectively, as the "Applicant."

The Proposed Action would facilitate the redevelopment of the Project Site with a new, approximately 925,630 gross square-foot (gsf), commercial office building of up to 1,050 feet tall (up to 1,080 feet including the bulkhead) with ground floor retail uses, and below-grade space (i.e., dedicated mechanical floors) (the "Proposed Project").

The Applicant is seeking two special permits (pursuant to Zoning Resolution § 81-633 and 81-634) available for developments within the Vanderbilt Corridor subarea that provide public realm improvements in the form of pedestrian and mass transit circulation improvements in and around Grand Central Terminal.

Specifically, the application requests:

- 1. A special permit to increase the maximum floor area ratio in connection with Grand Central public realm improvements (Zoning Resolution Section 81-633); and
- 2. A special permit to modify certain mandatory district plan elements, the street wall height, height and setback regulation, and curb cut regulations (Zoning Resolution Section 81-634).

An additional action needed for the Proposed Project is MTA's approval and execution of a 99-year lease from the MTA to BP (or its designee). In considering this proposed lease, the MTA is acting as an involved agency under CEQR and SEQRA.

The project would provide transportation improvements on-site that create new pedestrian access to, and egress from, the Long Island Rail Road East Side Access concourse and improve the 45th Street pedestrian connection to Grand Central Terminal. It would also improve passenger circulation at the Grand Central – 42nd Street Subway Station—including improvements to passenger connections to the IRT Flushing Line (#7 Train) platform.

The Project Site is comprised of Lots 23, 24, 25, and 48 on Block 1279 in the East Midtown neighborhood of Manhattan, within Community District 5 (with a portion of the proposed public realm improvements extending into Community District 6). Block 1279 is bounded by Madison Avenue to the west, Vanderbilt Avenue to the east, East 44th Street to the south, and East 45th Street to the north. The Project Site consists of the western portion of Block 1279, fronting on Madison Avenue, and contains three 13- to 20-story buildings that previously served as the headquarters of the MTA and a ventilation structure for MTA's East Side Access project, which is currently under construction with an anticipated completion in 2022. The buildings that used to contain the MTA headquarters total 351,871 gsf of commercial office and retail space that is now vacant.

The Project Site is zoned C5-3, a high-density commercial district that is intended for Central Business Districts with large-scale office and retail establishments. The C5-3 zoning allows for a basic maximum floor area ratio (FAR) of 15 for commercial and community facility uses and up to 10 FAR of residential uses.

Absent the Proposed Action, in the future No-Action condition, the RWCDS assumes that after the current buildings are demolished, a 15 FAR, 477,599 gsf (376,574 zsf) commercial office and retail building would be constructed. The building would contain 6,144 gsf of ground floor retail space, 411,540 gsf of commercial office space above, and 56,848 sf of mechanical space (i.e. dedicated mechanical floors). It would also include a 3,067-sf easement for East Side Access Circulation, to be built by the MTA. The building would be 472 feet high and 30 stories and feature a tower on a 114-foot-tall podium. The tower would have one set back at 194 feet. The ventilation structure on Lot 25 would remain under existing conditions.

For purposes of analysis, the Proposed Project represents the future With-Action condition consisting of a 30 FAR commercial office and retail building with a total of 925,630 gsf (753,152 zsf). The building would be approximately 55 stories tall and reach up to 1,050 feet tall (up to 1,080 feet including the bulkhead). The building would be a tower on a podium, with the podium reaching up to 301 feet.

The analysis year for the Proposed Action is 2026.

#### **Statement of Significant Effect:**

On behalf of the City Planning Commission (CPC), the Department of City Planning has determined, pursuant to 6 NYCRR Part 617.7, that the Proposed Actions may have a significant adverse effect on the environment as detailed in the following areas, and that an environmental impact statement will be required:

> The Proposed Actions may result in significant adverse impacts related to: land use, zoning, and public policy; open space; shadows; historic and cultural resources; urban design and visual resources; hazardous materials; water and sewer infrastructure; transportation; air quality; greenhouse gas emissions and climate change; noise; public health; neighborhood character; and construction.

> The Proposed Actions would not result in significant adverse impacts related to socioeconomic conditions; community facilities; natural resources; solid waste and sanitation services; and energy.

#### **Supporting Statement:**

The above determination is based on an Environmental Assessment Statement prepared for the Proposed Actions which finds that:

- The Proposed Action would affect the land use, zoning, and public policies within the Project Site and immediate surrounding area. The Proposed Action are discretionary and include special permits that would affect the Special Midtown District requirements applicable to the site. The Proposed Action has the potential to result in significant adverse impacts related to land use, zoning, and public policy.
- 2. The Proposed Action would not affect socioeconomic conditions on the Project Site or the surrounding area. The existing building on the site and the Proposed Project do not contain any residential uses. Furthermore, it would not result in significant adverse impacts related to direct or indirect business

displacement or impacts to a specific industry as it would not exceed any of the analysis thresholds specified in the CEQR Technical Manual. Therefore, the Proposed Action does not have the potential to result in significant adverse impacts related to socioeconomic conditions.

- 3. The Proposed Action would not directly affect any community facility. Additionally, the Proposed Action would not exceed any threshold warranting additional analysis for indirect effects to community facilities and services. Therefore, the Proposed Action would not result in significant adverse impacts to community facilities and services.
- 4. The Proposed Action would not directly affect any open space. The Proposed Action would result in an increase of 1,682 workers, which would exceed the analysis thresholds specified in the CEQR Technical Manual related to indirect effects on open space. Therefore, the Proposed Action does have the potential to result in significant adverse impacts related to open space.
- 5. The Proposed Action would result in an increase in building height over the No-Action Condition of 578 feet, which would exceed the analysis thresholds specified in the CEQR Technical Manual. The Proposed Action would therefore have the potential to result in significant adverse impacts related to shadows.
- 6. The Proposed Project would be located within close proximity to three architectural resources and in the vicinity of several other architectural resources. Additionally, the Proposed Action would result in new in-ground disturbance in an area with possible archaeological sensitivity. Therefore, the Proposed Action has the potential to result in significant adverse impacts related to historic and cultural resources.
- 7. The Proposed Action would introduce new building height and built-form not currently allowed as-ofright by zoning. The Proposed Action would create a new building with different massing, height, and architectural features that could change the streetscape from the pedestrian's viewpoint. In addition, the Proposed Actions could potentially change or restrict significant views of visual resources that are currently available from the surrounding area. Therefore, the Proposed Action has the potential to result in significant adverse impacts related to urban design and visual resources.
- 8. The Proposed Action would result in development in an area with no significant natural resources and the project area is located within a fully developed urban area, consisting of paved lots. Therefore, the Proposed Action would not result in significant adverse impacts related to natural resources.
- 9. The Proposed Action has the potential to result in an increase in pathways to human or environmental exposure to hazardous materials. Based on the Phase I Assessment conducted for the site, the Project Site has been determined to have the potential for subsurface contamination. Therefore, the Proposed Action has the potential to result in significant adverse impacts related to hazardous materials.
- 10. The Proposed Action would introduce mixed commercial space in Midtown Manhattan in a combined sewer area. While the incremental sewage generation of 41,926 gpd is below the threshold of significant increase in demand according to the CEQR Technical Manual, the development is significant enough to merit further analysis. Therefore, the Proposed Action may have the potential to result in significant adverse impacts related to water and sewer infrastructure.
- 11. The Proposed Action would not result in a substantial increase in solid waste production that would overburden available waste management capacity and would not result in solid waste generation greater than the threshold of 50 tons per week. Therefore, the Proposed Action would not result in significant adverse impacts related to solid waste and sanitation services.
- 12. The Proposed Action would not significantly affect the transmission or generation of energy or generate substantial consumption of energy. The project's projected energy use is estimated to be 96,897,425 mbtu/ sf over the No-Action condition, which is below the analysis thresholds specified in the CEQR Technical Manual. Therefore, the Proposed Actions would not result in significant adverse impacts related energy.

- 13. The Proposed Action would generate additional pedestrian, and transit volumes that are expected to exceed the analysis thresholds specified in the CEQR Technical Manual for those travel modes. Therefore, detailed analyses of the Proposed Project's potential to result in significant adverse impacts will be performed as the Proposed Actions may have the potential to result in significant adverse impacts related to transportation.
- 14. The Proposed Action would have the potential to create new stationary sources of pollutants and introduce new emissions stacks so that changes in the dispersion of emissions from the stacks may affect surrounding uses. Therefore, the Proposed Action has the potential to result in significant adverse impacts related to air quality.
- 15. The Proposed Action would result in development that would affect the City's greenhouse gases reduction goal. The Project Area is not located within the coastal zone boundary or within the current 100- or 500-year flood zone. Therefore, the Proposed Action does not have the potential to result in significant adverse impacts related to climate change, but does have the potential to result in significant adverse impacts related to greenhouse gas emissions.
- 16. The Proposed Action would introduce new noisesensitive receptors including commercial office space in an area with existing high ambient noise levels. Therefore, the Proposed Action has the potential to result in significant adverse impacts related to noise.
- 17. The Proposed Action would have the potential to result in unmitigated significant adverse impacts related to hazardous materials, air quality, or noise. Therefore, the Proposed Action could have the potential to result in significant adverse impacts related to public health.
- 18. The Proposed Action would have the potential to result in significant adverse impacts in the constituent technical areas related to neighborhood character or in moderate effects to several elements that define neighborhood character. Therefore, the Proposed Action has the potential to result in significant adverse impacts related to neighborhood character.
- 19. The Proposed Project is located in Midtown Manhattan, in one of the City's central business districts and would have a construction period of approximately 42 months, which would exceed the analysis thresholds specified in the CEQR Technical Manual warranted for construction activities. Therefore, the Proposed Actions may have the potential to result in significant adverse impacts related to construction.

#### **Public Scoping:**

The CEQR lead agency hereby requests that the applicant prepare or have prepared, at their option, a Draft Environmental Impact Statement (DEIS) in accordance with 6 NYCRR 617.9(b) and Sections 6-08 and 6-12 of Executive Order No. 91 of 1977 as amended (City Environmental Quality Review).

A public scoping meeting will be held on Thursday, August 27, 2020, at 2:00 P.M. In support of the City's efforts to contain the spread of COVID-19, DCP will hold the public scoping meeting remotely through video conferencing. 



The Procurement section of the City Record is comprised of notices of proposed New York City procurement actions, contract awards, and other procurement-related information. Notice of solicitations and other notices for most procurement methods when a the propert 000 000 most procurement methods valued at or above \$100,000 for goods, services, and construction must be published once in the City Record, among other requirements. Other procurement methods authorized by law, such as sole source procurements, require notice in the City Record for five consecutive editions. Unless otherwise specified, the agencies and offices listed are open for business Monday through Friday from 9:00 A.M. to 5:00 P.M., except on legal holidays.

# NOTICE TO ALL NEW YORK CITY CONTRACTORS

**CONTRACTORS** The New York State Constitution ensures that all laborers, workers or mechanics employed by a contractor or subcontractor doing public work are to be paid the same wage rate that prevails in the trade where the public work is being done. Additionally, New York State Labor Law §§ 220 and 230 provide that a contractor or subcontractor doing public work in construction or building service must pay its employees no less than the prevailing wage. Section 6-109 (the Living Wage Law) of the New York City Administrative Code also provides for a "living wage", as well as prevailing wage, to be paid to workers employed by City contractors in certain occupations. The Comptroller of the City of New York is mandated to enforce prevailing wage. Contact the NYC Comptroller's Office at www.comptroller.nyc.gov, and click on Prevailing Wage Schedules to view rates.

Any denial or revocation of pre-qualified status can be appealed to the Office of Administrative Trials and Hearings (OATH). However, there are certain types of payments that are not eligible for interest; these are listed in Section 4-06 of the Procurement Policy Board Rules. The Comptroller and OMB determine the interest rate on late payments twice a year: in January and in July.

The notices for each Agency (or Division) are further divided into three subsections: Solicitations, Awards; and Lists & Miscellaneous notices. Each of these subsections separately lists notices pertaining to Goods, Services, or Construction.

Notices of Public Hearings on Contract Awards appear at the end of the Procurement Section.

At the end of each Agency (or Division) listing is a paragraph giving the specific address to contact to secure, examine and/or to submit bid or proposal documents, forms, plans, specifications, and other information, as well as where bids will be publicly opened and read.
