Work of the Sanitary Inspectors.

The following is a summary of the operations of the Sanitary Bureau, which is charged with the duty of inspecting and reporting in proper form all nuisances or causes of danger to the public health, with the execution of the orders of the Board, and with the care of contagious diseases.

The number of inspections made by the Sanitary and Assistant Sanitary Inspectors was 20,484; the number of causes of complaint was 6,345, as follows :

The number of complaints received from citizens was 2,560, all of which were referred to the Sanitary Inspectors for investigation and report. The Sanitary Superintendent during the same period, under instruction and authority of the Board, granted 762 permits to discharge cargoes, upon proper vouchers from the Health Officer of the Port; 867 permits to scavengers to empty privies, their work being inspected by officers of this Board detailed for the purpose; 48 permits to land rags (in bulk) under bonds; 8 permits to transport manure; and 6 miscellaneous permits under the Sanitary Code.

During the three months ending December 31, 1882, seven thousand six hundred and sixty-five (7,665) permits were granted for burials. During the same period two hundred and twenty (220) applications for transit permits were received and permits granted; seven hundred and thirty-three (7,33) permits were granted for the burial of still-born children; nine hundred and six (906) Coroners' certificates were received and recorded; one thousand one hundred and seven (1,107)searches of the records of births, marriages and deaths were made; and five hundred and forty-three (543) transcripts of the records of deaths, one hundred and fourteen (114) of marriages and sixty-nine (69) of births from said records were issued. There were six thousand two hundred and sixty-six (6,266) persons registered as married during the quarter, and seven thousand two hundred and minety-four (7,294) children were born during the same period.

The notices of the Board for the abatement of nuisances are issued upon the facts and evidence contained in the written reports of the Sanitary Inspectors, the result of personal inspection of premises complained of. During the three months ending December 31, 1882, the number of notices issued by the Board was 5,337. These notices call the attention of owners, lessees, and agents as to violation of the Sanitary Code in each case, and require the necessary alteration, repair, cleaning, and improvement of the premises named within five days from the receipt of the notice. If, upon reinspection, it is found that the requirements of the notice have not been complied with, a suit for penalty is commenced against the delinquents, under section 82, chapter 335, Laws of 1873.
