BRIDGES OVER THE EAST RIVER.

No. 1—Brooklyn Bridge.

During the quarter the train and surface car service on the bridge was maintained free from serious or fatal accidents. Travel was interrupted twice by long delays—one on April 2, caused by a broken axle on a bridge motor car, which stopped travel on the bridge railway for two hours during the morning rush, and the other on May 9, caused by lack of electric power—the result of an accident in the B. R. T. power house—delayed travel on the bridge railway and surface cars for about one hour in the evening rush.

The regular summer service of through trains from all elevated railway lines in Brooklyn was resumed early in June. This service has been continued through the busy hours of Saturday afternoons in place of the four-car bridge trains formerly used.

Beginning June 28, the train service during the busy hours of the morning and evening was materially increased by substituting fourteen five-car bridge trains and four five-car elevated railway trains in place of the eighteen four-car bridge trains formerly used for this service.

A new entrance to the subway in Park row has been constructed under the lower surface car loop terminal, Manhattan station, and opened to public service.

No. 2—Williamsburg Bridge.

Construction.

Added Trolley Slips—The construction of the added trolley slips at the Manhattan end of the Williamsburg Bridge, to provide additional platform space and slips for the Brooklyn trolley cars, has been practically completed. Some delay was occasioned by the slow delivery of the special track work, but to date all of this has been delivered with the exception of one double crossover to be located at the westerly end of the temporary terminal, and the terminal is now working to its full capacity, with the exception of the two stands awaiting the above mentioned crossover.

The replanking of the platform in the vicinity of the new work is being pushed with the greatest possible expedition.

Howe Monument on Brooklyn Plaza—Work was commenced on the foundations for the equestrian statue of George Washington, to be erected by Ex-Registrar Howe, on the Brooklyn plaza. It was expected that the statue would be unveiled on June 16, but owing to unavoidable delay in the delivery of the granite shaft for supporting the bronze figure, it is now doubtful if the ceremonies will take place previous to Labor Day.

Manhattan Subway Station—Photographs have been taken over the entire area to be disturbed for the construction of the Manhattan subway station, for which bids were opened on June 14.

Bridge Lighting Station Walls—In connection with the erection of a foundry building for the R. Hoe Company, adjacent to the lighting station, on the south side, arrangements have been made with the contractors, Messrs. List & Rose, for this work, looking to the protection of the foundations of the lighting station from disturbance and injury. They have received a Department Order covering the cost of said work, and their precautionary measures are being observed by this office.

Grand Street Extension—The demolition of the buildings in connection with the extension of Grand street, to the Brooklyn plaza, is in progress.

General—Plans and specifications have been prepared for additional footwalks for the trolley tracks, and for the construction and re-construction of sewers in South Fifth street, and in Driggs avenue, for the Brooklyn approach.

Plans are also well under way for the construction of a pipe line on each roadway, between masonry approaches of the bridge for high pressure fire service, with a pumping plant to be located in the bridge lighting station.

Maintenance.

Electric Lighting—The lights on the bridge and plaza have been satisfactorily carried by the lighting plant, since the last quarterly

Holes are being drilled on the under side of the cable covers at each band, in order to provide for drainage of any condensed moisture which may collect within the covers. This work is being prosecuted in conjunction with the tightening of the bolts in the cable bands.

Main Span Blocking—As mentioned in the last quarterly report, blocking was placed between the main span platform and the Brooklyn anchorage, and by utilizing the rise in temperature, the position of the platform was corrected; upon the removal of this blocking, however, the span resumed its eccentric position and further attempts to rectify this irregularity will be postponed until after the new rollers are substituted on the New York side when it is expected that the span will resume its normal position.

Inspection—A careful and comprehensive inspection of the entire bridge is being carried on from day to day, and has been found to yield excellent results in the matter of maintaining the structure in a good working condition.

No. 3—Manhattan Bridge.

Office Work.

At the beginning of this quarter about a week's work remained to complete the revision of plans for the proposed Manhattan subway terminal station, Williamsburg Bridge, providing for future change to through traffic connection with rapid transit subway. But before the expiration of that time it was decided to extend the station another block to Essex street, and the revision of plans for this extension occupied the attention of office force until the 28th of April, when it was completed. About one week thereafter was consumed in the general review of plans and the preparation of general sewer plan, covering changes in sewers affected by the construction of the subway station. During the remainder of this quarter the office force, consisting of Messrs. Carman, Hawley, Perry and Vroman, has been engaged on the preliminary studies, the computation and preparation of detail plans of the approaches of Manhattan Bridge. This work is well under way.

Field Work.

Brooklyn Side—On the anchorage contract work has been continued, laying the various classes of masonry and backfilling around the anchorage.

At the beginning of this quarter there had been laid about 43,700 cubic yards of cyclopean masonry and No. 1 concrete and about 1,830 cubic yards of granite face masonry. At this date there have been laid 50,155 cubic yards of cyclopean masonry and No. 1 concrete, 106 cubic yards of substitute arch facing concrete and 3,340 cubic yards of granite face masonry. Some delay in setting granite face masonry during the quarter has occurred through the slowness and disorder in delivery of cut granite. The progress of work has been delayed on account of absence of anchor chains, girders, etc. The total settlement of anchorage since the records were begun, when the masonry had reached about the street level, is slightly more than three-eighths of an inch, practically uniform over the whole area. The backfilling to grade is nearly completed around the anchorage. The contract is now about 48 per cent. completed.

Manhattan Side—On the anchorage contract work has continued on the excavation, driving bearing piles and laying various classes of masonry.

The bearing pile driving was completed April 27 and the excavation for foundation was entirely completed at the close of May. The driving of bearing piles was delayed on account of poor quality of piles delivered and failure of parts of pile machines. The excavation and concreting of the westerly half of the middle section was much delayed by contractor's failure to remove, when he should, the pile of cyclopean masonry stone stored there. At the beginning of this quarter there had been laid about 9,160 cubic yards of cyclopean masonry and No. 1 concrete and 144 cubic yards of granite face masonry. At this date there have been laid 21,870 cubic yards of cyclopean masonry and No. 1 concrete and 421 cubic yards of granite face masonry. The granite face masonry work has progressed very slowly on account of lack of available place to lay stone. The work on this anchorage has been considerably delayed on account of failure of contractors to keep concrete material supplies on hand as needed and the unsatisfactory manner in which the work has been managed. The contract is now about 35 per cent. completed.

No. 4—Blackwell's Island Bridge.

Steel Superstructure.

Drawings—During the quarter the contractor for the steel superstructure has submitted about 150 drawings. These drawings have been checked, 94 have been duly approved and 9 have received preliminary approval.

Strain Sheets—The strain sheets have been checked and all except two have been approved; these two are held on account of possible changes in the arrangement of the material of members over the Manhattan and Queens anchor piers.

A satisfactory detail has been submitted of the anchorage at the Manhattan end of bridge; the anchorage in Queens will be of similar construction.

In the original design the lower floor was proportioned to carry a roadway and four trolley tracks, the two outer tracks being designed for conduit trolleys and the two inner tracks for overhead trolleys. Changes were made which called for two conduit trolleys on the north side of bridge and two overhead trolleys on the south side. Later it was decided to reinforce the inner trolley track stringers of both tracks so they will safely carry subway trains. In view of the uncertainty as to what kind of traffic the lower tracks may carry, it is deemed advisable to reinforce also the outer trolley stringers and floor-beam brackets for subway trains, and to leave the roadway, curb stringers, rail guards and grating as in the original design.

Manufacture—A total of 42,200 tons of material has been inspected and accepted at the mills. This is about 80 per cent. of the total material required for the superstructure of the main bridge.

The progress in shop work has been satisfactory; 14,533 tons of finished material was delivered at bridge site, and a large amount remains in the storage yards at Steelton and Pottstown, Pa.

Erection—The progress in erection has been slow. Owing to a strike of the bridge men no work was done this year before May 15. Since that date 1,130 tons of steel have been erected; 6,120 tons of structural steel and 480 tons of steel castings of the island span have been erected to date. All the lower floor, except the buckle plates, upper floor beams and track stringers, castings on Piers 2 and 3, pier members, lower chords and web members to the intersecting point have been erected. Two travelers will now be employed to complete the erection of the island span and its cantilevers. One of these travelers is ready to start, the other one is about 30 per cent. complete, and is expected to begin operations before the end of July.

A considerable amount of jacking will have to be done to bring the trusses into correct camber line and before the upper chords can be assembled. The contractor is doing this work now.

The first coat of paint on some of the material, which has been lying on the island for a long time, is in a very bad condition. The contractor is repainting the rusted places in the members and touching up minor defects and abrasions.

Masonry.

Anchor Piers—Work on the anchor piers is progressing very slowly. The last stone of the granite masonry was set on April 28. The contractor is laying the enameled brick of the well lining with a small force of men. The Manhattan and Queens anchor piers are about 95 per cent. complete.

Piers—Granite for the attics of Piers 1, 2, 3 and 4 has been delivered, and about 500 cubic yards of this has been cut. Laying masonry of the attics cannot be started until after the cantilever arms have been erected.

Elevator Towers—Owing to a probable change in the design, work on the elevator shafts of Piers 2 and 3 and the power houses on Blackwell's Island has not been started.

Approaches.

Queens Approach—General and detail drawings for the steel viaduct approach in Queens and the masonry foundations for the same are about 90 per cent. complete. Very little work has been done on the design of the masonry approach.

Manhattan Approach—A number of sketches have been made of the masonry approach in Manhattan. The design is being worked out with the assistance of the consulting architect.

BRIDGES OVER THE HARLEM RIVER AND IN THE BOROUGH OF MANHATTAN.

Maintenance.

No. 1. Willis Avenue Bridge—New window frames and sashes have been put in the Bridge Tenders' houses because the original ones were curved and very expensive to repair.

One cylinder from the turning engine has been overhauled and trued up at the Brooklyn Bridge shop. The side of the engine room opposite the ends of the boilers has been set back about three feet to give proper access to the boilers for cleaning.

No. 3. Third Avenue Bridge—The work of repainting the structure was begun in the early part of October, 1905, and was completed in April of this year. The structure was thoroughly cleaned and given one coat of paint, except the upper part of the draw span exposed to the weather, and those parts which in cleaning had been scraped bare, to which two coats were applied.

On the ends of the draw span at the inside edge of apron seats, steel ribs have been secured against which the asphalt pavement will finish, and will not, as heretofore, be crowded under the aprons.

During April, when a strike among the anthracite coal miners seemed probable, a coal bin was built under the north approach to Third Avenue Bridge and about 700 tons of coal stored in it, from which a supply could be drawn in case of necessity.

No. 4. Madison Avenue Bridge—No work has been done at this bridge except the usual replanking of the roadway.

No. 5. One Hundred and Forty-fifth Street Bridge—A line of lead pipe has been laid from the water main near River avenue to The Bronx abutment, and connected with the service pipes of the bridge, which furnishes a satisfactory supply of water. A metre has been put in the service.

No. 6. Macomb's Dam Bridge—The lifting aprons between draw span and approaches have never given satisfaction as they were lifted by hand and delayed the operation of the bridge; in addition to this the apron and lifting machinery on the Manhattan end had got in bad condition and could not be repaired without opening the draw and stopping travel for several days. It was, therefore, decided to take out the lifting aprons with their machinery and put in new ones, fixed to the approaches. This has been done on the Manhattan side and work begun on The Bronx side. There is now less delay at each opening of the draw and the completed apron is firm and smooth under travel.

No. 7. New York and Putnam—The truss span over tracks of the New York Central and Hudson River Railroad has been made safe by erecting two A frames over it from which the span is suspended.

No. 8. Washington—No painting has been done on this bridge, except on the balustrades and cornice, since 1897, and parts of this structure, particularly the buckle plates, require immediate attention. Therefore, when work on Third Avenue Bridge was finished in the latter part of April the whole painting force was put on Washington Bridge, and has been employed there constantly since then. The feet of the posts, where they rest on the steel arches, from pockets in which dirt and moisture collect and corrosion begins. These pockets are being filled with concrete as they can be reached from the scaffolding.

The average number of draw openings per day during the quarter have been as follows:

The annual contract for supplying hardware was executed May 1, 1906, W. E. Burke, Contractor. The annual contract for asphalt repairs has been awarded to the Uvalde Asphalt Paving Company, but has not yet been executed.

Construction.

No. 1. Willis Avenue—As noted in the last quarterly report the Southern Boulevard approach has been completed. The estimated cost was \$116,748. The actual cost under the contract was \$108,341.06.

No. 4. Madison Avenue—Bids for construction of the temporary bridge were opened May 24, 1906. Five bids were presented, of which that of Lawler Bros. Construction Company was the lowest, at \$66,399. The contract has been awarded but is not yet executed.

No. 9. University Heights—Work has been pushed with considerable vigor during this quarter. The Manhattan abutment and rest pier having been completed, the old draw span from ship canal was moved to the new pivot pier June 14, 1906. An account of the operation in detail has been given in the weekly report covering that date. The westerly approach span was also moved to the new site.

No. 10. Ship Canal—The old draw span was moved to University Heights June 14, and the new span which had been built on false work at the foot of Two Hundred and Eighteenth street, was moved into position June 16, and has been successfully operated since then, though the bridge is not yet complete in all its details.

Henry Hudson Memorial—In addition to the sum of \$1,000,000 appropriated in the early part of this year an additional appropriation of \$2,000,000 was made by the Board of Estimate and Apportionment, June 8, 1906, by the Board of Aldermen, July 10, 1906, and signed by the Acting Mayor, July 19, 1906.

Elaborate plans for a bridge with masonry approaches and a great steel arch span over the river have been prepared by Messrs. Boller and Hodge, consulting engineers, acting in collaboration with Walker and Morris, architects. These plans have been presented to the Art Commission, and if they are promptly approved the bridge can be put under contract early this fall and completed in time for the Hudson Tri-Centennial celebration.

A contract for diamond drill borings is now in course of preparation to determine the character of the river bed at the bridge site.

BRIDGES IN THE BOROUGH OF THE BRONX.

Maintenance and Repairs.

No. 1. One Hundred and Thirty-fifth Street Bridge Over Mott Haven Canal—The upper course of planking or wearing surface of the roadway was renewed. No other repairs of consequence were made.

No. 2. Westchester Avenue Bridge—Small repairs were made to the machinery and its supports, and the system of supplying current to the motor was changed from a loosely swinging cable to a fixed wire and trolley on the face of the back wall of the east abutment.

In accordance with a permit granted by the Commissioner of Bridges the Union Railway Company began to operate its cars across this structure on May 19; the company also relaid part of the wearing surface of the bridge roadway.

No. 2T. Westchester Avenue Temporary Bridge—The old draw span was not removed or disturbed. It is projected to leave it in its present position until money is appropriated for the construction of a new bridge at Eastchester, to which location it can be shifted and used as a temporary crossing during the construction of the permanent structure.

No. 3. Unionport Bridge—Small repairs were made to the timber deck and to the hand railing. Part of the south end of the pile fender, that had been damaged in a collision with a passing tow, was rebuilt.

No. 4T. Pelham Temporary Bridge—The timber sidewalk along the north causeway approach and part of the deck of the bridge were strengthened and renewed. Two broken wheels under the draw span were replaced. Further repairs are about to be made.

No. 5. City Island Bridge—The roadway of the approaches was resurfaced, but the bridge required no repairs of importance.

No. 6. Eastchester Bridge—This bridge was struck twice by passing tows and damaged, one of the posts over the drum being buckled and one of the floor beams being partly torn from the hangers. Repairs were made at once. On account of the narrow waterway, the crooked channel and the increasing width of vessels lately passing the bridge, these collisions were unavoidable. No pile protection can be built without impeding traffic on the stream. The entire deck of this bridge, including the timber stringers, was renewed during the quarter.

Bridges Projected or Under Construction.

No. 4. Pelham Bridge—The contract for the foundations, piers and abutments of Pelham Bridge was practically completed at the beginning of the quarter, the principal operations since April 1 being the pointing of part of the masonry, and the removal of the upper sections of the cofferdams and the dismantling of plant.

The contract for finishing the bridge and its approaches will be let early in the coming quarter.

No. 3. Unionport Bridge—No work was done on the project of a new bridge at this crossing, except the preparation of estimates of the probable cost of such a structure. The approaching completion of Tremont avenue, a new diagonal thoroughfare across the borough and intersecting Eastern Boulevard near the creek, will bring increased traffic to this section, and render advisable the building of an adequate modern bridge in place of the present antiquated structure. Surveys and studies have been made for this work, and plans and specifications will be made as soon as money is appropriated.

No. 6. Eastchester Bridge—The project of a new bridge at the crossing of the Boston post road and Hutchinson river has been approved by the Board of Estimate and Apportionment, but the ordinance granting the necessary funds has not yet been passed by the Board of Aldermen. In the meantime, surveys have been made of the bridge site and vicinity, and as soon as money is available borings and plans will be begun. As noted above, the Westchester avenue temporary bridge can be used at the crossing while the permanent structure is being built.

BRIDGES OVER NEWTOWN CREEK AND IN THE BOROUGH OF QUEENS.

Bridges Over Newtown Creek.

No. 1. Vernon Avenue Bridge—The work of preparing final estimate for construction of this bridge under way. The contractor has presented claims for extra work, which have been investigated, and it is expected that a final settlement will be made shortly.

The traffic over this bridge is quite heavy, and I believe it to be increasing steadily. The asphalt roadway of the north viaduct has been renewed at places at our expense, as there is no guarantee clause for its maintenance. This pavement will be a continued source of expense, and the repaving of this viaduct with wood blocks cannot be too strongly recommended.

The New York and New Jersey Telephone Company has been granted permission to lay ducts under the timber grillage of the sea walls to carry its submarine cables across Newtown creek, for which the company pays the city an annual rental of \$200. The ducts have been laid at south sea wall, and work at north sea wall has commenced, but not as yet completed.

Plans and specifications for a stairway at Flushing street have been prepared, and bids are called for to be opened on July 12, 1906. The abutting property owner (Long Island Railroad Company) has given its consent to the erection of this stairway.

The mechanical force of carpenters and ironworkers has been employed in making improvements at this structure. Among the more important of which may be mentioned the erection of a two-inch water pipe along the north viaduct, to be used in flushing the asphalt roadway.

The only interruption to traffic over this structure occurred on June 20, when the armatures on one of the solenoid brakes of Brooklyn leaf burned out, with the leaf in the open position delaying land traffic from 10 to 10.55 a. m.

The paving of Manhattan avenue under the south viaduct near the bulkhead, about 1,500 square yards, will be contracted for during the present summer.

The cars of the Brooklyn Heights Railroad Company commenced running over this structure on Sunday, June 10, at 6 a. m., and have continued uninterruptedly to present time.

No. 2. Greenpoint Avenue Bridge—Main operating pinion broken has been replaced. The machinery has been adjusted and placed in good condition, and we await the arrival of steel gears and clutches to replace slightly damaged ones. The end wedges have been improved in operation by the placing of "stops" to control the travel of connecting rod. New water pipe has been laid along Greenpoint avenue to supply shelter house. This structure is in good condition.

No. 3. Meeker Avenue Bridge—Additional bolting to support motor has proved satisfactory and this bridge has required no repairs without the exception of bolting of armor plate at northwest corner centre pier fender.

No. 4. Grand Street Bridge—The clutch operating end wedges has been replaced. Stops to control end wedges have been placed in position and the machinery has been adjusted and overhauled generally. New wood covers for bottom chord of draw span have been made and placed in position.

No. 5. Metropolitan Avenue Bridge—No work required during quarter.

As recommended in report for quarter ending March 31, 1906, plans have been prepared for the widening of this structure to full width of avenue, i. e., from 29 feet 6 inches to 66 feet. The sum of \$10,000 has been requested (May 4, 1906) for this work.

Bridges in Borough of Queens.

No. 6. Borden Avenue Bridge—This bridge is in very bad condition and the new structure, for which bids were received on May 24, 1906, is sorely needed.

The contract for the construction of the new bridge was awarded to the Degnon Contracting Company, whose bid of \$156,221.50 was the lowest of six received.

The work on this contract was commenced on June 28 by the driving of piles for draw-span pier and east approach of the temporary bridge. The names of commissioners to acquire land for permanent bridge were announced on June 8.

No. 7. Flushing Bridge Construction—Considerable progress has been made during the past quarter on this contract.

The west rest pier has been completed with the exception of some pointing, which the cofferdam prevented doing.

The erection of steel was commenced on April 24, on which date the north girders of east fixed span were placed in position. This work has advanced uninterruptedly to date. The east fixed span has been completed with the exception of the riveting of about one-half of the buckle plate floor and the aprons at end of span. The draw-span has been completely riveted and has received its first field coat of paint, as has also the east fixed span. About 30 per cent. of the counterweight is in place, and the erection of machinery was commenced May 31. The machinery, including motor on west leaf, is in place, and that of east leaf about 50 per cent. completed.

The shelter houses on east rest pier have been commenced, and good progress has been made. The contractor has made arrangements for the operating of the draw-span by temporary control as the operators' house will not be completed at the time the draw-span will be ready for operation.

The creosoted timber and hand railing have been delivered and the work of erection will be commenced early in July.

The reinforcement of the west abutment has been completed and the north wing wall repaired. Considerable earth-fill has been placed back of abutment from scow and also hauled by carts, and to date about two-thirds of fill is in place.

At the present rate of progress this bridge should be opened for traffic early in September.

No. 8. Strong's Causeway Bridge—Brooklyn Heights Railroad Company continued work of replacing flat rails on both approaches by 9-inch girder rail on west approach and 5-inch tee rail on east approach. This work is still in progress and when completed will afford better grades on both approaches.

No. 9. Little Neck Bridge—No work done during quarter. A new bridge is required at this point.

BRIDGES IN THE BOROUGHS OF BROOKLYN AND RICHMOND.

Borough of Brooklyn.

Hamilton Avenue Bridge—The concrete operators' houses at this bridge were completed in June, after much delay, due to difficulty in getting men of the different trades to perform the small amounts of work of the various classes, and are now occupied by the force on the bridge. These houses made it possible to operate the bridge with one less man than was required when the operating controllers and switch-board were below the street level.

The machinery of this bridge is running very smoothly. The bridge is so evenly balanced that it can be moved either up or down by hand power applied on the brake wheel.

Since construction the foundation walls of this bridge have developed some rather serious cracks, occurring on both sides of the canal, and there has been a movement of the walls towards the centre of the canal. During the last three months this movement has amounted to half an inch. Previously the movement totaled about three and one-half inches. From October to March there was practically no movement. A continuation of this movement for several inches more will result in the necessity of alterations in the centre of the leaves, as they will interfere before the bridge can be fully closed. This movement is doubtless caused by the sliding of the mud bottom of the canal. The walls are built on platforms supported on piles, only the rest piers being carried to a depth below the river bottom. I would recommend that a concrete apron two feet thick be laid across the canal bottom between the abutments to act as a compression member in case there is a tendency to further movement of considerable extent.

Ninth Street Bridge—This bridge has been painted and is operating satisfactorily. A toilet and wash-basin have been installed in the operators' house, doing away with the excuse for going to the corner saloon.

Third Street Bridge—This bridge has been painted and is operating well. A toilet and wash-basin were installed here also. The roadways at the side approaches to the property adjoining the bridge were originally paved with old Belgian blocks on two roads and old granite on the other two. A new granite block pavement on concrete would greatly improve the condition and appearance of the approaches and property adjoining them. I would recommend that this pavement be laid.

Carroll Street Bridge—This bridge has been painted. A new deck is needed here very soon, and I would recommend that next year a wood block pavement be laid on this bridge. This bridge is operated by an engine run by steam. It would be greatly improved by the installation of a motor and electric power. This was planned some time ago, but was not carried out owing to the difficulty in getting power to the bridge. The Edison Company are now laying conduits a block away on Bond street and power could doubtless be obtained much more cheaply than formerly. This matter will be looked up and reported upon later in the year.

The bulkhead at this bridge is in need of extensive repairs, but the funds available for this year make such repairs rather difficult at present. It will easily stand until next year, but should certainly be repaired then.

Union Street Bridge—This bridge has been painted and is operating satisfactorily. A storehouse has been built under the platform in front of the operators' house, and as soon as the roadway of the street is put in shape after the excavating now going on in it short lengths of concrete walk will be laid next the bridge to improve the general appearance of it. The present walks are of dirt, and rather unsightly. The roadway of the street to the west of the bridge is to be widened five feet to equal the width of the bridge roadway.

Washington Avenue Bridge—This bridge has been painted. The floor system of this bridge is being greatly overloaded by the heavy traffic and cars sent over it. A new floor system has been designed and will be put in if funds for it can be obtained. At present all heavy ash cars are being sent round by way of Flushing and Kent avenues. Repairs are also needed on the bulkheads and masonry. These can hold over until next year, when it is hoped more money will be available for repairs to the bridges in this borough.

Metropolitan Avenue Bridge—This bridge has been painted and is operating well except for the necessity of adjustment on the turntable to allow for expansion during hot weather.

As reported before, there is great need of a new bridge at this location. Traffic is increasing all the time, and the floor system is overloaded here, as at Washington Avenue Bridge. The floor is at present reinforced with wooden stringers next to the steel ones, and wherever the planking shows signs of weakness.

Harway Avenue Bridge—This bridge is operating well and has given no trouble.

Third Avenue Bridge—This bridge has been painted and a new asphalt roadway surface put on. The old surface has been patched so often it was judged advisable to put on a complete new surface.

Borough of Richmond.

Lemon Creek Bridge—No repairs have been made at this bridge. Plans for a new bridge are being drawn.

Fresh Kills Bridge—The turntable and tie rods between the cast iron piles require renewing. Plans for this work are prepared and work will be commenced as soon as prices can be obtained.

No. 4. Grand Street Bridge—The clutch operating end wedges has been replaced. Stops to control end wedges have been placed in position and the machinery has been adjusted and overhauled generally. New wood covers for bottom chord of draw span have been made and placed in position.

No. 5. Metropolitan Avenue Bridge—No work required during quarter.

As recommended in report for quarter ending March 31, 1906, plans have been prepared for the widening of this structure to full width of avenue, i. e., from 29 feet 6 inches to 66 feet. The sum of \$10,000 has been requested (May 4, 1906) for this work.

Bridges in Borough of Queens.

No. 6. Borden Avenue Bridge—This bridge is in very bad condition and the new structure, for which bids were received on May 24, 1906, is sorely needed.

The contract for the construction of the new bridge was awarded to the Degnon Contracting Company, whose bid of \$156,221.50 was the lowest of six received.

The work on this contract was commenced on June 28 by the driving of piles for draw-span pier and east approach of the temporary bridge. The names of commissioners to acquire land for permanent bridge were announced on June 8.

No. 7. Flushing Bridge Construction—Considerable progress has been made during the past quarter on this contract.

The west rest pier has been completed with the exception of some pointing, which the cofferdam prevented doing.

The erection of steel was commenced on April 24, on which date the north girders of east fixed span were placed in position. This work has advanced uninterruptedly and to date. The east fixed span has been completed with the exception of the riveting of about one-half of the buckle plate floor and the aprons at end of span. The draw-span has been completely riveted and has received its first field coat of paint, as has also the east fixed span. About 30 per cent. of the counterweight is in place, and the erection of machinery was commenced May 31. The machinery, including motor on west leaf, is in place, and that of east leaf about 50 per cent. completed.

The shelter houses on east rest pier have been commenced, and good progress has been made. The contractor has made arrangements for the operating of the draw-span by temporary control as the operators' house will not be completed at the time the draw-span will be ready for operation.

The creosoted timber and hand railing have been delivered and the work of erection will be commenced early in July.

The reinforcement of the west abutment has been completed and the north wing wall repaired. Considerable earth-fill has been placed back of abutment from scow and also hauled by carts, and to date about two-thirds of fill is in place.

At the present rate of progress this bridge should be opened for traffic early in September.

No. 8. Strong's Causeway Bridge—Brooklyn Heights Railroad Company continued work of replacing flat rails on both approaches by 9-inch girder rail on west approach and 5-inch tee rail on east approach. This work is still in progress and when completed will afford better grades on both approaches.

No. 9. Little Neck Bridge—No work done during quarter. A new bridge is required at this point.

BRIDGES IN THE BOROUGHS OF BROOKLYN AND RICHMOND.

Borough of Brooklyn.

Hamilton Avenue Bridge—The concrete operators' houses at this bridge were completed in June, after much delay, due to difficulty in getting men of the different trades to perform the small amounts of work of the various classes, and are now occupied by the force on the bridge. These houses made it possible to operate the bridge with one less man than was required when the operating controllers and switchboard were below the street level.

The machinery of this bridge is running very smoothly. The bridge is so evenly balanced that it can be moved either up or down by hand power applied on the brake wheel.

Since construction the foundation walls of this bridge have developed some rather serious cracks, occurring on both sides of the canal, and there has been a movement of the walls towards the centre of the canal. During the last three months this movement has amounted to half an inch. Previously the movement totaled about three and one-half inches. From October to March there was practically no movement. A continuation of this movement for several inches more will result in the necessity of alterations in the centre of the leaves, as they will interfere before the bridge can be fully closed. This movement is doubtless caused by the sliding of the mud bottom of the canal. The walls are built on platforms supported on piles, only the rest piers being carried to a depth below the river bottom. I would recommend that a concrete apron two feet thick be laid across the canal bottom between the abutments to act as a compression member in case there is a tendency to further movement of considerable extent.

Ninth Street Bridge—This bridge has been painted and is operating satisfactorily. A toilet and wash-basin have been installed in the operators' house, doing away with the excuse for going to the corner saloon.

Third Street Bridge—This bridge has been painted and is operating well. A toilet and wash-basin were installed here also. The roadways at the side approaches to the property adjoining the bridge were originally paved with old Belgian blocks on two roads and old granite on the other two. A new granite block pavement on concrete would greatly improve the condition and appearance of the approaches and property adjoining them. I would recommend that this pavement be laid.

Carroll Street Bridge—This bridge has been painted. A new deck is needed here very soon, and I would recommend that next year a wood block pavement be laid on this bridge. This bridge is operated by an engine run by steam. It would be greatly improved by the installation of a motor and electric power. This was planned some time ago, but was not carried out owing to the difficulty in getting power to the bridge. The Edison Company are now laying conduits a block away on Bond street and power could doubtless be obtained much more cheaply than formerly. This matter will be looked up and reported upon later in the year.

The bulkhead at this bridge is in need of extensive repairs, but the funds available for this year make such repairs rather difficult at present. It will easily stand until next year, but should certainly be repaired then.

Union Street Bridge—This bridge has been painted and is operating satisfactorily. A storehouse has been built under the platform in front of the operators' house, and as soon as the roadway of the street is put in shape after the excavating now going on in it short lengths of concrete walk will be laid next the bridge to improve the general appearance of it. The present walks are of dirt, and rather unsightly. The roadway of the street to the west of the bridge is to be widened five feet to equal the width of the bridge roadway.

Washington Avenue Bridge—This bridge has been painted. The floor system of this bridge is being greatly overloaded by the heavy traffic and cars sent over it. A new floor system has been designed and will be put in if funds for it can be obtained. At present all heavy ash cars are being sent round by way of Flushing and Kent avenues. Repairs are also needed on the bulkheads and masonry. These can hold over until next year, when it is hoped more money will be available for repairs to the bridges in this borough.

Metropolitan Avenue Bridge—This bridge has been painted and is operating well except for the necessity of adjustment on the turntable to allow for expansion during hot weather.

As reported before, there is great need of a new bridge at this location. Traffic is increasing all the time, and the floor system is overloaded here, as at Washington Avenue Bridge. The floor is at present reinforced with wooden stringers next to the steel ones, and wherever the planking shows signs of weakness.

Harway Avenue Bridge—This bridge is operating well and has given no trouble.

Third Avenue Bridge—This bridge has been painted and a new asphalt roadway surface put on. The old surface has been patched so often it was judged advisable to put on a complete new surface.

Borough of Richmond.

Lemon Creek Bridge—No repairs have been made at this bridge. Plans for a new bridge are being drawn.

Fresh Kills Bridge—The turntable and tie rods between the cast iron piles require renewing. Plans for this work are prepared and work will be commenced as soon as prices can be obtained.
