EXECUTIVE ORDER NO. 2

JANUARY 1, 1978

DEPUTY MAYORS

BY THE POWER VESTED IN ME AS MAYOR OF THE CITY OF NEW YORK, it is hereby ordered:

Section 1. There shall be seven Deputy Mayors. One of them shall be designated Deputy Mayor for Management, one shall be designated Deputy Mayor for Intergovernmental Relations, one shall be designated Deputy Mayor for Personnel and Labor Relations, one shall be designated Deputy Mayor for Policy, one shall be designated Deputy Mayor for Economic Development, one shall be designated Deputy Mayor for Finance, and one shall be designated Deputy Mayor for Criminal Justice.

§ 2. The Deputy Mayor for Management shall:

(a) Supervise and coordinate the operations of all administrations, departments, boards and agencies, except as otherwise provided in this Order or as the Mayor may direct.

(b) Maintain liaison with and review the activities of the Board of Education and the Board of Higher Education of The City of New York.

(c) Represent the Mayor when so directed on any board, committee, commission or corporation of which the Mayor is a member.

(d) Perform such other duties as the Mayor may direct.

§ 3. The Deputy Mayor for Intergovernmental Relations shall:

(a) In the absence of the Mayor from sessions of the Board of Estimate act on behalf of the Mayor at such sessions of the Board of Estimate.

(b) Act on behalf of the Mayor with respect to all Federal, State and local legislative matters affecting the City; direct the activities of the Mayor's legislative representative, the Albany office, and the Washington, D.C. office; represent the Mayor before Congressional and State legislative committees, maintain liaison with the Office of the President and all Federal departments and agencies thereof, the Office of the Governor and all State departments and agencies thereof, the Board of Estimate and the City Council; and supervise the activities of the New York City Commission for the United Nations and for the Consular Corps.

(c) Serve as the Mayor's representative on and maintain liaison with regional bodies

and intergovernmental agencies operating within the New York metropolitan regional bodies (d) Maintain liaison with the United States Conference of Mayors, the National League of Cities, the New York State Conference of Mayors and other similar bodies.

(e) Represent the Mayor when so directed by the Mayor on any board, committee,

commission or corporation of which the Mayor is a member.

(f) Perform such other duties as the Mayor may direct.

§ 4. The Deputy Mayor for Personnel and Labor Relations shall:

(a) Supervise and coordinate the operations of the Department of Personnel and the Office of Municipal Labor Relations; conduct all labor negotiations to which the City is a party; represent the Mayor and act on his behalf in connection with all labor negotiations in which the City has an interest, including, but not limited to, negotiations conducted by or on behalf of all public benefit corporations located within the City, the Board of Education and the Board of Higher Education of The City of New York.

(b) Represent the Mayor when so directed on any board, committee, commission or

corporation of which the Mayor is a member.

(c) Perform such other duties as the Mayor may direct.
The Deputy Mayor for Policy shall:

(a) Advise and assist the Mayor on matters of City policy.
(b) Maintain liaison with and review the activities of the Health and Hospitals Corpo-

ration of The City of New York.

(c) Represent the Mayor when so directed by the Mayor on any board, committee, commission or corporation of which the Mayor is a member.

(d) Perform the duties specifically referred to in Section 7 of the New York City Charter and other duties as the Mayor may direct. The Deputy Mayor for Economic Development shall:

(a) Head the economic development program, supervise and coordinate the efforts to

foster the economic growth of the City.

(b) Direct the operations of the Office for Economic Development.

(c) Represent the Mayor when so directed by the Mayor on any board, commission or corporation of which the Mayor is a member.

(d) Perform such other duties as the Mayor may direct.

The Deputy Mayor for Finance shall:
(a) Supervise and coordinate the City's fiscal operations, including the operations of

(a) Supervise and coordinate the City's fiscal operations, including the operations of the Office of Management and Budget.

(b) Act on behalf of and at the direction of the Mayor in exercising and carrying out the functions, powers and duties vested in or imposed upon the Mayor by the New York State Municipal Assistance Corporation Act, the Municipal Assistance Corporation for the City of New York Act and the New York State Financial Emergency Act for The City of New York.

(c) Act on behalf of and at the direction of the Mayor in the exercise of all functions, powers and duties which the Mayor may have pursuant to Article 10 of the Public Authorities Law, as enacted by Chapters 168 and 169 of the Laws of 1975 as from time to time amended (hereinafter called the Act), including, but not limited to, full power to execute amended (nereinatter casted the Act), including, but not limited to, full power to execute for, on behalf of, and at the direction of the Mayor any agreement pursuant to Section 3038 of the Act between The City of New York and the Municipal Assistance Corporation for The City of New York, any certificate pursuant to Section 3037 of the Act, and any other document in connection with the Act. The exercise of functions, powers and duties for, on behalf of and at the direction of the Mayor by such Deputy Mayor pursuant to this delegation shall not require the consent in writing of the Mayor or any other official of the City.

(d) For the purposes of Article 2, Section 9 of the Public Officers Law, notwithstanding the temporary inability of the Mayor to exercise such functions, powers and duties as he

the temporary inability of the Mayor to exercise such functions, powers and duties as he may have pursuant to the Act, by reason of sickness or otherwise, or his absence from the City, the delegation established by subdivision (c) of this Section 7 shall devolve upon the

Deputy Mayor for Finance.

(e) Act for, on behalf of and at the direction of the Mayor in the exercise of all functions, powers and duties which the Mayor may have pursuant to the New York City Seasonal Financing Act of 1975, Public Law 94-143, as the same may be from time to time amended, and a credit agreement made thereunder as of December 30, 1975 by and among the United States of America on the one hand and the State of New York, The City of New York and the New York State Emergency Financial Control Board on the other New York State Emergency Financial Control Board on the other hand, including, but not limited to, full power to execute for, on behalf of, and at the direction of the Mayor, any document pursuant to such agreement and any agreement, amendment to agreement or other document pursuant to such law. The exercise of functions, powers and duties for, on behalf of and at the direction of the Mayor by such Deputy Mayor pursuant to this delegation shall not require the consent in writing of the Mayor or any

other official of the City.

(f) Represent the Mayor when so directed by the Mayor on any board, committee, commission or corporation of which the Mayor is a member.

(g) Perform such other duties as the Mayor may direct. The Deputy Mayor for Criminal Justice shall:

(a) Serve as the coordinator of criminal justice provided by Section 13 of the New

York City Charter.

(b) Supervise and coordinate the operations of the Department of Correction, Police Department and Department of Probation. (c) Represent the Mayor when so directed by the Mayor on any board, committee, commission or corporation of which the Mayor is a member.

(d) Perform such other duties as the Mayor shall direct.
§ 9. References in Executive Orders to First Deputy Mayor are hereby amended to refer to the appropriate Deputy Mayor. The reference in Section 2 of Executive Order No. 43 of October 14, 1975 to "four Deputy Mayors" is hereby amended to refer to "seven Deputy Mayors." Executive Orders No. 2 of January 1, 1974, No. 40 of September 25, 1975, No. 49 of January 22, 1976, No. 71 of September 16, 1976, and No. 73 of October 20, 1976 are hereby revoked. Nothing in Executive Order No. 1 or this Executive Order shall be construed to affect the validity of any act performed prior to January 1, 1978 pursuant to such Executive Orders hereby validity of any act performed prior to January 1, 1978 pursuant to such Executive Orders hereby revoked.
