




Figure 1-2 Vicinity Map Southwest Brooklyn Marine Transfer Station








Figure 1-2 Vicinity Map Greenpoint Marine Transfer Station








Figure 1-2 Vicinity Map Hamilton Avenue Marine Transfer Station








Figure 1-2 Vicinity Map North Shore Marine Transfer Station


West 59th St Hudson River SITE OUTLINE






Figure 1-2 Vicinity Map West 135th Street Marine Transfer Station








Figure 1-2 Vicinity Map West 59th Street Marine Transfer Station








Figure 1-2 Vicinity Map East 91st Street Marine Transfer Station






Figure 1-2 Vicinity Map Southwest Brooklyn Marine Transfer Station








Figure 1-2 Vicinity Map Greenpoint Marine Transfer Station









Figure 1-2 Vicinity Map Hamilton Avenue Marine Transfer Station
