## Waste Setout Times Change April 1

Businesses that place waste at the curb\* for collection have two options:

- If using a container with a secure lid, place waste at the curb 1 hour before closing, **or**
- If putting bags directly on the curb, place waste out after 8:00 PM

\* This does not apply to businesses that have waste collected from a loading dock.

Remember, containers must be removed from the curb by the time your business reopens.

As part of our commitment to keeping our streets clean, the NYC Department of Sanitation is implementing a new rule to reduce the time that trash, recycling, and curbside composting will sit on sidewalks. The new rule goes into effect **April 1, 2023**. Businesses that place waste at the curb\* for collection have two options:

- If using a container with a secure lid, place waste at the curb 1 hour before closing, or
- If putting bags directly on the curb, place waste out after 8:00 PM

\* This does not apply to businesses that have waste collected from a loading dock.

Como parte de nuestro compromiso de mantener nuestras calles limpias, el Departamento de Sanidad de la Ciudad de Nueva York (NYC Department of Sanitation) está aplicando una nueva norma para reducir el tiempo que la basura y el material para reciclaje y compostaje permanecen en las aceras. La nueva norma entrará en vigencia el **1 de abril de 2023**. Las empresas que sacan los desechos a la acera\* para que se los recoja tienen dos opciones:

- Si se utiliza un contenedor con tapa cerrada, los desechos se deben colocar en la acera 1 hora antes del cierre.
- Si se ponen las bolsas directamente sobre la acera, los desechos se deben sacar después de las 8:00 p. m.

\* Esto no se aplica a las empresas cuyos desechos se recogen en un muelle de carga.

- 如果使用帶有安全蓋的垃圾桶，請在營業時間結束前一小時將垃圾放在路邊，或者
- 如果要將垃圾袋直接放在路邊，請等到晚上 8 點以後再把垃圾拿出去扔

\* 此做法不適用於從裝卸碼頭收集廢棄物的公司行號。
