### Chapter 8

# The Quality Housing Program 28-00

#### GENERAL PURPOSES

The Quality Housing Program is established to foster the provision of multifamily housing and certain #community facilities# that:

- (a) are compatible with existing neighborhood scale and character;
- (b) provide on-site amenity spaces to meet the needs of its residents; and
- (c) are designed to promote the security and safety of its residents.

#### 28-01

#### **Applicability of this Chapter**

The Quality Housing Program is a specific set of standards and requirements that, in conjunction with the #bulk# provisions for #Quality Housing buildings# set forth in Article II, Chapter 3, and Article III, Chapter 5, as applicable, apply to #buildings# containing #residences#, #long-term care facilities# or philanthropic or non-profit institutions with sleeping accommodations, or some combination thereof as follows:

- (a) In R6A, R6B, R7A, R7B, R7D, R7X, R8A, R8B, R8X, R9A, R9D, R9X, R10A or R10X Districts, and in the equivalent #Commercial Districts# listed in Sections 34-111 and 34- 112, all such #buildings# shall comply with the Quality Housing Program standards and requirements as set forth in this Chapter.
- (b) In other R6, R7, R8, R9 or R10 Districts, and in the equivalent #Commercial Districts# listed in Sections 34-111 and 34-112, all #developments# and #enlargements# of such #buildings# utilizing the Quality Housing #bulk# regulations in Article II, Chapter 3, shall comply with the Quality Housing Program standards and requirements set forth in this Chapter.
- (c) In R5D Districts, only the requirements set forth in Sections 28-12 (Refuse Storage and Disposal), 28-23 (Planting Areas) and 28-43 (Location of Accessory Parking) shall apply.
- (d) In R6 through R10 Districts, and in the equivalent #Commercial Districts# listed in Sections 34-111 and 34-112, for #developments# and #enlargements# of #community facility buildings# containing #long-term care facilities# or philanthropic or non-profit institutions with sleeping accommodations, or portions of #buildings# containing such #uses#, where such #buildings# utilize the #bulk# regulations for #Quality Housing buildings# in Article II, Chapter 3, in R6 through R10 Districts with a letter suffix, or the height and setback regulations for #Quality Housing buildings# in Article II, Chapter 3, in R6 through R10 Districts without a letter suffix, the Quality Housing Program standards and requirements of this Chapter shall apply, except that the provisions of Section 28-12 shall be optional.
- (e) The provisions of Article VII, Chapter 8 (Special Regulations Applying to Large-Scale Residential Developments), are not applicable to #Quality Housing buildings#.

 $(f \underline{e})$  The provisions of this Chapter shall not apply to #dwelling units converted#, pursuant to Article I, Chapter 5, unless such #conversions# meet the requirements for #residential developments# of Article II (Residence District Regulations).

#### ARTICLE VII **ADMINISTRATION**

#### Chapter 8

**Special Regulations Applying to Large-Scale Residential Developments** 

#### 78-00

GENERAL PURPOSES, DEFINITIONS AND GENERAL PROVISIONS

#### 78-01 **General Purposes**

The regulations set forth in this Chapter are ,designed to deal with certain types of problems which arise only in connection with large scale residential developments and to promote and facilitate better site planning and community planning through modified application of the district regulations in such developments.

For large - scale residential developments involving several zoning lots but planned as a unit, the district regulations may impose unnecessary rigidities and thereby prevent achievement of the best possible site plan within the overall density and bulk controls. For such developments, the regulations of this Chapter are, designed to allow greater flexibility for the purpose of securing better site planning for development of vacant land and to provide incentives toward that end while safeguarding the present or future use and development of surrounding areas and, specifically, to achieve more efficient use of increasingly scarce land within the framework of the overall bulk controls, to enable open space in large -scale residential developments to be arranged in such a way as best to serve active and passive recreation needs of the residents, to protect and preserve scenic assets and natural features such as trees, streams and topographic features, to foster a more stable community by providing for a population of balanced family sizes, to encourage harmonious designs incorporating a variety of building types and variations in the siting of buildings, and thus to promote and protect public health, safety and general welfare.

#### **Applicability of This Chapter**

78-03

#Large-scale residential developments# are governed by all the #use#, #bulk#, off-street parking and loading, and other applicable regulations of this Resolution, except for such special provisions as are specifically set forth in this Chapter and apply only to such #large - scale residential developments#. However, the Quality Housing Program is inapplicable in #large - scale residential development#.

\* \*

Any #large - scale residential development# having a total of at least 500 #dwelling units# shall be subject to the provisions of Section 78-11 (General Provisions), relating to Provision of Public Facilities in Connection with Large-Scale Residential Developments.

#Large-scale residential developments# within the #waterfront area# shall be subject to the provisions of Section 62-132 (Applicability of Article VII, Chapters 4, 8 and 9).



#### **Notice of Adoption**

**NOTICE IS HEREBY GIVEN** PURSUANT TO THE AUTHORITY VESTED IN the Commissioner of the Department of Consumer Affairs ("the Department") by section 2203(f) of the New York City Charter and section 20-546 of the New York City Administrative Code, and in accordance with the requirements of section 1043 of the New York City Charter, that the Department amends title 6 of the Rules of the City of New York.

This rule was proposed and published on October 23, 2019. A public hearing was held on November 22, 2019.

#### Statement of Basis and Purpose of Rule

The Department is amending title 6 of the Rules of the City of New York to clarify that mobile car wash services are subject to the license requirement for operating a car wash service. The rule sets specific application requirements for mobile car wash services as well as obligations to display licenses and keep certain records related to vehicles used for mobile car wash services. The rule also sets penalties for failure to provide the Department with updated information concerning vehicles used for mobile car wash services and failure to display the car wash license in vehicles used for mobile car wash services when the mobile car wash is in service.

[Deleted material is in brackets.]

"Shall" and "must" denote mandatory requirements and may be used interchangeably in the rules of this department, unless otherwise specified or unless the context clearly indicates otherwise.

#### **Rule Amendment**

Section 1. Paragraph 1 of Subdivision a of Section 2-431 of Subchapter HH of Chapter 2 of Title 6 of the Rules of the City of New York is amended to read as follows:

#### § 2-431 Insurance.

(a) Liability insurance.

(1) Every licensee must secure and maintain throughout the term of the license commercial general liability ("CGL") insurance which [shall] <u>must</u>:

(i) be issued by a company that may lawfully issue the CGL policy and which has an A.M. Best rating of at least A-/VII or a Standard & Poor's rating of at least A;

(ii) insure both the licensee and the City of New York and protect the City of New York from any claims for injury (including death) or property damage that may arise from, or allegedly arises from, the construction, operation or use of the car wash;

(iii) provide coverage of at least one million dollars (\$1,000,000) per occurrence and two million dollars (\$2,000,000) aggregate; [and]

(iv) provide coverage at least as broad as that provided in the most recently issued edition of Insurance Services Office ("ISO") Form CG 0001 and be "occurrence" based instead of "claims made"; and

 $(v)\,$  name the City of New York as an additional insured with coverage at least as broad as the most recent edition of ISO Forms CG 20 12 or CG 20 26.

2. Subdivision a of Section 2-433 of Subchapter HH of Chapter 2 of Title 6 of the Rules of the City of New York is amended to read as follows:

§ 2-433 Damage Complaint Records.

(a) *Chronological complaint log.* Each licensee must maintain a chronological log in an electronic format documenting complaints of damage to vehicles. The log must contain the following information where applicable:

- (1) Date of complaint;
- (2) Date licensee received complaint;

(3) Name, address, phone number and email address of individual or entity making the complaint;

- (4) Make and model number of vehicle;
- (5) Date licensee washed vehicle;
- (6) Description of complaint;
- (7) Whether individual or entity making complaint provided

photos or other documents;

(8) Resolution of complaint, including amount of compensation and method of payment;

(9) Name and address of insurance company or third party

involved in resolution, if any, and claim number;

- (10) Date of resolution; [and](11) Eventsees on even such a hear diad the
- (11) Employee or manager who handled the complaint;

(12) License plate number of vehicle(s) used to provide Mobile Car Wash Services that are the subject of the complaint; and

(13) Name of operator of vehicle used to provide Mobile Car Wash Services that are the subject of the complaint.

§ 3. Subchapter HH of Chapter 2 of Title 6 of the Rules of the City of New York is amended by adding a new Section 2-434 to read as follows:

§ 2-434 Additional Provisions Regarding Mobile Car Washes.

(a) Definitions.

Mobile Car Wash Services. The term "Mobile Car Wash Services" means any car washing services that are performed at a place other than the fixed business address of the car wash.

Mobile Car Wash. The term "Mobile Car Wash" means any individual, group of individuals, or business that provides Mobile Car Wash Services.

(b) License required. Each Mobile Car Wash is required to be licensed.

(c) Additional application requirements for Mobile Car Washes.

(1) In addition to the information and documentation required by § 20-541(d) of the Administrative Code, Mobile Car Wash applicants for a license required by this section must submit the following:

(i) The make, model, and license plate number of each vehicle used by the applicant for Mobile Car Wash Services;

(ii) Certification that all such vehicles are in compliance with all applicable laws and rules; and

(iii) Certification that all operators of such vehicles are legally allowed to operate them.

(2) An application for the renewal of a license granted pursuant to this section must include up-to-date information regarding the make, model, and license plate number of each vehicle used by the applicant for Mobile Car Wash Services.

(d) Display of license. Licensees must conspicuously display the license or a copy of the license in every vehicle used to provide Mobile Car Wash Services while such services are being provided. The license or copy of the license must be easily visible from the outside of the vehicle through either its back window or front windshield.

§ 4. Subchapter HH of Chapter 2 of Title 6 of the Rules of the City of New York is amended by adding a new Section 2-435 to read as follows:

§ 2-435 Application of this Subchapter.

Unless otherwise specified, the requirements of this subchapter apply with equal force to mobile car washes and car washes operating in a fixed location.

§ 5. Section 6-67 of Chapter 6 of Title 6 of the Rules of the City of New York is amended to read as follows:

§ 6-67 Car Washes Penalty Schedule.

All citations are to Title 20 of the Administrative Code of the City of New York or Title 6 of the Rules of the City of New York.

Unless otherwise specified, the penalties set forth for each section of law or rule shall also apply to all subdivisions, paragraphs, subparagraphs, clauses, items, or any other provision contained therein. Each subdivision, paragraph, subparagraph, clause, item, or other provision charged in the Notice of Violation shall constitute a separate violation of the law or rule.

In certain cases, the Department may ask for license suspension or revocation, as permitted by statute. If a respondent is found in violation of multiple provisions that require a suspension period, the suspension periods shall run concurrently.

Unless otherwise specified by law, a second or third or subsequent violation means a violation by the same respondent, whether by pleading guilty, being found guilty in a decision, or entering into a settlement agreement for violating the same provision of law or rule, within two years of the prior violation(s).

The parties shall be authorized to present evidence to mitigate the license revocation or suspension period within the date range marked by two asterisks (\*\*).

# **READER'S GUIDE**

The City Record (CR) is published each business day. The Procurement section of the City Record is comprised of notices of proposed New York City procurement actions, contract awards, and other procurement-related information. Notice of solicitations and other notices for most procurement methods yound at are about \$100,000 most procurement methods valued at or above \$100,000 for goods, services, and construction must be published once in the City Record, among other requirements. Other procurement methods authorized by law, such as sole source procurements, require notice in the City Record for five consecutive editions. Unless otherwise specified, the agencies and offices listed are open for business Monday through Friday from 9:00 A.M. to 5:00 P.M., except on legal holidays.

# NOTICE TO ALL NEW YORK CITY CONTRACTORS

CONTRACTORS The New York State Constitution ensures that all laborers, workers or mechanics employed by a contractor or subcontractor doing public work are to be paid the same wage rate that prevails in the trade where the public work is being done. Additionally, New York State Labor Law §§ 220 and 230 provide that a contractor or subcontractor doing public work in construction or building service must pay its employees no less than the prevailing wage. Section 6-109 (the Living Wage Law) of the New York City Administrative Code also provides for a "living wage", as well as prevailing wage, to be paid to workers employed by City contractors in certain occupations. The Comptroller of the City of New York is mandated to enforce prevailing wage. Contact the NYC Comptroller's Office at www.comptroller.nyc.gov, and click on Prevailing Wage Schedules to view rates.

# CONSTRUCTION/CONSTRUCTION SERVICES OR CONSTRUCTION-RELATED SERVICES

The City of New York is committed to achieving excellence in the design and construction of its capital program, and building on the tradition of innovation in architecture and engineering that has contributed to the City's prestige as a global destination.

#### VENDOR ENROLLMENT APPLICATION

VENDOR ENROLLMENT APPLICATION New York City procures approximately \$17 billion worth of goods, services, construction and construction-related services every year. The NYC Procurement Policy Board Rules require that agencies primarily solicit from established mailing lists called bidder/proposer lists. Registration for these lists is free of charge. To register for these lists, prospective suppliers should fill out and submit the NYC-FMS Vendor Enrollment application, which can be found online at www.nyc.gov/selltonyc. To request a paper copy of the application, or if you are uncertain whether you have already submitted an application, call the Vendor Enrollment Center at (212) 857-1680.

#### PRE-QUALIFIED LISTS

**PRE-QUALIFIED LISTS** New York City procurement policy permits agencies to develop and solicit from pre-qualified lists of vendors, under prescribed circumstances. When an agency decides to develop a pre-qualified list, criteria for pre-qualification must be clearly explained in the solicitation and notice of the opportunity to pre-qualify for that solicitation must be published in at least five issues of the CR. Information and qualification questionnaires for inclusion on such lists may be obtained directly from the Agency Chief Contracting questionnaires for inclusion on such lists may be obtained directly from the Agency Chief Contracting Officer at each agency (see Vendor Information Manual). A completed qualification questionnaire may be submitted to an Agency Chief Contracting Officer at any time, unless otherwise indicated, and action (approval or denial) shall be taken by the agency within 90 days from the date of submission. Any denial or revocation of pre-qualified status can be appealed to the Office of Administrative Trials and Hearings (OATH). Section 3-10 of the Procurement Policy Board Rules describes the criteria for the general use of pre-qualified lists. For information regarding specific pre-qualified lists, please visit www.nyc.gov/selltonyc.

#### NON-MAYORAL ENTITIES

The following agencies are not subject to Procurement Policy Board Rules and do not follow all of the above procedures: City University, Department of Education, Metropolitan Transportation Authority, Health & Hospitals Corporation, and the Housing Authority. Suppliers interested in applying for inclusion on bidders lists for Non-Mayoral entities should contact these

entities directly at the addresses given in the Vendor Information Manual.

#### PUBLIC ACCESS CENTER

The Public Access Center is available to suppliers and the public as a central source for supplier-related information through on-line computer access. The Center is located at 253 Broadway, 9th floor, in lower Manhattan, and is open Monday through Friday from 9:30 A.M. to 5:00 P.M., except on legal holidays. # ATTENTION: NEW YORK CITY MINORITY AND WOMEN-OWNED BUSINESS ENTERPRISES

Join the growing number of Minority and Women-Owned Business Enterprises (M/WBEs) that are competing for New York City's business. In order to become certified for the program, your company must substantiate that it: (1) is at least fifty-one percent (51%) owned, operated and controlled by a minority or woman and (2) is either located in New York City or has a significant tie to New York City's business community. #### PROMPT PAYMENT

It is the policy of the City of New York to pay its bills promptly. The Procurement Policy Board Rules generally require that the City pay its bills within 30 days after In the receipt of a proper invoice. The City pays interest on all late invoices. However, there are certain types of payments that are not eligible for interest; these are listed in Section 4-06 of the Procurement Policy Board Rules. The Comptroller and OMB determine the interest rate on late payments twice a year: in January and in July.

#### HOW TO READ CR PROCUREMENT NOTICES

Procurement notices in the CR are arranged by alphabetically listed Agencies, and within Agency, by Division if any. The notices for each Agency (or Division) are further divided into three subsections: Solicitations, Awards; and Lists & Miscellaneous notices. Each of these subsections separately lists notices pertaining to Goods, Services, or Construction.

Notices of Public Hearings on Contract Awards appear at the end of the Procurement Section.

at the end of the Procurement Section. At the end of each Agency (or Division) listing is a paragraph giving the specific address to contact to secure, examine and/or to submit bid or proposal documents, forms, plans, specifications, and other information, as well as where bids will be publicly opened and read. This address should be used for the purpose specified unless a different one is given in the individual notice. In that event, the directions in the individual notice should be followed.
