




#### Total DOC Population by Custody Status October 16, 2021 – October 22, 2021




#### City Sentenced Population by Custody Status October 16, 2021 – October 22, 2021






# Number and Percent of Patients with Confirmed COVID-19 October 16 – October 22, 2021

# Number of Incarcerated Patients Ever Confirmed Positive for COVID-19 While in Custody March 17, 2020 – October 22, 2021












