

That no ship, boat or other vessel or arti-cide shall be taken or allowed by any person to come into slip, or be placed thereon for the purpose of the shipmen or removal of any offal, garbage, rubbish, blood or offen-sive animal or vegetable matter, dirt or dead animals, or for the use of any contractor about the removal of any of the foregoing substances, without a permit from this Bo-partment.
