

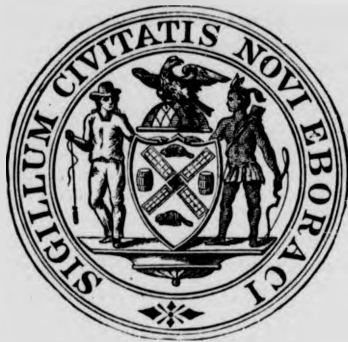

DEPARTMENT OF PUBLIC WORKS.

Report for the Quarter ending June 30, 1875.

To Hon. WILLIAM H. WICKHAM,
Mayor of the City of New York:

SIR—In compliance with section 26 of the Charter, I have the honor to submit herewith a report of the transactions of this Department, for the quarter ending June 30, 1875.

Statements "A" and "B" exhibit the amounts appropriated for the use of the Department; the expenditures incurred under the several appropriations; and the balances remaining unexpended. The reports of the various Bureaus in the Department give a detailed account of their respective operations and expenditures.

The following is a brief review of the progress and condition of the works under the control of the Department:

CROTON WATER SUPPLY.

The construction of a highway at the Storage Reservoir, at Boyd's Corners, is nearly completed. Work on the new Storage Reservoir, in the town of South East, Putnam County, is being vigorously prosecuted by the contractors.

It is expected that the Commission appointed by the Supreme Court, to appraise the additional lands required for the Reservoir, will soon make their report.

The rain fall in the Croton Basin has been less than for the past ten years, during the same period of the year, reducing the natural flow of the Croton river far below the quantity required for daily consumption; 425,000,000 gallons of water were drawn from the Storage Reservoir and the lakes to supply the deficiency.

The daily consumption is 107,000,000 gallons, or 5,000,000 gallons in excess of the consumption of last year.

The alterations of the Aqueduct, on Tenth avenue, are rapidly approaching completion.

In consequence of the funds for laying Croton pipes, issued under former laws, being nearly exhausted, and the failure of the Common Council to take the necessary action to make the appropriation under the law of 1875 available, very little work had been done in laying Croton pipes. The aggregate length of pipes laid is 1,755 feet; and by the placing of stop-cocks, the high-service water was made available for the highest portions of the Murray Hill district.

Ten of the six-foot pipes, which were originally laid by contract, have been, and others have to be, repaired.

STREET PAVEMENTS.

During the quarter, 23,417½ square yards of new stone-block pavements have been laid, under ordinances of the Common Council.

In consequence of the severe and late winter season, the pavements throughout the city were in very bad condition at the beginning of spring.

Repairs were begun with a large force, about the middle of April, in the lower and commercial part of the city, and continued until the streets in that quarter were in better condition than for many years past.

The unexpended balances of the appropriations for repairs of stone, wooden, and concrete pavements, will be applied to the repairs of the worst places above Canal street, for which they are barely sufficient; they are certainly inadequate to cover general repairs throughout the city.

GRADING, CURBING, GUTTERING, AND FLAGGING STREETS AND AVENUES.

The following quantities of work have been done, under contracts for the improvements of streets and avenues:

14,394 Cubic yards earth excavated.
41,353 Cubic yards rock excavated.
123,403 Cubic yards filling furnished.
8,371 Lineal feet curb and gutter stones set.
83,461 Square feet flagging laid.

SEWERAGE.

Under the direction of the Bureau of Sewers:

16,353 Lineal feet of sewers,
4,025 Lineal feet of drains,
297 Lineal feet of culverts, and
17 Receiving-basins, have been constructed.

The total length of Sewerage in the city now is 344.85 miles, with 4,139 receiving-basins.

CONSTRUCTION OF ROADS AND AVENUES.

Under the Eastern Boulevard Improvement Act, work has been prosecuted on the following streets and avenues:

Avenue A, between Fifty-seventh and Seventy-second streets.
Avenue A, between One Hundred and Sixteenth and One Hundred and Twenty-third streets.
First avenue, between One Hundred and Ninth and One Hundred and Sixteenth streets.
Tenth avenue, between One Hundred and Tenth and Manhattan streets.
Seventy-second street, between Third and Madison avenues.
One Hundred and Tenth street, between First avenue and Riverside Drive.
One Hundred and Sixteenth street, between Fourth and Sixth avenues.

Progress has also been made in the construction of sewers on the Boulevard and Avenue St. Nicholas, and in planting shade trees along the Boulevard, Avenue St. Nicholas, Sixth and Seventh avenues.

Under ordinances of the Common Council the following improvements have been prosecuted: Grading and superstructure of One Hundred and Twenty-second street, from Tenth avenue to Riverside Drive.

Grading New avenue, from One Hundred and Tenth to Manhattan street.

Grading Ninth avenue, from One Hundred and Twenty-third to One Hundred and Twenty-sixth street.

Grading Twelfth avenue, from One Hundred and Twenty-ninth to One Hundred and Thirtieth street.
Grading Morningside avenue, West, from One Hundred and Tenth to One Hundred and Twenty-second street.

Superstructure of One Hundred and Forty-fifth street, from Seventh avenue to Boulevard.

The following are the aggregate quantities of work done in the prosecution of these improvements:

8,907 Cubic yards earth excavated.
10,959 Cubic yards rock excavated.
52,259 Cubic yards filling furnished.

10,361 Cubic yards broken stone furnished.
6,200 Cubic yards retaining wall built.
28,480 Square yards Telford roadway laid.
13,793 Square yards Telford-macadam roadway finished.
9,469 Square feet flagging laid.
3,763 Lineal feet curb set.
1,559 Lineal feet curb reset.
3,135 Lineal feet brick sewers constructed.
466 Lineal feet pipe sewers laid.
14 Manholes, and 11 receiving-basins constructed.

PUBLIC LAMPS.

The number of public lamps in use throughout the city on the 1st of April was 20,071. During the quarter, 104 new lamps were erected and 117 old lamps were relighted, 387 were discontinued, leaving 19,905 lamps in use at the close of the quarter; a decrease of 166.

The cost of lighting the lamps for the current year is as follows:

The gas for the lamps in the Twenty-third and Twenty-fourth Wards is furnished under contracts made prior to the annexation of these wards to the city.

PUBLIC BUILDINGS.

In addition to the ordinary repairs required for the maintenance of the large number of public buildings under the care of the Department, the work of constructing a new roof on Tompkins Market building has been prosecuted under contract. It became necessary to strengthen the building by the erection of piers, to support the new roof; and a contract therefor was made, amounting to \$8,929. The building will be much improved, in strength and appearance, when the work now in progress shall be finished.

FREE FLOATING BATHS.

The two public baths were located at the foot of East Fifth street and foot of West Eleventh street, respectively, and were opened to the public on the 9th of June.

The average daily attendance to the 30th of June, was 7,200.

REMOVAL OF INCUMBRANCES.

The efforts of the Department for the removal of obstructions in streets and avenues, have been confined to the serving of notices on offending parties, in consequence of the refusal of the Finance Department to honor requisitions for funds authorized by law and appropriated by the Board of Estimate and Apportionment, for the forcible and summary removal of obstructions. In most cases, the notices of the Department receive no attention, in consequence of its inability to enforce the law.

SIR—I have the honor to report that during the quarter ending the 30th of June, 1875, there has been expended in this Bureau for work done and materials furnished, and for which bills have been transmitted, as follows:

The rain fall in the Croton Basin has been less during the past three months than for the same months for ten years past, and the natural flow of the Croton river has been less than the consumption of Croton water in the city during the greater portion of the month of June, making it necessary to draw about 425,000,000 gallons of water from the storage reservoirs and lakes to supply the deficiency, commencing two weeks earlier in the season in drawing from the stored water than ever before.

The work on the new highway, under contract with Dooley & Curran, on the northeast side of the reservoirs, at Boyd's Corners, has been prosecuted with vigor, and will soon be completed. There is yet due, for right of way for this road, one hundred and twenty five dollars.

The work of constructing the new storage reservoirs in the town of South East, Putnam County, under contract with Belden & Dennison, is progressing favorably and with a large force. The Commissioners for awarding land damages for lands to be overflowed by this reservoir have had several meetings, and it is expected will soon be able to make their awards.

The Aqueduct and reservoirs have been maintained in good order, and have furnished an uninterrupted supply of water. During the winter the water was drawn down in the reservoirs in Central Park, and, though bringing through the Aqueduct, 107,000,000 gallons daily, we have not succeeded in filling it, the consumption being nearly equal to the daily supply from the Aqueduct.

The work of altering the Aqueduct between Ninety-third and One Hundred and Thirteenth streets has been prosecuted with a large force since the weather has been favorable.

The work of constructing Sedgwick avenue, under High Bridge, and through the Croton Aqueduct lands, with the necessary retaining walls, has been nearly completed.

The appropriation for laying Croton water mains being nearly exhausted, there has been laid only

The proper connections having been made, and stop-cocks placed, for the higher portions of Murray Hill, and the water from the High-service at High Bridge was turned on to this district in the latter part of May.

Ten of the six-foot pipes on Eighth avenue and Ninetieth street have been repaired.

Many of the people using Croton water have formed the habit of wasting water during the past cold winter, still continue wasting it, especially during warm days, and are now using five millions gallons per day more water than at the same time last year.

SIR—I have the honor to submit the following report of the transactions of this Bureau for the months of April, May, and June, of this year:

REPAIRING CROTON PIPES, ETC.

Three companies have been employed in repairing and renewing pipes, stop-cocks, and fire hydrants.

The various reports from the police, citizens, and others, of these necessary repairs have been attended to without any serious inconvenience to the public, unless may be excepted the repairs to a stop-cock on Houston street at Broadway, which necessitated the temporary shutting off of the 30-inch line on Broadway at that point.

When the repairs named were made, it was found impossible to raise the water gate, it having become rusted and corroded by age. A portion of the inhabitants of the lower part of the city were thus cut off from their usual supply of water, but this was remedied in a few hours by the turning on in full force water in the new thirty-six inch main on the east side of the city. This main was laid in the years 1871, 1872, 1873, and 1874.

There are a number of old water gates on the first lines of pipe laid in this city which need renewing or repairing, and a new main on the west side similar to the one above named would much assist to avoid a diminution of the supply of water in any portion of the city, by the recurrence of such an event as happened at Broadway and Houston street.

LAYING CROTON WATER MAINS.

A small force of men have been employed in laying mains in the upper part of the city, but works of this character will in a few weeks be suspended unless additional funds are provided for their maintenance.

REPAIRING SIX-FEET PIPES.

A company of men have been employed in repairing six-foot pipes, which are the continuation of the Aqueduct in Eighth avenue, between Eighty-eighth and Eighty-ninth streets, and in Ninetieth street, between Eighth and Ninth avenues, but for the same reason as mentioned in relation to laying Croton-mains will have to be suspended in a few days.

REPAIRS TO PAVEMENTS.

About the middle of April work was commenced repairing the pavements of the commercial quarter of the city, the business traffic being much impeded by the bad condition of the pavements rendered worse than is usual at the opening of the season for repairs by the continued severity of cold weather the past winter, the deep frost working out of the ground having much effect upon them, particularly cobble and wooden pavements. The streets of the lower portion of the city have been put in better condition than they were ever known to be before. The force of men, though not sufficient for general repairs, will be reduced in a few days, owing to the insufficiency of the appropriations. The amount authorized by the Board of Apportionment, for repairs to stone pavements for this year, was \$100,000, of which over \$50,000 has already been expended in the space of two and one half months. The amount authorized for wooden and concrete pavement repairs was \$50,000, of which over \$30,000 has in the same time been expended for labor and materials, besides accounts not yet presented amounting in the aggregate to \$3,000 on stone pavement, and \$3,000 on wooden, etc., pavements.

The balances of these appropriations it is intended to expend in repairing the very bad places in pavements above Canal street, general repairs being impossible with the means at hand.

SIR—In compliance with your directions, I herein submit a report of the business of the Bureau of Lamps and Gas for the three months ending June 30, 1875.

In Exhibit marked "A" will be found an abstract of all vouchers drawn during the quarter. In Exhibit "B" is a statement showing the amounts paid for gas to the various public markets, offices, etc., and for fitting, repairing, and lighting the public lamps, etc. In Exhibit "C" is a summary of the appropriation for Lamps and Gas for 1874, showing an available balance of seven thousand two hundred and thirty-three dollars and ninety-eight cents (\$7,233.98). Exhibit "D" is a summary of the appropriation for Lamps and Gas for 1875, showing an expenditure during the quarter ending June 30 of one hundred and sixty-five thousand eight hundred and three dollars and twenty-nine cents (\$165,803.29), with liabilities amounting to forty-four thousand six hundred and forty-one dollars and seventy-eight cents (\$44,641.78), leaving an available balance of three hundred and thirteen thousand two hundred and thirteen dollars (\$313,213.00). Exhibit "E" is a summary of the appropriation for Lamps and Gas, Twenty-third and Twenty-fourth Wards, for 1875, showing an expenditure, on this account, of twenty-eight thousand eight hundred and thirty dollars and thirty-seven cents (\$28,830.37), with liabilities amounting to nine thousand six hundred and eighteen dollars and forty-three cents (\$9,618.43), leaving an available balance of forty-two thousand three hundred and two dollars and thirty cents (\$42,302.30). In Exhibit "F" will be found a summary of the Lamp Account, showing the number of new lamps lighted, old lamps relighted, and lamps discontinued by each gas company during the quarter. By the recapitulation of this statement, it will be seen that one hundred and four new lamps have been lighted, one hundred and seventeen old lamps relighted, and three hundred and eighty-seven lamps discontinued during the quarter; the total number of lamps burning June 30 being nineteen thousand nine hundred and five (19,905), a decrease of one hundred and sixty-six lamps since March 31.

SIR—In compliance with your instructions, and with section 27 of the Charter, I have the honor to submit the following report of the transactions of this Bureau for the three months ending June 30, 1875:

Repairs have been made on the following roads and avenues:
Eighth avenue, from One Hundred and Twenty-first street to Harlem river.
Tenth avenue, from Manhattan street to One Hundred and Fifty-fourth street.
Kingsbridge road, coated with gravel from One Hundred and Fifty-ninth street to Kingsbridge;
Lawrence street, from One Hundred and Twenty-sixth street to the Boulevard; all cross streets,
from One Hundred and Twenty-sixth to One Hundred and Thirty-third street, between Tenth
avenue and the Boulevard; One Hundred and Twenty-sixth street, Third to Sixth avenue.
Madison avenue, from One Hundred and Twenty-fifth street to Harlem river.
One Hundred and Forty-first street, from Bloomingdale road to Boulevard.
Bloomingdale road, from One Hundred and Thirty-fifth to One Hundred and Forty-third street.
One Hundred and Fifty-first street, from Boulevard to Hudson river.
One Hundred and Fifty-second street, from Avenue St. Nicholas to Boulevard.
One Hundred and Fifty-eighth street, from Tenth avenue to Hudson river.

In addition to ordinary repairs, the culverts on Eighth avenue, One Hundred and Forty-first, One

Hundred and Fifty-third streets, were put in complete order; broken stone was placed on Break-Neck
Hill road, and several large holes in other streets were filled in.

Hon. FITZ JOHN PORTER:

SIR—In compliance with your request, I respectfully make the following report of the operations
of this Bureau during the months of April, May, and June, 1875:

There have been received, during the past three months, at this office, 349 complaints of obstruc-
tions and incumbrances on streets and sidewalks; notices were made out and served on the parties
complained of, who, in some cases, removed the obstructions. I would state in connection that in
many instances the complaints are against nuisances of long standing, and great detriment to individ-
uals and the public generally, and have to be submitted to, from the fact that this Bureau is entirely
without funds to remove nuisances. There have also been issued during said months 624 builders'
permits to temporarily occupy the streets with building material. These permits are issued without
charge to parties applying therefor, and are in many instances made nuisances to the neighborhood.
The number of permits daily issued require more attention than this Bureau, with its limited means,
can give.

There have been issued, and served on the owners, 54 notices to repair sidewalks, most of which
have been complied with.

There have been 10 permits issued to cut down trees, also 24 special permits.

SIR—In obedience to your request, I have the honor herewith to submit the following report explanatory of the various transactions of this office during the months of April, May, and June of the current year.

In this office articles of various kinds are contracted for and purchased upon the proper requisitions, signed by the different heads of Departments of the city government, in conformity with the provisions of the Charter, together with those emanating from all the bureaus of the Department of Public Works, and, as these are numerous, they demand constant and careful supervision.

Supplies of every nature required are now obtained at from thirty to fifty per cent. cheaper than the prices heretofore paid for the same commodities during the last several years.

The amount of material actually necessary for separate and distinct purposes has been exceedingly great this spring, but by the exercise of the utmost economy, and by careful use of the money at the disposal of the Department, I hope to secure a satisfactory result.

Since the first of April the Department has had seven public lettings, embracing forty-three different classes of public works, and thirty-one miscellaneous contracts have been awarded in addition, the majority of which are now in progress towards completion.

AN ORDINANCE to amend an ordinance entitled "An ordinance to amend an ordinance to regulate permits for street-stands, show-cases, signs, stairways, hoistways, and deliveries," approved February 24, 1866, which became adopted July 27, 1874.

The Mayor, Aldermen, and Commonalty of the City of New York do ordain as follows:

Section 1. Section 1 of the ordinance of 1874, amending section 5 of the ordinance of 1866, is hereby amended by striking from the last clause in the said section 5 the words, "use the street beyond the stoop line," and inserting in lieu thereof the following, "place any sign upon the top, or from on front, above the second floor, of any building that shall project into the street, or over the sidewalk from any such building, in any street or avenue in the City of New York," so that said section 5, when so amended, shall read as follows:

§ 5. Every grantee of a privilege under this ordinance for a show-case, signs, stairways, or hoistways, shall pay a sum of one dollar for each, and grantees of all other privileges the sum of one dollar, towards the expense of executing this ordinance, to be accounted for among other fees of the Mayor's office. It is hereby understood and expressed that for the receiving and delivering of goods no fee shall be charged, and the Corporation Attorney shall not hereafter institute suits for alleged obstructions occasioned by the receipt or delivery of merchandise in the ordinary course of business, but no person shall deposit any article or articles upon any street or sidewalk in the city in such manner as to obstruct the free use thereof by the public. The aggregate sum for any one permit containing all or any portion of the privileges expressed in this section shall not exceed the sum of three dollars, and all may be granted for that fee; but in no case is permission to be given to place any sign upon the top or from in front, above the second floor of any building that shall project into the street or over the sidewalk from any such building in any street or avenue in the City of New York.

Sec. 2. All ordinances or parts of ordinances inconsistent or conflicting with the provisions of this ordinance are hereby repealed.

Sec. 3. This ordinance shall take effect immediately.

Adopted by the Board of Aldermen, September 30, 1875.

Approved by the Mayor, October 4, 1875.

Whereas, From the result of the deliberations of the State Board of Equalization, based on the estimates of the valuation of the State Assessors, it is evident, that under the present system no relief will be afforded the City and County of New York, but the unequal ratio of State taxes, burdened upon it for years, continued; and

Whereas, It is well known that the value of real estate in the City of New York, as estimated for the years 1873 and 1874, and on which the State Assessors have based their ratios of assessment, has depreciated full twenty-five per cent., if not more, in the city, while the same cannot be said of the counties, and the State Assessors, as far as it concerns the City of New York, have wholly disregarded this fact, and its enunciation as expressed in the estimates of our local assessors, showing the full value of the city property to be one billion three hundred and ninety-four million four hundred and eighty-eight thousand nine hundred and sixty dollars, against one billion nine hundred and thirty-five million twenty-one thousand five hundred and forty dollars, as in the table of the State Assessors; and

Whereas, The exhibit of the State Assessors, made before the State Board of Equalization, shows that, while they have added to the full valuation of property as presented by our local assessors not less than five hundred and forty million five hundred and thirty-two thousand five hundred and seventy-four dollars, they at the same time have diminished the valuation of local assessors in other cases, as, for instance, in Cayuga County, the home of State Assessor Fowler, from forty-six million two hundred and twenty-five thousand seven hundred and nine dollars to thirty-eight million seven hundred and forty-two thousand and ninety-three dollars; in Seneca County, the home of State Assessor Hadley, from twenty-two million eight hundred and forty-four thousand and twenty-five dollars to nineteen million six hundred and seventy-seven thousand five hundred and ten dollars; and in Albany, Erie, Onondaga, Steuben, Washington, and other counties, the homes of one or another member of the State Board of Equalization, reductions from the valuation of the local assessors have been made by the State Assessors amounting to from seven to ten and seventeen millions of dollars in several single cases; and

Whereas, By this arbitrary, unjust, and self-interested proceeding of the State Assessors, and a majority of the State Board of Equalization—Lieutenant-Governor Dorsheimer, State Treasurer Raines, and State Assessor Briggs, from Kings County, only voting in favor of justice and fairness—one million two hundred and fifty-four thousand four hundred and seventy-six dollars more taxes

have been put upon this city than could be justly claimed by the State, while the rest of the State has been unduly relieved from the same amount of taxation, burdening on the city for the value of its assessed property eight million twelve thousand three hundred and eighty-six dollars, where it should have been six million seven hundred and fifty-seven thousand nine hundred and ten dollars, and telling off the balance of the State with seven million seven hundred and fifteen thousand and ninety-six dollars, instead of imposing upon it eight million nine hundred and sixty-nine thousand five hundred and seventy-two dollars; therefore be it

Resolved, That this Board, as the representative of the citizens and taxpayers of the City and County of New York, do earnestly protest against the continued unjust treatment this overburdened community, in spite of all protestations, is receiving at the hands of the State Assessors and the State Board of Equalization;

Resolved, That the Committee on Finance be and is herewith instructed to give this matter of State taxation their due consideration, in order to suggest to this Board such remedies as in their opinion may tend to relieve this city from a continuance of such unwarranted extortion;

Resolved, That the thanks of this Board, and of the citizens at large, are due to the Commissioners, George H. Andrews, Wilson G. Hunt, and Isaac Sherman, appointed agreeably to a resolution of this Board by his Honor the Mayor, and with a view of convincing the State Assessors and the State Board of Equalization of the wrongful burdens imposed upon this city for a number of years, and of impressing them with the justice of final relief, said Commissioners having spared no efforts, by means of facts and arguments submitted to the aforesaid State Boards, to attain such end;

Resolved, That the Commissioners aforesaid are herewith requested to submit to this Board, directly or through his Honor the Mayor, a full report of all such matter and facts as in their opinion may aid this Board in continuing its exertions in the same direction.

Resolved, That permission be and the same is hereby given to the Singer Manufacturing Company to pave with granite-block pavement the sidewalk in front of the entrance to their stable, No. 160 West Fifteenth street, the work to be done at their own expense, under the direction of the Commissioner of Public Works; such permission to continue only during the pleasure of the Common Council.

Resolved, That in selecting plans for the erection of a rapid transit railroad, the Commissioners be and they are hereby respectfully requested to reject any and all plans which may contemplate the construction of such roads over the sidewalk in any street, avenue, or public place in the City of New York, and that, in the consideration of such plans, preference be given to the one that provides for the erection of such railroad over the centre of the carriageway, and that may present the least impediment to the public uses of the carriageway of every such street, avenue, or public place.

Received from his Honor the Mayor, October 4, 1875, without his approval or objections thereto; therefore, under the provisions of section 11, chapter 335, Laws of 1873, the same became adopted.

Resolved, That the Commissioner of Public Works be and he is hereby authorized and directed to immediately cause the second story of the building on the southwest corner of Centre and Chambers streets, to be fitted up in a suitable manner for the use of the firemen of Engine Company No. 7; and also the third story of the same building, for the occupancy and use of the First District Civil Court.

Linden; and the Comptroller, after such transfer shall have been made, is hereby authorized and directed to draw a warrant in favor of the said Koster & Green for the said sum of forty dollars, and charge the same to the appropriation for that purpose, when made, as above requested, by the Board of Estimate and Apportionment.

CORPORATION SALE OF FERRY FRANCHISES.

SEALED BIDS WILL BE RECEIVED AND publicly opened at the Comptroller's office, on Thursday, October 22, 1875, at 2 o'clock P. M., for Leases of Franchise or right to maintain and operate several ferries around the City of New York for the term and on the conditions hereafter set forth.

The leases will be made to conform to the requirements of the laws relative to ferries, and subject to such regulations, ordinances, or by-laws, as now are or hereafter may be made or passed by the Common Council or State Legislature, and the lessees will also provide that the lessees shall take and assume at their own costs and charges all or any responsibilities and liabilities of the Corporation of the City of New York to the present lessees of ferries in relation to boats, fixtures, etc., belonging to such lessees at the respective ferries.

The minimum rate for which the ferry franchise or license to operate ferries shall be used or enjoyed, has been appraised and set by the Commissioners of the Sinking Fund at two and one-half per centum of the gross receipts for ferriage that shall hereafter accrue at each separate ferry, to be paid quarterly-yearly to the Corporation, and a covenant will be contained in each lease requiring the lessees to make and deliver to the Comptroller of the City of New York, quarterly-yearly, a statement in writing verified by oath or affirmation of the lessee or of such proper officer of the lessee as may be designated by the Comptroller of the actual total gross receipts for ferriage received by such lessee during the preceding three months, and also that the lessees shall keep regular books of account showing the daily gross receipts of the ferry leased, and allow said Comptroller or any person designated by him to examine such books.

The Department of Docks of the City of New York has fixed and established the rent for which it will lease the property in wharves, piers, slips, and lands under water belonging to the Corporation, at the several ferries to be leased to the parties or persons to whom the lease of the ferry franchise shall be awarded by the Commissioners of the Sinking Fund, for the term specified for the lease of the franchise, at the rates set forth hereafter, and no deviation will be made from the same, and covenants will be contained in such leases for construction, maintenance and surrender of all necessary fixtures and appurtenances to the wharf and pier property belonging to the city used by such respective ferries.

Proposals for the lease or license to use the ferry franchise at the respective ferries, to state the maximum percentage on gross receipts which the person or parties offering to take each ferry will pay in addition to the rent fixed by the Department of Docks for the use of the pier or wharf property belonging to the city, but no lease will be given at less than the minimum rate of 2½ per cent. on the gross receipts.

Security satisfactory to the Comptroller will be required for the punctual performance by the lessees of the covenants of the lease of the franchise in their behalf.

The several ferries at which the franchise only is to be leased are as follows:

1st. The ferry from the foot of Tenth street, East river, to Greenpoint, Long Island, for the term of five years from November 1, 1875.
The several ferries at which the franchise is to be leased, with use of pier and wharf property belonging to the City of New York, are as follows:

2d. The ferry from the north side of Twenty-third street, East river, as now occupied, to Greenpoint, Long Island, for the term of five years from November 1, 1875, subject to \$2,000 per annum rent, payable as last mentioned.

3d. The ferry from the foot of Grand street, East river, to Grand street, Brooklyn, E. D., including such wharf property as shall have been heretofore used by the ferry run from these points, for the term of ten years from November 1, 1875, subject to payment of \$2,000 per annum for the first five years and \$3,000 per annum during the second five years, rent payable quarterly-yearly to the Department of Docks.

4th. The ferry from the foot of Desbrosses street, North river, to Jersey City, New Jersey, for the term of one year from November 1, 1875, subject to \$3,000 per annum rent, payable as last mentioned.

All of such leases to contain, in addition to the usual covenants and agreements, a clause to the effect that the lessees will, at all times during the term of their respective leases, well and sufficiently repair, uphold, sustain, amend, maintain and keep all and singular the floats, racks, fenders, bridges, and other fixtures at each landing place

of their respective ferries, and that in the event of any damage to the bulkheads and piers adjoining their respective ferries, from collision by ferryboats or otherwise, from any action or negligence on their part, that they the said lessees will immediately repair and restore said property to its former good condition, free of cost and expense to the Corporation; also, that if at any time during the continuance of the demised term the Department of Docks shall require any of the premises connected with any ferry slip or landing place so leased, upon written notice having been given for three months previously that it is the desire of the Department of Docks to progress with the improvements in that vicinity, such Department of Docks may declare the demised term to be terminated, and the lessees shall surrender up the premises and vacate the same without any claim upon the City of New York for any damages whatever.
