Tenth Annual Report on Homeless Deaths New York City Department of Health and Mental Hygiene Bureau of Vital Statistics Local Law 63 (2005) July 1, 2014 – June 30, 2015

Background

This report has been prepared and submitted pursuant to Local Law 63 (LL63) which requires the City of New York to track and report deaths of homeless persons in the City. The original Local Law 63 of 2005 was extended on January 30, 2012. This report contains data provided by the NYC Office of Chief Medical Examiner (OCME), the NYC Department of Homeless Services (DHS), the NYC Department of Housing Preservation and Development (HPD), and the NYC Human Resources Administration (HRA) to the Department of Health and Mental Hygiene (DOHMH) throughout the annual period of July 1, 2014 – June 30, 2015. DHS, HPD, and HRA maintain records on the homeless individuals for whom they provide temporary housing in New York City. OCME, responsible for investigating NYC deaths that are suspicious, unusual, violent, or criminal in nature, investigates most homeless deaths. Data presented herein were compiled from the agencies and matched against NYC death certificates and analyzed by the DOHMH Office of Vital Statistics.

Summary

For the period July 1, 2014 through June 30, 2015, there were a total of 212 homeless deaths reported by OCME and DHS, a decrease of one death from the prior year. The largest number of deaths (n=69; 33%) for this reporting year (FY15) occurred during the third quarter (Jan 1-March 31, 2015).

Note that the NYC Human Resources Administration (HRA) simultaneously and separately reported 48 homeless deaths during this period. Due to confidentiality concerns, HRA data could not be assessed for potential duplication with deaths reported by the other agencies or matched to death certificates. As a result, findings from the 2 groups of deaths are reported separately.

Homeless deaths reported by DHS, HPD, and OCME

Of the 212 deaths reported by DHS, HPD, and OCME, the majority were male (81%; n=172) and more than half were aged 45 to 64 (55%; n=116). Non-sheltered decedents accounted for just over half (51%; n=108).

Location of death was grouped into hospital, shelter, outdoors and other places.

- Hospital deaths accounted for 57% (n=121) among all decedents while hospital deaths among the sheltered accounted for 56% (n=58) and 58% (n=63) among non-sheltered.
- The proportion of deaths that occurred in shelters for those sheltered was 37% (n=38).
- Outdoor deaths accounted for 13% (n=27) among all decedents. Outdoor deaths accounted for 3% (n=3) among the sheltered and 22% (n=24) among non-sheltered. Deaths in other places accounted for 12% (n=26) among all decedents.
- Deaths in other places accounted for 6% (n=6) of deaths among the sheltered and 19% (n=20) among non-sheltered. Refer to Table 1 for definitions of outdoor and other place deaths.
- The top five leading causes of death were drug overdose (21%; n=45), heart disease (18%; n=38), accidents (11%; n=23), alcohol abuse (6%; n=12), and cancer (5%; n=11).
- The majority of deaths were investigated by OCME (81%; n=171), comparable to past annual reports.

Homeless deaths reported by HRA

Of the 48 deaths reported by HRA, most were male (81%; n=39) and between the ages of 45 and 64 (81%, n=39). All 48 homeless decedents were sheltered within an HRA emergency residence. Most decedents died in shelters (63%; n=30) and hospitals (33%; n=16). Information on OCME investigations of HRA homeless deaths and community board district of death is not available. Cause of death information cannot be extracted from the death certificate or analyzed as HRA does not provide identifying information for cases, due to laws protecting data confidentiality.

Additional Methodological Information

Definitions

LL63 defines, a "homeless person" as "a person who at the time of death did not have a known street address of a residence at which he or she was known or reasonably believed to have resided." A "homeless shelter" is "(i) a residence operated by or on behalf of the Department of Homeless Services; (ii) an emergency residence operated by or on behalf of the Department of Social Services/Human Resources Administration which is available primarily for homeless persons with HIV or AIDS related illness; or (iii) a residence operated by or on behalf of the Department of Housing Preservation and Development to the extent that such residence houses clients of the Department of Homeless Services; provided, however that such term shall not include any residence that is available primarily for battered women." A "homeless shelter resident" or "sheltered" is "a person who at the time of death lived in a homeless shelter."

Outdoor and other place location of death categories are given in Table 1.

Methods

DHS, HPD, and OCME provided homeless death case reports to DOHMH using the definitions above. These reports were validated and duplicates (i.e. when DHS cases were, also, OCME cases) were removed. HRA did not disclose any identifiable information on HRA homeless residents, per Article 27-F of the New York State Public Health Law, which prohibits disclosure of information that could reasonably identify someone as having an HIV-related illness or AIDS. As a result, HRA homeless deaths could not be distinguished from DHS, HPD and OCME deaths, and total NYC homeless deaths could not be ascertained.

Case reports from DHS, HPD, OCME, and HRA were compiled. Because HRA cases remain anonymous, only DHS, HPD, and OCME case reports were matched against NYC DOHMH Vital Statistics death certificates. DOHMH followed up with agencies to obtain any missing data elements. Some cases may have been determined not to meet the LL63 homeless case definition. Such cases were removed from the annual report.

DEATHS OF HOMELESS PERSONS




Figure 1. Deaths of Homeless Decedents by Reporting Agency and Year, July 1, 2005 - June 30, 2015

The number of homeless decedents reported annually by DHS, HPD, and OCME has ranged between 125 and 213 (Figure 1). The month with the highest number of deaths (n=27) was January 2015. The quarter with the highest number of deaths (n=69) was from January 1 to March 31, 2015 (Table 2).




Figure 2. Percent of Homeless Decedents Investigated by OCME, July 1, 2005 - June 30, 2015

OCME investigated the majority of homeless deaths (81%; n=171), consistent with previous years (81-91%) (Figure 2). Among the 104 sheltered decedents, 83% (n=86) were investigated by OCME, and among the 108 non-sheltered decedents, 80% (n=86) were investigated by OCME (Table 2).




Figure 3. Percent of Homeless Decedents by Shelter Residency Status, July 1, 2005 – June 30, 2015

Of the 212 deaths reported in FY15, 51% (104) of decedents were sheltered and 49% (108) were non-sheltered (Figure 3, Table 2).

LOCATION OF DEATH

The location of death (shelter, hospital, outdoors, or other place), stratified by borough, community district, and shelter residency status are shown in Table 4a for deaths reported by DHS, HPD, and OCME. Categories of outdoor and other place deaths are provided in Table 1. HRA-reported homeless deaths, stratified by location of death, are presented, separately, in Table 4b, by borough only, as community district is not available for these deaths.

Non-sheltered decedents (DHS, HPD, and OCME)

Hospital deaths accounted for 59% (n=64) of deaths among the non-sheltered (Figure 4, Table 4a). This proportion has increased since reporting began, up from 31% in the first annual report. Non-sheltered individuals also died outdoors (22%, n=24) and in other places (19%; n=20). The proportion of outdoor deaths among non-sheltered individuals has ranged from 47% in the first reporting year to 20% in the 7th Annual Report (FY12) (Figure 4).


Sheltered decedents (DHS, HPD, and OCME)

Deaths in hospitals accounted for more than half (55%; n=57) of deaths among the sheltered (Figure 4, Table 4a). The next most frequent locations of death were shelter (37%; n=38), other places (6%; n=6), and outdoors (3%; n=3). The sheltered decedents, who died in other places, were found in the apartment of friends or family, on subway tracks or in a subway station, or in a public space or in a building. Location of shelter for sheltered decedents included Brooklyn (38% n=39); Manhattan (29%; n=30), the Bronx (26%; n=27), and Queens (8%; n=8) (Table 3).

Sheltered decedents (HRA)

The 48 HRA reported homeless decedents died in shelters (63%; n=30), hospitals (33%; n=16), and other places (4%, n=2) (Table 4b). The majority of deaths among HRA decedents occurred in Manhattan (42%; n=20) and the Bronx (40%; n=19). Seven deaths (15%) occurred in Brooklyn and one in Queens. None died in Staten Island (Table 4b).





AGE AND GENDER

DHS, HPD, and OCME reported deaths

Male decedents accounted for the majority of deaths (81%; n=172). Decedents aged 45 to 64 accounted for 55% of deaths (n=116). The number of deaths in the 45-64 years age group has increased since FY11. The proportion of decedents aged > 65 was 15% (n=32). Decedents aged 1 to 24 years accounted for 5% (n=11) of deaths. There were 7 infant deaths (3%). The number of infant deaths has ranged from 1-14 since reporting began.





Figure 5a. Male Homeless Decedents by Age Group, New York City, July 5, 2005 - June 30, 2015

Males aged 45 to 64 accounted for just under half of decedents (48%; n=101) (Figure 5a, 5b, Table 5). Males aged 45 to 64 and 25 to 44 years have ranked as the first and second largest age-gender classes of homeless decedents since reporting began.

HRA reported deaths

Among the 48 HRA homeless deaths, 81% (n=39) were male, 15% (n=7) were female and 4% (n=2) were transgender female. The age group 45 to 64 accounted for 81% (n=39) of decedents, those aged 25-44 13% (n=6), and two decedents (4%) were 65 and older (Table 5).

LEADING CAUSE OF DEATH (DHS, HPD, and OCME reported deaths only)

Drug overdose continues as the leading cause of deaths, accounting for 21% (n=45) (Table 6a). Heart disease accounted for 18% (n=38), followed by accidents (11%; n=23), alcohol abuse (6%; n=12), and cancer (5%; n=11). Drug overdose includes accidental and intentional overuse, or abuse of, illicit and/or therapeutic drugs. Additionally, drug overdose and alcohol abuse include acute intoxication, harmful use, dependence syndrome, and withdrawal state (Table 6a).




Figure 6a. Leading Cause of Death, July 1, 2005 - June 30, 2015

Leading Causes of Death by Sex




Figure 6b. Leading Cause of Death by Sex, July 1, 2005 – June 30, 2015

During FY15 the leading cause of death was drug overdose for both males (20%; n=35) and females (25%; n=10) (Figure 6b, Table 6a).

Leading Causes of Death and Shelter Status

In FY15, the leading cause of death among sheltered decedents was drug overdose (30%; n=31), followed by heart disease (22%; n=23), cancer (5%; n=5), assault (5%; n=5) and alcohol abuse (4%; n=4).

Among non-sheltered homeless, the leading cause of death was accidents (19%; n=20), followed by heart disease (14%; n=15), drug overdose (13%; n=14), alcohol abuse (7%; n=8), and cancer (6%; n=6) (Table 6b).

Leading Causes of Death and Shelter Status by location of death

There were 24 outdoor deaths among the non-sheltered during FY15. These included accidents (42%; n=10), heart disease (13%; n=3), alcohol abuse (13%; n=3), accidents (13%; n=3), drug overdose (8%; n=2) and suicide (8%; n=2). There were 20 other place (not outdoor or hospital) deaths among the non-sheltered. Non-sheltered other place deaths were due to drug overdose (n=5), heart disease (n=4), alcohol abuse disease (n=2), and pneumonia and influenza (n=2). There were 3 outdoor deaths among the sheltered. Sheltered outdoor deaths included one each of alcohol abuse, heart disease, and homicide. There were 6 other place deaths among the sheltered. Sheltered other place deaths included heart disease (n=2) and one each of drug overdose, cancer, chronic liver disease, and influenza and pneumonia.

Leading Causes of Death among Homeless Infants

Since reporting began, in 2005, 78 homeless infant deaths were reported. All, but 11, deemed natural deaths, were investigated by OCME. Among the 7 infant deaths in FY15, three had pending causes of death, two were undetermined cause of death, and final two were in the category "other causes".

External Causes of Death among DHS, HPD, and OCME Homeless Persons

External causes of death are those which are not due to natural causes, such as accident, homicide, or suicide. The number of external cause deaths has ranged between 52 and 104 since reporting began. Among the 81 external deaths reported in this annual report, 38% (n=31) were overdose deaths. (Figure 7, Table 6c, 6d). Undetermined intent deaths accounted for 17% (n=14) of external deaths. This was followed by poisoning by other noxious substance (12%; n=10), homicide (10%; n=8), motor vehicle (6%; n=5), suicide (6%; n=5) and exposure to excessive natural cold (6%; n=5). Falls, other land transport accidents, and other non-transport accidents rounded off the list with one each.




Figure 7. External Cause of Death, July 1, 2005 – June 30, 2015

To comply with Article 27-F of the New York state Public Health Law which prohibits disclosure of any information that could reasonably identify someone having an HIV related illness or AIDS, personal identifiers on HRA homeless deaths were not provided; hence corresponding death certificates could not be reviewed to determine whether deaths were also reported by OCME
