

New York, July 31, 1878.

Hon. SMITH ELY, JR., Mayor and Chairman of Board of Commissioners of the Sinking Fund of the City of New York:

SIR-At a meeting of the Board governing this Department, held this date, the following

resolution was adopted, to wit:

"Resolved, That the Commissioners of the Sinking Fund, pursuant to the authority vested in them by subdivision II, of section 6, chapter 574, Laws of 1871, be and are hereby respectfully requested to direct the Comptroller of the City of New York to prepare and issue Dock Bonds of the City of New York, for the amount of two hundred and fifty thousand dollars (\$250,000), for the uses and purposes of the Department of Docks."
