### DEPARTMENT OF CORRECTION.

#### REPORT OF TRANSACTIONS, JULY 13 TO 19, 1908.

##### Communications Received.

From the Office of the Mayor—Acknowledging receipt of report of the Department of Correction for the three months ending June 30, 1908, which has been sent to the CITY RECORD for publication. On file.

From the Office of the Mayor—Transmitting to heads of City Departments request of The Charter Revision Commission for any views or suggestions regarding changes which may be deemed advisable in their Departments. On file.

From the Board of Aldermen—Clerk of the Board transmits certified copy of resolution which reads as follows:

Resolved, That the Board of Aldermen hereby approves of and concurs in the following amended resolution, adopted by the Board of Estimate and Apportionment June 5, 1908:

Resolved, That the resolution adopted by the Board of Estimate and Apportionment May 24, 1908, which reads as follows:

Resolved, That, pursuant to the provisions of section 47 of the Greater New York Charter, as amended, the Board of Estimate and Apportionment hereby approves of the issue of Corporate Stock of The City of New York, to an amount not exceeding three hundred and fifty thousand dollars (\$350,000), for the purpose of providing means for the construction of a new Women's Prison in Raymond street, the construction, in connection therewith, of an Administration Building for the Raymond Street Jail; the painting of cells and interior walls of the present Men's Prison and the making of certain alterations in the Civil Prison of said jail; said work to be done under the jurisdiction of the President of the Borough of Brooklyn; and that when authority therefor shall have been obtained from the Board of Aldermen, the Comptroller is authorized to issue Corporate Stock of The City of New York, in the manner provided by section 169 of the Greater New York Charter, to an amount not exceeding three hundred and fifty thousand dollars (\$350,000), the proceeds whereof to be applied to the purposes aforesaid."

—be and the same is hereby amended by striking therefrom the words "jurisdiction of the President of the Borough of Brooklyn" and inserting in place thereof the words "jurisdiction of the Commissioner of Correction;" and be it further

Resolved, That the Commissioner of Correction be and he is hereby directed to employ the firm of D'Oench & Yost, Architects, to use the plans prepared by said firm and to enter into a new contract to take the place of the contract known as No. 19538, entered into by the President, Borough of Brooklyn, and the said firm of D'Oench & Yost, for the preparation of complete plans and specifications for improvements, etc., to the Kings County (Raymond Street) Jail.

Adopted by the Board of Aldermen, June 30, 1908, a majority of all the members elected voting in favor thereof.

Approved by the Mayor, July 9, 1908.

Receipt acknowledged. Messrs. D'Oench & Yost, Architects, requested to call at Central Office of Department of Correction, with plans, specifications, etc.

From Department of Water Supply, Gas and Electricity—In regard to lighting by electricity of buildings and roads on Blackwells Island. Commissioner states that as increased consumption reduces the rate charged, and that, at 50,000 kilowatt hours, the rate will only be three (3) cents per kilowatt hour, "at such a price, even with free labor, no municipal plant can compete."

The Commissioner therefore believes that a saving can be effected by accepting the offer of the Edison Company. On file.

### BOROUGH OF RICHMOND.

#### LOCAL BOARD, STATEN ISLAND DISTRICT.

Meeting July 21, 1908, 10:30 a. m.

Present—Aldermen Collins, Rendt and Cole, President Cromwell.

The minutes of the meeting of June 16 were approved.

##### Petition 842. (Resolution 40.)

To pave and repair sidewalks in Pennsylvania avenue, Ward 4, and Burger avenue and Brook street, Ward 1.

The following resolution was moved by Alderman Rendt and was adopted:

Whereas, A petition for a local improvement described below has been received by the President of the Borough of Richmond, etc.

Resolved, That this Board does hereby initiate proceedings for the said local improvement, to wit:

To pave or repair the sidewalks with either natural or artificial stone wherever the same are not now paved or are out of repair, on both sides of Pennsylvania avenue, between New York avenue and the Staten Island Rapid Transit Railroad, in the Fourth Ward of the Borough of Richmond, and to do such other work as may be necessary to the completion of the work described, the estimated cost being \$900 and the assessed valuation being \$32,750.

Affirmative—Aldermen Collins, Rendt and Cole, President Cromwell.

Negative—None.

On motion of Alderman Collins the petition as to Burger avenue and Brook street was laid over.

##### Petition 843.

To construct sanitary sewer in Central avenue, south of Staten Island Rapid Transit Railroad tracks, Ward 3.

Referred to the Commissioner of Public Works.

##### Petition 844.

To open a public park bounded by Grant, Van Duzer, Brewster and Swan streets; to extend Brewster and Van Duzer streets, and to widen Grant, Washington and Swan streets, Ward 2.

General opposition was made by owners of assessable property to the proposed plan of improvement, and the petition was referred to the Commissioner of Public Works.

On motion, the Board adjourned.


