FISA values the importance of a diverse workforce. Our Agency Head and EEO Officer review CEEDS data and workforce reports on a quarterly basis before submitting the Agency's quarterly EEO report. For the 1st quarter of FY 2022, FISA posted discretionary positions to recruitment sources and our Agency will diligently continue to address any underutilization of job groups identified. The CEEDS reports for the 1st quarter indicate that we need to address the underutilization of Females, Blacks and Hispanics in the Managers

groups, Blacks in the Science Professionals group, as well as Females and Hispanics in the Para Professionals group.

FISA's Human Resources Unit will consider utilizing diverse recruiting sources to post discretionary positions at targeted locations such as "Women for Hire" and the "Association of Latino Professionals For America" (ALPFA). In addition, FISA continues to post discretionary positions of the Agency to the CUNY Hostos Career Link to attract a wider pool of Hispanic candidates for positions. FISA will also assess the feasibility of expanding its recruiting outreach by posting discretionary positions to other job sources such as Diversity.com and www.bdpa.org (Black Data Processing Associates).

FISA in collaboration with OPA, will periodically review the e-Hire Applicant Data Report, now available via NYCAPS LRS; this report should better help us assess the impact of our job postings via external recruiting sources. We will also target conducting a job analysis/skills audit in FY 2022 and we plan to use the DCAS Retirement Predictor Tools, when available.

FISA will continue to distribute essential COVID-19 information throughout the pandemic.

- FISA's Administration Unit continues to distribute to all Agency staff, the City's Health and Leave Policy guidelines regarding COVID-19, as issued by DCAS, DOHMH and the New York State Department of Labor.
- On 07/06/2021, FISA's Administration Unit distributed the DCAS Commissioner's Directive 2020-1, which addresses the safety practices of City employees during the COVID-19 crisis, specifically with regards to wearing of face coverings by City employees. Revisions and updates to this Directive have since been distributed to all staff during August and September 2021.
- On 07/16/2021, FISA's Administration Unit deployed the mandatory EEO Awareness CBT to all staff members, with instructions to complete the training by August 22, 2021. FISA accomplished 100% compliance on October 6, 2021.
- On 08/20/2021, FISA's Administration Unit distributed an Update on COVID-19 Safety Requirements, as issued by DOHMH with regards to face coverings, and the provision of COVID-19 vaccination documentation and/or weekly COVID-19 test results, as applicable.
- On 08/24/2021, FISA's Administration Unit distributed registration information about Bi-weekly COVID-19 Briefings for City Workers; the briefings which started on 08/26/2021 will thereafter, occur every other Thursday at 12:00 pm.
- 08/31/2021, FISA submitted the first draft of its FY 2022 Annual Diversity & EEO Plan to OCEI for review. OCEI's Jerzy Warman acknowledged receipt of the draft.
- On 09/01/2021, FISA's Administration Unit distributed Executive Director Neil Matthew's message, "Return to Office Alert" in accordance with the Mayor's Restart Taskforce, which mandates that all City employees are to resume pre-March 2020 work scheduled, effective 09/13/2021.

- On 09/14/2021, FISA's Administration Unit announced the offering of mandatory COIB Chapter 68 training sessions for all staff members; training sessions will be held virtually via WebEx and hosted by a COIB Instructor.
- OCEI's EEO Best Practices meeting was held on 8/19/2021. The following agenda items were addressed:
 - o Deadlines for the FY 2021 Quarterly EEO Reports as well as for drafts of the FY 2022 Annual Diversity & EEO Plan.
 - o Complaints & Reasonable Accommodations Data Reporting and Quarterly Affirmations.
 - On overview of the EEPC's 2021 Racial and Ethnic Classification Report as mandated by Local Law 13, i.e. the EEPC must analyze and report annually, for 10 years on citywide racial and ethnic classification and underutilization.
 - o Statistical Data and hiring initiatives regarding the 55-a Program.
 - o Recognition of the National Disability Employment Awareness Month, which will be celebrated in October 2021.
 - OCEI's overview of the City's Vaccination Mandates, i.e. E.O. 75 (for new hires), and effective September 13 2021, current employees must provide proof of vaccination or submit to weekly COVID-19 tests (except if they have an approved reasonable accommodation.
 - Review of the Reasonable Accommodation process, including ways to engage in Cooperative Dialogue, how to conduct Direct Threat analysis and Undue Hardship analysis, and Religious accommodations.
