To the Honorable the Board of Assistant Aldermen of the City of New York:

GENTLEMEN—The undersigned, Mr. Harrison Durkee, by his Counsel, Mr. Clark Bell, respectfully represents to your Honorable Board:

That the said Harrison Durkee is the owner of the house and premises No. 714 Fifth avenue, in the City of New York, and resides therein, and has resided there for some time past.

That the said Harrison Durkee respectfully protests against, and objects to, the adoption by your Honorable Body of the resolution or ordinance reported by the Committee on Ordinances, on the 29th June, 1874, and which was then laid over, or to any permission for a projection beyond the street line, on the application and petition of the Presbyterian Church on the corner of Fifth avenue and Fifty-fifth street, in said city. The said Harrison Durkee represents that his house and lot is within less than twenty-six feet, and is only twenty-five feet distant, from the said Presbyterian Church for which the said permission to erect a projection is asked; and that he has never consented, verbally or in writing, to the said proposed projection on the Fifth avenue, nor will he consent thereto.

That said proposed resolution, as reported by the Committee on Ordinances, would greatly injure the value of the said real estate and residence of the said Harrison Durkee, and would obstruct his view looking southerly down the Fifth avenue from his said residence.

That the said resolution is in violation of the General Ordinance of 1873, No. 1274, which passed your Body February 20, 1873, and was approved March 5, 1873, as the undersigned is the owner of property within fifty feet of the house upon which said projections are proposed, to wit, only twenty-five feet therefrom, so that your Board should not even entertain such a petition or resolution.

REPORT:

That, in reply to the application of Mrs. Randel, wife of John Randel, Jr., who made the surveys and maps of the City of New York, north of North street, now Houston street, under the act of the Legislature, passed 3d April, 1807, and under the direction of the Surveyor General of the State, we find the facts to be as follows:

First. That Mr. Randel performed certain duties, and no doubt well; that the results of his labors were put on record in the Street Department over fifty years ago, and remained as such for a general index, and used as references daily, and that the making of said maps were all he was engaged to perform under such instructions. That any field notes could not be used as evidence unless proved by the maker of such notes, if used as evidence to prove boundary lines, and which have now been surveyed and resurveyed for fifty years past, and as there is not any special question now to be decided in the interest of the city, and said field notes could only be used, if used under any pretenses, as an ancient record, are of the opinion that they would not only be useless, but in some instances disturb lines which may have been adjusted between owners of land, and not made a matter of record, should therefore recommend that they should not be purchased, or become the property of the city.

Resolved, That this Board non-concur in the action of the Board of Aldermen.

Resolved, That the Board of Estimate and Apportionment be and they are hereby requested to appropriate the sum of \$5,000 to purchase the original maps, field notes, etc., of the Randel survey of the city, north of North street.

PAPERS FROM THE BOARD OF ALDERMEN.

Ordinance, as follows:

AN ORDINANCE to amend an ordinance, entitled "An ordinance to provide for the killing of dogs in the City of New York," passed May 27, 1874.

The Mayor, Aldermen, and Commonalty of the City of New York do ordain as follows:

SECTION 1. Section 1 of the above-entitled ordinance is hereby amended by adding thereto, at the end thereof, the following: "And the Commissioners of Police are hereby authorized and directed to cause complaint to be made to the Corporation Attorney against the owner or possessor of every dog permitted to go loose or at large within the corporate limits aforesaid, for recovery of the penalties prescribed in this ordinance, such penalty, when collected, to be accounted for semi-monthly, and paid to the Comptroller of the City of New York, and upon the requisition of the Mayor, to be applied towards the payment of the expenses of enforcing the provisions of this ordinance."

SEC. 2. Section 2 of the above-entitled ordinance is hereby amended, and shall read as follows:

§ 2. The Mayor of the City of New York is hereby authorized and empowered to take such measures as he may deem most expedient to carry into effect the provisions of section 1 of this ordinance, and for that purpose is hereby further authorized and empowered to appoint two or more persons, each of the age of twenty-one years or upwards, in each of the Assembly Districts in the City of New York, to seize and capture all such dogs found running loose, or at large, and to pay such persons so appointed, for every such dog so captured and delivered, at a place to be provided and designated by the Mayor, the sum of fifty cents. No person shall hinder or molest any person or persons so appointed by the Mayor, while engaged in seizing or capturing, and delivering any such dog as aforesaid, or any other person engaged in the performance of any other duty enjoined by the provisions of this ordinance, under a penalty of not less than twenty-five, nor more than one hundred dollars, for every offence, to be sued for and recovered in the manner now provided by law or ordinance for the recovery of penalties for violations of the ordinances of the Common Council, on complaint of the person so hindered or molested; the penalty, when recovered, to be accounted for, paid, and appropriated, as provided in section 1 of this ordinance; and the Commissioners of Police are hereby authorized and directed to cause the persons so engaged in the performance of any of the duties prescribed in this ordinance to be protected from hindrance or molestation. Every dog mentioned in this ordinance, when so captured and delivered as aforesaid, if not claimed by the owner or any other person, within a period of forty-eight hours thereafter, shall, within six hours after the expiration of the time, be killed and destroyed in such manner as may be determined upon by the Mayor. Any owner or other person who may claim such dog shall, before being placed in possession thereof, pay therefor the sum of three dollars.

SEC. 3. Section 3 of the above-entitled ordinance is hereby amended by adding after the word "paid" before the words "until otherwise ordered," the words "and all other expenses of enforcing the provisions of this ordinance."

SEC. 4. Section 4 of the above-entitled ordinance is hereby repealed.

SEC. 5. Sections 5, 6, and 7 of the above-entitled ordinance shall hereafter be numbered respectively 4, 5, and 6.

SEC. 6. All ordinances, or parts of ordinances, inconsistent or conflicting with the provisions of this ordinance, are hereby repealed.

SEC. 7. This ordinance shall take effect immediately.

The said ordinance, when so amended, shall read as follows:

AN ORDINANCE to provide for the killing of dogs in the City of New York.

The Mayor, Aldermen, and Commonalty of the City of New York, do ordain as follows:

Section 1. Hereafter it shall not be lawful to permit any dog to go abroad loose, or at large, in any of the streets, lanes, alleys, where not inclosed, highways, parks, or public places within the corporate limits of the City of New York, unless the head of every such dog shall be encased in a wire muzzle sufficiently large to cover the head entirely, but so constructed as to admit of the dog opening its mouth to the fullest extent, and in no case to permit the nose of the dog to protrude; the muzzle to be securely fastened around the throat and behind the ears of every such dog, under a penalty of three dollars for each offence, to be recovered against the owner, possessor, or person who harbored such dog within three days previous to the time of such dog being so found going abroad, loose, or at large, and the Commissioner of Police are hereby authorized and directed to cause complaint to be made to the Corporation Attorney against the owner or possessor of every dog permitted to go loose or at large within the corporate limits, as aforesaid, for the recovery of the penalties prescribed in this ordinance; such penalty, when collected, to be accounted for semi-monthly, and paid to the Comptroller of said city, and upon the requisition of the Mayor, to be applied towards the payment of enforcing the provisions of this ordinance.

SEC. 2. The Mayor of the City of New York is

hereby authorized and empowered to take such measures as he may deem most efficient to carry into effect the provisions of section 1 of this ordinance; and for that purpose is further authorized and empowered to appoint two or more persons, each of the age of twenty-one years or upwards, in each of the Assembly Districts in the City of New York, to seize and capture all such dogs found running loose or at large, and to pay such persons so appointed for every such dog so captured and delivered at a place to be provided and designated by the Mayor, the sum of fifty cents. No person shall hinder or molest any person or persons so appointed by the Mayor while engaged in seizing or capturing and delivering any such dog as aforesaid, or any other person engaged in the performance of any duty enjoined by the provisions of this ordinance, under a penalty of not less than twenty-five nor more than one hundred dollars for every offence, to be sued for and recovered in the manner now provided by law or ordinance for the recovery of penalties for violations of the ordinances of the Common Council, on complaint of the person so hindered or molested; the penalty, when recovered, to be accounted for, paid, and appropriated as provided in section 1 of this ordinance. The Commissioners of Police are hereby authorized and required to cause the persons so engaged in the performance of any of the duties prescribed by this ordinance, to be protected from hindrance or molestation. Every dog mentioned in this ordinance, when so captured and delivered as aforesaid, if not claimed by the owner thereof, or any other person, within a period of forty-eight hours thereafter, shall, within six hours after the expiration of the time, be killed and destroyed in such manner as may be determined upon by the Mayor. Any owner or other person who may claim such dog shall, before being placed in possession thereof, pay therefor the sum of three dollars.

SEC. 3. The person authorized to pay for the capture of such dogs shall render under oath, semi-monthly, a statement of all dogs so captured and killed, and the amount paid therefor, to the Mayor of this city, who shall thereupon certify the same to the Comptroller, when a warrant for the amount shall be drawn in favor of the said Mayor for the sum thus expended, which shall be paid, and the other expenses of enforcing the provisions of this ordinance, until otherwise ordered, from the appropriation for City Contingencies.

SEC. 4. The provisions of this ordinance shall apply only to dogs owned or claimed by residents of this city, and any person who shall present any such dog, and claim payment for the capture thereof, which shall not be owned or captured within the corporate limits of this city, shall thereby incur a penalty of ten dollars. This ordinance shall apply only to any such dogs of the age of six months and upwards.

SEC. 5. Chapter XLIV. of the Revised Ordinances of 1866, and all other ordinances or parts of ordinances inconsistent or conflicting with the provisions of this ordinance, are hereby repealed.

SEC. 6. This ordinance shall take effect immediately.
