Whereas, Proceedings have again been taken to have Commissioners of Estimate and Assessment appointed by the Supreme Court, on Monday, June 28, 1875, in the matter of a Parade Ground in the upper part of this island of about 100 acres of land; and

Whereas. Proceedings previously taken to carry out this project were discontinued by the Department of Public Parks for good and sufficient reasons, and this discontinuance was sustained by a decision of the Court of Appeals against an appeal made by property owners in interest; and

Whereas, The laying out of a Parade Ground in the proposed locality was projected prior to the annexation of a portion of Westchester County to the City of New York, as presenting the most eligible site then available for the purpose; and

Whereas, The present time is one of great financial embarrassment, causing a depression in business bearing heavily upon the resources of all classes of the community, and crippling the means of taxpayers, especially by reduction of rentals and incomes from city property, making it imperative that all unnecessary expenditures by the city and increase of the public debt shall be avoided as far as possible; and

Whereas, The estimated cost of the proposed Parade Ground, for lands taken and laying out the grounds alone, will amount to about one million and a half dollars (\$1,500,000), to be added to the city debt by the issue of bonds, the interest on which, with the expenses of maintenance, will require the sum of at least one hundred and twenty-five thousand dollars (\$125,000) to be raised annually by taxation for this object; and

Whereas, So large an increase of the funded debt and of the taxes, already so oppressive and heavy upon the taxpayers of this city, are not wise and judicious measures at this time of general depression of business; therefore

AN ORDINANCE to amend an ordinance entitled "An ordinance to amend section 44, article 4 of chapter 42 of the Revised Ordinances of 1866, entitled 'Of Pawnbrokers, Dealers in Second-hand Articles, and Keepers of Junk Shops," passed April 19, 1875.

The Mayor, Aldermen, and Commonalty of the City of New York, do ordain as follows:

Section 1. Section 4. of critical 4 of chapter 42 of the Revised Ordinances of 1866, as above

Sec. 44. A separate license shall be obtained, by the owner thereof, for each and every cart, wagon, or other vehicle, boat or other vessel, and the owner of every such licensed cart or other vehicle, boat or other vessel, shall procure "for every such cart or other vehicle, boat or other vessel, one metal badge containing the license number of such cart or boat, and no person shall buy or sell, or solicit for the purchase or sale of any rags, papers, bottles, old metal, or junk of any description, unless he have such badge conspicuously displayed upon his person, under a penalty of not less than one dollar (\$1.00), nor more than twenty-five dollars (\$25.00), for every offense." The form and material of such badges shall be determined by the Mayor. Any forfeiture or penalty arising under this ordinance may be enforced by the Mayor, or recovered by an action in the name of the Mayor, Aldermen, and Commonalty of the City of New York, prosecuted in any Court of Justice, as prescribed by the City Charter, or by law, and the forfeiture or penalty so recovered shall be paid into the City Treasury.

SIR—Below I give further details of work by this Department proposed for this year in laying as for a better distribution of Croton water, with estimated cost of same, as asked for in the Board of Aldermen.

Fifth avenue is supplied with water only by a 6-inch pipe connected with some of the cross street pipes—the supply of water coming from the large mains on Eighth and Third avenues. The present large mains on Third avenue being connected with the cross-mains only at long intervals, and at no place directly with the present 6-inch pipe from which the adjacent houses on this avenue are supplied, the amount of water now used in this district is so large that it is necessary to provide for it by laying a larger main and connecting it with each pipe in the streets crossing this avenue.

Twenty-inch pipe on Fitth avenue, between Fifty-seventh and Tenth streets, with the necessary connections, 12,600 feet, at \$8.50 per foot, \$107,100.00.

The east side of the city, from Ninety-fourth to Fourteenth street and east of Fourth avenue, now depends for its supply on a 30-inch main running through Seventy-ninth street and Third avenue south. The many high points in this district are now suffering from an insufficient supply of water, and to provide for this there is now being laid a 48-inch main in Eightieth street, to go down First avenue, connecting with the cross streets and avenues, giving a direct supply from the reservoirs in Central Park.

Forty-eight inch pipe through Eightieth street to First avenue, and down First avenue to Sixty-sixth street, for which we have the pipes from the Fourth avenue Improvement, 5,400 feet, at \$10 per

Foot, \$54,000.00.

Randall's Island is now supplied by a 3-inch lead pipe, the 8-inch cast iron pipe under the Harlem river (laid in 1869) to this Island having burst this spring, is useless and cut off. A communication has been received from the Commissioners of Charities and Correction, requesting that this Department give them an increased and adequate supply of water. To do this it will be necessary to put a 6-inch pipe across and under Harlem river to this Island, and to lay a 6-inch main across the Island to the several Institutions.

6-inch wrought iron pipe, boxed, etc., across the Harlem river to Randall's Island, esti-

There are now on file in this office several ordinances directing the laying of Croton-mains in streets where no pipes are now laid, and there is a regular and steady demand to have pipes laid by persons building on new streets. This necessitates not only the laying of pipes in the immediate place called for, but the necessary mains to get the water to these pipes and keep up the circulation.

The Fourth Avenue Improvement caused this Department to entirely clear the Fourth avenue of all pipes from Harlem river to Forty-second street. On account of the unfinished condition of the work, but few of them have been replaced, leaving a very large number of ends of pipes, supplying whole blocks of houses, with no direct circulation of water in them, giving the parties using water from these ends cause for complaint of bad water. To remedy this will require a main to be laid on each side of Fourth avenue, connecting with the pipes on each street.

To supply the above will require—

15,000 feet of 12 inch pipe, at \$5.00 per foot.

The Legislature, by chapter 329, section 14, Laws of 1874, authorizes this Department to construct and lay a main on Third avenue, from Harlem bridge to Fordham station, on the Harlem Railroad, but made no appropriation of money to do the same.

The Department, in laying a main under and across Harlem river and up Third avenue to One Hundred and Fifty-eighth street, expended moneys that were appropriated in 1873 for laying mains in the city proper. To carry out the Law of 1874, and to supply the large number of houses in this new district (Twenty-third and Twenty-fourth Wards), will require a large number of small pipes.

The lower part of the city, between Canal and Wall streets, especially on the higher portion, is inadequately supplied with large pipes and large hydrants. The buildings in this district of the city being now built over more space, and higher than in former years, require a much larger supply of water and larger hydrants.

In laying the new 36-inch main down town a branch and stop-cock was put in, at the corner of Chambers and Williams streets, for the purpose of placing a large main through William street, and providing it with large hydrants.

20 inch pipe on William street, from Chambers to Wall street, and large hydrants. \$24,500 00

The district now supplied with high service water uses so much that it is not safe or economical to trust to one pumping engine, now running night and day to do the work. Another engine should be at once put up, so that in case of accident to the one now in use this district shall not be entirely cut off from the Croton water.

Another main should be laid south from Carmansville as the high grounds at Yorkville and at Muray Hill are now supplied, and at times scantily, from one main, and in case of accident to this their supply will be cut off.

Another main should also be laid across Central Park, through the Transverse Road at Eighty-sixth street, to give a full supply of water on the high grounds at Yorkville, and enable us to include in the high service the district laying between Lexington and Third avenues and Eighty-fourth and Ninety-fourth streets, as requested by the Board of Aldermen on the 19th of May.

It will be thus seen that the work for this season is based on a fund of some \$750,000. Of course this estimate is approximate, and it is hoped that in its application there will be saving largely to the benefit of the city.

There is of the amount previously authorized to be expended by this Department in laying Croton water mains, for the better distribution of the Croton water, \$250,000 that has not been drawn upon by this Department, for the reason that the Comptroller claims that the right to use this money has elapsed.

elapsed.

I asked the Board of Apportionment to authorize the issue of bonds for this amount in a communication to your Honor of the 26th June. Should this amount be authorized there is use for it in the new district. As applications are being constantly made to this Department for extensions of the Croton mains, and in extending the 48-inch main down First avenue, and also in the lower part of the city where, for the safety of the city against fire, the demand and necessity is the most urgent.

The bill to which the concurrence of the Common Council and the approval of your Honor is asked was for \$1,500,000 when passed by the Assembly, but was by the action of the Senate limited to \$500,000 for any one year.

I have to add that, unless means are provided, the laying of new mains for extending the distribution of Croton water must cease, and the gangs now at work must be discharged immediately.

The responsibility of further obstructing the progress of this work must rest elsewhere. I am unwilling that it should be borne by this Department, which, with your aid, has striven to meet the urgent wants of the city in the particulars above indicated.

Kasmire:

To the Honorable the Board of Aldermen of the City of New York:

GENTLEMEN—Police Magistrates in the City of New York have power to punish for disorderly conduct any person suffering and permitting a vicious and unmuzzled dog to run at large in the public streets, and they may order the killing of any dog on evidence that the dog has bitten some person in a public street or highway; but they have no power to enforce the order to kill, as the Supervisors must sue for the recovery of the money penalty attached to the non-compliance with the order. I have great trouble in dealing with this class of cases, and probably listen to as many as a dozen complaints in one day from persons who have been bitten by dogs running at large in the public streets. You will perceive it is difficult, in many cases, to find an owner or possessor for the dog; consequently a complaint for disorderly conduct cannot be taken, neither can an order to kill be issued. Many uneducated people believe that serious consequences are certain to ensue if the dog biting the person be not immediately killed, and they suffer great agony of mind in consequence of such belief.

In the upper portion of the city the running of dogs at large has become an outrage and a

In the upper portion of the city the running of dogs at large has become an outrage and a nuisance, and while I do not desire to suggest to your Honorable Board what action should be taken in abatement thereof, I cannot refrain, in the performance of my duty as a Police Magistrate, from calling your attention to it, as the whole matter is entirely within your control, and ought certainly to be promptly and effectually attended to.

The following is a record of the work performed in the Sanitary Bureau for the week ending July 10, 1875. The number of inspections made by the Sanitary and Assistant Sanitary Inspectors was 1,945, as follows, viz.: 2 public buildings, 952 tenement houses, 92 private dwellings, 85 other dwellings, 27 manufactories and workshops, 27 stores and ware-houses, 47 stables, 4 markets, 24 slaughter-houses, 11 fat-melting establishments, 9 dumping grounds, 1 coal yard, 1 roadway, 25 sunken and vacant lots, 1 public sewer and drain, 67 yards, courts, and areas, 59 cellars and basements, 66 waste-pipes and drains, 152 privies and water-closets, 131 street gutters and sidewalks, 8 dangerous stairways, 3 dangerous and smoky chimneys, 3 cisterns and cesspools, 3 violations of code, 20 other nuisances, together with 95 visits of the Inspectors to cases of contagious diseases.

The number of reports thereon received from the Inspectors was 761.

During the past week 68 complaints were received from citizens, and referred to the Sanitary and Assistant Sanitary Inspectors for investigation and report. 55 permits were issued to the consignees of vessels to discharge cargoes, on vouchers from the Health Officer of the Port.

218 permits were granted scavengers to empty, clean, and disinfect privy-sinks.

The Disinfecting Corps have visited 114 premises where contagious diseases were found, and

have disinfected and fumigated 92 houses, together with clothing, bedding, etc. They have also disinfected 1,347 privy sinks, 31 cellars, and 44 yards, and 153½ miles of street gutters.

56 persons were removed to the hospital, and 5 dead bodies to the Morgue, by the Ambulance

No fees of any kind exist or are allowed in regard to jury notices, and any one asking, receiving, or giving any such "fee" or "present" will be arrested, and, if possible, punished to the full extent of the law.
