RESOLVED That the Design Commission, having considered designs for the construction of an observation wheel, terminal building and parking garage, and rooftop park, including a playground, Richmond Terrace, Nicholas Street and Hamilton Avenue, Staten Island, submitted by the Economic Development Corporation on behalf of NY Wheel, LLC, represented by exhibits 138-GF, GK, GM, GN, GO and GQ, of record in this matter, hereby gives to the same unanimous preliminary approval with the understanding that, per the working sessions with the Department of City Planning, all elements of the design that have not been agreed to as of the August 12th working session will remain flexible in the Uniform Land Use Review Procedure (ULURP) drawings. The Commission also notes that all of the following conditions must be addressed by the applicant at subsequent committee meetings prior to submission for final review by the Design Commission.

Approval is given to the design of the terminal building subject to (1) further developing Option H for the Bank Street entrance by (a) raising the height of the entrance to the second horizontal division, (b) making the soffit and end wall Chinese red or another bright color, (c) incorporating additional step downs on the terra cotta end wall proud of the greenwall, and (d) exploring a light, cable-supported canopy that projects eastward and tapers in plan and depth with the understanding that, since the canopy dimensions have not been finalized, they will remain flexible in the ULURP drawings; (2) developing the Richmond Terrace entrance in a similar way, potentially including a canopy, but at a smaller scale, again with the understanding that, since the design has not been finalized, it will remain flexible in the ULURP drawings; and (3) submitting final materials selections, including a detailed list and samples.

Approval is given to the landscape and observation wheel designs presented to the committee on July 15, 2013, which do not include subsequent changes to the reflecting pool, the area under the wheel itself and the Richmond Terrace grove planting, none of which has been submitted to the Design Commission for its review. The Commission also notes that while the proposed plant material is appropriate, approval is given with the understanding that the plant list and planting plan have not been finalized and will remain flexible in the ULURP drawings, and all wood should be specified as domestic hardwood or Forest Management- or Chain-of-Custody-certified tropical hardwood consistent with the Mayor's Office of Long-Term Planning and Sustainability's policy on tropical hardwood.

Approval is also given subject to the submission of (1) a revised design for the mechanical tower that, per one of the working sessions with the Department of City Planning, treats it as a singular sculptural object, noting that any footprint included in the ULURP drawings is a placeholder only and does not represent an actual design; (2) lighting proposals for the wheel, building and landscape, which have not been submitted to the Design Commission for its review; and (3) building graphics, wayfinding signage and sponsorship opportunities, if applicable, which have not been submitted to the Design Commission for its review, with the understanding that any notations in the ULURP drawings are placeholders, and once those elements are developed by the graphic designer, they will be submitted for review by the Design Commission.

The Commission thanks the architect and developer for their responsiveness.
