

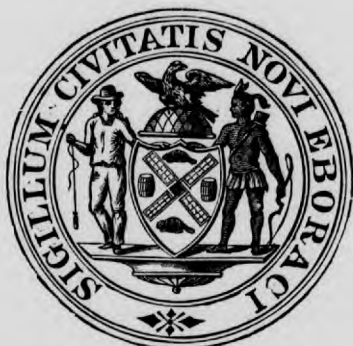

BOARD OF ALDERMEN.

TUESDAY, January 25, 1887,
1 o'clock P. M.

The Board met in their chamber, room 16, City Hall.

The minutes of the last meeting were read and approved.

PETITIONS.

By the President—

Petition of owners of property to have Ninety-first street, from Ninth to Tenth avenue, regulated, graded, etc.

Petition of the Harlem Lighting Company for permission to light with electric lights Third avenue, from Eighty-sixth to One Hundred and Seventieth street.

In connection therewith Alderman Mooney offered the following :

Resolved, That the Harlem Lighting Company be and is hereby granted permission to light, free of expense to the City, One Hundred and Twenty-fifth street, from Eighth avenue to Fourth avenue, and Third avenue, from Eighty-sixth to One Hundred and Seventieth street, with electric arc lights, for a period of ninety days, and that they be permitted to erect the necessary lamps and supports for this purpose, subject to the approval of the Subway Commission, and under the supervision of the Commissioner of Public Works.

Resolved, That St. Ann's avenue, between the northerly curb-line of the Southern Boulevard and the southerly curb-line of Clifton street, in the Twenty-third Ward, be regulated and graded, that the sidewalks on said avenue, between said limits, be flagged a space four feet wide where not heretofore flagged, and that the curb and gutter stones be set and crosswalks laid, where not heretofore set and laid within said limits, under the direction of the Commissioners of the Department of Public Parks; and that the accompanying ordinance therefor be adopted.

Masterson, Alderman-elect to this Board from the Nineteenth Assembly District, and that the Clerk call the roll of the members of this Board, and that each member rise in his place, and announce the name of his choice to fill the vacancy in this Board.

Resolved, That the Committee on Street Pavements be and it hereby is directed to inquire into the opening of street surfaces and the restoration of the same, and that said Committee report to this Board such additional rules and regulations as in its opinion should be adopted to ensure more efficient performance of such work, and better protection to the public interests.

The President put the question whether the Board would agree with said resolution.

Which was decided in the affirmative.

By Alderman Bennett—

Resolved, That an improved iron drinking-fountain (for man and beast) be erected on the southeast corner of Avenue D and Fourteenth street, under the direction of the Commissioner of Public Works.

Which was referred to the Committee on Public Works.

By Alderman Conkling—

Resolved, That permission be and the same is hereby given to Julius A. Robinson to erect an ornamental lamp-post and lamp in front of his premises, Nos. 663 and 665 Broadway, near the curb, the work to be done and gas supplied at his own expense, under the direction of the Commissioner of Public Works; such permission to continue only during the pleasure of the Common Council.

Alderman Dowling moved that the resolution be referred to the Committee on Lamps and Gas.

The President put the question whether the Board would agree with the said motion.

STEAMBOAT PILOTS' ASSOCIATION,
January 24, 1887.

At a meeting of the above Association, held January, 22d inst., it was unanimously resolved to appeal to the Common Council of the City of New York to prevent the Department of Street Cleaning from dumping alleged snow, but what is in reality principally street dirt, into the North and East rivers, as the practice is calculated to fill up the harbor, and thereby embarrass and endanger the commerce of the port.

To the Honorable Board of Aldermen of the City of New York.

Resolved, That the privilege heretofore granted to the Department of Street Cleaning to dump snow from the docks on the North and East rivers be and is hereby rescinded, for the reason that it is impossible to separate from the snow the large amount of dirt which the law requires shall be taken to sea and dumped.

Which was referred to the Committee on Street Cleaning.

By the same—

Resolved, That permission be and the same is hereby given to Augustus C. Bechstein to lay a three-inch iron pipe across Franklin street, for the purpose of conducting steam from the premises Nos. 157 and 159 to No. 164, on the opposite side of the street, provided the said Augustus C. Bechstein shall stipulate with the Commissioner of Public Works to save the city harmless from any loss or damage that may occur during the progress or subsequent to the completion of the work of laying said pipe, to any water-pipes, gas-pipes or sewer, or from any other cause, the work to be done at his own expense, under the direction of the Commissioner of Public Works; such permission to continue only during the pleasure of the Common Council.

(Vice-President Divver was here called to the chair.)

The President moved that the paper be referred to the Committee on Public Works.

The Vice-President put the question whether the Board would agree with said motion.

OFFICE OF EXECUTIVE BOARD OF THE OCEAN ASSOCIATIONS,
NEW YORK, January 18, 1887.

To Your Honorable Body the Board of Aldermen:

Through the Executive Board of the Ocean Association your Honorable Body are required to answer the following questions: 1st. By whose permission has the Old Dominion S. S. Co. trespassed upon the public thoroughfare, at the foot of Beach street, to the detriment of the majority of the citizens of this city; also, if there has been a conspiracy hatched anywhere granting said S. S. Co. the privilege of completely blocking the bulkhead of all secure travel to pedestrians. To the above questions you are politely requested through your Board an answer, also, how much said company pay for the privilege; 20,000 'longshoremen have requested of you an answer through this committee appointed; also, how much the Morgan S. S. Co. pay for their privilege of occupancy of acres, and other companies, also, who, however, use more discretion than the others named above. An immediate answer is required.
