

The \$73 deaths represent a death-rate of 27.20, against 28.37 for the previous week and 22.81 for the corresponding week of 1890. Diphtheria decreased slightly and measles and scarlet fever showed a considerable increase, the number of cases reported being respectively 90, 392 and 241, against 95, 325 and 199 for the previous week. The decrease of diphtheria was most marked between Rivington and Fourteenth streets, east of Avenue B, and between Division and Rivington, the Bowery and Norfolk street, while there was a considerable increase above Eighty-sixth street, south of the Harlem river, the variations elsewhere being slight. The increase of scarlet fever was pretty general all over the city, excepting that there was a marked decrease between Rivington and Fourteenth, the Bowery and Third avenue, and Avenue B. Measles increased pretty generally, the increase being greatest between Fortieth and Eighty-sixth streets, East, where the number of cases reported more than doubled (120 against 58), while there was a marked decrease south of Rivington street, east of the Bowery, and between the Bowery, Third avenue, Avenue B, Rivington and Fourteenth streets.
