#### BOARD OF ARMORY COMMISSIONERS.

MAYOR'S OFFICE, CITY HALL, New York, April 10, 1889.

A meeting of the Armory Board was held this day, at I P. M., at the office of his Honor Mayor Grant.

The Mayor, the President Commissioner of the Department of Taxes and Assess-Present-

ments, and the Commissioner of the Public Works Department.

The minutes of the last meeting were read and approved.

Benjamin J. Sturges & Son offered as armory sites the following plots of land, at the prices

150 feet by 204 feet 4 inches, on west side of Tenth avenue, between Eighty-fifth and Eighty-

sixth streets. Price, \$170,000.

Also, 114 feet 6 inches by 204 feet 4 inches, irregular, on east side of Boulevard, between Eighty-fifth and Eighty-sixth streets. Price, \$145,000.

They were ordered on file.

A communication was received from the Comptroller, containing a certified copy of the action of the Sinking Fund, approving of a site for an armory on the easterly side of Fourth avenue, between Thirty-third and Thirty-fourth streets.

Commissioner Coleman offered the following preamble and resolution:

Whereas, Under and in pursuance of the provisions of chapter 330 of the Laws of 1887, the Department of Public Works has prepared and furnished, at the request of this Board, a survey, map or plan, together with field notes and explanatory remarks, of a site for armory purposes, on the easterly side of Fourth avenue, extending from Thirty-third street to Thirty-fourth street, and running easterly 236 feet on each of said streets; and

Whereas, Under and in pursuance of the provisions of said chapter 330 of the Laws of 1887, said survey, map or plan, with field notes and explanatory remarks, showing said site, has been duly submitted to the Commissioners of the Sinking Fund, and said Commissioners of the Sinking Fund have duly approved of said site and consented to the acquisition thereof for said purposes, and have indicated such approval and consent by a certificate to that effect, indorsed upon or attached to said survey, map or plan, so as aforesaid submitted to said Commissioners; therefore, it is Resolved, That this Board does hereby select, locate and lay out, as a site for armory purposes, all those pieces or parcels of land which are bounded and described as follows:

Beginning at a point on the southerly line of Thirty-fourth street, distant 188 3-10 feet westerly from the westerly line of Lexington avenue; thence southerly and parallel with said avenue 197 5-10 feet to the northerly line of Thirty-third street; thence westerly along the northerly line of Thirty-third street; thence westerly along the northerly line of Thirty-third street; distance 236 7-10 feet to the easterly line of Fourth avenue; thence northerly along said easterly line of Fourth avenue, distance 197 5-10 feet, to the southerly line of Thirty-fourth street; thence easterly along said southerly line of Thirty-fourth street 236 7-10 feet to the point or place of beginning, containing 46,748 25-100 feet.

Resolved, That this Board does now proceed to certify the survey, map or plan showing said site, which has been duly prepared and furnished by the Department of Public Works at the request of this Board, and which has been duly submitted to the Commissioners of the Sinking Fund, said Commissioners of the Sinking Fund having duly approved of said site and consented to the acquisition thereof for said purposes, and indicated such approval and consent by a certificate to that effect indorsed upon or attached to said survey, map or plan; that the Secretary of this Board be and he hereby is directed to transmit said survey, map or plan to the Department of Public Works for the information of said Department, and that said Department be and is hereby respectfully requested to prepare and furnish this Board with a true copy thereof, and that when that has been done the said Secretary be and he hereby is directed to file said survey, map or plan in the office of the Register of the City and County of New York, and the true copy thereof, certified as such by the Chairman of this Board and the Commissioner of Public Works, in the office of said Commissioner of Public Works, as required by said chapter 330 of the Laws of 1887. of Public Works, as required by said chapter 330 of the Laws of 1887. This resolution was unanimously adopted.

Hon. MICHAEL COLEMAN, Secretary of the Armory Board:

DEAR SIR—I beg leave to acknowledge receipt of your communication of the 16th ultimo, wherein you state that at a meeting of your Board held on the 14th ultimo, the following business was enacted:

"The Secretary was directed to write the Corporation Counsel as to the power of closing Hall place and using it for such a purpose."

In answer thereto I beg leave to say that your Board has no power to close the above-named street. The act authorizing the laying-out and acquisition of land as sites for armory purposes, chapter 330 of the Laws of 1887, provides that "no site shall be located in any park or public place or on land now occupied by reservoir." The term "public place" is broad enough to cover a street such as Hall place. That power to close streets is vested by law in the Board of Street Opening and Improvement. If that Board, therefore, will authorize the initiation of the necessary proceedings, Hall place can be closed.

The land east of Hall place can, of course, be condemned by your Board for armory purposes by causing a survey or map to be prepared and by proceeding as prescribed in chapter 330 of the Laws of 1887, which confers power upon you for the purpose.

With the closing of the street the entire plot can then be utilized as an armory site.

If it is concluded to close Hall place and condemn the land east of it in the manner above mentioned, I would advise that both proceedings be commenced at about the same time, and that the report of the Commissioners of Estimate in the proceeding to acquire the land east of Hall place be first confirmed and then the report of the Commissioners in the closing proceeding, as it would greatly facilitate matters if the City would become the owner of the lands on both sides of Hall place before the preparation of the report of the Commissioners in the closing proceeding.

### AQUEDUCT COMMISSION.

Minutes of Stated Meeting of the Aqueduct Commissioners, held at their Office, No. 209 Stewart Building, on Wednesday, March 20, 1889, at 3 o'clock P. M.

Present-The Comptroller, the Commissioner of Public Works, and Commissioners Duane, Tucker, Scott and Howe.

The minutes of the stated meeting of March 13, 1889, were read and approved.

The Committee of Finance and Audit reported their examination and audit of bills contained Jouchers Nos. 4531 to 4542, inclusive, amounting to \$1,097.53.

On motion of Commissioner Howe, the same were approved and ordered certified to the Comp-

troller for payment.

The Committee of Finance and Audit report—

That they have examined the bids and checks received March 13, 1889, for furnishing all the labor and materials necessary for clearing and removing all timber, etc., of reservoirs on the east branch of Croton river and Bog brook, in the town of South East, Putnam County, New York.

The checks, amounting to \$3,000 in all, were found correct, and were transmitted to the Comptroller, and his receipt therefor is on file in this office. The bids were also found correct as to their formality. The sureties proposed appeared to be sufficient.

On motion of Commissioner Howe, the report was approved.

To the Board of Aqueduct Commissioners:

GENTLEMEN—The Committee of Finance and Audit, to whom was referred the resolution of the Comptroller, "that some method be adopted by the Finance Committee, and reported to this Board for the future allowance of expenses, what shall be expenses, and what shall be allowed for traveling expenses," would respectfully report as follows:

As the Committee understands the resolution, its intention is to obtain for the information of the Board a general statement of what purchases may be made for the use of the Board, and what allowances have been heretofore permitted for traveling expenses.

Board a general statement of what purchases may be made for the use of the Board, and what allowances have been heretofore permitted for traveling expenses, transportation, supplies, and incidentals of the Engmeer Corps, and of the Commissioners' office.

From the circumstances leading to the adoption of this resolution, which are of record on the minutes of the Board, it appears to be the intent of the resolution that the Committee of Finance and Audit shall make such recommendation to the Board as will establish some general rules for the future determination of such expenses.

It will be convenient in considering the matter so referred to the Finance Committee to state first, in detail, the exact system heretofore pursued in making purchases or procuring work to be done, or of making allowances or disbursements for incidental expenses; and afterwards to state the views of the Committee for the consideration of the Board concerning the propriety of continuing certain expenses and allowances. certain expenses and allowances

views of the Committee for the consideration of the Board concerning the propriety of continuing certain expenses and allowances.

First, as to purchases—All supplies or purchases and allowances made are either for the Engineer Corps, which includes the office of the Chief Engineer and all his subordinates connected with the construction or for supplies for the use of the Commissioners' and the Secretary's offices.

First, as to the Engineer Corps—The rule is that supplies needed along the line of the work, of stationery, fodder, instruments, etc., are first ordered by the Division Engineer, who makes requisition upon the Chief Engineer, naming the kind and quantity of articles desired. The Chief Clerk draws a requisition of the articles desired for the office of the Chief Engineer. These requisitions are first approved by the Chief Engineer, or, in his absence, the Deputy Chief Engineer. If any article is asked for not customarily used, the Division Engineer is required by the Chief Engineer to explain the special reasons therefor. The requisition, after being made in due form and so certified by the Chief Engineer, is transmitted to the Secretary of the Commission for his signature on behalf of the Commissioners, if the claim be allowed. He consults the Purveyor as to any doubtful article. With the signature of the Secretary, the requisition goes to the Purveyor, a press copy being first made in the Requisition Book, so that any alteration in quantity or character of articles cannot subsequently be made without detection. The Purveyor then makes the purchase, giving an order to the merchant. Of these orders press copies are retained, which are numbered consecutively, containing also the requisition number, which is likewise consecutive. The goods so ordered are sent with the original bill to the Division Engineer making the requisition, or to the Chief Engineer's office, as the case may be. A duplicate bill with the original order is sent at the same time to the Purveyor. The Division Engineer or other party done and furnished. The bills with such certificates are then transmitted to the Auditor. He then examines the bills and certificates to see that they are correct as to form, and checks off every item in the bills against the requisition. He also examines the same as to prices, to see that they conform with standing arrangements made by the Purveyor or conform to previous bills. The Auditor then makes a voucher, attaching to it the bills and certificates, adding such memoranda in red ink on the bills as may be necessary from time to time to explain or indicate the use, disposition or distribution upon the books of the items therein. The voucher is then signed by the Auditor and certified to the Secretary of the Commission, who examines and signs the same, and the Auditor transmits it to the Finance Committee.

Forms of requisition, orders, certificates, audits and vouchers as above-described are annexed

All such bills are considered by the Finance Committee in open meeting. Every item of every bill is first read by the Chairman, and in case of doubt or uncertainty, the Auditor (who is also the Secretary of that Committee, and who is always present), is called upon to explain the same; and,

as frequently happens, the Purveyor is called in to answer questions as to prices or quantities.

Bills and vouchers are then examined in the same manner and signed by a majority or all of the three Commissioners constituting the Committee of Finance and Audit, who certify the same to the

At the regular meeting of the Commissioners the bills are approved and certified to the Comptroller, first receiving the audit and signature of a majority of the whole Board, usually not less than five Commissioners adding their signatures and certifying that they have examined the bills annexed; that the articles enumerated were received in good condition by the Commissioners solely for the purpose of effecting the construction of the Aqueduct, dams, reservoirs, etc., and were necessary for the lawful uses and purposes of said Commissioners; that the prices charged therein are approved as reasonable and proper; and that they certify the same to the Comptroller for payment as required by

Requisitions for the office of the Commissioners and the Secretary are made in the same manner and go through the same examination, audit and approval before going to the Comptroller, except that the requisition and approval of the Secretary takes the place of the approval of the Chief Engineer. The only deviation from this system is where, for special reasons by previous resolutions of the Board, purchases are made by authority of the Chief Engineer, and certified as having been made under such resolution, and afterwards transmitted to the Finance Committee for approval.

The question as to what expenses should be allowed to the members of the Engineering Corps is one which has been the subject of frequent and careful examination and discussion by the Finance

The expenses which have heretofore been allowed for this Corps may be divided into the fol-

Transportation.

Traveling expenses, including allowance of meals and board on special occasions. Rent and expenses of maintenance of office and rooms for the use of the Engineer Corps. Equipment of the Engineer Corps.

Expenses for postage, telegrams, expressage and the like.

#### TRANSPORTATION.

A matter as to which objection has been made in the Board, and for which information is apparently intended to be asked for in the resolution addressed to this Committee, is that of trans-

As is well understood by the Board, the line of operation extends from Central Park to the Harlem river, and from the Harlem river to Croton Lake, a distance in the aggregate of thirty-two miles, and includes the entire Croton Water-shed, containing three hundred and sixty-one square

A great part of the Aqueduct work lies at places remote from towns where it was necessary that the Engineer staff should have their office so as to be accessible to the Commissioners, Chief Engineer, Contractors and others, with reference to convenient communication concerning the work, as well as occupying the middle ground between the river and the railroad where the supplies, brick, cement and other things were received and had to be inspected, and the tunnel proper where the

work of construction was going on.

The Engineers and their assistants, including Superintending Inspectors, as well as the Inspectors themselves from time to time, and others employed on the work, were constantly required to go from place to place on this great line of work.

At the outset, therefore, provision had to be made for their transportation, and the pressure caused by the rapidity of construction, and the large number of working parties at the different headings demanded that as little time as possible should be lost in moving about from one place to another for such supervision and inspection. At the same time, the rules required that Inspectors and certain other subordinates should make their permanent residence within easy and convenient distances of their regular employment, and as to such no such reason for regular transportation existed.

The equipment for such transportation grew with the work, and the present Commissioners had their attention directed very early to the question of cost of such transportation; and the Committee of Finance and Audit were directed to prepare a report showing in detail the cost of transportation throughout the whole line of the Aqueduct. Such report was made on the 21st of November, 1888, and appears in the minutes of the Board meeting of that date. It recommended the reduction of force employed at various divisions, and these recommendations have, for the most part, been

force employed at various divisions, and these recommendations have, for the most part, been carried out, and a considerable reduction in monthy cost has been thereby effected.

Other changes recommended could not be conveniently carried out without prejudice to the work at that time, but were deferred for consideration until certain changes in the situation of divisional headquarters could be made, which could not be economically done at that time in consequence of pending leases which will expire on the 1st of May.

Concerning the matter of transportation upon the Cable Railway, on Manhattan Island, which has been made a matter of criticism, the Committee at the time of the report above-mentioned made an examination which showed that the cost of transportation on Manhattan Island was materially less with an equal service than that of any other division in consequence of the facilities offered by the Cable Railway running along the line of the work.

examination which showed that the cost of transportation on Manhattan Island was materially less with an equal service than that of any other division in consequence of the facilities offered by the Cable Railway running along the line of the work.

The system then and now in operation was the furnishing to those necessarily required to go from one point to another of badges from these railways, at a cost of \$3 a month for each person, enabling them to ride through working hours as often as might be required.

In response to an inquiry directed to Division Engineer Wegmann as to the practical working of this system, he reported that such badges amounted in all, on the Tenth Avenue Railway, to twenty, and on the Eighth Avenue Railway to ten. Those furnished therewith on the Cable Railway consisted of the following: D vision Engineer, three Assistant Engineers, three Transitmen, one Leveler, two Rodmen, seven Axemen, and three Superintending Inspectors. On the Eighth Avenue Railway, Division Engineer, two Assistant Engineers, one Transitman, one Rodman, one Chainman, three Axemen and one Superintending Inspector.

In the report furnished by the Division Engineer, it was stated "that these badges are used by the parties to whom they are issued during their working hours in going from one point to another. No badges have been given to the Inspectors and Axemen who are assigned to some particular shaft and have not to travel up and down the line in the pursuit of their duties. No badge has been given to any party to enable him simply to ride to and from his work." He adds, "that they effect a saving to the city, and are a great convenience, as it would be very difficult to keep track of the car-fares to which twenty-five or thirty employees are entitled while engaged on the work."

The Committee of Finance and Audit are well satisfied that this is a necessary and proper expenditure, and believe that the privilege is not abused. The saving of time is not so great in consequence of the shorter distances as in the case

cars at all times during working hours.

On the question of traveling expenses, the Committee have adopted and adhered to a very

where any member of the Engineer Corps has been regularly and permanently engaged at any given point, as for instance at a particular shaft or dam, he has been expected to so arrange his residence as to be near his work; and if he has chosen to keep a residence so far away from his work as to involve expense in going to and fro, no allowance has been made to him for such expense. On the other hand, where a member of the force in the performance of his duty has been obliged to cover constantly many different points at great distances from each other, so that no residence he could possibly acquire would be near his place of duty, it has been the custom to allow him reasonable traveling expenses to and from his home. Thus the Deputy Chief Engineer has been specifically charged by the Commission with the duty, in addition to his other duties, of superintending the work of repairs over the whole line of the Aqueduct, from One Hundred and Thirty-fifth street to Croton Lake. He may and often is required to be on one day at the extreme upper end of the line, the next day on the Section between One Hundred and Thirty-fifth street and the Harlem river, the next day at Tarrytown or Ardsley, the following day at Shaft 24 on the north side of the Harlem river, the next day at Yonkers, and the next at the Pipe-line below One Hundred and Thirty-fifth street. It is absolutely clear that no residence he could acquire would bring him within easy reach of more than one or two of these points. It also frequently happens that Division or Assistant Engineers employed on the line of the Aqueduct and living in the vicinity of their work are summoned or find it necessary to come to the Chief Engineer's office for instruction or consultation. In such cases

it has been customary and, as your Committee consider, perfectly proper to allow the fair traveling

On the question of meals the Committee have followed a similar rule, In cases where a member of the Engineer Corps of any grade has been required by the exigencies of the service to go to a point remote from that at which he is usually employed, he has been allowed the fair and reasonable cost of the meals which he has been obliged to procure while in the performance of such duty. In very rare cases bills for the board of members of the Corps have been allowed by the Committee, but only under exceptional circumstances. An instance in point occurred a week or two since, and has attracted adverse criticism from two members of the Commission, who, it is presumed, were not conversant with all the circumstances.

The Commission ordered certain surveys and soundings to be made near the proposed site of the Quaker Bridge Dam, and a party was made up for that purpose out of the regular Engineer force. It was essential that the work should be prosecuted expeditiously, and for that reason it was necessary that the force employed upon it should eat and sleep near the scene of operation, while at the same time the location was so remote from other work in which any member of the force has been engaged, and the special service to which the party was estimated was so temporary in its pature. been engaged, and the special service to which the party was assigned was so temporary in its nature, that it would have been unreasonable to ask or expect the members of that party to break up their homes, and to seek new residences for a period not covering at the most more than a very few weeks. Under these circumstances, the Committee on Construction authorized the Assistant Engineer in charge of the surveying party to procure board for his party in the immediate vicinity of the work to be done. He did so, and the bill for such board was audited and allowed by the Finance Committeee.

The party whose board was thus paid consisted of the following members of the force:

One Inspector, at a salary of \$120 per month.

One Rodman, at a salary of \$75 per month.

Five Axemen, at a salary of \$2 per day.

If the Committee had refused to allow this bill for board, the work would have been unreasonably prolonged and delayed, or the men composing the party would have been forced to pay from 25 to 50 per cent. of their salaries for board, in addition to their usual expenditures for the maintenance of their house and the support of their families. The Committee feel that they would tenance of their homes, and the support of their families. The Committee feel that they would have been open to just censure if they had insisted upon casting upon men, receiving such small salaries, so large and extraordinary expense for the benefit of the city.

#### RENT AND EXPENSES OF OFFICES.

The Committee found that it had been the custom of the Commission to provide offices along the line for the use of the Engineer Corps, and this custom has been continued. The Engineers have much work to do besides that which can be performed in the tunnel. This work consists of plotting cross-sections from their field notes, calculating and estimating the amount of work of different kinds that has been done by the contractors and the like. All this requires offices adapted to the purpose, which must be heated and lighted.

When the present Commission entered upon their duties, it appeared that the Engineer Corps had been supplied from time to time with necessary instruments and stationery for carrying on the

work.

In view of the approaching completion of the work, the Committee of Finance and Audit caused an inventory to be made of all instruments, tools and property generally in the possession of the Commission at the various stations along the line; and instructions were given that before purchasing new instruments for one Section, that it should appear that suitable instruments could not be spared from other divisions of the work; and that as to the purchase of new instruments, they should not be purchased on the requisition of the Division Engineer, as in the case of ordinary supplies, except with the approval of the President of the Board.

For the future it is believed that little, if any, will have to be purchased in this direction, so that further comment as to instruments is unnecessary.

One matter, however, was early brought to the attention of the Finance Committee, and that was the purchase of rubber boots for Inspectors and Assistants in the Engineer Corps. A careful inquiry was instituted as to the propriety of such purchases, and it appeared that they were demanded and used from the beginning of the work by the Engineers while engaged in the tunnel, but the furnishing of such rubber goods to Inspectors does not appear to have been formally authorized by the Board. A petition from several Inspectors, however, to be furnished with boots was received by the present Commissioners not long after their appointment, and an inquiry as to its propriety showed that the Inspectors were necessarily compelled to wade through more or less water in all parts of the tunnel, and at the bottom of shafts. Under a ruling of the Corporation Counsel in January, 1888, to the effect that it would be proper for the Commissioners to allow pay to Inspectors during such time as they might be detained from work in consequence of injuries or illnesses incurred while on duty, it seemed to the Commissioners that, while on general principles the same rule should be applied to Inspectors as to Engineers, that there would undoubtedly be a saving to the city in providing them with necessary protection against dangerous exposure, and that it seemed probable that Inspectors would, either from economy or neglect, be likely to omit to pro-

saving to the city in providing them with necessary protection against dangerous exposure, and that it seemed probable that Inspectors would, either from economy or neglect, be likely to omit to provide themselves with such protection, as was in many cases known to be the fact; and if, as so frequently happened, severe colds or rheumatism incapacitated Inspectors from work, the amount of their salary when sick and when they were performing no service would, in the aggregate, amount to very much more than the cost of supplying them with the boots.

For these reasons the Commissioners adopted a resolution authorizing the purchase for use in the tunnel and shafts by Inspectors of such boots; and it is the opinion of the Finance Committee that it is a necessary and proper expenditure under all the circumstances, and under the safeguards here-tofore referred to, and the furnishing of the same should be continued so long as similar exposure shall continue to be demanded of the Inspectors and others in the tunnel. As this work is now approaching completion, it is believed that the aggregate of such purchases will be comparatively small.

#### INCIDENTAL EXPENSES.

The constant necessity for intercommunication between the Chief Engineer and the several Deputies and Assistants along the line requires equally constant disbursement in petty sums for postage, telegrams and frequently expressage. The custom of this Commission as to these expenses corresponds with that of all or most of the City Departments. The amounts are advanced by different members of the force, and then reimbursed by voucher upon the Comptroller.

Sir.—I have received your letter of the 7th instant, by which I am informed that a certificate has been transmitted to the Committee on Construction by the Chief Engineer of the Aqueduct Commissioners that the work to be done by John Brunton & Co., under their contract with said Commissioners, for Section 13 of the New Aqueduct, has been completely performed under and according to the terms of said contract, which certificate is dated the 27th day of February, 1889.

Your letter also calls my attention to the clause M of the contract, which provides that the contractors will complete the work within the time limited for such completion, or such further time as may be allowed by the Aqueduct Commission, and that, in case of failure to complete within the

may be allowed by the Aqueduct Commission, and that, in case of failure to complete within the period named, the contractors shall pay to the Mayor, Aldermen and Commonaity of the City of New York one thousand dollars per day as the damages sustained by reason of such default, and that the City may deduct and retain said sum of one thousand dollars per day out of any moneys that may be due under the agreement.

Your letter also informs me that the period fixed for the completion of the work, as extended by

the Aqueduct Commission, expired November 16, 1888.

Your letter also informs me that it is "probably true that extra work not included in any of the specifications of the contract has been authorized by the Aqueduct Commission and performed."

That the contractors claim and insist that the work required to be done under their contract was

That the contractors claim and insist that the work required to be done under their contract was completed in the month of October, 1888, prior to the expiration of the time.

My attention is also called to the provision of the contract, that whenever, in the opinion of the Engineer, the contractor shall have completely performed his contract, the Engineer shall so certify in writing, stating from actual measurements the whole amount of work and the value thereof, according to the terms of the contract, and that on the expiration of thirty days after the acceptance of the work by the Aqueduct Commissioners, the City shall pay to the contractor the amount due, after deducting therefrom sums theretofore paid, and also after deducting such sums of money as the City may be authorized to reserve or retain.

Your letter then asks:

First—Should the Aqueduct Commissioners determine judicially whether or not the contract was, in point of fact, completed within the time stipulated?

Second—If the Commissioners are of the opinion that the work was not completed within the time required, and that such failure was not excused by any fact or circumstance, should they deduct from the final estimate the amount of the penalty accrued, or should the Aqueduct Commissioners, in such case, certify the final estimate to the Comptroller, and leave it for him to assert, on behalf of the City, the counterclaim or set-off of the penalty for failure to complete within the con-

Third-Should the Aqueduct Commissioners postpone the acceptance of the work until the contractors' claims for extra work shall have been presented and passed upon by the Commissioners or should the Commissioners certify to the Comptroller a final estimate covering all the contract items, and subsequently transmit an additional and separate voucher for the amount, if any, which shall be found to be due to the contractor for extra work.

I beg leave to answer these inquiries as follows:

1. It is well settled by judicial decisions that the addition of extra work to the work comprehended within the contract does involve a release of the covenant in relation to time of per-

The question whether or not the contractor is liable to the penalty of overtime depends upon facts which are within the knowledge of the Aqueduct Commissioners.

The Aqueduct Commissioners know, first, to what time the period of completion has been

extended; second, whether extra work has been added to the work required by the contract; third, the actual time of completion.

It seems to me, therefore, that the Aqueduct Commissioners should themselves determine the facts upon which depends the question whether or not the contractor is liable to penalties on this

The contractor has communicated with me since the reception of your letter, and shown to me certificates in relation to the work, made monthly from 1st November to 1st January, which seems to me admissions that the work in question was completed prior to the 1st of November.

I mfer from the admission contained in your letter that it is probably true that work not included in the specifications of the contract has been authorized by the Aqueduct Commissioners during the progress of the work and that the contractors may easily author their

during the progress of the work, and that the contractors may easily sustain their contention that

the time clause has been thereby legally abrogated.

It seems to me, therefore, that a determination against the contractors in relation to the penalties referred to would, in all probability, be reversed by the Court in any litigation which

If, however, the Commissioners should be of the opinion that the contractors are liable to penalties, they should certify their final estimate to the Comptroller, and also separately certify to him the fact that penalties were due from the contractor, and the amount to be deducted on account

2. The Commissioners should not postpone the acceptance of the work, and the certification of the final estimate for the contract items, until the claims for extra work have been presented and

passed upon by the Commission.

I am of the opinion that it would be proper and lawful for the Commission to certify a final estimate, covering all the contract items, and, subsequently, after examination, transmit an additional and separate voucher for the amount, if any, found to be due to the contractors for extra

Your letter also transmits a form of resolution, and of certificate, the former to be adopted by the Aqueduct Commission, and the latter to be signed by the members of the Commission, formally accepting the section from the contractor.

The form of resolution and certificate suggested seems to me to be that which is required by

the contractor, and to be valid and sufficient.

Your letter calls my attention to the provisions of Clause S of the contract, and informs me that

the Commissioners have contemplated waiting ten days after the adoption of the resolution of acceptance before giving the certificate of acceptance.

Section S of the contract provides that the contractor will furnish to the Aqueduct Commissioners evidence that all persons who have done work or furnished materials under the agreement, and who may have given written notice to the Commissioners before or within ten days after the final completion and acceptance of the work, that any balance for such work or materials is due and unpaid, have been fully paid or satisfactorily secured; and in case such evidence is not furnished as a five-said such acceptance of the persons aforesaid.

and unpaid, have been fully paid or satisfactorily secured; and in case such evidence is not furnished as aforesaid, such amount as may be necessary to meet the claims of the persons aforesaid, may be retained from the moneys due said party of the second part under this agreement until the liabilities aforesaid shall be fully discharged or such notice withdrawn.

I do not perceive any utility or necessity to withhold the certificate of acceptance after the adoption of the resolution of acceptance.

Under Section T of the contract the moneys to be paid thereunder by the City do not become payable to the contractor until the expiration of thirty days after the acceptance, and the City is authorized at the time of payment to deduct all sums which it is entitled to reserve or retain.

It follows, therefore, that if the certificate of acceptance be filed with the Comptroller immediately after the adoption of the resolution of acceptance, that parties remaining unpaid for work or labor furnished upon the work, will have ample opportunity to file claims with the Commissioners before actual payment.

And if such claim shall be filed with the Commissioners within ten days after the acceptance of the work, it will be their duty to give notice thereof to the Finance Department, that the amount of such claim may be retained from the sum due the contractor.

GENTLEMEN—I have previously reported verbally to your Committee that a portion of the Aqueduct between Shafts 13 and 13 A would require the same treatment as the portion recently grouted south of Shaft 17½. The case is somewhat similar, as there are probably some cavities left above the Aqueduct. This part of the excavation was supported by tumber which, owing to the unstable condition of the ground, could not be removed and the masonry built up to the lagging, leaving, unavoidably, outside of the side-walls, vacancies which, in case of a fall overhead, might allow a movement of the sidewalls, and a consequent injury to the arch.

I now recommend that grouting should be resorted to to secure that part of the Aqueduct. The proposed work consists in injecting grout behind the lagging into the vacant spaces to such a height as will procure beyond question the stability of the arch.

This work is not covered by the requirements of the contract. It is an unusual remedy for an unusual condition of things. It would cost less than \$5,000, and could be done in the same manner as the grouting recently done south of Shaft 17½. The proposed grouting would take place at and about Stations 778 and 779.

hospital. It shall be the duty of the physician or physicians, of the officers, managers and of every one in
charge of a hospital or dispensary, and of every one who
has any duty or office in respect to patients in the course
of treatment, or persons who apply for treatment or care
at a dispensary or hospital, to see that a report is immediately made to the Health Department of the City of
New York of every person infected with a contagious
disease who comes to their knowledge, and that such
person or persons so infected are properly isolated and
kept separate from other persons and other patients.

SEC. 18. That no owner or lessee of any building, or any part thereof, shall lease or let, or hire out the same or any portion thereof, to be occupied by any person, or allow the same to be occupied, as a place in which, or for any one, to dwell or lodge, except when said buildings or such parts thereof are sufficiently lighted, ventilated, provided and accommodated, and are in all respects in that condition of cleanliness and wholesomeness, for which this Code or any law of this State provides, or in which they or either of them require any such premises to be kept. Nor shall any such person rent, let, hire out, or allow, having power to prevent the same to be used as or for a place of sleeping or residence, any portion or apartment of any building, which apartment or portion has not at least one foot of its height and space above the level of every part of the sidewalk and curbstone of any adjacent street, nor of which the floor is damp by reason of water from the ground, or which is impregnated or penetrated by any offensive gas, smell, or exhalation prejudical to health. But this section shall not prevent the leasing, renting, or occupancy of cellars or rooms less elevated than aforesaid and as a part of any building rented or let, when they are not let or intended to be occupied or used by any person as a sleeping apartment, or as a principal or sole dwelling apartment.

The apportionment of the regular rents upon dwelling-houses are on the basis that but one family is to occupy the same, and for each additional family, one dollar per year shall be charged.

METERS will be placed on all houses where waste of water is found, and theywill be charged at rates fixed by the Department for all the water passing through them. The extra and miscellaneous rates shall be as follows,

Bakeries.—For the average daily use of flour, for each barrel, three dollars per annum.

BARBER SHOPS shall be charged from five to twenty dollars per annum each in the discretion of the Com-missioner of Public Works; an additional charge of five dollars per annum shall be made for each bathtub therein.

tub therein.

BATHING TUBS in private houses, beyond one, shall be charged at three dollars per annum each, and five dollars per annum each in public houses, boarding-houses, and bathing establishments. Combination stationary wash-tubs, having a movable division in the centre and capable of use for bathing, shall be charged the same as bathing tubs.

BUILDING PURPOSES.—For each one thousand bricks laid, or for stone-work—to be measured as brick—ten cents per thousand. For plastering, forty cents per hundred yards.

DINING SALOONS shall be charged an annual rate of from
five to twenty dollars, in the discretion of the Commissioner of Public Works,

HORSES, PRIVATE.—For two horses there shall be charged
six dollars per annum; and for each additional horse,
two dollars.
HORSES, LIVERY.—For each horse up to and not exceeding thirty in number, one dollar and fifty cents each
per annum; and tor each additional horse, one dollar.
HORSES, OMNIBUS AND CART.—For each horse, one dollar,
per annum.

per annum; and for each additional horse, one dollar horses, Omnbbus and Cart.—For each horse, one dollar per annum.

Horse Troughs.—For each trough, and for each half barrel or tub on sidewalk or street, twenty dollars per annum; each trough is to be fitted with a proper ball-cock to prevent waste.

Hotels and Boarding Houses shall, in addition to the regular rate for private families, be charged for each lodging room, at the discretion of the Commissioner of Public Works.

Laundries shall be charged from eight to twenty dollars per annum, in the discretion of the Commissioner of Public Works.

Liquor and Lager Beer Saloons shall be charged an annual rate of ten dollars each. An additional charge of five dollars per annum shall be made for each tap or wash-box.

Photograph Galleries shall be charged an annual rate of from five to twenty dollars, in the discretion of the Commissioner of Public Works.

Printing Offices, when not metered, shall be charged at such rates as may be determined by the Commissioner of Public Works.

Soda, Mineral, Water and Root Beer Fountains shall be charged five dollars per annum each.

Steam Engines, where not metered, shall be charged by the horse-power, as follows: For each horse-power up to and not exceeding ten, the sum of ten dollars per annum; for each exceeding ten, and not over fifteen, the sum of seven dollars and fifty cents each and for each horse-power over fifteen, the sum of five dollars.

Water-Closets and Urinals.—To each building on a

niteen, the sum of seven dollars and fifty cents of five dollars.

WATER-CLOSETS AND URINALS,—To each building on a lot one water-closet having sewer connection is allowed without charge; each additional water-closet or urinal will be charged as hereinafter stated. All closets connected in any manner with sewer shall be charged two dollars for each seat per annum, whether in a building or on any other portion of the premises. Urinals shall be charged two dollars per annum each. Urinals shall be charged two dollars per annum each. WATER-CLOSET RATES.—For hoppers of any form, when water is supplied direct from the Croton supply, through any form of the so-called single or double valves, hopper-cocks, stop-cocks, self-closing cocks, or any valve or cock of any description attached to the closet, each, per year, twenty dollars.

For any pan closet, or any of the forms of valve, plunger, or other water-closet not before mentioned, supplied with water as above described, per year, ten dollars.

For any form of hopper or water-closet, supplied from the ordinary style of cistern filled with ball-cock, and overflow pipe that communicates with the pipe to the water-closet, so that overflow will run into the hopper or water-closet, when ball-cock is defective, or from which an unlimited amount of water can be drawn by holding up the handle, per year, each, five dollars.

For any form of hopper or water-closet, supplied from any of the forms of waste-preventing cisterns, that are approved by the Engineer of the Croton Aqueduct, which are so constructed that not more than three gallons of water can be drawn at each lift of the handle, or depression of the seat, if such cisterns are provided with an overflow pipe, such overflow pipe must not connect with the water-closet, but be carried like a safe-waste, as provided by the Board of Health regulations, per year, two dollars.

Cistern answering this description can be seen at this Department.

METERS.

Under the provisions of section 352, Consolidated Act 1882, water-meters, of approved pattern, shall be hereafter placed on the pipes supplying all stores, workshops, hotels, manufactories, public edifices, at wharves, ferry-houses, stables, and in all places where water is furnished for business consumption, except private dwellings.

It is provided by section 352, Laws of 1882, that "all expenses of meters, their connections and setting, water rates, and other lawful charges for the supply of Croton water, shall be a lien upon the premises where such water is supplied, as now provided by law." \*

All manufacturing and other business requiring a large supply of water will be fitted with a meter.

The rate charged for steam-vessels taking water daily or belonging to daily lines, is one-half cent, per ton (Custom House measurement) for each time they take water. Steamers taking water other than daily, one cent per ton (Custom House measurement).

Water supplied to sailing vessels and put on board, twenty-five cents per hundred gallons.

All matters not hereinbefore embraced are reserved for special contract by and with the Commissioner of Public Works

HYDRANTS, HOSE, TROUGHS, FOUNTAINS, ETC., ETC.

No owner or tenant will be allowed to supply water to another person or persons.

All persons taking water from the City must keep their own service-pipes, street tap, and all fixtures connected therewith, in good repair, protected from frost, at their own risk and expense, and shall prevent all waste

of water.

The use of hose to wash coaches, omnibuses, wagons, railway cars or other vehicles or horses, cannot be per-

railway cars or other vehicles or horses, cannot ne permitted.

No horse-troughs or norse-watering fixtures will be permitted in the street or on the sidewalk, except upon a ticense or permit taken out for that purpose. All licenses or permits must be annually renewed on the first of May. Such fixtures must be kept in good order and the water not allowed to drip or waste by overrunning the sidewalk or street, or to become dangerous in winter by freezing in and about such troughs or fixtures.

No hydrant will be permitted on the sidewalk or in the front area, and any hydrant standing in a yard or alley, attached to any dwelling or building, must not be left running when not in actual use, and if the drip or waste from such hydrant freezes and becomes dangerous in winter, the supply will be shut off in addition to the penalty of five dollars imposed.

Taps at wash-basins, water-closets, baths and urunals for each offense, which will be strictly enforced.

Fountains or jets in hotels, porter-houses, eating-saloons, confectioreries or other buildings are strictly prohibited.

The use of bose for washing sidewalks, stoons areas.

saloons, confectoreries or other buildings are strictly prohibited.

The use of hose for washing sidewalks, stoops, areas, house-fronts, yards, court-yards, gardens, and about stables, is prohibited. Where premises are provided with wells, special permits will be issued for the use of hose, in order that the police or inspectors of this department may understand that the permission is not for the use of Croton water. use of Croton water.

Opening fire-hydrants to fill hand sprinklers or other vessels will not be allowed.

The penalty for a violation of any of the preceding rules and regulations will be five dollars for each offense, and if not paid when imposed will become a lien on the premises in like manner as all other charges for unpaid water rates.

PUBLIC NOTICE AS TO WATER RATES.

PUBLIC NOTICE IS HEREBY GIVEN 1HA1 in compliance with the provisions of chapter 559, Laws of 1887, amending sections 350 and 921 of the New York City Consolidation Act of 1882, passed June 9, 1887 the following changes are made in charging and collections water rests:

1st. All extracharges for water incurred from and after June 9, 1887, shall be treated, collected and returned in arrears in the same manner as regular rents have hereto-tore been treated.

arrears in the same manner as regular rents have heretolore been treated.

2d. In every building where a water meter or meters
are now, or shall hereafter be in use, the charge for water
by meter measurement shall be the only charge against
such building, or such part thereof as is supplied through

such building, or such part thereof as is supplied through meter.

3d. The returns of arrears of water rents, including the year 1887, shall be made as heretofore on the confirmation of the tax levy by the Board of Aldermen, and shall include all charges and penalties of every nature.

4th. A penalty of five dollars (\$5) is hereby established, and will be unposed in each and every case where the rules and regulations of the Department prohibiting the use of water through hose, or in any other wasteful manner, are violated, and such penalties will be entered on the books of the Burcau against the respective buildings or property, and, if not collected, be returned in arrears in like manner as other charges for water.

5th. Charges for so-called extra water rents of every nature, imposed or incurred prior to June 9, 1881, will be canceled of record on the books of the Department.

NOTICE TO CROTON WATER CONSUMERS.

NUMEROUS APPLICATIONS HAVE BEEN made to this Department by citizens claiming reductions or rebates on bills for water supplied through meters, on the alleged ground of leakage caused by defective plumbing and worn-out service pipes, or by willful waste of water by tenants allowing the faucets to be turned on in full force in water-closets, sinks, etc., without the knowledge or consent of the owners of the premises.

out the knowledge or consent of the owners of the premises.

The main object of the use of water-meters is to enable this Department to detect and check the useless and unwarrantable waste of an element so valuable and essential to the health and comfort of all the citizens, and this object can only be accomplished by enforcing payment for the water wasted.

Under the law all charges for water supplied through meters are a lien against the respective premises, and the law therefore holds the owner of the premises responsible for the amount of water used or wasted.

Notice is therefore liven to all householders that, in all turther applications for reduction of water rents, no allowance will be made on account of waste of water occurring through leaks, from defective service pipes or plumbing, or wasteful use of water by tenants or occupants of buildings, though such leakage or waste may have occurred without the knowledge or consent of the owners of the buildings.

House-owners are further notified that whenever their premises become vacant, and are likely to remain vacant, they must notify this Department in writing, and that unless this requirement is complied with no deductions in extra water rents will he allowed for any portion of one year.

THE OWNERS OF LANDS IN THE CITY OF New York, which were formerly under water, and which were granted by the City or New York, are notified that nearly all of the grants of such lands contain covenants, on the part of the grantees, and their successors and assigns, to maintain and keep in repair the adjacent streets. The condition of many of these streets is such as to make it necessary that they should be repaired and repaved, and that the obligation resting upon the present owners of adjacent lots to do this work should now be enforced. Many of such owners have requested that such covenants be commuted, and wholly released, upon the payment by them of a certain sum per lot.

The matter will shortly be presented to the Commis sioners of the Sinking Fund for their consideration, and the adjustment of the basis of commutation, and application for releases should therefore be made at once.
