Re: Agency-based Voter Registration Under LL29 of 2000, Mayoral Directive One of 2014, LL61 of 2014 and LL63 of 2014

July 1 through December 31, 2022 Report

Local Law 29 of 2000 requires that specified agencies offer voter registration in their encounters with the public. Mayoral Directive One of 2014 strengthened the requirements of LL29, putting a structure in place to monitor agency efforts to increase voter registration. Local Laws 61 and 63 of 2014 increased the number of agencies required to offer voter registration.

The Board of Elections reported that it processed 433 voter registration applications originating at City agencies (called Code 9 applications) between July 1 and December 31, 2022. This does not include applications from DSS/HRA, where voter registration applications are offered, collected, and sent to the Board of Elections under the requirements of the National Voter Registration Act (NVRA) and are not denoted as Code 9. DSS/HRA reported sending 1,707 applications to the Board of Elections during the reporting period, yielding a combined total of 2,380 City agency submissions to the Board of Elections. The total for the comparable period in 2022 was 6,839.

Some highlights of agency activities during the reporting period include:

1. DCAS, DOF, and SBS reported difficulties with measuring traffic access to NYC Votes website:
 - a. The Office of Technology and Information (OTI) ceased their usage of WebTrends in January 2023, which previously measured website clicks to NYC Votes, due to faulty measurement. No data could be provided to DCAS and DOF due to access to the tool being terminated and subsequent loss of access to the analytics system.
 - b. SBS was unable to find a tool to measure website clicks to NYC Votes.
2. HPD, CCHR, and DOT was unable to verify or record the amount of voter registration forms distributed or sent to BOE, due to the mode of distribution.
3. To promote and increase voter engagement, outreach efforts by agencies included: sending voter registration forms and information by mail and email, ACS collaborated with NYC Votes and the NYC Campaign Finance Board, and DOC partnered with The Legal Aid Society.
4. COVID-19 continues to affect City agencies: DCP reported not meeting with the public face-to-face, instead conducting virtual events and distributing applications by mail. DORIS and DFTA began to

resume in-person services, the former by appointment only. DEP and DOHMH reported seeing a decrease in staffing with multiple vacancies. HRA reported lowered voter registration due to site closures, reduced foot traffic, and some programs only contacting clients by teleconference.

5. The low number of voter registration forms sent to BOE by DFTA, FDNY, and some HRA programs was attributed to a large quantity of customers served saying that they have already been registered to vote.
6. BIC, DCP, DCAS, HPD, and DORIS did not distribute any applications.

Describe how your agency distributes applications.

ACS distributes voter registration forms throughout ACS borough offices and youth- concentrated programs which includes the **Nicholas Scopetta Children’s Center** (NSCC), which serves as youth’s first point of contact with the agency before they are placed with a foster family, **Family Permancy Services** (FPS) which ensures high quality services are provided to children in foster care: **Housing Acadmey Collaborative** (HAC) which supports youth in foster care in obtaining housing, and our **Youth Reception Centers** (YRC), a residential safe place for youth in foster care and service provider that includes independent living skills, education, employment, and financial literacy.

Describe any special registration activities, if any.

ACS Summer Internship Program: ACS liased with NYC Votes and the NYC Campaign Finance Board (NYCCFB) and hosted weekly virtual interactive voter registration meetings for ACS summer interns with a focus on the youth demographic and how patterns in socio economics affects voter turnout in communities with higher incomes versus those living in low-income communities. The interns were also educated on the voting process from registering to vote to conducting their own voter registration drives and outreach efforts. Seventy-Five of the 200 summer interns that ACS employed, participated in the workshop. Over the course of the program, these 75 interns learned how to:

- Support and obtain resources for their communities.
- Organize community events (beautification projects, voter registration drives, job fairs).
- Use social media platforms to share information.

ACS will continue to work with NYC Votes and NYCCFB and expand on voter knowledge and voter registration activities with the implementation and continuation of the following ACS programs:

- **Youth Aging Out of Care**
- **ACS Interns**
- **12 Metro Tech Teen Center**

LatinX Fatherhood & Father Figure Family Fun Day-

- ACS Co-sponsored a youth and community event in the summer of 2022. Over 40 registration forms were distributed to residents/visitors. As an incentive to incite residents to register to vote, registrants received a registration kit that included a poster, sticker and pen.

ACS Website and Social Media Page: ACS Intranet “Insider” Newsletter portal posted and delivered content accessible to over 6,000 staffers. The landing page served as a hub to provide resources promoting voter registration deadlines, voter education, and election information. Voter registration content was shared via the following methods:

- **ACS Commissioner Public Service Announcement (PSA):** The PSA, featuring ACS commissioner, was shared via ACS social media platform (YouTube, ACS Intranet page, Twitter, Facebook) encouraging ACS Staff, partners, and stakeholders to register to vote, while providing guidance on how to vote safely. The PSA reached over 1,000 subscribers.
- **ACS E- Bulletin:** Early voting and election day reminders were sent out weekly, reaching over 6,000 employees.

Describe challenges, both resolved and unresolved.

Challenges:

- **Lack of language access:** Multi-language forms are not readily available. Citizens with language barriers are more disenfranchised.
- **Polling Place Closures:** Residents complained of not receiving notification of polling site closures, which largely affects communities of color. Some residents shared that some of the new locations are too far to get their by walking.
- Potential voters expressed candidates do not represent their views or real-time experiences of community residents.

Potential resolutions:

- By understanding the demographics of a community, local leaders should require community based organizations/ civic engagement programs to order voter registration forms based on the most commonly spoken language.

- Increase advertisements within the community on Polling place closures, specifically in community based business spaces- libraries, churches, supermarkets, laundry mats, schools, etc. Organize local transportation services for seniors and the disabled.
- Increase the visibility of candidates at community events, town halls, and community board meetings.

Describe how your agency distributes applications.

The Department for the Aging (NYC Aging) requires each funded program, project and site (including contractor satellite offices) to offer voter registration materials to participants and any members of the public who inquire about NYC Aging or City services. As of 2021, this requirement has been incorporated into provider staff trainings offered by the agency. In addition, all public-facing NYC Aging units inform applicants for services about the opportunity to register to vote.

Throughout the COVID-19 public health emergency and when in-person services were suspended, NYC Aging prominently displayed voter information on social media channels, our monthly agency newsletter, and monthly Commissioner Column, which is printed in local community and ethnic media newspapers. Now that in-person services have resumed across the agency's network of services, NYC Aging continues to display voter information on our social media channels during election season. In addition, the voting.nyc tile (which links to the NYC Board of Elections website) is permanently displayed on NYC Aging's homepage under *City Programs*.

To ensure the Commission's staff can best address the needs of the public in a way that continues to comply with health and safety guidance, the Commission, where possible, schedules appointments to ensure utmost preparedness for those meetings and encounters.

The Law Enforcement Bureau and the Community Relations Bureau, consistent with Citywide policy, have primarily resumed their public facing engagement work in person. This includes intake appointments and walk-in interviews, trainings, workshops, conferences and presentations. Voter registration forms are distributed during these in-person exchanges and events, and remain available to the public at all five (5) Commission offices. The Commission's persistence and expansion in engagement and outreach, has contributed to the increase in the number of individuals served, and considerable distribution of hard copy voter registration forms. It is important to note, that given the continuance of the COVID-19 pandemic, the Commission, when necessary, still conducts some of its public facing engagement work remotely.

While working remotely, the Commission has continued to develop digital distribution of these forms. For example, links to voting information are made available to the public on the Commission's website. In addition, links to voter registration information is also contained in a growing number of Commission communications to the public. Specifically, members of the public are informed of, and provided voter registration resources during virtual intakes, trainings, meetings, workshops, campaigns, and presentations.

Describe challenges, both resolved and unresolved.

Challenges noted in prior reports remain. The Commission continues to serve and reach thousands of individuals during the COVID-19 pandemic, both virtually and in-person. The Commission is not able to track how many people who receive links to voter registration materials use them, analogous to the same challenges noted in prior reports to the distribution of hard copy voter registration forms which the public may use, but which are not submitted to the agency. Therefore, with specific regard to the latter, it is difficult to track the number of distributed voter registration forms that are ultimately submitted.

There are a number of factors that may determine the number of people served. They include the number of individuals in attendance at Commission workshops, presentations, and conferences, the number of intakes and walk-in meetings conducted by the Law Enforcement Bureau, and the number of those who use online resources to access the electronic voter registration form. It may also be determined by the event's location and proximity, virtual setting, technological platform, and type of event taking place, as well as the extent to which technology is accessible to the public. Although there has been a significant increase in the use of technology by the public, access to technology and electronic means of communication is still not completely widespread for a variety of reasons.

Another reality influencing the number of electronic voter registration forms that are submitted to the Board of Elections is the receiving population's eligibility to vote. Commission events are regularly frequented by individuals who may not be eligible to vote, which may depress the number of voter registration forms that are accessed, filled out, and ultimately submitted online.

Continuing to emphasize the importance of political engagement to the public across all channels may contribute to an increased number of distributions and submissions.

The Department ensures that voter registration forms and absentee ballot applications are readily available in each facility's law library and similarly upon discharge. Persons in custody have the opportunity to complete these applications and send them directly to their local Board of Elections (BOE) office or have DOC's Senior Program Liaison (SPL) hand deliver them to the applicable BOE office. Correctional Health Services (CHS), in partnership with the Department, and during routine medical visits, provides assistance in completing forms and coordinate with the SPL for their collection and distribution to BOE. All individuals in custody have recently been assigned a tablet again under the new tablet program, and the Department is in the process of uploading voter education information, candidate information, and registration forms and absentee ballots to them.

Describe special registration activities, if any.

As part of the Department's voter registration initiative, we have been partnering with The Legal Aid Society ("Legal Aid"). Legal Aid provides volunteers on a monthly basis that meet with persons in custody and assist with the voter registration process. These monthly civic engagement events provide the incarcerated population a recurring means of connecting and engaging with the community and participating in the electoral process. Legal Aid is also part of the voting rights coalition on Rikers Island which remains active and engaged on a monthly basis.

The Department has worked diligently to provide as much information as possible and on a regular basis to the population. In partnership with NYC Votes, another coalition partner, the Department distributed literature that outlined key election dates, races, and need-to-know voting information. The Department also provided this messaging as part of a weekly flyer that goes out to the incarcerated population.

Describe challenges, both resolved and unresolved.

As per the past several reporting periods, conducting voter engagement activities, especially those done in-person, remained a challenge due to the ongoing global pandemic. And yet, in light of this continuing difficult situation, the Department is pleased to report continued progress. The Department has maintained relations with the multitude of stakeholders that make up the aforementioned voting rights coalition and has once again rolled out tablets to the incarcerated population which will help ease the flow of voting information.

The voting process on Rikers Island does remain complicated in the absence of a direct polling site. The Department collects and delivers registration forms and absentee ballot applications directly to BOE if individuals in custody choose to take advantage of that option. If individuals choose not to have DOC staff collect and hand-deliver their forms to the appropriate BOE office, they have the opportunity to mail their forms with free weekly stamps or pre-stamped envelopes provided by the Department. The Department also operates a social services request system which can be utilized to provide voter documents in various languages and also to provide voter assistance when requested.

DOT remains committed to registering voters. At the end of March 2020, due to Covid-19, DOT’s public service centers (PSCs) closed. DOT will resume distribution of the voter registration (VR) packets at the PSCs as soon as they fully reopen. DOT resumed mailing VR hard copies with all document requests after October 31st, 2021. Now that we are back in the office. This period saw an increase of 284 VR packets sent over 11/-6/30/22:

- 1) The Customer Service, Language Access, and Correspondence Unit (CSLACU) includes hard copy VR packets with every literature request sent to customers.
- 2) DOT customers calling 311 are sent VR packets.
- 3) The DOT website has a “Register to Vote” icon/tile on its landing page. The hyperlink sends DOT customers directly to “NYC Votes”.

Describe any special registration activities, if any.

DOT will resume distributing VR materials at expanded outreach events once it is safe to do so.

Describe challenges, both resolved and unresolved.

It is impossible for DOT to know which customers receiving the VR packets with their correspondence and/or documents, or visiting DOT’s PSCs (when they reopen) are already registered to vote. DOT can readily disseminate the voter registration materials, but cannot compel customers to complete the forms and return them to the Board of Elections, or submit them to the PSC managers (when the PSCs reopen). If completed forms are not collected on-the-spot and sent to the BOE by the PSC managers, it is not possible to monitor and track the level of customer participation and the number of forms being returned to the Board of Elections. We have spoken with the Board of Elections and the Campaign Finance Board (CFB) and, currently, there is no method in place that could determine which voter registrations, if any, have been returned as a result of DOT’s efforts. Since MOO seems so focused on measuring the efficacy of City Agencies registering voters, it is important for the Board of Elections (BOE) to give each designated agency a distinct VR code printed on all of each Agency’s VR materials, English and non-English. In this way, the BOE can count how many forms are submitted from each agency.

The BOE could set up electronic sorting to scan the agency codes, since they cite being understaffed. The TLC currently maintains a staff of approximately 600 employees, many of whom interface daily with licensees. Voter registration forms are distributed in four separate ways to various TLC divisions and departments:

- **Human Resources** (located in Lower Manhattan) includes registration forms in hiring packets for new employees.
- **Policy/External Affairs** (located in Lower Manhattan) distributes voter registration forms at outreach events and presentations to licensees and industry stakeholders across all 5 boroughs.
- **Licensing Division** (located in Long Island City, Queens) has forms available for visitors to take at its licensing transaction counters. Licensing maintains about 300 applications available for distribution at all times. Also, information on how to contact the Board of Elections is included on many TLC-issued forms for licensees.
- **Safety + Emissions Division** (located in Woodside, Queens, and Staten Island) has forms available for distribution at its counter operations that licensees must visit on a regular basis (ranging from three times a year to once every two years) for inspection of their vehicle.

By using these targeted strategies, TLC helps licensees and incoming employees receive voter registration information.

Describe any special registration activities, if any.

TLC plans and attends public events where voter registration forms are available to the public.

Additionally, TLC shared voter registration and upcoming election information with licensees during the reporting period. Licensees were informed of various voting methods including Early Voting, Absentee Ballot Voting, and voting on Election Day prior to the November 8, 2022, General Election.

TLC emails are sent to a list of over 250,000 licensees.
