

BOARD OF COMMISSIONERS CONSTITUTED BY CHAPTER 299, LAWS OF 1890, TO SELECT AND LOCATE A SITE FOR A NEW MUNICIPAL BUILDING, AND TO CONSTRUCT THE SAME NEAR, BUT NOT IN THE CITY HALL PARK.

At the call of the Mayor, the Board met at his office, at I o'clock P. M., on Friday, October 17, 1890.

Present-Hugh J. Grant, Mayor ; Frederick Smyth, Recorder ; Theodore W. Myers, Comptroller ; Thomas C. T. Crain, Chamberlain ; and Walton Storm, Chairman Committee on Finance, Board of Aldermen-Commissioners of the Sinking Fund ; and P. J. Scully, Acting County Clerk, and Frank T. Fitzgerald, Register.

Absent-Rastus S. Ransom, Surrogate.

The minutes of the meeting held July 2, 1890, were read and approved.

The Mayor offered the following preambles and resolutions on the death of Edward F. Reilly, late County Clerk, and member of the Commission, and on his motion, seconded by the Chamberlain and the Comptroller, they were unanimously adopted :

Whereas, It has pleased Divine Providence to remove from his earthly sphere of usefulness Edward F. Reilly, late County Clerk, and member of this Commission ; and,

Whereas, In every official position occupied by him, he had not only inspired the warm regard of his associates, but demonstrated his thorough devotion and unswerving loyalty to the interests of the City which had honored him by its confidence ; therefore,

Resolved, That in his death the City loses a devoted son, the people a fearless champion, and his associates in office a genial companion and friend ; and,

Resolved, That a copy of these resolutions be transmitted to his widow, with the heartfelt assurance of the sympathy of this Commission in this her hour of grief.

On motion of the Comptroller, it was ordered that the preambles and resolutions be suitably engrossed and certified by the Chairman and Secretary of the Board and sent to the family of the deceased.

The Comptroller presented a report of the Committee appointed to examine locations for a suitable site for a Municipal Building in the neighborhood of the County Court-house Building, but not in the City Hall Park, as provided by chapter 299 of the Laws of 1890, together with a list of the City Departments and Public Offices which it is proposed shall occupy the building, and diagrams of three available locations as sites for its erection thereon.

NEW YORK, October 2, 1890.

To the Board of Commissioners constituted by chapter 299, Laws of 1890, to Select and Locale a Site for a new Municipal Building, and to Construct the same near, but not in the City Hall Park :

GENFLEMEN-Your Committee, appointed on July 2, 1890, to examine locations in the vicinity of the City Hall Park for a suitable site for the erection thereon of a new Municipal Building, pursuant to the provisions of chapter 299 of the Laws of 1890, would respectfully report as follows :

The Commissioners are well aware of the urgent necessity for the speedy erection of the proposed building. Motives of convenience, economy and safety all demand that the provisions of the act referred to be carried out with the least delay necessary to decide wisely upon the most suitable site. With so many departments and offices of the city and county widely scattered, to the great inconvenience of all having business therein ; with an annual expense in the form of rentals which, as is shown by the table appended, represents the interest upon almost \$4,500,000, and with so many priceless documents and records exposed to destruction by fire, it becomes a matter of vital concern to the City's welfare, and to the interests of the entire community, that there should be no unnecessary procrastination.

In the discharge of the duty imposed upon your Committee, every site which has appeared to answer the requirements of the law has received thorough examination, and the special as well as the comparative merits and disadvantages of each have been carefully weighed.

Several sites suggested are considered available, and in the main almost equally desirable, as far as accessibility and extent are involved. But it has naturally been the wish of your Committee to avoid, as far as possible, the dislodgment of important settled commercial interests, and to discover the site where desired results can be secured with the least outlay.

In submitting, therefore, the three following sites which seem to your Committee the most desirable, they are not presented as the only locations available, but since a selection will rest entirely with the Commission, they are proposed in order that full discussion, leading more quickly to definite action, may follow :

Site No. 1, as submitted by your Committee, comprises the block bounded by Broadway and Chambers, Church and Warren streets. Included in this block are some 77,000 square feet, equal to about 30 and 8. 10ths city lots. But from this area must be deducted 15,775 square feet, required for additional width of sidewalk, and 9,625 square feet imperatively needed for a court-yard, to provide requisite light and ventilation, leaving some 51,600 square feet available for building purposes. Of this area, walls, corridors, stairways, etc., would pre-empt about 12,500 square feet, and 39, 100 square feet can be assumed to be left for room area.

The advantages of this location for the proposed building are obvious. Occupying an entire block, both safety and the construction of a magnificent edifice, architecturally speaking, are assured, and its proximity to City Hall Park, as well as its Broadway frontage, make it most accessible to the public, who will transact business therein.

Its absence of frontage width, however, is noticeable, and, above all, the enormous outlay necessary to obtain the area in question, occupied already by many costly edifices, would appear an almost insuperable objection to its acquisition. The assessed valuation of the property in question is \$2,323,990, and estimating these figures as representing 60 per cent. of the actual value, no less a sum than \$3,873,316 would be required for its purchase.

Site No. 2 comprises the area of ground east of the Emigrant Savings Bank building on Chambers street, and is bounded by that building and Chambers, Centre and Reade streets. To insure safety, and to provide for a partial continuation of Elm street traffic, it would seem desirable that in the event of the selection of this site, a portion of the territory immediately adjacent to the Emigrant Savings Bank building should be made a new street, to afford direct communication from Chambers to Reade street, and to supply to Elm street (at present ending with Reade street) an outlet in Chambers screet, although one only to be reached by an awkward detour.

The requirements of this proposed new street would reduce the available area of this site to an extent which would leave only some 48.999 square feet for building purposes. Courtyard, walls, corridors, stairways, etc., would call for a further diminution of 21,500 square feet, leaving only 27,499 square feet of available room area.

The taxable valuation of the property in question is \$1,232,000, and (observing the previous ratio) about \$2,053,333 would represent the expense of its purchase.

This site, like No. 1, has the manifest advantage of contiguity to the other public buildings in the City Hall Park. But, with ample frontage upon Chambers street assured, its limited depth is a decided ground for objection, and the proposed new street must be considered an inadequate substitute for the extension of Elm street, so urgently advocated. Still, as in the case of site No. 1, it is submitted for the Commission's consideration.

Site No. 3, a diagram of which (as well as diagrams of the other sites) furnished, with explanations, by Engineer McLean of the Finance Department, is herewith submitted, is on the northerly side of Chambers street, between Centre street and Park Row, extending northerly to a proposed new Duane street, the present street being included within the limits of the site. Upon this territory can be erected a building having about 223 feet frontage on Chambers street, 111 feet on Park Row, 344 feet on the new Duane street, and 273 feet on Centre street. As shown by the diagram of the ground plan, the building is assumed to be set back about fifteen feet from the present and new street lines on all its sides, in order to provide ample sidewalk accommodation of some thirty feet in width ; while an interior court, containing about 9,700 square feet, insures adequate light and thorough ventilation.

To provide adequate facilities for the increased traffic which will naturally seek the new Duane street, between Centre street and Park Row, owing to the proposed closing of portions of Reade street and City Hall Place, it is contemplated to extend the new Duane street, in an almost direct line from Centre to Chambers street. As will be seen by reference to the diagrams, this will entail the acquiring and throwing into the street area of about 1,830 square feet of the southerly portion of the block bounded by Park Row, Chambers, William and Pearl streets, in this wise avoiding a most awkward cul-de-sac at the juncture of Duane street and Park Row, and also a similar acquisition and devotion to street uses of some 330 square feet of the southerly apex of the triangular block bounded by Centre, Park and Pearl streets.

The assessed valuation of the property required for the site under consideration is \$587,700; no valuation of the church property on Duane street (estimated at \$162,000,) having been made by the Assessors. The estimated price for which this property, including that occupied by the church, can be acquired, each lot having been separately and carefully examined and appraised, is, \$1,331,900.

It will be seen by a comparison of the figures already given that the relative expense of acquiring by purchase the territory comprehended in Site No. 3 is considerably less than that of either of the other two sites, the three several estimated valuations being as follows : \$2.873.316 00 F

It should also be remembered as an advantage which Site No. 3 possesses, exclusively, that, apart from the very considerable saving in purchase money, which can be counted upon to be made, the erection of the contemplated imposing edifice in the locality in question will, beyond a doubt, at once greatly increase the taxable valuation of an extensive neighborhood ; for it will desirably open up a district at present neglected and uninviting, and must materially benefit adjacent property to an extent in which the City will proportionately share. In short, aside from the necessary provision of safe and commodious quarters for the transaction of municipal affairs, a most valuable public improvement seems certain to result, the manifold advantages of which are self-evident.

Without, therefore, the expression of a preference, but leaving the comparative merits of the three sites to be passed upon by the Commission, your Committee reports the same for such action as may seem desirable. Respectfully submitted,


