DEPARTMENT OF DOCKS.

At a meeting of the Board of Docks of the City of New York, held at the office of the Board, Pier "A," Battery place, Friday, November 25, 1892, at 11 o'clock A. M.

Present—President Cram.

Commissioner Post.

Absent—Commissioner Phelan.

The minutes of the meeting held the 17th instant were read and approved.

George Liddle, having been duly notified November 10, 1892, to appear before the Board, November 25, 1892, at 11 A. M., for trial on the charge preferred by Andrew McC. Parker, Assistant Engineer, of inefficiency and incompetency in the performance of his duties and for being disrespectful to his superior officer, was present; Andrew McC. Parker, Assistant Engineer, and John J. Boyle, Carpenter, were duly sworn and examined in support of said charges, and George Liddle, Dock Builder, and Thomas Roberts, Charles Eagle and George Sparks, Ship Carpenters, were duly sworn and heard on behalf of said Liddle and the Board having decided that the charges were fully sustained.

On motion, the following resolution was adopted:

Resolved, That George Liddle, Dock Builder, be and is hereby discharged from the service of this Department.

The report on Secretary's Order No. 12214, recommending the approval of the plans and specifications (as amended) submitted by the Old Colony Steamboat Company for the extension of Pier, old 28, North river, was taken from the table, placed on file and the recommendation adopted.

The report on Secretary's Order No. 11976, submitting copies of maps showing the change of lines proposed for Pier, new 19, North river, together with a technical description of said property, was taken from the table, placed on file and the following resolution adopted:

Resolved, That this Board deems it advisable to change the location and width of Pier, new 19, North river, at the foot of Warren street, from the location therefor, as laid down on the plans determined by this Board, December 3, 1877, and adopted and certified to by the Commissioners of the Sinking Fund, February 7, 1878, the site of the new pier to be bounded and described as follows:

The easterly prolongation of the inshore portion of the northerly line of said Pier, new 19, to intersect the easterly line of West street, at a point distant 8.92 feet northerly from the northerly side of Warren street; and said northerly line of Pier, new 19, to make an angle of 90 degrees 50 minutes 10 seconds, with the bulkhead-line established in 1871 on the northerly side. The point of beginning to be at the intersection of the said northerly line of Pier, new 19, with the said bulkhead-line; thence running westerly in a line making an angle of 90 degrees 50 minutes 10 seconds with the said bulkhead-line on the northerly side, 205.35 feet; thence deflecting to the south through an angle of 3 degrees 34 minutes 33 seconds, and running westerly 240.47 feet; thence deflecting to the north through an angle of 3 degrees 34 minutes 33 seconds and running still westerly and parallel to the first-mentioned course, 253.83 feet to the pier-head line determined by the Department of Docks, July 3, 1890, and approved by the Commissioners of the Sinking Fund, July 24, 1890; thence southerly and along said pier-head line 45.02 feet; thence easterly and parallel to the first-mentioned course 699.67 feet to the aforesaid bulkhead-line; thence northerly and along said bulkhead-line 60 feet to the point or place of beginning.

The width of the outshore portion of said Pier, new 19, to be 45 feet for a distance of 253.83 feet easterly from the pier-head line, and the width of the innermost 205.35 feet of said pier to be 60 feet; all of which is shown on the plan submitted herewith in duplicate by the Engineer-in-Chief.

Resolved, That the Commissioners of the Sinking Fund be and hereby are requested to consent to and approve the change in the length, width and location of new pier at the foot of Warren street, North river, to be known as Pier, new 19, as above set forth.

The following communications were received, read and, On motion, ordered to be placed on file, viz.:

From the Counsel to the Corporation:

1st. Transmitting duplicate copies of a proposed agreement with John H. Starin for the contemplated improvement near the foot of Cortlandt street, North river, with his approval as to form indorsed thereon.

2d. Approving form of Contract No. 431 for repairing Pier, new 59, North river.

From the Finance Department—Returning the proposals of Theodore F. Booth and Robert P. Staats for furnishing sawed yellow pine timber under Contract No. 428; for repairing pier and approach at the foot of West Thirty-seventh street under Contract No. 426 and for preparing for and building a new wooden pier with appurtenances at the foot of East Ninety-fourth street, East river, under Contract No. 430 with the approval of the sureties.

From the Department of Public Charities and Correction, together with a report on Secretary's Order No. 12415—As to the repairs required to Penitentiary Dock, Blackwell's Island. The Engineer-in-Chief directed to repair, and extend the said dock northerly a distance of about thirty feet.

From the Board of Estimate and Apportionment—Requesting the Department to prepare plans and estimates for building around Riker's Island in sections, an inclosure of either rip-rap or crib-work in accordance with the recommendation of the Committee appointed to consider the subject of the final disposition of material collected by the Department of Street Cleaning. The Secretary directed to reply.

From Julius A. Candee, John M. Canda and George Moore Smith—Authorizing the Department to enter upon the premises owned by them between Twenty-fifth and Twenty-sixth streets, easterly of Avenue A, for the purpose of dredging and constructing a bulkhead wall thereat, as provided by resolution adopted October 27, 1892.

From Borden & Lovell, transmitting copy of a resolution adopted by the Directors of the Old Colony Steamboat Company—Accepting the terms of the resolution adopted by the Board November 3, 1892, agreeing to lease Pier, new 19, North river.

From the East Bay Land and Improvement Company—Stating that the filling in which has been done in the vicinity of Leggett's creek, is not on land under water belonging to the City and was not done pursuant to the permit dated May 7, 1891.

From Louis A. Jackson—Demanding payment of salary, as Assistant Secretary, from February 1, 1876, to November 1, 1892, with interest. Send the Counsel to the Corporation a history of the case.

From John Bunke—Requesting a lease of the bulkhead foot of East Twenty-ninth street. Application denied, as said bulkhead must be sold at public auction.

From Barth. S. Cronin—Requesting an extension of time for the completion of the work of building a bulkhead between West Tenth and Charles streets, North river, under Contract No. 416. Time extended to November 4, 1892.

From Dock Master Kenny:

1st. Reporting that the oyster scows have moved from the bulkhead between Bogart and Bloomfield streets to the bulkhead at West Tenth street.

2d. Reporting repairs required to the bulkhead between Bogart and Bloomfield streets, the approach to Pier foot of Jane street and the approach to Pier foot of Horatio street, North river. The Engineer-in-Chief directed to examine and repair if necessary.

3d. Reporting dredging required at the bulkhead between Piers, old 56 and 57, at the Pier foot of Bogart street and at the bulkhead between Piers, old 57 and 58, North river. The Engineer-in-Chief directed to make requisition for dredging if necessary.

From Dock Master Meehan:

1st. Reporting repairs required to the bulkhead between Seventy-eighth and Seventy-ninth streets, East river. The Engineer-in-Chief directed to repair if necessary.

2d. Reporting dredging required in the slip between the Piers foot of East Eighty-sixth street, also in front of the bulkhead, and on the north side of the Pier foot of said street. The Engineer-in-Chief directed to make requisition for dredging if necessary.

From Dock Master Martin—Reporting repairs required to the sheathing over the sewer at the bulkhead foot of Ninety-sixth street, North river. The Engineer-in-Chief directed to repair if necessary.

The following communications were referred to the Engineer-in-Chief to examine and report:

From the Department of Street Cleaning—Submitting a report from their Superintendent of Tugs and Scows stating that the slip foot of Canal street, North river, requires dredging.

From the Pacific Mail Steamship Company, lessee—Stating that they were unable to use the south side of Pier, new 34, North river, on the 22d instant, owing to the grounding of the dumping scows of the Street Cleaning Department.

From Owens & Co., lessees—Requesting dredging at the bulkhead foot of East Forty-seventh street.

From H. W. De Forest—Requesting permission to widen the pile platform at One Hundred and Thirtieth street, Harlem river, in accordance with plan submitted and to extend the temporary open shed thereon.

From Patrick Sheehy and Patrick Kearns—In reference to the complaint of October 20, 1892, respecting the damage to the sewers foot of Vestry street and at Pier 13, North river.

The Treasurer, Commissioner Phelan, submitted his report of receipts for the week ending November 23, 1892, amounting to \$4,481.47, which was received and ordered to be spread in full on the minutes, as follows:

From the Engineer-in-Chief:

1st. Report for the week ending November 19, and for the quarter ending October 31, 1892. Transmit quarterly report to his Honor the Mayor.

2d. Recommending that he be directed to obtain the necessary permits from the Building Department for the buildings, etc., at the East Twenty-fourth Street Yard. Recommendation adopted.

3d. Recommending that repairs be ordered to Pier, old 54, North river. Recommendation adopted.

4th. Recommending that the lessee be directed to repair Pier, new 41, North river. Recommendation adopted.

5th. Report on Secretary's Order No. 12373, recommending that the owners and lessees of the platform south of Pier, old 54, North river, be directed to dredge in front of said platform, and rake out the mud from beneath the same, in conjunction with dredging to be done by the Department in front of that portion of the platform owned by the City. Recommendation adopted.

6th. Report on Secretary's Order No. 12398, stating there is no objection to granting the New Haven Steamboat Company a permit to build a platform in lieu of repairing the pavement on the bulkhead between Piers 26 and 27, East river, provided it is not extended beyond the platform at Pier 27, East river. Permit granted to continue only during the pleasure of the Board, the work to be done under the supervision of the Engineer-in-Chief.

7th. Report on Secretary's Order No. 12322, submitting cost of repairs to the Pier foot of West Thirty-fifth street. The Treasurer authorized to collect from Michael Mitchell, lessee.

8th. Partial report on Secretary's Order No. 12331, as to the non-commencement of filling in between Thirty-third and Thirty-fourth streets, North river, by S. V. Tripp. Send copy of said report to the Counsel to the Corporation.

9th. Partial report on Secretary's Order No. 12363, submitting specifications and form of contract for dredging at the Pier foot of West Fifty-fifth, Fifty-sixth, Fifty-seventh and Fifty-eighth streets, North river, approved, subject to the approval of the Counsel to the Corporation as to form and the Secretary directed to advertise for estimates for doing said dredging.

TO OWNERS OF LANDS ORIGINALLY ACQUIRED BY WATER GRANTS.

ATTENTION IS CALLED TO THE RECENT act of the Legislature (chapter 449, Laws of 1889), which provides that whenever any streets or avenues in the city, described in any grant of land under water, from the Mayor, Aldermen and Commonalty containing covenants requiring the grantees and their successors to

pave, repave, keep in repair or maintain such streets, shall be in need of repairs, pavement or repavement, the Common Council may, by ordinance, require the same to be paved, repaved or repaired, and the expense thereof to be assessed on the property benefited; and whenever the owner of a lot so assessed shall have paid the assessment levied for such paving, repaving or repairing, such payment shall release and discharge such owner from any and every covenant and obligation as to paving, repaving and repairing, contained in the water grant under which the premises are held, and no further assessment shall be imposed on such lot for paving, repaving or repairing such street or avenue, unless it shall be petitioned for by a majority of the owners of the property (who shall also be the owners of a majority of the property in frontage) on the line of the proposed improvement.

The act further provides that the owner of any such lot may notify the Commissioner of Public Works, in writing, specifying the ward number and street number of the lot that he desires, for himself, his heirs and assigns, to be released from the obligation of such covenants, and elects and agrees that said lot shall be thereafter liable to be assessed as above provided, and thereupon the owner of such lot, his heirs and assigns shall thenceforth be relieved from any obligation to pave, repair, uphold or maintain said street, and the lot in respect of which such notice was given shall be liable to assessment accordingly.

The Commissioner of Public Works desires to give the following explanation of the operation of this act: When notice, as above described, is given to the Commissioner of Public Works, the owner of the lot or lots therein described, and his heirs and assigns, are forever released from all obligation under the grant in respect to paving, repaving or repairing the street in front of or adjacent to said lot or lots, except one assessment for such paving, repaving or repairs, as the Common Council may, by ordinance, direct to be made thereafter.

No street or avenue within the limits of such grants can be paved, repaved or repaired until said work is authorized by ordinance of the Common Council, and when the owners of such lots desire their streets to be paved, repaved or repaired, they should state their desire and make their application to the Board of Aldermen and not to the Commissioner of Public Works, who has no authority in the matter until directed by ordinance of the Common Council to proceed with the pavement, repavement or repairs.
