DEPARTMENT OF DOCKS.

At a meeting of the Board of Docks, held April 17, 1879.

Present—Commissioners Dimock and Vanderpoel.

On motion, Commissioner Dimock took the chair.

On motion, it was

Resolved, That this Board hereby certify to the Comptroller that the failure of Charles Guidet and I. Eugene White to complete the repairs to Pier 7, East river, within the time stipulated therefor under their contract dated February 3, 1879, has not caused the Corporation to sustain any loss or damage whatsoever, beyond the wages paid to the Inspector of the work, amounting to the sum of \$70 (being for 140 hours, at fifty cents per hour), and that the lessees of said pier can have no claim for loss or damage sustained through such failure of the contractors, for the reason that said lessees were permitted by the said contractors to occupy the pier for a considerable portion of the time while the work of repairing was in progress.

The Auditing Committee presented an audit of two bills or claims amounting in the aggregate to the sum of \$17,203.33; and being read, was

On motion, accepted and adopted, and the Secretary directed to forward the said bills, together with proper requisitions for the amount to the Finance Department for payment.

On motion, the Secretary was directed to arrange with James M. Oakley & Co., auctioneers, to offer at public sale to be held on Monday, April 28, 1879, for purchase by the highest bidder, the right to collect and retain all wharfage accruing at certain 18 lots of piers and bulkheads, leases of which have expired or terminate prior to November 1, 1879, as designated by the Commissioners, subject to the terms and conditions as set forth in the advertisement prepared by the Secretary, and cause said sale to be published for ten days in the CITY RECORD and other newspapers designated by law for corporation notices.

On motion, M. J. Watson was appointed as laborer.

RAPID TRANSIT COMMISSION.

Appointment of Commissioners.

MAYOR'S OFFICE,
NEW YORK, April 2, 1879.

It appearing by the application, made to me on the 4th day of March, 1879, by fifty reputable householders and taxpayers of the City and County of New York, in the State of New York, verified upon oath before a Justice of the Supreme Court, that there is need in said city and county of a street railway or railways for the transportation of passengers, mails and freight; and thirty days not having expired since said application, now, in pursuance of the provisions of the act entitled, "An Act further to provide for the construction and operation of a steam railway or railways in counties of the State," passed June 18, 1875, three-fifths being present, I, Edward Cooper, Mayor of the City of New York, do hereby appoint the following five persons, residents of said city and county, to be commissioners under and in pursuance of the provisions of said act, namely: Henry F. Spaulding, Benjamin G. Arnold, Henry G. Stebbins, Lewis G. Morris, Samuel R. Filley.
