The City Planning Commission (CPC), acting as lead agency, issued a Notice of Completion on May 6, 2022, for a Draft Environmental Impact Statement (DEIS), for the Innovative Urban Village proposal in accordance with Article 8 of the Environmental Conservation Law. **A public hearing on the DEIS, will be held on Wednesday, August 24, 2022, at 10:00 A.M., in conjunction with the CPC's public hearing, pursuant to ULURP. Comments are requested on the DEIS and will be accepted through 5:00 P.M., September 6, 2022. In support of the City's efforts to contain the spread of COVID-19, DCP will hold the public hearing remotely.**

The Applicant, Innovative Urban Living, LLC, is seeking City Planning Commission approval of a zoning map amendment, zoning text amendments, a large-scale general development special permit, a special permit to reduce required accessory residential parking, and a special permit for a public parking garage (the "Proposed Actions") to facilitate the redevelopment of the Christian Cultural Center (CCC) campus in the East New York neighborhood of Brooklyn Community District 5. The area subject to the Proposed Actions (the "Project Area") includes Block 4430, Lot 1 and Block 4434, Lots 1 and 10 (the "Development Site"), as well as de minimis portions of the north side of Block 4434, Lot 60 and Block 4431, Lots 70 and 100. The Development Site is bounded by the centerlines of Flatlands Avenue to the north, Pennsylvania Avenue to the east, and Louisiana Avenue to the west.

The Proposed Actions would facilitate a proposal by the Applicant to develop an approximate 2,200,538 gross square foot (gsf) mixed-use, purpose-built development comprising ten buildings ranging from 2 to 15 stories (the "Proposed Project") on the 10.3-acre Development Site, a portion of which includes the Christian Cultural Center (CCC) facility. The Proposed Project would include 1,645,820 gsf of residential space accommodating 2,050 income-based residential units; 100,904 gsf of community facility space, 110,570 gsf of commercial space, a performing arts center (PAC) (16,500 gsf), and 343,244 gsf of parking (886 parking spaces). The Proposed Project would also include approximately 84,950 square feet (sf) of publicly accessible open space and approximately 65,400 sf of private open space.

Specifically, the Proposed Actions include:

- Zoning Map Amendment
A zoning map amendment to rezone the Project Area from and R5 district to an R7-2 district with a C2-4 commercial overlay
- Zoning Text Amendments to the Zoning Resolution (ZR)
Amendment to Appendix F of the Zoning Resolution (ZR) to designate the Project Area as a Mandatory Inclusionary Housing (MIH) area, Option 1;
Amendment to Appendix I of the ZR (Transit Zone) to expand the boundary of the Transit Zone to include the Project Area;
- Special Permits
Special Permit, pursuant to ZR 74-743(a) (2) to locate buildings without regard for yard, court, distance between buildings, and height and setback regulations in general large-scale developments;
Special Permit, pursuant to ZR 74-512 to permit a public parking garage with more than 150 spaces.

The Applicant also intends to seek public funds and/or financing from various City and New York State agencies and/or programs related to affordable housing development.

The Proposed Project would be constructed in phases over a planned 10-year period, with an anticipated Build Year of 2031.

In order to assess the potential effects of the Proposed Actions, a reasonable worst-case development scenario (RWCDs) for both "future No-Action" (No-Action) and "future with the Proposed Actions" (With-Action) conditions will be analyzed for an analysis year, or Build Year, of 2031. The future With-Action scenario identifies the amount, type and location of development that is expected to occur by the end of 2031 as a result of the Proposed Actions. The No-Action scenario identifies development projections for 2031 absent the Proposed Actions. The effect of the Proposed Actions would be the incremental change in conditions between the No-Action and With-Action scenarios.

Compared to future conditions without the Proposed Actions, the RWCDs anticipates that the Proposed Actions would result in a net increase of 2,050 dwelling units (1,645,820 gsf), 110,570 gsf of commercial space, 8,120 gsf of community facility space, and 501 parking spaces. The Proposed Actions would result in a net increase of 4,797 residents 480 employees. This net increment represents the basis for environmental analyses in the DEIS.

The DEIS identifies potential significant adverse impacts related to community facilities (childhood programs, libraires), transportation (traffic, subway, busses, pedestrians), noise, and construction impacts (traffic, noise), as well a temporary active open space impact during the construction period.

Potential mitigation measures for impacts to early childhood programs are being explored by the Applicant in consultation with the New York City Department of City Planning (DCP) and the New York City Department of Education (DOE) and will be refined between the DEIS and FEIS. Such measures may include, but are not limited to, provision of space for an on-site early childhood program, provision of a suitable location off-site, funding or making program or physical improvements to support additional capacity, and/or other measures. Absent the implementation of such measures, the Proposed Actions could result in an unmitigated significant adverse impact to publicly funded early childhood programs.

Potential mitigation measures for impacts to libraires are being explored in consultation with the Brooklyn Public Library (BPL) and will be refined between the DEIS and FEIS. Such measures may include, but are not limited to, providing project residents with computer labs that have free internet access, and providing space within the PAC and outdoor space for use by BPL for programming. Absent the implementation of such measures, the Proposed Actions could result in an unmitigated significant adverse impact to libraries.

Potential mitigation measures for the temporary indirect active open space impact are being explored in consultation with the New York City Department of Parks and Recreation (Parks) and will be refined between the DEIS and FEIS. Absent the implementation of suitable measures, the Proposed Actions could result in an unmitigated significant adverse temporary active open space impact.

Regarding the potential for transportation (traffic) impacts, the Proposed Actions would result in significant adverse impacts at nine of the 13 study area intersection during one or more analyzed peak hour during the weekday A.M., weekday midday, weekday P.M., and Saturday midday peak hours. Significant adverse impacts were also identified at four of the seven intersections analyzed for the Sunday peak hour. The majority of the impacted intersections could be fully mitigated with standard traffic engineering improvements such as signal timing changes, parking regulation changes to gain a travel lane at key intersections, and lane restriping. Implementation of the recommended traffic engineering improvements is subject to review and approval by the New York City Department of Transportation (DOT) and will be further refined between the DEIS and FEIS. If, prior to implementation, DOT determines that an identified mitigation measure is infeasible, an alternative mitigation measure will be identified, if possible. In the absence of the application of mitigation measures, the impacted locations would remain unmitigated.

Regarding the potential for transportation (subway) impacts, significant impacts were identified at the Glenwood Avenue fare control area within the Rockaway Parkway L subway station during the AM peak hour. Potential mitigation measures for impacts to subways are being explored in consultation with the New York City Transit (NYCT) and will be refined between the DEIS and FEIS. Absent the implementation of such measures, the Proposed Actions could result in an unmitigated significant adverse impact to subways.

Regarding the potential for transportation (bus) impacts, the Proposed Actions would result in significant adverse bus line haul impacts on the B82 bus route during the AM peak hour, and the B82 Select Bus Service (SBS) and B83 bus routes during the A.M. and P.M. peak hours. The general policy of NYCT is to provide additional bus service where demand warrants, taking into account financial and operational constraints.

Regarding the potential for transportation (pedestrian) impacts, incremental demand from the Proposed Project would result in significant adverse impacts to one pedestrian element (one crosswalk) during the weekday A.M. and midday peak hours, two pedestrian elements (two crosswalks) during the weekday P.M. peak hour, four

pedestrian elements (three crosswalks and one sidewalk) during the Saturday peak hour, and 12 pedestrian elements (five crosswalks, three sidewalks, and four corners) during the Sunday peak hour. It was determined that the pedestrian impacts could not be mitigated with typical improvement measures. Therefore, the Proposed Actions could result in an unmitigated significant adverse impact to pedestrians.

The Proposed Actions would result in the potential for significant adverse impacts to one existing residential building, located at 1180 Pennsylvania Avenue, primarily resulting from the proposed childcare facility playground, which would be fully mitigated with the introduction of a solid wall along the southern perimeter of the daycare playground facility.

The Proposed Actions could result in significant adverse construction noise impacts at new buildings that would be introduced with the phased development, and at existing residential buildings located immediately south of the Development Site. No feasible mitigation measures were identified to mitigate the potential construction noise impact. While additional mitigation measures will be explored between the DEIS and FEIS, the Proposed Actions have the potential to result in an unmitigated significant adverse construction (noise) impact.

Regarding the potential for construction (traffic) impacts, significant impacts were identified at two of the seven analysis intersections during the A.M. peak hour and at nine of the 12 analysis intersections during the P.M. peak hour. Significant impacts at four intersections could not be fully mitigated during the P.M. peak hour. Therefore, the Proposed Actions could result in an unmitigated significant adverse construction (traffic) impact.

In addition, two potential alternatives to the Proposed Actions were studied: a No-Action Alternative, and a No Unmitigated Significant Adverse Impacts Alternative. Neither of these alternatives would meet the primary objectives of the Proposed Actions, and no feasible alternatives are available that would result in no unmitigated impacts and meet the Proposed Actions' goals.

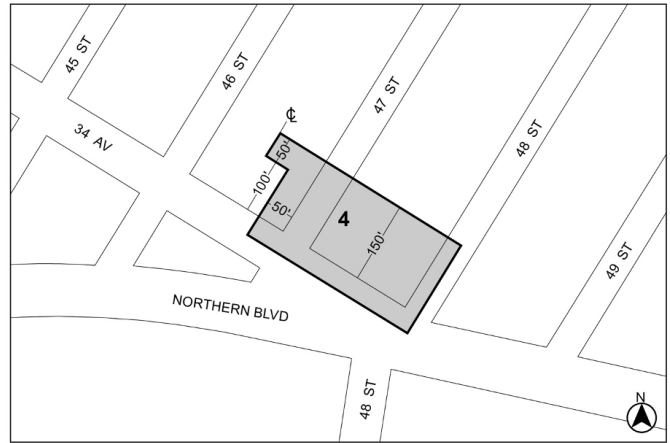

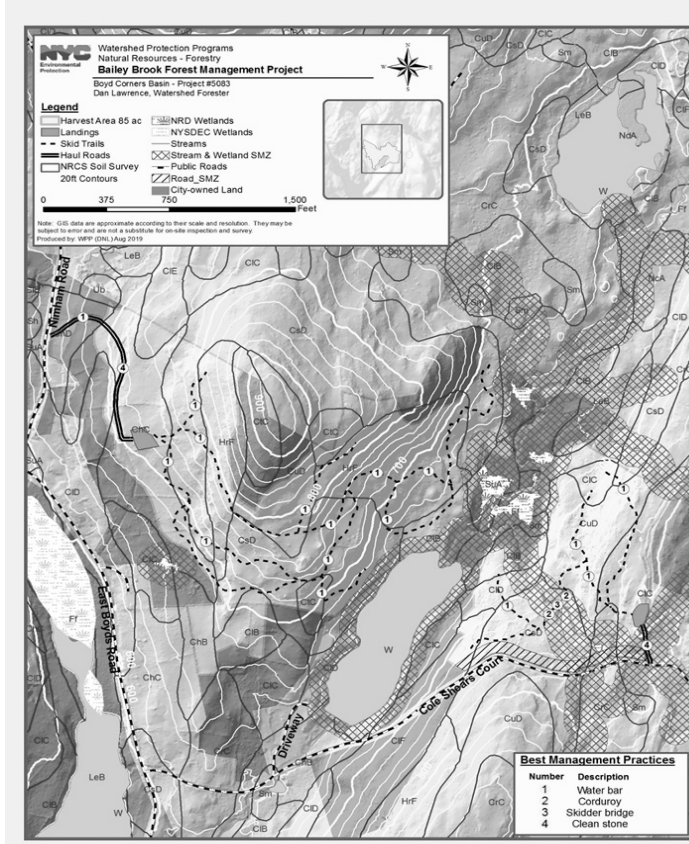

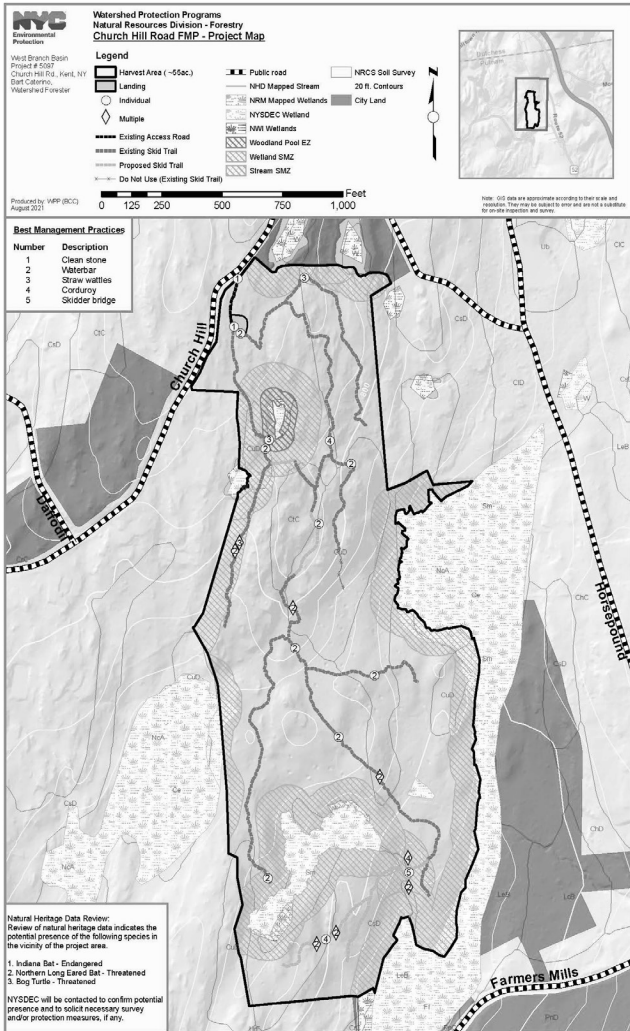
