Whereas, The Commissioners of Public Charities and Correction did, on the 23d of November, 1866, adopt the following resolutions:

Resolved, That when a member of a Medical Board of either of the Hospitals of the Department shall have served fifteen years as Visiting Physician or Surgeon he shall be advanced to the rank of Consulting Physician or Surgeon, and therefore shall cease to be a member of the Medical Board, to which he may be attached. But such period of fifteen years shall be considered as not having commenced prior to 1860, the year of the creation of this Commission.

Resolved, That any visiting physician or surgeon having actually served fifteen years, who may without reference to the year above mentioned, resign as a member of a Medical Board, shall be advanced to the rank of Consulting Physician or Surgeon; and

Whereas, By virtue of the foregoing resolutions, two-thirds of the members of the Medical Board of Bellevue Hospital will be advanced on the 1st of January, next, to the rank of Consulting Physicians and Surgeons, and thereby be exempt from duty in the hospital, it has been deemed expedient that the present Medical Board shall cease and determine on the 1st September, next, in order that provisions may be made for the more equal representation of the Medical Colleges and of the profession at large in a new Board, and for longer continuous service by its several members, and that definite terms for the tenure of office may be established; it is therefore

Resolved, That in view of the early dissolution of the relations between the Medical Board of Bellevue Hospital and the Board of Commissioners of Public Charities and Correction. The Commissioners bear testimony to the conspicuous

ability and zeal with which the members of the Medical Board have discharged their high duties, and tender to them their thanks for their wise administration of the Hospital and for their generous and gratuitous service through a long course of years to the patients under their charge.

DEPARTMENT OF PUBLIC PARKS.

Abstract of the proceedings of the Board of Commissioners of the Department of Public Parks for the four weeks ending August 29, 1874.

The application of George Raphael, for permission to erect on the Central Park, free of charge to the Department, a more suitable building for his Camera Obscura, was refused.

It was directed that advertisements be published for proposals to lay concrete flagging on Five Points Park.

The permission to let donkeys on the Central Park for hire, was extended until further orders, and the following courses and rates of fare were established:

1. From the stand near Bow bridge to Gill bridge and return, 10 cents.

2. From the stand to Vista rock and return, 20 cents.

3. From the stand to Vista rock, or from Vista rock to the stand, either way being half of the round trip, 15 cents.

Seats were directed to be constructed and placed around the fountain on Union Square, the cost not to exceed \$725.

The position of the track of the Central Cross-town Railroad Company, on the north end of Union Square, was fixed at fourteen feet from the northernmost curb.

Proposals for the construction of the Gapstow Bridge and Outset Arch were directed to be advertised for.

The title of "Chief Clerk," given to D. P. Lord, was changed to "First Clerk."

The following resolutions were adopted on the 26th day of August, 1874:

Resolved, That it is hereby determined that the permanent position of the track of the Eighth Avenue Railroad, between the Circle and One Hundred and Tenth street, shall be at a distance of three feet between the nearest rail of said track and the easterly curb line of the said avenue, as determined by resolution of this Board of 14th of July, 1874.

Resolved, That permission is hereby given the Eighth Avenue Railroad Company to retain in its present position so much of their track as is now laid west of the easterly curb-line of said avenue, until otherwise ordered.
