

REGULATIONS ESTABLISHING A SCALE OF WATER RENTS AND RULES GOVERNING THE USE OF WATER, FOR THE CITY OF NEW YORK, BY ORDER OF JOHN NEWTON, COM-MISSIONER OF PUBLIC WORKS.

UNDER CHAPTER 410, LAWS 1882, SECTIONS 350, 351, 352 and 353, and as amended by chapter 350, 351, 352 and 353, 559, Laws 1887, as follows :

NDER CHAPTER 470, LAWS 1882, SECTIONS 559, Laws 1887, as follows: "The commissioner of public works shall, from time to time, establish scales of rents for the supplying of water, which rents shall be collected in the manner now provided by law, and which shall be apportioned to different classes of buildings in said city in reference to their dimensions, values, exposure to fires, ordmary uses for dwellings, stores, shops, private stables and other common purposes, number of families or occupants, or ocnsumption of water, as near as may be practicable, and which they are restricted in the regular rents, and shall be determent to the observations of buildings in said city in reference to the classes of buildings and establishments. All extra charges for water shall be determed to be included in the regular rents, and shall become a charge and lien upon the buildings upon which they are restectively imposed, and, if not paid, shall be crewed as arrears to the clerk of arrears. rallway cars or other vehicles or horses, cannot oe per-mitted. No horse-troughs or norse-watering fixtures will be permitted in the street or on the sidewalk, except upon a license or permit taken out for that purpose. All licenses or permit taken out for that purpose. All licenses or permit must be annually renewed on the first of May. Such fixtures must be kept in good order and the water not allowed to drip or waste by overrunning the sidewalk or street, or to become dangerous in winter by freezing in and about such troughs or fixtures No hydrant will be permitted on the sidewalk or in the front area, and any hydrant standing in a yard or alley, attached to any dwelling or building, must not be left running when not in actual use, and if the drip or waste from such hydrant freezes and becomes dangerous in winter, the supply will be shut off in addition to the penalty of five dollars imposed. Taps at wash-basins, water-closets, baths and urmals must not be left running, under the penalty of five dollars for each offense, which will be strictly enforced. Fountams or jets in hotels, porter-houses, eating-saloons, confectioreries or other buildings are strictly prohibited. The use of hose for washing sidewalks, stoops, areas, house-fronts, yards, court-yards, gardens, and about

saloons, conrectoreries of other outdings are strictly prohibited. The use of hose for washing sidewalks, stoops, areas, house-fronts, yards, court-yards, gardens, and about stables, is prohibited. Where premises are provided with wells, special permits will be issued for the use of hose, in order that the police or inspectors of this depart-ment may understand that the permission is not for the use of Croton water. Opening fire-hydrants to fill hand sprinklers or other vessels will not be allowed. The penalty for a violation of any of the preceding rules and regulations will be five dollars for each offense, and if not paid when imposed will become a lien on the premises in like manner as all other charges for unpaid water rates. PUBLIC NOTICE AS TO WATER RATES.

PUBLIC NOTICE IS HEREBY GIVEN 1HAT in compliance with the provisions of chapter 550, Laws of 1887, amending sections 350 and 921 of the New York City Consolidation Act of 1882, passed June 9, 1887, the following changes are made in charging and collect-ing water rents:

ing water rents: rst. All extra charges for water incurred from and after June 9, 1887, shall be treated, collected and returned in arrears in the same manner as regular rents have hereto-tore been treated. zd. In every building where a water meter or meters are now, or shall hereafter be in use, the charge for water by meter measurement shall be the only charge against such building, or such part thereof as is supplied through meter.

such building, or such part thereof as is supplied through meter.
3d. The returns of arrears of water rents, including the year 1887, shall be made as heretofore on the confirmation of the tax levy by the Board of Aldermen, and shall include all charges and penalties of every nature.
4th. A penalty of five dollars (\$5) is hereby established, and will be imposed in each and every ycase where the rules and regulations of the Department prohibiting the use of water through hose, or in any other wasteful manner, are violated, and such penalties will be entered on the books of the Bureau against the respective buildings or property, and, if not collected, be returned in arrears in like manner as other charges for water.

NOTICE TO CROTON WATER CONSUMERS.

NUMEROUS APPLICATIONS HAVE BEEN made to this Department by citizens claiming reductions or rebates on bills for water supplied through meters, on the alleged ground of leakage caused by de-fective plumbing and worn-out service pipes, or by willful waste of water by tenants allowing the faucets to be turned on in full force in water-closets, sinks, etc., with-out the knowledge or consent of the owners of the prem-ises.

out the knowledge or consent of the owners of the prem-ises. The main object of the use of water-meters is to enable this Department to detect and check the useless and un-watrantable waste of an element so valuable and essential to the health and comfort of all the citizens, and this ob-ject can only be accomplished by enforcing payment for the water wasted. Under the law all charges for water supplied througn meters are a lien against the respective premises, and the law therefore holds the owner of the premises re-sponsible for the amount of water used or wasted. Notice is therefore are not all householders that, in all further applications for reduction of water rents, no allowance will be made on account of waste of water occurring through leaks, from defective service pipes or plumbing, or wasteful use of water by tenants or occu-pants of buildings, though such leakage or waste may have o, curred without the knowledge or consent of the owners of the buildings. Mouse-owners are luither notified that whenever their premises become vacant, and are likely to remain vacant, they must notify this Department in writing, and that unless this requirement is complied with no deductions in extra water rents will he allowed for any portion of one year. GRANTS OF LANDS UNDER WATER.

GRANTS OF LANDS UNDER WATER. THE OWNERS OF LANDS IN THE CITY OF New York, which were formerly under water, and which were granted by the City ot New York, are noti-fied that nearly all of the grants of such lands contain covenants, on the part of the grantees, and their succes-sors and assigns, to maintain and keep in repair the adjacent streets. The condition of many of these streets is such as to make it necessary that they should be re-paired and repaved, and that the obligation resting upon the present owners of adjacent lots to do this work should now be enforced. Many of such owners have requested that such covenants be commuted, and wholly released, upon the payment by them of a certain sum per lot. The matter will shortly be presented to the Commis-sioners of the Sinking Fund for their consideration, and applica-tion for releases should therefore be made at once.
