DECEMBER SOLUTION



Marvin' the Meerkat's New Year's resolutions presented some serious potential violations of Chapter 68. Let's look at each in turn:

The loan would be a prohibited financial relationship between a superior and subordinate; printing advertising on the copier is a misuse of City resources (and misuse of City time, if it's during work hours). Marvin should secure capital from other funding sources and design and print his fliers at home.

2) LOOK OUT FOR HIS FAMILY Marvin's sister Melissa the Meerkat just graduated from business school and is looking for a job. Marvin will call up some vendors he works with at his City position, and see if any of them are hiring. This is a **misuse of position**: the vendors Marvin has power over might feel pressured to interview or hire his sister. However, if a job is publicly posted, he could encourage Melissa to apply on her own, and even help her with her resume, so long as he takes no direct action with any vendor with whom he works to help her.

3) GET IN SHAPE Marvin wants to join a gym, but there are so many to choose from! He'll spend a few minutes at his desk reading online reviews. This is actually **allowed** under the City's **Acceptable Use Policy**, which COIB (like many agencies) has adopted. Checking out a few gym reviews is minimal (not costly to the City), incidental (brief and doesn't interfere with job responsibilities), and personal (no money to be made, non-political, etc).

4) ORGANIZE FOR A WORTHY CAUSE Marvin plans to raise funds for his favorite environmental not-for-profit, JustDeserts. He'll send a personal email to the COIB staff members he is closest to, including some subordinates, asking if they would like to contribute any amount they see fit. Another misuse of position — the workers who Marvin oversees might feel undue pressure to donate to their supervisor's favorite charity. Marvin should never ask subordinates to donate to his pet causes. Ask friends and family instead!

5) WORK ON HIS MANNERS The public loves the great job Marvin does promoting COIB, and sometimes people want to show their gratitude with a little cash bonus. Marvin is going to work on remembering to say "thank you" and accepting their tips gracefully, instead of just taking the shiny coins in his teeth and scampering away. As a City worker, Marvin is already paid a salary for his work. Any additional "thank you" payment offered by a member of the public is a **prohibited gratuity**. Even though he works very hard, Marvin must refuse all tips offered by his adoring public.
