

Whereas, The said Engineer-in-Chief has reported to this Board that the work of the Depart-ment has not been actually delayed by the non-delivery of said material for more than 20 days; therefore.

Therefore, Resolved, That this Board hereby certify to the Comptroller that the failure of John M. C. Scully to deliver the material specified in the final estimate (No. 5), within the time stipulated therefor under his contract for furnishing small cobble and rip-rap stone, dated July 14, 1879, has not caused the corporation to sustain any loss or damage whatsoever beyond a delay in the pro-gress of the work of this Department of twenty days' time, the premises for which the said material was ordered not being in readiness to receive it, owing to unexpected delays in dredging and other work; and that the penalty incurred by said contractor for the twenty days' delay referred to herein, is the sum of \$1 000
