Working plans in duplicate, drawn to a scale of one-quarter inch to the foot, shall be required to accompany each application, showing elevation plans and vertical section of extent of

Working plans in duplicate, drawn to a scale of one-quarter inch to the foot, shall be required to accompany each application, showing elevation plans and vertical section of extent of projection, one copy of which shall be filed in the office of the Department and one, duly certified by said Commissioner, shall be returned to the applicant for filing in the Department of Buildings.




