Re: Agency-based Voter Registration Under LL29 of 2000, Mayoral Directive One of 2014, LL61 of 2014, LL63 of 2014, and LL21 of 2021.

January 1 through June 30, 2023 Report

Local Law 29 of 2000 requires that specified agencies offer voter registration in their encounters with the public. Mayoral Directive One of 2014 strengthened the requirements of LL29, putting a structure in place to monitor agency efforts to increase voter registration. Local Laws 61 and 63 of 2014 increased the number of agencies required to offer voter registration.

This report cycle includes a new question, "Number of printed educational materials about ranked choice voting distributed," pursuant to [Local Law 21 of 2021](#). Local Law 21 of 2021 subdivision d requires the Campaign Finance Board to provide agencies with educational materials about ranked choice voting. Subdivision e of the law requires agencies to report on the number of printed educational materials the agency has distributed. Department of Finance (DOF), Fire Department (FDNY), Department of Homeless Services (DHS), Housing Preservation and Development (HPD), Human Resources Administration (HRA), NYC Commission on Human Rights (CCHR), Department of Parks and Recreation (DPR), and Department of Youth and Community Development (DYCD) did not report on this new category. The Mayor's Office of Operations will work with these agencies to include this data in future cycles.

The Board of Elections reported that it processed 406 voter registration applications originating at City agencies (called Code 9 applications) between January 1 and June 30, 2023. This does not include applications from DSS/HRA, where voter registration applications are offered, collected, and sent to the Board of Elections under the requirements of the National Voter Registration Act (NVRA) and are not denoted as Code 9. DSS/HRA reported sending 705 applications to the Board of Elections during the reporting period, yielding a combined total of 4,036 City agency submissions to the Board of Elections. The total for the comparable period in 2022 was 19,275.

Some highlights and challenges of agency activities during the reporting period include:

1. DPR and DOF reported difficulties with measuring web traffic to the Campaign Finance Board website because the system used by Office of Technology and Innovation (OTI) to track web clicks is no longer in service.
2. After 3 years, the effects of the COVID-19 pandemic continue to challenge the activities of City agencies, including:
 - a. Department of City Planning (DCP) still distributes applications through agency mailings and holds virtual public hearings and virtual application reviews.
 - b. Department of Probation (DOP) have just begun returning to their office, so they were unable to complete any special registration activities.

- c. Department of Records and Information Services (DORIS) provides services by scheduling appointments. As a result, the agency will continue focusing on digital voter outreach and voter information efforts.
 - d. HRA experienced challenges collecting data and submissions of applications mainly due to transitioning their Voter Registration process online. Most applications are now received online via ACCESSHRA, and as such, in person foot traffic has been declining in recent years. The Home Care Services Program (HCSP) began forwarding the blue dot Mailed NYS Agency-Based Voter Registration form to clients who expressed interest in completing a Voter Registration Application which helped resolve some data collecting challenges. HASA Centers have received fewer voter registration applications from clients since the start of the pandemic.
 - e. Administration for Children's Services (ACS) went through a staffing transition causing the activity of distribution and registration to be put on hold. They are working to reset partnerships and activities for voter registration beginning August 2023 with their new staff.
3. Notable outreach efforts include:
- a. In early June of this reporting period, Civilian Complaint Review Board (CCRB) conducted canvassing with the Civic Engagement Commission to provide voter registration information to the public in Queens, NY.
 - b. Department of Correction (DOC) has been in partnership with the NYC Campaign Finance Board on the development of a voter education module to acquaint people in custody with basic concepts of democracy and the role of the election process.
 - c. Taxi and Limousine Commission (TLC) informed licensees of various voting methods including early voting, absentee ballot voting, and ranked choice voting, prior to the June Primary Election.

However due to staff transition, activities to distribute and registration activities at ACS for the summer months were put on hold during this time period. Elvita Dominique, Executive Director of Equity Strategies is now the ACS new point of contact and is working to reset partnerships and activities for voter registration starting in August 2023.

Describe any special registration activities, if any.

ACS typically hosts voter registration meetings for ACS summer interns. However due to staff transition, activities to distribute and registration activities at ACS were put on hold during this time period. Elvita Dominique, Executive Director of Equity Strategies is now the ACS new point of contact and is working to reset partnerships and activities for voter registration starting in August 2023.

Going forward in August 2023, Elvita will work with the NYC Campaign Finance Board's Youth Programs Manager to increase awareness about voting among the youth, specifically. One event that ACS will participate in is the 5th Annual Youth Hearing to be held on August 16, 2023. The Youth VAAC Hearing is a chance for young people to voice their thoughts and concerns on voting and local government in New York City. Youth voices are often excluded in conversations on civic participation, and they want to create a space that centers and uplifts the experiences of New Yorkers aged 14-25. The feedback received at this event will guide their youth programming over the next year.

Describe challenges, both resolved and unresolved.

Due to staff transition activities during this period to distribute and registration activities at ACS were put on hold during this time. ACS new point of contact is working to reset partnerships and activities for voter registration starting in August 2023.

Our plan starting in August will be to resume community-based events that feature voter registration activities as we have conducted in the past year. ACS will connect with its partnership with the Parent Advocacy Council on voter registration drives and will continue to work with NYC Votes and NYCCFB and expand on voter knowledge and voter registration activities with the implementation and continuation of the following ACS programs, and many more:

- o Youth Aging Out of Care
- o ACS Interns
- o 12 Metro Tech Teen Center
- o Family Enrichment Centers

Challenges continuing from 2022:

- **Lack of language access:** multi-language forms are not readily available. Citizens with language barriers are more disenfranchised.
- **Polling Place Closures:** Residents complained of not receiving notification of polling site closures, which largely affects communities of color. Some residents shared that some of the new locations are too far to get there by walking.
- **Candidate Issues:** Potential voters expressed candidates do not represent their views or real-time experiences of community residents.

Potential resolutions:

- By understanding the demographics of a community, local leaders should require community-based organizations/ civic engagement programs to order voter registration forms based on the most spoken language.
- Increase advertisements within the community on Polling place closures, specifically in community based business spaces- libraries, churches, supermarkets, laundry mats, schools, etc.
- Organize local transportation services for seniors and the disabled.
- Increase the visibility of candidates at community events, town halls, and community board meetings

Describe how your agency distributes applications.

To ensure the Commission's staff can best address the needs of the public in a way that continues to comply with health and safety guidance, the Commission, where possible, schedules appointments to ensure utmost preparedness for those meetings and encounters. The Law Enforcement Bureau and the Community Relations Bureau, consistent with Citywide policy, have primarily resumed their public facing engagement work in person. This includes intake appointments and walk-in interviews, trainings, workshops, conferences, and presentations. Voter registration forms are distributed during these in-person exchanges and events and remain available to the public at all five (5) Commission offices. The Commission's persistence and expansion in engagement and outreach, has contributed to the increase in the number of individuals served, and considerable distribution of hard copy voter registration forms. It is important to note, that given the continuance of the COVID-19 pandemic, the Commission, when necessary, still conducts some of its public facing engagement work remotely. While working remotely, the Commission has continued to develop digital distribution of these forms.

Application documents are completed electronically by staff, making it impossible for DHS to physically attach a voter registration form to an application document provided to the client. DHS's solution has been to provide access to voter registration forms at intake by placing them in waiting areas for applicants and clients to pick up if they are interested in registering to vote.

The Department ensures that voter registration forms and absentee ballot applications are readily available in each facility's law library and similarly upon discharge. Persons in custody can complete these applications and send them directly to their local Board of Elections (BOE) office or have DOC's Senior Program Liaison (SPL) deliver them to the applicable BOE office. When Correctional Health Services (CHS) providers meet with persons in custody for routine visits, they can provide assistance with the completion of these forms as well. CHS staff collaborates with DOC's SPL, who will collect and distribute forms to the BOE offices.

Describe any special registration activities, if any.

The Department has a multi-pronged approach to registering voters. In partnership with the New York City Campaign Finance Board (CFB), we have been working on the development of a voter education module to acquaint persons in custody with the basic concepts of democracy and the role of the election process. The voter education and training module is designed to educate individuals in custody and promote participation in the electoral process.

Additionally, we are leveraging the Department's tablet technology to increase awareness of upcoming elections, distribute information about issues and candidates, and enable persons in custody to request voter registration forms and absentee ballot applications. We are also recruiting volunteers who commit to independently lead voter registration drives at our facilities on a bi-monthly basis, after they have received training and necessary security clearances.

In partnership with The Legal Aid Society and other community-based organizations, we lead monthly voter registration initiatives, where a small group of volunteers from these organizations visit select housing units to discuss the importance of civic engagement, distribute voter registration forms and absentee ballots, and aid in getting these forms completed and collected.

The voting process on Rikers Island remains challenging in the absence of a direct polling site, however the Department works with stakeholders to identify solutions that mitigate the impact of this challenge. The Department collects and delivers registration forms and absentee ballot applications directly to BOE if individuals in custody choose to take advantage of that option. If individuals choose not to have DOC staff collect and hand-deliver their forms to the appropriate BOE office, they can mail their forms with free stamps or pre-stamped envelopes provided by the Department. DOT remains committed to register voters. As of June 30, 2023, DOT's public service centers (PSCs) are open and all have voter registration forms. DOT will continue distribution of the voter registration (VR) packets at the PSCs. DOT mailed VR hard copies with all document requests from January 1st to June 30th 2023. During this period DOT saw an increase of VR packets sent:

- 1) After DOT customers call 311 and a service request is generated, Customer Service, Language Access, and Correspondence Unit (CSLACU) includes hard copy of VR packets with every literature request sent to customers.
- 2) The DOT website has a "Register to Vote" icon/tile on its landing page. The hyperlink sends DOT customers directly to "NYC Votes".

Describe any special registration activities, if any.

DOT will continue distributing VR materials at PSCs. During elections, DOT includes VR in all the email communications received by customers. In addition, DOT website displays an icon directing customers to "NYC Votes".

Describe challenges, both resolved and unresolved.

It is impossible for DOT to know which customers receiving the VR packets with their correspondence and/or documents, or visiting DOT's PSCs are already registered to vote. DOT can readily disseminate the voter registration materials, but cannot compel customers to complete the forms and return them to the Board of Elections, or submit them to the PSC managers. If completed forms are not collected on-the-spot and sent to the BOE by the PSC managers, it is not possible to monitor and track the level of customer participation and the number of forms being returned to the Board of Elections.

Describe challenges, both resolved and unresolved (continued)

As stated in the biennial VR report submitted to the Mayor Office of Operations (MOO), it is important to differentiate between the numbers of VR distribution packets distributed and the actual number of voter registrations taking place. Currently, DOT has no way of knowing whether the customers corresponding with DOT, or requesting DOT literature, are already registered to vote. DOT is also unable to determine if a customer completes the VR forms and returns them to the Board of Elections (BOE). The PSC managers will continue to encourage VR. Unless the customer fills out the VR forms at the PSC, we would not see the VR forms or be able to return the VR forms to the BOE.

The BOE could set up electronic sorting to scan the agency codes, since they cite being understaffed. It is important that MOO recognize the fact that these VR forms are blindly distributed without considering that the recipient might already have registered or may be ineligible to register. DOT has also sent our suggestions to the Campaign Finance Board.

Describe how your agency distributes applications.

The TLC currently maintains a staff of approximately 600 employees, many of whom interface daily with licensees. Voter registration forms are distributed in four separate ways to various TLC divisions and departments:

- **Human Resources** (located in Lower Manhattan) includes registration forms in hiring packets for new employees.
- **Policy/External Affairs** (located in Lower Manhattan) distributes voter registration forms at outreach events.
- **Licensing Division** (located in Long Island City, Queens) has forms available for visitors to take at its licensing transaction counters. Licensing maintains about 300 applications available for distribution at all times. Also, information on how to contact the Board of Elections is included on many TLC-issued forms for licensees.
- **Safety + Emissions Division** (located in Woodside, Queens, and Staten Island) has forms available for distribution at its counter operations that licensees must visit on a regular basis (ranging from three times a year to once every two years) for inspection of their vehicle.

By using these targeted strategies, TLC helps licensees and incoming employees receive voter registration information.

TLC plans and attends public events where voter registration forms are available to the public.

Additionally, TLC shares voter registration and upcoming election information with licensees through social media and email blasts. TLC emails are sent to a list of over 250,000 licensees.

During the reporting period, licensees were informed of various voting methods including Early Voting, Absentee Ballot Voting, and ranked choice voting, prior to the June Primary Election.
