

Ordinances, Resolutions, etc., approved by the Mayor during the week ending February 16, 1878.

Resolved, That permission be and the same is hereby given to Samuel Grunburg to place and keep a meat rack in front of his premises, No. 34 Henry street, the work to be done at his own expense, under the direction of the Commissioner of Public Works; such permission to continue only during the pleasure of the Common Council.

Adopted by the Board of Aldermen, January 26, 1878.

Received from his Honor the Mayor, February 15, 1878, without his approval or objections thereto; therefore, as provided in section 11, chapter 335, Laws of 1873, the same became

Resolved, That permission be and the same is hereby given to J. E. Campbell to place a sign on the sidewalk in front of his place of business, southwest corner of Sixth avenue and Forty-eighth street, the work to be done at his own expense, under the direction of the Commissioner of Public Works; such permission to continue only during the pleasure of the Common Council.

Resolved, That the Commissioner of Public Works be and he is hereby requested to pave with Belgian or trap-block pavement, the following-named streets: Madison street, from New Chambers street to Grand street; Market street, from Division street to the East river; Jefferson street, from Division street to the East river; Montgomery street, from Division street to the East river; Montgomery street, from Division street to the East river.

Whereas, It is alleged that the rooms over Essex Market, occupied as an armory by the Sixty-ninth Regiment, N. G. S. N. Y., are in an unsafe and dilapidated condition and unfit for the uses for which they were intended; therefore be it

Resolved, That the Superintendent of Buildings be and he is hereby authorized and directed to cause the inspection of the walls and foundation of the above-named building, and report to this Board as to the condition of the same.

Adopted by the Board of Aldermen, February 5, 1878. Approved by the Mayor, February 14, 1878.

Whereas, This city was mulcted a few weeks ago about \$7,000 in costs and damages in a suit by one of its citizens having fallen because the owner or occupant failed to have some ice cleaned off

of the sidewalk in front of his premises; and

Whereas, The police on this case had reported the owner several times for neglect, and have also reported within the last four days several thousand of our citizens for failing to remove snow and ice,

reported within the last four days several thousand of our cluzens for falling to remove show and lee, or to ash or sand the same; and

Whereas, The Commissioners of the Park Department have neglected to clean the walks around, through, and across the parks in this city, in violation of the city ordinance, thereby showing their incompetency for the position, and a disregard for their oath of office, and also laying the city liable to be mulcted in damages for accidents to its citizens and others; and further showing the incompetency by having the snow where shoveled, thrown into the streets, causing the Street Cleaning Bureau to cart it away, at the cost of several hundred dollars, when it is a well-known fact that snow shoveled on the grass would be of great benefit to the same; such facts clearly showing that the Commissioners have no knowledge of agriculture, horticulture, or economy in looking after the city's interest; and

Whereas, The department at this time has a full year's appropriation for the care and maintenance of the parks, and thousands of laborers are now out of employment and would be glad to get work for a single day, and the ordinance for cleaning snow and ice away applies to the city in the care of its parks, just as much as it does to the citizens for the care of their sidewalks, and section 23, subdivision 4, of the Charter of 1873, defines the duty of the Mayor, as follows: "To be vigilant and active in causing the ordinances of the City and laws of the State to be executed and enforced;" and,
Whereas, Section 25 of the Charter gives his Honor full power to remove, and sections 94 and 95 define the duty and oath of every Commissioner; therefore be it

Resolved, That hereafter all snow and ice be removed by the Park Department, the same as by the citizens, and the snow from the park walks be shoveled on to the grass plots, not only as a benefit to the same, but as a matter of economy to the tax-payer.

Whereas, A bill to repeal the "Act establishing the College of the City of New York" has been presented to the Legislature of the State of New York by Hon. Thomas F. Grady, member of Assembly; and,

Whereas, Said college was established in the year 1847 by an overwhelming popular vote, and the continued popularity of the college is seen by the increased number of applicants for admission therein every year, and by the advantages of free education which it supplies to the rich and poor alike, and as a matter of right, cannot be procured by pupils of public schools of the city through any other channel than by this or a similar institution; and,

Whereas, The said college is a natural outgrowth of our free common school system, and, together with the Normal College for females, completes the education of both sexes of our city; and to take away from this city by a simple vote of the Legislature this right confirmed by the direct vote of the people is a measure traught with the utmost danger to free education, not only in this city, but throughout the entire State; now therefore be it

Resolved, by the Board of Aldermen of the City of New York, That we disapprove of said contemplated repeal, and hereby urge upon his Honor the Mayor of the City of New York to respectfully notify the Legislature of said disapproval.

The Common Council of the City of New York would most respectfully ask that your Honorable Bodies will pass the act now pending, making an appropriation of a sum sufficient to commence and carry on during the ensuing year the work of improving the navigation of the Harlem river and Spuyten Duyvil Creek on the plans and specifications prepared by General John Newton, United States Engineer, as set forth in his report to the Secretary of War, July 14, 1876.

This work would be of great benefit to the City of New York in affording increased convenience for the handling of coal, grain, building materials, and other commodities which reach this city by water transportation, and considering the great proportion of the Federal revenue contributed by New York, it seems but proper that this work, which will be of great importance, should be at once commenced.

HEALTH DEPARTMENT No. 301 MOTT STREET, New YORK, February 8, 1878.}

A T A MEETING OF THE BOARD OF HEALTH of the Health Department of the City of New York, held at its office on the 8th day of February, 1878, the following resolution was adopted:

Resolved, That the following sections of the Sanitary Code be and are hereby annulled:
Section 33. That no person shall, in the built-up portion of the City of New York, or adjacent thereto, sell or have for sale any fish in or from any vehicle, or in any street or public place, from which all parts which are not usually cooked for food have not been removed.

Section 62. That no person shall become, or continue, or engage as, or in the business of a butcher, at or in any public or private market or stand in the City of New York, without a permit therefor from this Department.

Section 65. That no person engaged in the selling or keeping for sale of any fish, meat, birds, fowl, fruit, or vegetables, shall, without a permit from this Department, occupy or encroach upon any portion of any street or sidewalk, or public place in the City of New York.

And Section 168 That every car used for the transportation of passengers in the City of New York, shall be so constructed as at all times to provide and secure good ventilation.
