

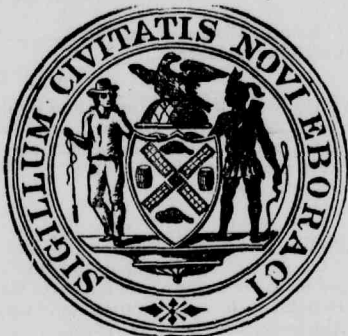

DEPARTMENT OF PUBLIC PARKS.

Abstract of the Proceedings of the Department of Public Parks during the week ending Saturday January 4, 1879.

MEETING HELD JANUARY 3, 1879.

Present—Commissioners Wenman (President), Wetmore, Conover and Lane.

The following resolution of the Board of Aldermen was returned to his Honor the Mayor for amendment, for the reason that the word "ordered" therein is directed by law to be done by the Department of Public Works, namely:

Resolved, That Eighty-first street, from Eighth to Ninth avenue, be graded, curbed, and be paved with Belgian or trap-block pavement, and that at the several intersecting streets and avenues crosswalks be laid where not now laid, and relaid where those now laid are, in the opinion of the Commissioner of Public Parks, not in good repair, or are not upon a grade adapted to the grade of the proposed new pavement, under the direction of the Commissioners of Public Parks; and that the accompanying ordinance therefor be adopted.

Messrs. Charles H. Haswell, William E. Worthen, and John Bogart, the Commission of Engineers appointed to examine the work of constructing Riverside avenue, presented their report, whereupon the following preambles and resolution were adopted:

Whereas, It appears by a report made by a Board of Engineers, appointed to investigate the conduct of the work of Riverside Drive, that in consequence of the lax supervision of the Superintending Engineer, the work has not, in the opinion of said Board of Engineers, been performed by the contractors in every respect fully in the spirit and letter of the contract; and

Whereas, The Superintending Engineer has been specially charged by this Department with the supervision and proper conduct of this work, and to represent the Department in the same; therefore

Resolved, That the Secretary be directed to transmit a copy of these preambles and resolution to the said Superintending Engineer, and notify him to appear before this Board at its next meeting, and present in writing his reasons, and any statement he may wish to make, why he should not be removed from his present position of Superintending Engineer.

Permission was granted to Mr. Columbus Ryan to cut and take the ice from the pool in Central Park during the present season.

Mr. Josiah A. Briggs, Inspector on the work of constructing sewers in Mott avenue, One Hundred and Thirty-eighth street and One Hundred and Forty-fourth street, and who had been suspended on account of the stopping of the work for the winter, was directed to resume duty until the contractor had cleared up the work and streets.

The following resolutions were adopted:

Resolved, That the resolution adopted by the Board, at a meeting held on the 20th of March, 1878, "authorizing the Treasurer to purchase supplies and materials for the Department, which shall be approved by the President, until the further order of the Board," be and the same is hereby rescinded, and that said purchasing power be and the same is hereby vested in the President until the further order of the Board.

Resolved, That a special committee be appointed to consider and report, for the consideration of the Board, such alterations and amendments to the By-Laws as they in their judgment may deem necessary.

Commissioners Conover and Wetmore were appointed such committee.

Resolved, That the President be requested to confer with the Counsel to the Corporation, submitting to him all the papers in connection with the work on cases for Museum of Natural History, and ask him for his opinion and advice as to the duty of the Department, in view of all the facts in the case as to the Board this day presented.
