

Hon. WM. F. SMITH, President Board of Police Commissioners:

DEAR SIR—In view of certain newspaper statements, in relation to your recent orders to the Police Court Squad Sergeants, I beg to state that I recognize the right of the Commissioners to direct the Sergeant to deliver the returns personally to the Magistrate; and also their right to direct their officers to make no complaints in the absence of the Magistrates.

The effect of the charge in the Fourth District Court, where I have the honor to sit, is, that it obliges the Justice to get to the court half an hour or so earlier, which is no serious inconvenience to him, and may be of some advantage to the public.

Sergeant Osborn, who is stationed at this court, is civil, courteous, and prompt, and his men are faithful.
