

## APPROVED PAPERS

Approved Papers for the week ending June 14, 1890.

Resolved, That Tuesday, July I, 1890, at one o'clock P. M., at the Board of Aldermen, Room No. 16, City Hall, be and hereby are designated as the time and place where the application of the Harlem, Mott Haven and Morris Avenue Railroad Company to the Common Council of the City of New York for its consent and permission for the construction, maintenance and operation of the street surface railroad described in the petition of said company for such consent, will be first considered by the Railroad Committee of this Board, and that public notice be given by the Clerk of the Board, by publishing the same for fourteen days, exclusive of Sundays, in two newspapers published in this city, to be designated therefor by his Honor the Mayor, according to the provisions of chapter 252 of the Laws of 1884, such advertising to be at the expense of the petitioner.

Adopted by the Board of Aldermen, May 20, 1890.

Received from his Honor the Mayor, June 9, 1890, without his approval or objections thereto; therefore, as provided in section 75, chapter 410, Laws of 1882, the same became adopted; no newspapers designated.

Resolved, That the sidewalks on the northeast corner of Park avenue and One Hundred and Twentieth street, extending a distance about fifty feet on Park avenue and about one hundred feet on One Hundred and Twentieth street, be flagged full width, where not already done, and that the flagging and the curb now on the sidewalks be relaid and reset where necessary, and that new flagging and curb be furnished where the present flagging and curb are defective, as provided by section 321 of chapter 410, Laws of 1882, as amended by chapter 569, Laws of 1887, under the direction of the Commissioner of Public Works; and that the accompanying ordinance therefor be adopted.

Adopted by the Board of Aldermen, June 3, 1890. Approved by the Mayor, June 9, 1890.

Resolved, That the Comptroller be and he is hereby authorized and directed to draw a warrant in favor of Nicholas W. Day, Treasurer of the Memorial Committee of the Grand Army of the Republic, for the sum of five hundred dollars, to be applied in aid of the Grand Army in celebrating Decoration Day, May 30, 1890, and charge the amount to the appropriation for "City Contingencies," that sum having been transferred to that appropriation, for that purpose, by the Board of Estimate and Apportionment. Estimate and Apportionment.

Adopted by the Board of Aldermen, June 3, 1890. Approved by the Mayor, June 9, 1890.

Resolved, Pending the report of the Committee on Railroads in the matter first referred to them, the ordinance passed May 20, 1890, providing for the running and operating of the lines of the railroad companies mentioned in the resolution so referred, between 12 m. midnight and 6 o'clock A. M., be suspended.

AN ORDINANCE to amend section 230 of article XXIV. of chapter 8 of the Revised Ordinances

AN Ordinance to amend section 230 of article XXIV. of chapter 8 of the Revised Ordinances of 1880.

The Mayor, Aldermen and Commonalty of the City of New York do ordain as follows:
Section 1. Section 230 of article XXIV. of chapter 8 of the Revised Ordinances of 1880 is hereby amended, by inserting in the third line thereof, after the word "straw," the word "paper," so that said section, when so amended, shall read as follows:

"Sec. 230. No person or persons shall throw, cast or lay any ashes, offal, vegetables, garbage, dross, cinders, shells, straw, 'paper,' shavings, dirt, filth or rubbish of any kind whatever on any street, lane, alley or public place in the City of New York."

Sec. 2. All ordinances or parts of ordinances inconsistent or conflicting with the provisions of this ordinance are hereby repealed.

Sec. 3. This ordinance shall take effect immediately.

Adopted by the Board of Aldermen, June 10, 1890. Approved by the Mayor, June 12, 1890.

Resolved, That the name of James Herlihy, to whom was recently granted permission to keep and place a watering-trough at One Hundred and Seventy-fourth street and Kingsbridge road, be and it is hereby corrected and amended so as to read William H. Herlihy.

It becomes my duty as Commissioner of Public Works and custodian of the many and immense interests involved in the City's water supply, to briefly present to the people of the City the present condition of the supply, and the extreme necessity for care and economy in the use of the water.

For a number of years past and up to the present time, the old Aqueduct and the Bronx river conduit have delivered in the City all the water which they are capable of carrying, the supply thus remaining stationary when the City has been constantly growing in population, buildings, manufactures and commerce, creating new and additional demands upon the water service. The consequence is that at certain seasons of the year, notably in extreme cold weather, when the habit of wasting water from faucets to prevent freezing in the pipes prevails, and in warm and dry weather, when various methods of waste are in vogue, the daily consumption exceeds the supply which can by any possibility be received through the old Aqueduct and the Bronx river conduit, the excess of consumption being drawn from the city reservoirs, diminishing the depth of water and the pressure in the distributing mains. There is no possibility of increasing the water supply received in the City until the new Aqueduct is brought into operation, and in the meantime the only reliance for a fair and equal distribution of water throughout the city is care and economy in its use on the part of the people. Already the depth of water in the reservoirs is being diminished at the rate of one inch per day, and if this should continue for any length of time, the pressure in the distributing mains would be so reduced that it would be impossible to deliver water in thousands of houses located on high ground, and in some other locations even in the basements or cellars.

A TTENTION IS CALLED TO THE RECENT act of the Legislature (chapter 449, Laws of 1889), which provides that whenever any streets or avenues in the city, described in any grant of land under water, from the Mayor, Aldermen and Commonalty, containing covenants requiring the grantees and their successors to pave, repave, keep in repair or maintain such streets, shall be in need of repairs, pavement or repaired, and the expense thereof to be assessed on the property benefited; and whenever the owner of a lot so assessed shall have paid the assessment levied for such paving, repaving or repairing, such payment shall release and discharge such owner from any and every covenant and obligation as to paving, repaving and repairing, contained in the water grant under which the premises are held, and no further assessment shall be imposed on such lot for paving, repaving or repairing such street or avenue, unless it shall be petitioned for by a majority of the owners of the property (who shall also be the owners of a majority of the property (who shall also be the owners of a majority of the property (who shall also be the owners of a majority of the property in frontage) on the line of the proposed improvement.

The act further provides that the owner of any such lot may notify the Commissioner of Public Works, in writing, specifying the ward number and street number of the lot, that he desires, for himself, his heirs and assigns, to be released from the obligation of such covenants, and elects and agrees that said lot shall be thereafter liable to be assessed as above provided, and thereupon the owner of such lot, his heirs and assigns shall thenceforth be relieved from any obligation to pave, repair, uphold or maintain said street, and the lot in respect of which such notice was given shall be liable to assessment accordingly.

A penalty of five dollars (\$5) is hereby established, and will be imposed in each and every case where the rules and regulations of the Department prohibiting the use of water through hose, or in any other wasteful manner, are violated, and such penalties will be entered on the books of the Bureau against the respective buildings or property, and, if not collected, be returned in arrears in like manner as other charges for water.

5th. Charges for so-called extra water rents of every nature, imposed or incurred prior to June 9, 1837, will be canceled of record on the books of the Department.
