

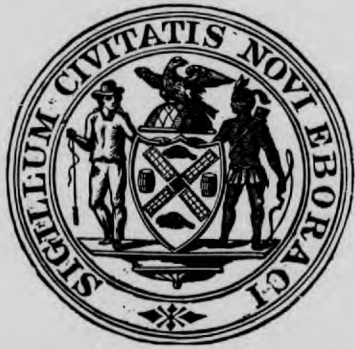

The following rules and regulations, for the management of contagious diseases, were adopted: 1st. The Summer Corps to report all cases of contagious diseases promptly each day to its Chief Inspector, giving location, name, age, sex and disease, whether isolation is allowable or removal to hospital necessary; also, to report each day the location and character of any unsanitary condition of premises needing interference by action of the Board thereon.

2d. The Chief Inspector of the Summer Corps to report daily to the Chief of the Fourth Division all cases of contagious diseases forwarded to him by the Summer Corps; also to forward to the Sanitary Superintendent all reports of unsanitary condition of premises for inspection by the First or Third Division.

3d. The Chief of the Fourth Division to cause immediate examination of all cases of contagious diseases reported to him by the Chief of the Summer Corps, to verify the diagnosis, and to determine the question of isolation or removal to hospital. Immediately after this question is determined, he shall report the result of each case to the Chief Inspector of the Summer Corps, for his further care or not, as the case may be. All measures for disinfection and supply of disinfectants for the use of patients isolated, to be promptly supplied by the Chief Inspector of the Fourth Division, and removal to hospital to be promptly done upon the decision of the Chief of the Fourth Division.

4th. The Chief of the Fifth Division to receive and care for all cases of contagious diseases removed from their domiciles to hospital.

Resolved, That the Board of Health request of the public dispensaries their co-operation in the medical attendance of the sick poor of the city in the furnishing of medicines to those too poor to buy the same, upon the prescription of and signed by the Sanitary Inspectors of the Summer Corps in their respective localities.

## Sanitary Bureau.

The following is a record of the work performed in the Sanitary Bureau for the week ending July 9, 1887:

The total number of inspections made by the Sanitary Inspectors was 4,963.

The number of complaints returned by the Sanitary Inspectors was 534.

During the past week 446 complaints were received from citizens, and referred to the Sanitary Inspectors for investigation and report.

There were issued to the consignees of vessels, to discharge cargoes on vouchers from the Health Officer of the Port, 78 permits.

There were issued to consignees, to discharge rags (in bulk, under bonds), 1 permit.

There were issued, under the Sanitary Code, 6 miscellaneous permits.

There were issued to scavengers to empty, clean and disinfect privy-sinks, 52 permits.

At premises where contagious diseases were reported, 407 visits were made, and 207 disinfections and 55 fumigations were performed.

The number of cases of contagious disease removed to Riverside Hospital was 6.

The number of vaccinations performed was 67, of which 20 were primary and 47 revaccinations.

There were seized and condemned, 24,265 pounds of meat and 10,700 pounds of fish, 10 boxes of oranges, 56 crates of tomatoes, 19 egg plants, 19 bunches of bananas, 1,875 watermelons, 9,150 pineapples.

The number of specimens of milk examined was 66, the number of analyses of same made, was 9, the number of quarts of adulterated milk destroyed was 85, and the number of arrests made was 4.

The certificates of 592 births, 69 still-births, 189 marriages, and 1,276 deaths, reported to have taken place in this city, were received by this Bureau during the week ending Saturday, July 9, 1887. This shows a decrease of 22 births and 86 marriages, and an increase of 9 still-births and 252 deaths when compared with the number received during the preceding week, but when compared with the corresponding week of the year 1886 there was an increase of 39 births, 3 marriages and 165 deaths, and a decrease of 1 still-birth. Compared with the mortality reported during the preceding week, the deaths from scarlatina decreased 3; diphtheria, 22; croup, 3; erysipelas, 1; alcoholism, 1; phthisis pulmonalis, 15; bronchitis, 3; marasmus, tabes mesenterica and scrofula, 3; hydrocephalus and tubercular meningitis, 3; cirrhosis and hepatitis, 6; premature and preterm births, 14; while the deaths from small-pox increased 3; whooping cough, 5; typhoid fever, 2; cerebro-spinal fever, 3; malarial fevers, 3; puerperal diseases, 4; diarrhoeal diseases, 163; inanition, 4; rheumatism and gout, 1; cancer, 3; pneumonia, 1; heart diseases, 1; meningitis and encephalitis, 10; convulsions, 9; direct effect of solar heat, 31; apoplexy, 3; all diseases of the brain and nervous system, 66; gastritis, enteritis and peritonitis, 26; Bright's disease and nephritis, 8; cyanosis and atelectasis, 1; suicide, 2; drowning, 2. The number of deaths from measles and aneurism was the same in the two successive weeks.

Deaths from the principal Zymotic Diseases, Phthisis Pulmonalis, Pneumonia, Bronchitis, and Children under five years of age, reported during the week and compared with the three preceding weeks.

Of the total number of deaths reported for the week, 180 were in institutions, 834 in tenement-houses, 234 in houses containing three families or less, 5 in hotels and boarding-houses, 23 in rivers, streets, boats, etc.; 14 were on the basement floor, 225 on the first, 321 on the second, 261 on the third, 180 on the fourth, 70 on the fifth, 1 on the sixth; 1,256 were stated to be residents of New York City, and 20 non-residents; 96 were stated to be single, 202 married, 107 widowed, and the condition of 871 was not stated; these were children who had not attained a marriageable age.

The total number of burial permits issued during the week are as follows, viz.: City deaths, 1,276; still-births, 69; bodies in transitu, 20; of the total burial permits issued for city and still-births, 138 were upon certificates received from the Coroners; 592 births, 189 marriages, 69 still-births, 1,276 deaths; 20 applications for transit permits were recorded, indexed and tabulated; 103 searches of the registers of births, marriages, and deaths were made, and 8 transcripts of the birth record, 8 of marriage, and 79 of death were issued during the week.

The mean temperature for the week ending July 9, 1887, was 78.9 degrees Fahr.; the mean reading of the barometer was 29.900; the mean humidity was 73, saturation being 100; the number of miles traveled by the wind was 1,252, and the total amount of rain-fall was 0.87 inch depth of water, as reported by D. Draper, Ph. D., Director of the New York Meteorological Observatory, Central Park.

The disposition of 1,200 deaths and still-births, or 89.22 per cent. of the total number reported, was in the following 14 cemeteries: Bayside (Jewish), 42; Calvary (Roman Catholic), 476; City pauper burial-ground (undenominational), 146; Greenwood (undenominational), 59; Lutheran (undenominational), 244; Cypress Hills (undenominational), 27; Evergreen (undenominational), 73; Woodlawn (undenominational), 27; St. Michael's (Protestant Episcopal), 41; Union (Methodist Protestant), 3; Holy Cross (Roman Catholic), 12; Machpelah, L. The actual mortality for the week ending July 2, 1887, was 1,212; this is 429 more than the number that occurred during the corresponding week of the year 1886, and 396 more than the average of the corresponding weeks of the past five years, and represents an annual death-rate of 42.53 per 1,000 persons living, the population estimated at 1,482,041.

The fines if unpaid will be entered as judgments upon the property of the delinquents. All good citizens will aid the course of justice, and secure reliable and respectable juries, and equalize their duty by serving promptly when summoned, allowing their clerks or subordinates to serve, reporting to me any attempt at bribery or evasion, and suggesting names for enrollment. Persons between sixty and seventy years of age, summer absentees, persons temporarily ill, and United States and District Court jurors are not exempt.

Every man must attend to his own notice. It is a misdemeanor to give any jury paper to another to answer. It is also punishable by fine or imprisonment to give or receive any present or bribe, directly or indirectly, in relation to a jury service, or to withhold any paper or make any false statement, and every case will be fully prosecuted.

#### PUBLIC NOTICE AS TO WATER RATES.

PUBLIC NOTICE IS HEREBY GIVEN THAT in compliance with the provisions of chapter 559, Laws of 1887, amending sections 350 and 921 of the New York City Consolidation Act of 1882, passed June 9, 1887, the following changes are made in charging and collecting water rents:

1st. All extra charges for water incurred from and after June 9, 1887, shall be treated, collected and returned in arrears in the same manner as regular rents have heretofore been treated.

2d. In every building where a water meter or meters are now, or shall hereafter be in use, the charge for water by meter measurement shall be the only charge against such building, or such part thereof as is supplied through meter.

3d. The returns of arrears of water rents, including the year 1887, shall be made as heretofore on the confirmation of the tax levy by the Board of Aldermen, and shall include all charges and penalties of every nature.

4th. A penalty of five dollars (\$5) is hereby established, and will be imposed in each and every case where the rules and regulations of the Department prohibiting the use of water through hose, or in any other wasteful manner, are violated, and such penalties will be entered on the books of the Bureau against the respective buildings or property, and, if not collected, be returned in arrears in like manner as other charges for water.

5th. Charges for so-called extra water rents of every nature, imposed or incurred prior to June 9, 1887, will be canceled of record on the books of the Department.

#### NOTICE TO CROTON WATER CONSUMERS.

NUMEROUS APPLICATIONS HAVE BEEN made to this Department by citizens claiming reductions or rebates on bills for water supplied through meters, on the alleged ground of leakage caused by defective plumbing and worn-out service pipes, or by willful waste of water by tenants allowing the faucets to be turned on in full force in water-closets, sinks, etc., without the knowledge or consent of the owners of the premises.

The main object of the use of water-meters is to enable this Department to detect and check the useless and unwarrantable waste of an element so valuable and essential to the health and comfort of all the citizens, and this object can only be accomplished by enforcing payment for the water wasted.

Under the law all charges for water supplied through meters are a lien against the respective premises, and the law therefore holds the owner of the premises responsible for the amount of water used or wasted.

Notice is therefore given to all householders that, in all further applications for reduction of water rents, no allowance will be made on account of waste of water occurring through leaks from defective service pipes or plumbing, or wasteful use of water by tenants or occupants of buildings, though such leakage or waste may have occurred without the knowledge or consent of the owners of the buildings.

House-owners are further notified that whenever their premises become vacant, and are likely to remain vacant, they must notify this Department in writing, and that unless this requirement is complied with no deductions in extra water rents will be allowed for any portion of one year.

Labor for removing and replacing fence, gas-lamps and gas-lamp pedestals on premises, drilling holes for pipe connections, etc., as specified.  
Labor and necessary materials for doing all specified trimming and patching about wall, and for covering the top of the catch-basin as specified.
