

**New York City Department of Correction
Annual Education Report
School Year (2022 – 2023)**

Pursuant to New York City Administrative Code §9-151, the Department is required to report on information related to adolescents and young adults located in a Department of Education facility controlled by the Department of Correction that offers educational programming to incarcerated individuals. The reporting period pertains to the 2022 – 2023 City school year (7/5/2022 – 6/27/2023).

- 1) The number of departmental infractions issued to adolescents at a Department of Education site, and the number of departmental infractions issued to young adults at a Department of Education school site, in total and disaggregated by the type of infraction, as defined by the Department:**

By October 2018, all adolescents were transferred to the custody of the Administration of Children’s Services (ACS). There were no infractions issued to young adults at a Department of Education (DOE) site during the 2022 – 2023 school year.

- 2) The number of students prevented from attending educational programming by the Department of Correction because of a behavioral issue or an assault:**

Due to behavioral concerns, 14 individuals were temporarily restricted from attending educational programming in the reporting period.

- 3) The number of assaults on staff at a Department of Education site, in total and disaggregated by whether such assault was committed by an adolescent or young adult:**

There were no reported instances of assaults on staff committed by young adults on DOE school sites for the 2022-23 school year.

¹ Class A Use of Force is a classification used to describe Use of Force Incidents that require medical treatment beyond the prescription of over-the-counter analgesics or the administration of minor first aid, including those resulting in one or more of the following treatments/injuries: multiple abrasions and/or contusions, chipped or cracked tooth, loss of tooth, laceration, puncture, fracture, loss of consciousness, concussion, suture, internal injuries (e.g., ruptured spleen, perforated eardrum, etc.), or admission to a hospital. Class B Use of Force is a classification used to describe Use of Force Incidents that do not require hospitalization or medical treatment beyond the prescription of over-the-counter analgesics or the administration of minor first aid (e.g., Use of Force Incidents that result in a superficial bruise, scrape, scratch, or minor swelling); or involve the forcible use of mechanical restraints in a confrontational situation that results in minor injury. Class C Use of Force is used to describe Use of Force incidents that result in no injury to anyone involved (e.g., incidents where the use of chemical agents results in no injury beyond irritation that can be addressed through decontamination).
