On Wednesday, July 10, 2024, a public hearing is being held by the City Planning Commission (CPC), accessible in-person and remotely, in conjunction with the above hearing to receive comments related to a Draft Environmental Impact Statement (DEIS) concerning an application by the New York City Department of City Planning (DCP). DCP is proposing a package of zoning text amendments with citywide applicability to provide a broader range of housing opportunities across the city. The Proposed Action seeks to enable more housing and wider variety of housing types in all neighborhoods citywide, from the lowest-density districts to the highest, to address the housing shortage and high cost of housing in New York City. Incremental changes across a wide geography can create a significant amount of housing and affordable housing without resulting in dramatic change to neighborhoods. To create more housing and more types of housing, the Proposed Action comprises project components in four broad categories: Medium- and High-Density proposals in R6-R10 districts and equivalents; Low-Density proposals in R1-R5 districts and equivalents; Parking proposals, which span the full range of districts and densities; and assorted other changes in line with project goals. In general, the Proposed Action would apply in underlying zoning districts, Special Districts, and other geographies that modify underlying zoning, with limited adjustments to reflect planning goals in specific areas. As such, the Proposed Action would affect all 59 community districts in the City. The analysis year is 2039.

Written comments on the DEIS are requested and will be received and considered by the Lead Agency through 5:00 P.M. on Monday, July 22, 2024.

HEALTH AND MENTAL HYGIENE

■ NOTICE

Notice of Adoption of Amendments to Title 24 of the Rules of the City of New York

In accordance with section 1043(b) of the New York City Charter, a notice of intention to amend Chapter 28 of Title 24 of the Rules of the City of New York, to prohibit the sale of flavored tobacco products, electronic cigarettes and flavored e-liquids to entities located outside of the City of New York, was published in the City Record on April 5, 2024. A public hearing was held on May 6, 2024. No one testified at the hearing, and no written comments were received. Accordingly, the Department did not substantively amend the proposed rule and now adopts such rule as indicated below.

Statement of Basis and Purpose

Section 17-715 of the Administrative Code of the City of New York (the "Code") prohibits the sale of flavored tobacco products except in tobacco bars and altogether prohibits the sale of flavored electronic cigarettes and flavored e-liquids. Such section does not identify any exception to the prohibition of sales other than the sale of flavored tobacco products in tobacco bars. However, when the Department originally promulgated section 28-02 in Title 24 of the Rules of the City of New York, it adopted a narrow reading of section 17-715 that excepted sales of such products to entities located outside of the City of New York (the "City"), in addition to excepting sales of flavored tobacco products in tobacco bars, the latter of which is consistent with section 17-715.

The Department is eliminating the exception that allows sales of flavored tobacco products, electronic cigarettes and e-liquids to entities located outside of the City. The Department's prohibition of such outside sales is motivated by several factors. First, the U.S. Food and Drug Administration (FDA) made it unlawful in 2016 to market tobacco products not authorized by the FDA, and, in 2022, made it unlawful to market non-tobacco nicotine products not authorized by the FDA. None of the flavored products covered by section 17-715 of the Code are authorized by the FDA, making the marketing of such products a violation of federal law. Second, the exception to the prohibition on sales to entities located outside of the City makes it easy for wholesalers located in the City to evade liability for illegal sales made to entities located in the City by wrongfully claiming that the sale of flavored tobacco products, electronic cigarettes and e-liquids is meant for out-of-City buyers. Finally, the adopted interpretation of section 17-715 better conforms to the letter and intent of such law, which makes no explicit exception for outside sales.

Statutory Authority

These rules are promulgated pursuant to the authority of DOHMH established in Charter sections 389, 556, and 1043.

The adopted rules are as follows.

Section 1. Section 28-02 of Title 28 of the Rules of the City of New York is amended to read as follows:

§ 28-02 Sale or Offer for Sale of Flavored Tobacco Products, Flavored Electronic Cigarettes, and Flavored E-Liquids Restricted.

(a) Only the following entities may sell or offer for sale flavored tobacco products:

(1) Tobacco bars; and

(2) Tobacco wholes alers, but only where the sale or offer of sale is made to a tobacco bar [or to an entity located outside the City of New York].

(b) [Flavored] <u>The sale of flavored</u> electronic cigarettes and flavored e-liquids [may only be sold or offered for sale by wholesalers where the sale or offer of sale is made to an entity located outside the City of New York] <u>is prohibited</u>.

(c) Tobacco products that do not impart a characterizing flavor other than menthol, mint, and wintergreen are not subject to the restriction on sale set forth in § 17-715 of the Administrative Code or these rules, and may lawfully be sold by any retail dealer or wholesale dealer licensed to sell tobacco products, regardless of whether such sale occurs to or in a tobacco bar.

Notice of Adoption

A notice of public hearing and opportunity to comment on a proposal by the NYC Department of Health and Mental Hygiene ("Department") to create a new Chapter 37 in Title 24 of the Rules of the City of New York was published in the City Record on January 19, 2024. A virtual public hearing was held on February 22, 2024. No one testified at the hearing and no written comments were received on the proposal. The Department has not made any substantive changes to the proposed rule and now adopts the rule as provided below.

Statement of Basis and Purpose of Proposed Rule

In accordance with Charter § 1043(g), any person may petition an agency to consider the adoption of any rule and each agency is to prescribe by rule the procedure for submission, consideration and disposition of such petitions. Chapter 37 provides procedures for how the public may petition the Department to amend, adopt or delete a rule promulgated by this Department.

Statutory Authority

These rules are promulgated pursuant to Charter §1043(g).

The adopted rules are as follows.

RESOLVED, that Title 24 of the Rules of the City of New York is amended by adding a new Chapter 37 to read as follows:

Chapter 37

Petitioning the Department to Commence Rulemaking

- <u>§ 37.01</u> Definitions.
 - (a) <u>Department means the New York City Department of Health</u> and Mental Hygiene.
 - (b) Petition means a request or application by a member of the public for the Department to create, amend or repeal a rule promulgated by the Department.
 - (c) Petitioner means the person who submits a petition.
 (d) Rule shall have the meaning set forth in § 1041(5) of the New York City Charter ("Charter") and, for the purposes of this Chapter, means only those provisions of law contained in, or to be contained in, Title 24 of the Rules of the City of New York with numerical Chapter headings and also known as Commissioner of Health Regulations ("Commissioner Regulations"). For the purposes of this Chapter, rule does not include any provision of the New York City Health Code.

<u>§ 37.03</u> <u>Scope.</u>

This Chapter governs the procedures by which the public may petition the Department to commence rulemaking of Commissioner Regulations pursuant to § 1043(g) of the Charter.

<u>§ 37.05</u> Procedures for Submitting Petitions; Responses to Petitions.

- (a) Any person may petition the Department to consider the adoption, amendment or repeal of a rule. The petition must be in writing and must contain the following information:

 (1) The rule to be considered, including proposed language for adoption;
 - (2) A statement as to the purpose of the rule, amendment

or repeal and the Department's authority to promulgate the rule;

- (3) Petitioner's argument(s) in support of adoption of the rule, amendment or repeal.
- (4) The period of time the rule should be in effect, if applicable;
- (5) Whether the person submitting the petition represents another individual or an organization;
- (6) <u>The name, address and telephone number of the</u> petitioner or his or her authorized representative;
- (7) The signature of petitioner or their representative.
- (b) Illegible petitions will not be accepted.
- (c) All petitions must be delivered to the office of the Secretary to the Department by mail, courier, facsimile, electronic mail or online.
- (d) The petitioner must promptly communicate any changes in the information required by this section in writing to the office of the Secretary to the Department.
- (e) Upon receipt of a petition submitted in the proper form, the Secretary to the Department will stamp the petition with the date it was received and assign the petition a number and a date-stamped receipt with the petition number shall be sent to the petitioner. The Secretary will forward the petition to the Commissioner and appropriate staff of the Department for their review.
- (f) Within sixty (60) days from the date the petition is properly received by the Secretary to the Department, the Commissioner will either deny such petition in a written statement to the petitioner containing the reasons for denial, or state in writing to the petitioner the intention to grant the petition and to initiate rulemaking on the subject matter by a specified date. In all cases where the Commissioner has granted a petition to initiate rulemaking, the Department is not bound by any specific language proposed by the petitioner.
- (g) The Commissioner's decision to grant or deny a petition will be a final decision which is not subject to judicial review pursuant to § 1043(g) of the Charter.

- (A) This restriction shall not apply to a new transfer station that is located at or adjacent to a rail yard, rail spur, industrial track or vessel facility, provided that at least ninety percent of the solid waste received is subsequently transported from the transfer station by rail or vessel.
- (B) Any new transfer stations operating a truck-to-truck facility must obtain a corresponding reduction (offset) in the lawful daily permitted throughput capacity at a transfer station within the same community district at a rate of one ton for every new ton of capacity. Such reduction must be of the same type of solid waste (putrescible for putrescible, construction and demolition debris for construction and demolition debris, or fill material for fill material).
- (C) Any application for a new putrescible or construction and demolition debris transfer stations located at or adjacent to a rail yard, rail spur, industrial track or vessel facility, and where at least ninety percent of the solid waste received is subsequently transported from the transfer station by rail or vessel, must obtain a corresponding reduction (offset) in the lawful daily permitted throughput capacity at a putrescible or construction and demolition debris transfer station within the same community district at a rate of one ton for every new ton of capacity.
- (D) Any transfer station that is lawfully operating that is located at least 500 feet from a residential district, hospital, public park or school may increase its lawful daily permitted throughput capacity only if such owner/operator obtains a corresponding reduction (offset) in the lawful daily permitted throughput capacity at a transfer station located in the same community district at a rate of one ton for every new ton of capacity. Such reduction must be of the same type of solid waste (putrescible for putrescible, construction and demolition debris for construction and demolition debris, or fill material for fill material).
- (E) Any putrescible or construction and demolition debris transfer station that is lawfully operating at or adjacent to a rail yard, rail spur, industrial track or vessel facility where at least ninety percent of the solid waste received is subsequently transported from the transfer station by rail or vessel, may increase its lawful daily permitted throughput capacity provided that the owner/ operator obtains a corresponding reduction (offset) in the lawful daily permitted throughput capacity at a putrescible or construction and demolition debris transfer station within the same community district at a rate of one ton for every new ton of capacity.
- (F) Any transfer station that is lawfully operating may increase its lawful daily permitted throughput capacity, subject to Department review and approval, provided that it is located at least 500 feet from a residential district, hospital, public park or school. This restriction shall not apply to a transfer station that is located at or adjacent to a rail yard, rail spur, industrial track or vessel facility, provided that at least ninety percent of the solid waste received is subsequently transported from the transfer station by rail or vessel.
- (G) Any transfer station that is lawfully operating may increase its lawful daily permitted throughput capacity, subject to Department

review and approval, provided that it is located at least 400 feet from a residential district, hospital, public park or school. This restriction shall not apply to a transfer station that is located at or adjacent to a rail yard, rail spur, industrial track or vessel facility, provided that at least ninety percent of the solid waste received is subsequently transported from the transfer station by rail or vessel.

(H) Any new transfer station shall not be located in an M1 district if the M1 districts in such community district cumulatively contain three or more lawfully operating transfer stations.

Notice of Final Scope of Work Targeted Draft Environmental Impact Statement Proposed Redevelopment of the former St. John Villa Campus, Staten Island

On behalf of the New York City Department of Education (NYCDOE), the New York City School Construction Authority (NYCSCA) proposes to create three new schools, an athletic field with an approximately 700 seat bleacher section, a maintenance building, an internal driveway network, and a parking lot on the former St. John Villa campus at 57 Cleveland Place in the Arrochar section of Staten Island, NY. The three new schools would consist of an approximately 764-seat Gifted and Talented primary school/intermediate school (PS/IS) and two separate, independently operated, approximately 627-seat intermediate/high schools (IS/HS). The two IS/HS schools would also contain 96 seats for a District 75 program and share a gymatorium, auditorium, kitchen and lobby. The proposed PS/IS would serve students in grade levels pre-kindergarten through eight throughout New York City. Each IS/HS school would serve students in grade levels six through twelve in the Borough of Staten Island. All three schools would also serve special education students enrolled in a District 75 program in the Borough of Staten Island. Construction would be phased beginning in Q4 2024 and would conclude in Q3 2030. Therefore, 2030 is assumed for the analysis year.

The Final Scope of Work (FSOW) to Prepare a Targeted Draft Environmental Impact Statement (DEIS) is available on the SCA website at https://www.nycsca.org/Community/New-School-Sites.

The Draft Scope of Work (DSOW) to Prepare a Targeted DEIS was originally published on February 21, 2024, and discussed during a March 7, 2024 virtual public scoping meeting and a second public scoping meeting held as a hybrid event (i.e., simultaneously in-person and virtual) on May 16, 2024. The FSOW to prepare a Targeted DEIS includes responses to comments received during both public scoping meetings as well as written comments accepted through the close of the public comment period, which ended at 5:00 P.M. on June 3, 2024.
