

To the Honorable the Common Council of the City of New York:

GENTLEMEN—The undersigned, property owners, tradesmen and residents of the Ninth, Fifteenth and Sixteenth Wards of this city, respectfully petition that the block of ground bounded by Gansevoort, Little West Twelfth, Washington and West streets, known as part of the "Fort Gansevoort property," be set apart as a depot for farmers' wagons, for the sale of garden pr duce by market gardeners.

Your petitioners respectfully represent that the market gardeners have at present no fixed or permanent stand, and their locations are continually changing, to the great detriment of their business. This is unjust, as the tax paid by them is a large source of revenue to the city, and their interests should be protected by the city authorities. Having regular customers among the retail tradesmen of the city, the continual shifting of their stations entails great injury and loss, not only upon them but upon those who deal with them.

The "Fort Gansevoort property," so called, is a valuable property, is owned by the city, and no revenue is at present derived from it. Should it be selected as a depot for this purpose, and a permanent stand thereby secured, the number of market wagons doing business in the city will be largely increased, and the revenue derived by the city from this source be greatly augmented.

The location is a desirable one for this business, being situated about midway between the Battery and Fifty-ninth street. The possible objection that it is too far west is met by the statement that there is no suitable plot on the east side of the city where these wagons could be stationed, and that the retail grocers and others on the east side are supplied in the neighborhoods of Twenty-third street and Thirty-fourth street ferries by the Long Island farmers who croos those ferries.

AN ORDINANCE, to amend chapter XLV of the ordinances o 1866, entitled "Of nuisances and noxious things and practices."

The Mayor, Aldermen and Commonalty of the City of New York, do ordain as follows:

Sec. 1. Chapter XLV of the ordinance of 1866, is hereby amended by adding thereto a new section as follows:

section as follows:

SEC. 57. No person shall sell or expose for sale in any street, avenue, or public place in the City of New York, in any wagon or other vehicle, saw-dust, or any like light substance, unless such saw-dust or other light material shall be inclosed in bags, so that, in windy weather it shall not be blown or scattered over or upon any of the streets or sidewalks of this city, or persons travelling thereon, under a penalty of ten dollars for every oftence to be imposed as provided in sections 20 and 21 of an act of the Legislature relative to the powers of the Common Council of the City of New York, and the Criminal Courts of said city, passed January 23, 1833, and the provisions of section 5, of article 4, of an act in relation to the Police Department of the City of New York, passed April 13, 1853.

SEC. 2. All ordinances or parts of ordinances inconsistent or conflicting with the provisions of this ordinance are hereby repealed.

SEC. 3. This ordinance shall take effect immediately.

Hon. SMIT H ELY, JR., Mayor of the City of New York:

Sire—I beg leave to call your attention to the great embarrassment and obstruction which occurs to the business of street cleaning by reason of the multitude of vehicles which are standing in the paved streets of the city without teams attached. The pavements under and around them cannot be cleaned, and the sweepers have not the physical power to remove them for the purpose of cleaning the area which they occupied; and if they had, the removal of eighteen thousand vehicles at each cleaning, and the restoration of them to their former positions, would call for a large increase of the street sweeping force, and add no small sum to the already large expenditure for street cleaning.

The number of vehicles referred to was counted on Friday night, and numbered (18,765) eighteen thousand seven hundred and sixty-five. The numbers were counted again on Sunday, during the day, and found to be (18,690) eighteen thousand six hundred and ninety.

Schedules herewith inclosed will exhibit the locations and distribution of the vehicles by Precincts.

Numbers of these vehicles are not in constant use, and are, no doubt, a street incumbrance,

which should be dealt with by the Bureau of Street Incumbrances.

You are repectfully requested to consider this matter as one affecting permanently the interests of the city, and to suggest such legislation and any modification of the ordinances of the Common Council as shall be, in your judgment, calculated to afford remedy, and to call upon the Bureau of Incumbrances to take measures to mitigate this nuisance as far as it shall exist in violation of the city ordinances.

To build tugs by contract under the restrictions of section 91 of the Charter would cost largely

more than to buy them in open market; and besides, one tug is wanted now, and it would take six to nine months to build one.

The purpose is to buy one now, which can be had very cheap, and a second whenever the second tug now on hand shall fail.

The number of reports thereon received from the Inspectors was 559.

During the past week 79 complaints have been received from citizens, and referred to the Sanitary and Assistant Sanitary Inspectors for investigation and report.

Permits were issued to the consignees of 46 vessels to discharge cargoes, on vouchers from the Health (Miscar of the Port.)

36 permits were granted scavengers to empty, clean, and disinfect privy-sinks.

The Disinfecting Corps have visited 60 premises where contagious diseases were found, and have disinfected and fumigated 55 houses, 55 privy-sinks, together with clothing, bedding, etc.

During the week ending January 19, 1878, there were issued from this Bureau 489 burial permits for city deaths, 26 for bodies in transitu, and 31 for the interment of still-born infants. There were recorded 489 deaths, 131 marriages, 580 births, 31 still-births, 26 applications for transit permits, and 48 returns from coroners. There were 24 searches of the registers of births, marriages, and deaths, and 2 transcripts of birth record, 2 of marriage, and 19 of death were issued from this Bureau.
