

关于发送停止收债沟通函的说明

根据纽约市和联邦法律,消费者可随时要求收债人永久停止就所欠债务或声称债务与其联系。此外,如因冠状病毒 (COVID-19) 危机而面临财务困难,您可以要求收债机构暂停就所欠债务与您联系*。

请完整填写随附表格信函,并将其邮寄给与您联系的收债机构。(随附信函填写步骤。)请保留一份副本备用。收债人在收到该信函后直到纽约市的紧急状态解除前,不能再与您联系,但少数几种特殊情况除外。如果他们继续与您联系,请致电 311 或访问 <u>nyc.gov/consumers</u> 向消费者事务局 (Department of Consumer Affairs, DCA) 提出投诉(需提供一份您之前发送的信函副本)。

*重要须知:

- 如果您不知道收债人的名称或地址,请查看以往的对账单、询问给您打电话的收债人或者通过其留下的语音邮件查找公司名称。
- 请访问 <u>nyc.gov/consumers</u> 查阅 DCA 收债指南,以了解收债人与您联系时您所享有的权利。
- 如果收债人就您并不知悉、自认为未拖欠或已全额偿还的声称债务与您联系,则您应要求收债人将 声称债务的书面证明发送给您。
- 由于 COVID-19 危机,某些债务获准暂停支付,并且无需支付罚款;请与您的债权人或贷款服务机构(并非收债人)联系,以了解债务状况。
- 要求收债人停止就所欠债务或声称债务与您联系,并不意味着收债人必须停止收债活动,包括与债权人合作就债务提起诉讼或向消费者报告机构报告。
- 如果您在管理债务或给债权人写信方面需要帮助,请通过 <u>nyc.gov/TalkMoney</u> 预约免费电话财务咨询服务。
