Introduction

Lobbying in the City of New York is governed by Administrative Code §§ 3-211 through 3-223 and Chapter 1 of Title 51 of the Rules of the City of New York (collectively, the "Lobbying Law.") This is the seventeenth annual report issued by the Lobbying Bureau (the "Lobbying Bureau") of the Office of the City Clerk (the "City Clerk") pursuant to § 3-212(c) of the Administrative Code of the City of New York (the "Administrative Code"), the text of which follows:

The city clerk shall prepare and post on the internet an annual report relating to the administration and enforcement of the provisions of this subchapter. Such report shall contain information regarding (i) the number of complaints received from the public and the disposition of such complaints; (ii) the number and amount of civil penalties imposed pursuant to subdivisions (a), (b), (c) and (d) of section 3-223 of this subchapter; (iii) the number and duration of orders issued pursuant to subdivision (a) of section 3-223 of this subchapter; (iv) the number of random audits conducted by the city clerk and outcomes thereof; (v) compliance programs developed and implemented for lobbyists and clients; (vi) the types and number of requests for assistance related to the lobbying law received by the city clerk, and, as soon as practicable, the average response and resolution times of such requests; (vii) the number of lobbyists filing statements of registration pursuant to section 3-213 of this subchapter for the first time; (viii) the subject matter of lobbying activity most frequently reported by lobbyists; (ix) the lobbying targets most frequently reported by lobbyists; (x) the lobbyists that received the highest compensation; and (xi) such other information and analysis as the city clerk deems appropriate. Such report shall be posted on the internet no later than March first of each year and shall contain information relating to the preceding calendar year.

Listed hereafter is the information required by the Administrative Code for calendar year 2022.

(i) Number of complaints received from the public and the disposition of such complaints.

In 2022, the Lobbying Bureau did not receive any complaints from the public regarding possible violations of the Administrative Code.

(ii) Number and amount of civil penalties imposed pursuant to subdivisions (a), (b), (c) and (d) of § 3-223 of the Administrative Code.

Violators of the Lobbying Law are subject to the penalties detailed in Administrative Code § 3-223 *et seq.* Pursuant to Administrative Code § 3-223(a), the penalties for knowing and willful violations of the Lobbying Law include: a civil penalty not to exceed \$30,000; the issuance of a cease and desist order; or both a civil penalty and a cease and desist order. Pursuant to Administrative Code § 3-223(b), violators are subject to a civil penalty not to exceed \$30,000 for violating a cease and desist order or for violating the proscription against contingency agreements. In addition to penalties for any late filing, pursuant to Administrative Code § 3-223(c), violators may be subject to a civil penalty, not to exceed \$20,000, if a violation is not cured. Lastly, for any violation of the Lobbying Law not covered in the foregoing provisions, pursuant to Administrative Code § 3-223(d), violators may be subject to a civil penalty not to exceed \$20,000, if a violation is not cured.

Listed below are the late filing and civil penalties¹ incurred for each reporting period as of February 25, 2023.

2021 Reports (Client Annual Reports, Sixth Periodic Reports and Sixth Periodic Fundraising and Political Consulting Reports)

The Lobbying Bureau identified 38 Lobbyists² that failed to timely file an aggregate of 48 sixth periodic/annual reports³ for 2021. For this failure, such Lobbyists incurred \$11,425.00 in aggregate late filing penalties. (See <u>Appendix A</u> attached hereto.)

The Lobbying Bureau identified two Lobbyists who failed to timely file four fundraising and political consulting reports. For this failure, such Lobbyists incurred \$3,562.50 in aggregate late filing penalties. (See <u>Appendix B</u> attached hereto.)

The Lobbying Bureau identified 254 late client annual reports. For this failure, such clients incurred \$70,282.50 in aggregate late filing penalties. (See <u>Appendix C</u> attached hereto.)

No civil penalties were warranted for the late filing of the above-listed reports.

2022 Statements of Registration and Periodic Reports

The Lobbying Bureau identified 82 Lobbyists who failed to timely file an aggregate of 153 statements of registration. For this failure, such Lobbyists incurred \$60,480.00 in aggregate late filing penalties. (See <u>Appendix D</u> attached hereto.) No civil penalties were warranted in connection with such failures.

One hundred and ninety-nine Notices to Cure were sent to Lobbyists who failed to timely pay registration fees or submit retainer agreements or amended retainer agreements. The Lobbyists cured such failures either by paying the fees or submitting the retainers. No civil penalties were warranted in connection with such failures.

The Lobbying Bureau identified 42 Lobbyists who failed to timely file an aggregate of 60 first periodic reports. For this failure, such Lobbyists incurred \$5,785.00 in aggregate late filing penalties. (See <u>Appendix E</u> attached hereto.)

The Lobbying Bureau identified 34 Lobbyists who failed to timely file an aggregate of 35 second periodic reports. For this failure, such Lobbyists incurred \$5,725.00 in aggregate late filing penalties. (See <u>Appendix F</u> attached hereto.)

The Lobbying Bureau identified 21 Lobbyists who failed to timely file an aggregate of 33 third periodic reports. For this failure, such Lobbyists incurred \$4,537.50 in aggregate late filing penalties. (See <u>Appendix G</u> attached hereto.)

The Lobbying Bureau identified 41 Lobbyists who failed to timely file an aggregate of 129 fourth periodic reports. For this failure, such Lobbyists incurred \$17,955.00 in aggregate late filing penalties. (See <u>Appendix H</u> attached hereto.)

The Lobbying Bureau identified 31 Lobbyists who failed to timely file an aggregate of 58 fifth periodic reports. For this failure, such Lobbyists incurred \$4,250.00 in aggregate late filing penalties. (See <u>Appendix I</u> attached hereto.)

2022 Fundraising and Political Consulting Reports

The Lobbying Bureau identified 2 Lobbyists who failed to timely file a total of 4 fundraising and political consulting reports. For this failure, such Lobbyists incurred \$3,362.50 in aggregate late filing penalties. (See <u>Appendix J</u> attached hereto.)

No civil penalties were warranted for the late filing of fundraising and political consulting reports.

2022 Termination Notices

Ninety-eight Notices to Cure were sent to Lobbyists and 407 Notices to Cure were sent to clients who failed to timely file termination notices. The filers cured such failures either by filing the missing termination notice or extending the lobbying contract. Four clients failed to timely cure. For this failure, such clients incurred \$966.57 in aggregate late filing penalties. (See Appendix K attached hereto)

(iii) Number and duration of orders issued pursuant to subdivision (a) of § 3-223 of the Administrative Code.

None.

(iv) Number of random audits conducted by the city clerk and outcomes thereof.

The Lobbying Bureau selected 45 Lobbyists for audit in 2022. The 2022 audits encompass an examination of all filings made in 2021 by the 45 randomly selected Lobbyists and associated clients to determine if such filings were complete, accurate, timely filed and otherwise in compliance with the Lobbying Law. The audits resulted in 74 findings and 74 required actions. Samples of audit findings included: reporting incorrect compensation and expenses; reporting incorrect subject category; failing to report all lobbying activity; failing to file termination notices; failing to upload amended retainer agreements; failing to properly describe subject details; failing to report targets and contact names; reporting incorrect targets; failing to report addresses of subject property; inadvertently listing the names of children of lobbying employees in the statement of registration; and failure to list employees on authorization letter. Samples of required

actions included: correcting compensation and expense amounts; reporting correct subject category; reporting all lobbying activity; filing termination notices; uploading amended retainer agreements; amending reports to properly describe subject details; reporting targets and contact names; reporting correct targets; reporting subject addresses; removing the names of children of lobbying employees from the statement of registration; and listing employees on authorization letter.

(v) Compliance programs developed and implemented for lobbyists and clients.

The Lobbying Bureau works with filers⁴ to improve compliance with the Lobbying Law in a variety of ways including training, outreach and other educational efforts. In addition, the Lobbying Bureau receives numerous telephone and e-mail inquiries throughout the year for: providing assistance with filing reports; answering questions regarding requirements of the Lobbying Law; and providing technical assistance with e-Lobbyist. See (vi) The types and number of requests for assistance related to the lobbying law received by the city clerk for further information. Responding to these questions and requests for assistance continues to be an integral part of the Lobbying Bureau's daily functions.

Amendment of Rules

In 2022, the Lobbying Bureau worked with the Law Department to amend Chapter 1 of Title 51 of Rules of the City of New York to remove paragraphs 2 and 3 of subdivision (c) of section 1-11 which granted lobbyists and clients an automatic extension when a filing was late due to the client's or the lobbyist's failure to enroll in e-Lobbyist. The extension remained in place until two days after the client or the lobbyist enrolled in e-Lobbyist. The automatic filing extension was unlimited and left room for potential misuse, and accordingly the amended rule removed it.

The amended rule was proposed and published in the City Record on July 15, 2022. The required public hearing was held on August 18, 2022. The Notice of Adoption was published in the City Record on October 6, 2022. Pursuant to the Citywide Administrative Procedure Act, the rule became effective November 6, 2022.

Training

Pursuant to the Administrative Code, Lobbyists must complete the mandatory training biennially. If a Lobbyist registers thirty or more clients and lists five or more lobbying officers or employees, then two officers or employees, one of whom must have lobbied in the prior year, must complete the training.

In 2022, in connection with the mandatory training program, the Lobbying Bureau conducted 9 trainings with approximately 271 attendees. Three lobbyist training sessions and 6 lobbyist/client filer training sessions were held. Each session included a detailed overview of the requirements of the Lobbying Law and provided in-depth instructions on filing reports in e-Lobbyist. Sessions were held remotely via Zoom and/or Microsoft Teams platforms. Ninety-eight filers opted to fulfill the training program via pre-recorded video. In 2022, the Lobbying Bureau expanded our enforcement efforts to ensure that first time filers were trained within fifteen days of commencing lobbying activities. Filers were emailed a training video and advised of the mandatory training requirement upon their enrollment in the e-Lobbyist system.

Eleven Notices to Cure were served in connection with the failure of Lobbyists to attend mandatory training. Ten of the Lobbyists cured by completing training. One Lobbyist failed to timely cure and enforcement proceedings are pending.

Outreach Efforts

Notification to Recipients of Discretionary Funds under the City Council Fiscal Year 2023 Adopted Expense Budget - Schedule C

The Lobbying Bureau sent approximately 1,889 emails to entities that received discretionary funding from the City Council for fiscal year 2023 that were not registered New York City Lobbyists. Enclosed with the email was a summary of the Lobbying Law. The email alerted entities to the Lobbying Law and encouraged them to review their activities and related compensation and expenses to determine whether or not they were required to comply. The Lobbying Bureau received numerous telephone and email inquiries as a result of this outreach effort.

Comparison of New York City and New York State Lobbying Reports

The Lobbying Bureau continued its efforts to uncover unreported City lobbying in 2022 by comparing 6,777 statements of registration filed with the New York State Commission on Ethics and Lobbying in Government ("CELG")⁵ with statements of registration filed with the Lobbying Bureau as of August 22, 2022.

In total, 55 entities reported lobbying City targets with CELG but did not file a statement of registration with the Lobbying Bureau. As a result, the Lobbying Bureau sent notices to these entities. Forty-eight entities submitted affidavits affirming that they were not required to file statements of registration because: (1) the entity inadvertently listed a New York City target on the CELG statement of registration when no City lobbying took place; or (2) the entity did not exceed the \$5,000 reporting threshold for City lobbying. Three entities filed the required reports and paid late filing penalties. Enforcement proceedings are pending for four entities.

Other Compliance Efforts

The Lobbying Bureau examines reports filed on e-Lobbyist to determine the accuracy of the information contained in the statements of registration, retainer agreements and periodic reports. In 2022, the Lobbying Bureau reviewed approximately 2,868 retainer agreements filed by lobbyists to ensure that the retainer agreements complied with the Lobbying Law.

Retainer Issues

All retainer agreements must contain: (1) the compensation payable to the Lobbyist; (2) the client's name; (3) the terms of any third-party payments for the lobbyist's services; and (4) the duration of the term of representation, including the specific start date. *See* Chapter 1 of Title 51 of the Rules of the City of New York § 1-08. The Lobbying Bureau identified approximately 121 statements of registration which contained retainer issues including: (1) failure to include a full force and effect letter, (2) failure to upload the original retainer with the amended retainer, and (3) uploading the wrong retainer. Non-compliant Lobbyists were contacted and required to correct the retainer issues within the cure period. Five Notices to Cure were served on 4 Lobbyists. The Lobbyists cured the retainer issues and no civil penalties were imposed.

Date Issues

In order to resolve date discrepancies, the Lobbying Bureau cross-checked start and end dates listed on the statements of registration with the corresponding retainer agreements contained in e-Lobbyist. The Lobbying Bureau identified approximately 123 statements of registration which contained issues with start and end dates in Lobbyists' filings by comparing the dates on the statements of registration with the dates listed on the related retainer agreements. Lobbyists were instructed to cure by amending either the date on the statement of registration or the date on the corresponding retainer agreement. Five Notices to Cure were served on four Lobbyists. The Lobbyists cured the date issues and no civil penalties were imposed.

Entity Name Issues

In order to resolve entity name discrepancies, the Lobbying Bureau cross-checked client names listed on the statements of registration and retainer agreements with the client enrollment name. The Lobbying Bureau identified 54 statements of registration which contained entity name issues. Notices to Cure were served on 4 Lobbyists for a total of 5 entity name issues. The Lobbyists were instructed to cure by: (1) filing an amended statement of registration with an amended retainer agreement listing the correct name; or (2) enrolling the new entity and filing reports under the new entity name. The Lobbyists cured the entity name issues and no civil penalties were imposed.

(vi) The types and number of requests for assistance related to the lobbying law received by the city clerk.

In 2022, the Lobbying Bureau recorded its activities and the types and number of requests received.⁶ From January 1, 2022 through December 31, 2022, the Lobbying Bureau's time was allocated as follows: compliance 50%, audits 29%, enforcement 10%, e-Lobbyist assistance 6%, outreach/training 4% and investigations 1% (see page 38).⁷ In addition, the Lobbying Bureau received approximately 721 telephone calls (see pages 39-41) and 6,758 email requests (see pages

<u>42-44</u>). The majority of telephone calls consisted of compliance inquiries. The majority of emails involved filers requesting technical assistance in completing an e-Lobbyist enrollment.

(vii) The number of lobbyists filing statements of registration pursuant to § 3-213 of the Administrative Code for the first time.

In 2022, 82 Lobbyists filed statements of registration for the first time. This is a 91% increase from the previous year. Forty-two of these entities are lobbyists and 40 entities are lobbyist/client filers. The 40 lobbyist/client filers' industry categories were reported as follows: 8 public, community interest and not-for-profit organization; 5 transportation; 5 banking and financial services; 3 education; 4 health and mental hygiene; 3 technology, telecommunications and other media; 3 real estate, construction, engineering & developer; 3 environment and natural resources; 3 entertainment and sports; 2 labor; and 1 trade association.

(viii) The subject matter of lobbying activity most frequently reported by lobbyists and lobbyist/client filers.

(xi) Other information and analysis.

Number of Reporting Lobbyists and Clients

For calendar year 2022, approximately 610 Lobbyists filed statements of registration on behalf of 2,265 clients⁸. Such Lobbyists paid approximately \$200,850 in registration fees.

Outlook For 2023

In 2023, the Lobbying Bureau will remain focused on compliance and enforcement of the Lobbying Law. The Lobbying Bureau will continue to: (1) fulfill its statutory mandates; (2) confirm the veracity of reports filed by Lobbyists and clients; (3) check information contained in the reports to verify the accuracy of the filings and resolve any discrepancies; (4) respond to requests for guidance and interpretations of the Lobbying Law; (5) conduct random audits; and (6) investigate unreported lobbying. The Lobbying Bureau intends to focus additional efforts on enforcing late amendments and drafting advisory opinions on emerging areas of the law.

In the upcoming year, the Lobbying Bureau expects to collaborate with the NYC Office of Technology and Innovation ("OTI")⁹, and other city agencies, to develop and work towards implementing a new e-Lobbyist system.

The Lobbying Bureau, in conjunction with OTI, will continue to make information available via NYC Lobbyist Search, the public database of filings. The enhanced lobbyist search has enabled the Lobbying Bureau to further its mission of increasing transparency in government and allowed requests for information to be fulfilled more efficiently.

Analysis of Lobbying Data¹⁰

Each year the Lobbying Bureau analyzes the available data and reports on various macro and micro trends in City lobbying. In addition, the Lobbying Bureau receives many requests for information about City lobbying activity from the media and government watchdog organizations. In order to facilitate the transparency goals of the Lobbying Law, and in response to requests for







COMPARISON OF COMPENSATION OF TOP LOBBYISTS FROM 2019-2022*







COMPARISON OF TOTAL CLIENTS OF TOP LOBBYISTS FROM 2019-2022*







TOP TEN LOBBYIST/CLIENT FILERS OF 2022 BY COMPENSATION




COMPARISON OF LOBBYIST/CLIENT FILERS' COMPENSATION FROM 2019-2022*





DISTRIBUTION OF CLIENTS' INDUSTRIES IN 2022





DISTRIBUTION OF SUBJECT CATEGORIES OF 2022*








ANALYSIS OF FUNDRAISING REPORTS 2022



ANALYSIS OF LOBBYING BUREAU STAFF TIME BY SUBJECT CATEGORY




DISTRIBUTION OF TELEPHONE INQUIRIES BY SUBJECT CATEGORY




DISTRIBUTION OF EMAIL INQUIRIES BY SUBJECT CATEGORY
