

The following communications were received, read, and, On motion, laid on the table to await action, as stated, to wit : From Comptroller of the City—In reference to site for market purposes for the West Washing-ton Market Association, and enclosing copy of the petition presented to the Commissioners of the Sinking Fund, in relation thereto, and requesting information as to the views of the Commissioners ot Docks on the subject. Booth & Edgar, on terms and conditions to be 'thereafter agreed upon, be and hereby is rescinded and annulled to take effect on February I proximo, and that the Dock Master within whose district said bulkhead is situated, be notified hereof.

SIR—There were 627 deaths reported to have occurred in this city during the week ending Saturday, February 9, 1884, which is an increase of 43, as compared with the number reported the preceding week, and 9 more than were reported during the corresponding week of the year 1883. The actual mortality for the week ending February 2, 1884, was 557, which is 105.0 below the average for the corresponding week for the past five years, and represents an annual death-rate of 21.60 per 1,000 persons living, the population estimated at 1,340,865.

A T 9.30 P. M. ON THURSDAY THE 15TH instant, the aqueduct had to be shut off to repair a large leak that could not be repaired in the usual manner from the exterior. This leak had suddenly devoloped in the section south of Yonkers, where smaller fissures had previously occurred. The examination showed fissures aggregating 2,000 feet in length. The repairs were finished and water was again turned on by 4.9. M., on Saturday, the 17th instant. While the flow through the aqueduct was interrupted the supply in the Central Park reservoir was drawn down five eet.

The supply in the Central rare reservoirs, accurring five eet. This loss of supply in the city reservoirs, occurring now, as winter is approaching, makes it necessary to take extra precautions against waste of water. Being aware of the temptation to leave faucets open in cold weather to prevent freezing in the pipes, I specially protest against that practice, and appeal to all citizens to abstain from wasteful use of water in any manner whatever. The present condition of the supply and the possibility of a recurrence of similar leaks in the aqueduct make it my duty to give this public notice that I shall hereinafter resort to the peremptory measure of shutting off the water in all places where persistent waste is discovered.
