# Department of Environmental Protection Announces Promotion of 16 Veteran Members of its Police Division

The New York City Department of Environmental Protection today announced the promotion of 16 environmental police officers. The veteran officers were promoted March 9 during a ceremony at the Staff Sgt. Robert H. Dietz DEP Police Academy in Kingston, NY.

The DEP Police Division was established more than 100 years ago. Its 220 members are charged with protecting 19 reservoirs, three controlled lakes, more than 185,000 acres of watershed land, roughly 300 miles of aqueducts, 29 water supply dams, 57 bridges, seven wastewater treatment plants, and more than 280 shafts, chambers, laboratories and treatment facilities that help the water system function. These facilities and lands stretch across parts of eight counties and roughly 2,000 square miles of watershed. DEP Police patrol the watershed by foot, bicycle, all-terrain vehicle, boat and helicopter. They also maintain specially trained units, including a Detective Bureau, Emergency Service Unit, Canine Unit and Aviation Unit.

The following lieutenants were promoted to the rank of captain:

 Capt. Robert Flynn was appointed to the DEP Police in June 1993, and began his career on patrol out of the Beerston Precinct. He transferred to the then Neversink Precinct in 1995. In December 1997 he was promoted to sergeant in charge of the Environmental Enforcement Unit for the west-of-Hudson area. He was promoted to lieutenant in January 2003, commanding the newly formed Detective / Intelligence Division and has served with the division since its inception.

- Capt. Joseph Miceli was appointed to the DEP Police in December 2001, and began his career on patrol assigned to the then Croton Precinct. In 2003 he was selected for and transferred to the police academy staff. In June 2004 he was promoted to sergeant and in October 2005 he was promoted to lieutenant. He currently serves as the commanding officer of the Eastview Precinct and previously served as the commanding officer and executive officer of the Hillview and Eastview precincts. Miceli is certified as a police instructor, having specialized certifications in Crisis Intervention, Ethical Awareness, Cultural Diversity, Mental Health and DWI Detection.
- Capt. Joseph Miceli was appointed to the DEP Police in December 2001, and began his career on patrol assigned to the then Croton Precinct. In 2003 he was selected for and transferred to the police academy staff. In June 2004 he was promoted to sergeant and in October 2005 he was promoted to lieutenant. He currently serves as the commanding officer of the Eastview Precinct and previously served as the commanding officer and executive officer of the Hillview and Eastview precincts. In addition to various awards for service, Turck is a recipient of the Meritorious Police Service Award for Heroism for actions preformed in April 2008. Turck studied criminal justice at SUNY Ulster and is a graduate of the Federal Bureau of Investigation National Academy's 227th Session.
- Capt. David Wiswall was appointed to the DEP Police in August 1998 and began his career in the Patrol Division reporting out of Ashokan Precinct. In March 2001 he was promoted to detective and in June 2004 he was promoted to sergeant. He was promoted to detective in June 2000 and promoted to sergeant in December 2001. He currently serves as the sergeant for the west-of-Hudson Detective Bureau. Santamaria served with the U.S. Army and the New York Army National Guard for 17 years. He attended Broome Community College and studied criminal justice. Prior to his service with the DEP Police, he served with the Village of Deposit and Village of Port

Dickenson police departments for three years.

 Lt. Jon Shamro was appointed to the DEP Police in June 1999 and began his career in the Patrol Division reporting out of the then Neversink Precinct. In June 2000 he was promoted to detective in the Patrol Division. He was promoted to sergeant in January 2002 and assigned to the Grahamsville Precinct.

The following detectives were promoted to the rank of sergeant:

- Sgt. Erik Johnson was appointed to the DEP Police in January 2001 and began his career in the Patrol Division reporting out of the Gilboa Precinct. He transferred to the Detective Division in December 2004 and earned the rank of detective in 2005. He continues to serve in the Detective Division. Prior to his service with the DEP Police he served with the Fulton County Sheriff's Office, Northville Police Department and the Margaretville Police Department for three years.
- Sgt. Kelly Kilpatrick was appointed to the DEP Police in October of 2002 and began her career in the Patrol Division out of the Ashokan Precinct. In September of 2003 she was selected for and transferred to the Canine Unit. She was promoted to detective in May 2017. She and her canine partner Bingham are currently assigned to the Gilboa Precinct. Kilpatrick is a New York State certified canine patrol, explosives detection and narcotics detection trainer and examiner.

DEP manages New York City's water supply, providing more than 1 billion gallons of high-quality water each day to more than 9.5 million New Yorkers. This includes more than 70 upstate communities and institutions in Ulster, Orange, Putnam and Westchester counties who consume an average of 110 million total gallons of drinking water daily from New York City's water supply system. This water comes from the Catskill, Delaware, and Croton watersheds that extend more than 125 miles from the City, and the system comprises 19 reservoirs, three controlled lakes, and numerous tunnels and aqueducts. DEP has nearly 6,000 employees, including almost 1,000 scientists, engineers, surveyors, watershed maintainers and other professionals in the watershed. In addition to its \$70 million payroll and \$166 million in annual taxes paid in upstate counties, DEP has invested more than \$1.7 billion in watershed protection programs—including partnership organizations such as the Catskill Watershed Corporation and the Watershed Agricultural Council—that support sustainable farming practices, environmentally
