The minutes of the last meeting were read and approved.

PAPER RETURNED FROM HIS HONOR THE MAYOR.

The President laid before the Board the following resolution, returned by the Mayor, by request of the Board:

Resolved, That the Commissioner of Public Works be and he is hereby directed to cause the sidewalk in front of Nos. 305, 307 and 309 Bridge street, Nos. 24 and 26 Whitehall street, No. 157 Cedar street, and on the west side of Church street, between Fulton and Vesey streets, to be repaired, and the flagging laid or relaid on the established grade, as provided in sections 99, 103 and 104 of article VII. of chapter 6 of the Revised Ordinances of 1880.

Alderman Cleary moved a reconsideration of the vote by which the resolution was adopted.

BOARD OF REVISION AND CORRECTION OF ASSESSMENTS.

A meeting of the Board of Revision and Correction of Assessments was held at the Comptroller's Office on Tuesday, May 19, 1885, at 11.15 o'clock A. M.

Present—Edward V. Loew, Comptroller; E. Henry Lacombe, Counsel to the Corporation.

Absent—Frederick Smyth, Recorder.

The minutes of the meetings held February 12 and March 11, 1885 were read and approved.

The following assessment lists, received from the Board of Assessors with communications dated April 8, 1885, were presented by the Comptroller, viz.:

1. Setting curb, laying flagging and gutter-stones on St. Ann's avenue, from One Hundred and Thirty-ninth to One Hundred and Forty-first street.
2. Receiving-basins on the northeast and southeast corners of Frankfort and Cliff streets.
3. Curbing and flagging One Hundred and Seventy-fifth street, from Tenth avenue to Kingsbridge road.
4. Sewer in One Hundred and Seventh street, between Third and Lexington avenues.
5. Fencing vacant lots on east side Fourth avenue, between Sixty-fourth and Sixty-fifth streets, and on south side of Sixty-fifth street, between Fourth and Lexington avenues.
6. Receiving-basins on the northwest corner of One Hundred and Fourth street and Fourth avenue, and on northwest corner of One Hundred and Seventeenth street and Lexington avenue.
7. Sewer in Ninety-fifth street, between Eighth and Ninth avenues.
8. Sewer in Avenue B, between Fourth and Fifth streets.
9. Sewer in Lexington avenue, between One Hundred and Eighth and One Hundred and Ninth streets.
10. Sewer in One Hundred and Forty-sixth street, between Boulevard and Tenth avenue, and in Tenth avenue, west side, between One Hundred and Forty-sixth and One Hundred and Forty-seventh streets.

The foregoing assessment lists being in proper form, and no objections having been filed, on motion, they were severally confirmed, all the members of the Board present voting in the affirmative.

The assessment list for paving Fourth avenue, from Seventy-second to Ninety-sixth street, with granite-block pavement and concrete foundation, with objections of various parties, ordered to be returned to the Board of Assessors at meeting of February 12, 1885, for the purpose of ascertaining the additional cost of the work on account of the concrete foundation, were presented by the Comptroller, having been received from the Board of Assessors under date of April 2, 1885, together with a communication from the Department of Public Works in relation thereto.

Messrs. Charles E. Miller and T. H. Baldwin, attorneys, and Mr. Cornelius O'Reilly were heard in opposition to the assessment. Mr. W. H. Jasper, Secretary of the Board of Assessors, made explanation as to the action of the Board. On motion of the Counsel to the Corporation, it was ordered that the said assessment list be returned to the Board of Assessors, with the request that they throw off from the assessment fifty per cent. of the amount of cost of the concrete foundation included therein, and reapportion the assessment in accordance with such reduction.

The Comptroller presented the assessment list for paving Fourth avenue, from One Hundred and Sixteenth to One Hundred and Twenty-fourth street, with granite-block pavement, with objections of James King and others, filed by T. H. Baldwin, attorney, and of Timothy Donovan and others, filed by John C. Shaw, attorney, the same having been received from the Board of Assessors under date of April 6, 1885.

After hearing Mr. Baldwin and Mr. Shaw in opposition to the assessment, it was, on motion, ordered that the said assessment list be returned to the Board of Assessors with the request that they throw off from the assessment fifty per cent. of the amount of cost of the concrete foundation included therein and reapportion the assessment in accordance with such reduction.

The assessment list for regulating and paving with granite-block pavement Fourth avenue, on the west side, from One Hundred and Twenty-fourth to One Hundred and Thirty-third street, and on the east side, from One Hundred and Twenty-fourth to One Hundred and Thirty-second street, and objections of Thomas Mackellar and others, filed by T. H. Baldwin, attorney, and of R. P. Lounsbury, Wm. Astor and others, filed by John C. Shaw, attorney, were presented by the Comptroller, having been received from the Board of Assessors under date of April 6, 1885.

After hearing Mr. Baldwin and Mr. Shaw in opposition to the assessment, it was, on motion, ordered that the said assessment list be returned to the Board of Assessors, with the request that they throw off from the assessment fifty per cent. of the amount of cost of the concrete foundation included therein, and reapportion the assessment in accordance with such reduction.

The assessment list for the construction of retaining walls, arch, steps, railing and for the filling and grading necessary for the support and protection of the forty feet roadway excavated in the centre of Forty-second street, between First and Second avenues, and objections of Robert and Ogden Goelet and others, filed by John C. Shaw, attorney; the New York Central and Hudson River Railroad Company and others, filed by Truman H. Baldwin, attorney; of Wm. Baker and others, filed by Knevals & Ransom, attorneys, and of Jacob Voorhis, filed by James C. Murray, attorney, were presented by the Comptroller, having been received from the Board of Assessors under date of April 25, 1885.

After hearing Messrs. John C. Shaw, T. H. Baldwin and James C. Murray, attorneys, in opposition, and Mr. Jasper, Secretary of the Board of Assessors, in explanation of the assessment, on motion, the said assessment list was laid over.

The Comptroller presented the assessment list for regulating and paving with granite-block pavement Forty-second street, from Second to First avenue, and setting curb and gutter stones and flagging sidewalks therein, together with objections of Robert and Ogden Goelet and others, filed by John C. Shaw, attorney; William Baker and others, filed by Knevals & Ransom, attorneys; The New York Central & Hudson River Railroad Company and others, filed by T. H. Baldwin, attorney, and of Jacob Voorhis, filed by James C. Murray, attorney, the same having been received from the Board of Assessors under date of April 25, 1885.

After hearing Messrs. Shaw, Baldwin and Murray, attorneys, in opposition, on motion, the said assessment list was laid over.

The Comptroller presented the assessment list for regulating, grading, setting curb and gutter stones and flagging Forty-second street, from Second avenue to the East river, together with objections of L. Cowen and others, filed by John C. Shaw, attorney; of Jacob Voorhis, filed by James C. Murray, attorney; of Peter A. Cassidy, filed by J. M. Fitzsimon, attorney; of William H. Meader and others; also notices of Francis Ridel and Richard J. Clarke of claim for damages, filed by T. H. Baldwin, attorney, and objections of Patrick King and others, the same having been received from the Board of Assessors under date of April 25, 1885.

After hearing Messrs. Shaw, Baldwin and Murray, attorneys, in opposition, on motion, the said assessment list was laid over.

The assessment list for paving Forty-second street, from First avenue to the East river, with Belgian or trap-block pavement, and objections of Patrick Donahue, M. and P. Donahue and John Ashbals, filed by T. H. Baldwin, attorney, were presented by the Comptroller, having been received from the Board of Assessors, under date of April 6, 1885.

After hearing Mr. Baldwin, on motion, the said assessment list was laid over.

The assessment list for sewer in Fourth avenue, east side, between Eighty-second and Eighty-third streets, and objections of J. Bentley Squier, filed by T. H. Baldwin, attorney, and of Cornelius O'Reilly, referred back to the Board of Assessors at meeting of February 12, 1885, for the purpose of ascertaining the amount assessed for the sewer in Eighty-second street on Mr. O'Reilly's property, situated in the rear of his lots on Fourth avenue, known as Nos. 2 and 3, were presented by the Comptroller, the same having been returned by the said Board, with a communication dated April 29, 1885.

The Board state that "the cost of the work has been reapportioned by assessing Ward Nos. 2 and 3 in Block No. 373, according to the area, as it was found upon investigation that the rear of "those lots had already paid their proportionate share for the sewer constructed in Eighty-second street, east of Fourth avenue."
