

The 782 deaths registered during the week represent an annual death-rate of 26.78 on an estimated population of 1.518,376, as against 25.15 for the previous week and 25.71 for the corresponding week of 1887. The increase of 48 deaths over the previous week was mainly due to an increase in bronchitis, phthisis and pneumonia, the deaths from diphtheria having diminished by 1 and those from scarlatina having increased by 4. The total increase of deaths was greatest in the Eleventh, Twelfth and Eighteenth Wards, and the decrease greatest in the Thirteenth, Seventeenth and Twenty-second Wards.
