Approved Papers for the week ending January 24, 1891.

Resolved, That an improved iron drinking-fountain be placed on the sidewalk, near the curb, in front of No. 1396 Boston avenue, under the direction of the Commissioner of Public Works.

Adopted by the Board of Aldermen, January 13, 1891.

Received from his Honor the Mayor, January 24, 1891, without his approval or objections thereto; therefore, as provided in section 75, chapter 410, Laws of 1882, the same became adopted.

Resolved, That gas-mains be laid, lamp-posts erected and street-lamps placed thereon and lighted in Trinity avenue, between the Southern Boulevard and One Hundred and Thirty-second street, and in One Hundred and Thirty-second street, between Trinity and Willow avenues, under the direction of the Commissioner of Public Works.

Approved by the Mayor, January 24, 1891.

Resolved, That gas-mains be laid, lamp-posts erected and street-lamps placed thereon and lighted in Jennings street, from Union avenue to Stebbins avenue, under the direction of the Commissioner of Public Works.

Adopted by the Board of Aldermen, January 20, 1891.

Approved by the Mayor, January 24, 1891.

Resolved, That the house and lots on Third avenue, north of One Hundred and Seventieth street, shall be numbered continuously with the houses and lots south of One Hundred and Seventieth street and Third avenue, under the direction of the Commissioner of Public Works.

Adopted by the Board of Aldermen, January 20, 1891.

Approved by the Mayor, January 24, 1891.

Resolved, That One Hundred and Ninth street, from Manhattan avenue to Columbus avenue, be regulated and graded, the curb-stones set and sidewalks flagged a space four feet wide through the centre thereof, under the direction of the Commissioner of Public Works; and that the accompanying ordinance therefor be adopted.

Resolved, That lamp-posts be erected and street-lamps placed thereon and lighted in One Hundred and Sixtieth street, from St. Nicholas avenue to Edgecombe road, under the direction of the Commissioner of Public Works.

Resolved, That the vacant lots on the block bounded by One Hundred and Nineteenth and One Hundred and Twentieth streets, Madison and Park avenues, be fenced in, where not already done, under the direction of the Commissioner of Public Works; and that the accompanying ordinance therefor be adopted.

Resolved, That permission be and the same is hereby given to the Twenty-eighth and Twenty-ninth Street Railroad Company to pave the sidewalk in front of their depot, Nos. 406, 408 and 410 East Thirty-third street, with asphalt pavement on a concrete foundation of five inches, the work to be done at the expense of the said company, under the direction of the Commissioner of Public Works.

Resolved, That permission be and the same is hereby given to Frederick Scharman to place and keep an ornamental lamp-post and lamp in front of No. 112 Third avenue, provided the lamp be kept lighted during the same hours as the public lamps, that the post shall not exceed the dimensions prescribed by law (eighteen inches square at the base), the lamp not to exceed two feet in diameter and not to be used for advertising purposes, the work to be done and gas supplied at his own expense, under the direction of the Commissioner of Public Works; such permission to continue only during the pleasure of the Common Council.

Whereas, Through permission heretofore granted by the Board of Commissioners of Emigration, the Fire Department is now in possession of a space of about one hundred and fifty feet in length, on the northwest water-front of Castle Garden, as a berth and landing-place for one of its fire-boats; and, whereas, the Board of Fire Commissioners are informed that said Castle Garden property will shortly revert to the custody of the Board of Commissioners of the Sinking Fund by surrender or expiration of lease; therefore

Resolved, That the Board of Fire Commissioners hereby respectfully request the Board of Commissioners of the Sinking Fund to set apart and to assign to the use of the Fire Department, as a berth and landing-place for one of its fire-boats, that portion of the northwest water-front of Castle Garden now in possession of said Department for that purpose, not less than one hundred and fifty feet in length; also,

Resolved, That the Board of Sinking Fund Commissioners are further respectfully requested to set apart and assign to the use of the Fire Department a plot of ground immediately adjacent to said landing-place, of dimensions sufficient to place therein a building for the accommodation of the men composing the crew of said fire-boat, and to authorize the Fire Department to select a suitable building from among those already erected at Castle Garden, and not otherwise required, and remove the same to the place designated above.

TO OWNERS OF LANDS ORIGINALLY ACQUIRED BY WATER GRANTS.

ATTENTION IS CALLED TO THE RECENT act of the Legislature (chapter 449, Laws of 1889), which provides that whenever any streets or avenues in the city, described in any grant of land under water, from the Mayor, Aldermen and Commonalty, containing covenants requiring the grantees and their successors to pave, repave, keep in repair or maintain such streets, shall be in need of repairs, pavement or repavement, the Common Council may, by ordinance, require the same to be paved, repaved or repaired, and the expense thereof to be assessed on the property benefited; and whenever the owner of a lot so assessed shall have paid the assessment levied for such paving, repaving or repairing, such payment shall release and discharge such owner from any and every covenant and obligation as to paving, repaving and repairing, contained in the water grant under which the premises are held, and no further assessment shall be imposed on such lot for paving, repaving or repairing such street or avenue, unless it shall be petitioned for by a majority of the owners of the property (who shall also be the owners of a majority of the property in frontage) on the line of the proposed improvement.

The act further provides that the owner of any such lot may notify the Commissioner of Public Works, in writing, specifying the ward number and street number of the lot that he desires, for himself, his heirs and assigns, to be released from the obligation of such covenants, and elects and agrees that said lot shall be thereupon liable to be assessed as above provided, and thereupon the owner of such lot, his heirs and assigns shall thereupon be relieved from any obligation to pave, repair, uphold or maintain said street, and the lot in respect of which such notice was given shall be liable to assessment accordingly.
