## NOTES TO FINANCIAL PLAN STATEMENTS

### Summary of Significant Financial Policies, Procedures and Development

#### **A. Financial Plan Statements**

The City's Financial Plan Statements (FPS) represents the accounts of the General Fund and certain transactions of the Capital Projects Fund of the City, including the Department of Education and the City University of New York. They do not include the total operations of the New York City Health + Hospitals but do include the City's subsidy to the system.

The City's Financial Plan Statements incorporate the policies and procedures discussed in Note B. Such data are unaudited. Prior years' balances for cash, accounts receivable and outstanding obligations are consistent with the FY 2022 audited Annual Comprehensive Financial Report (ACFR). Whenever appropriate, adjustments have been incorporated into the Financial Plan Statements as they relate to the audit of the Annual Comprehensive Financial Report (ACFR). The Financial Plan on which these statements are based was prepared in accordance with generally accepted accounting principles (GAAP), except for the application of GASB 49 which prescribes the accounting treatment of pollution remediation costs and without regard to changes in certain fund balances described in General Municipal Law 25.

#### **B. Basis of Accounting**

##### **1. Revenues**

Real estate tax revenue is recorded on the modified accrual basis of accounting, which recognizes as revenue payments received against the current year levy, late payments received within the first two months of the following year, and prior year levies received in the current year. Real estate tax revenue is reduced by actual tax refunds to be made in the period.

Taxpayer assessed revenues (e.g. sales, income and certain excise taxes), net of estimated refunds, are recorded on a modified accrual basis. Revenues are susceptible to accrual if they are both measurable and available to be used to finance governmental operations during the year.

Federal categorical grants except as noted below are recognized as revenue as claims are filed during the year and adjusted at year-end for revenues earned but not claimed. State grants are recognized in the same manner. Advances provided to the City in anticipation of filing of claims by the City for federal and state reimbursement of Medicaid and welfare expenditures are recognized as revenue when received.

All other revenues are recorded when received in cash.

## 2. Expenditures

### (a) Debt Service

Debt Service expenditures on general obligation issuances are recorded when City real estate tax collections are deposited into the Debt Service fund in advance of the actual debt service payment. Debt Service expenditures for the Transitional Finance Authority (TFA) are recorded when City personal income tax collections are retained by the TFA. Lease debt expenditures are recorded when the respective lease agreement requires City payment in advance of a payment to bondholders.

### (b) Fixed Assets

Acquisitions of fixed assets costing more than \$50,000 and having a minimum useful life of either three years for certain information technology assets (computer hardware, software, networks, and information technology systems) or five years for all other types of assets are treated as capital expenditures. All other acquisitions of fixed assets are treated as operating expenditures.

### (c) Encumbrances

Encumbrances entered during FY 2023 for OTPS purchase orders and contracts expected to be received by June 30, 2023 are treated as expenditures.

### (d) Risk Management

The City generally assumes the risk of its own losses with respect to most types of risks, including, but not limited to, property damage (both claims against the City and damage to the City's own property), personal injury, and workers' compensation; any losses incurred are paid out of the City's budget. The City's budgets and financial plans include estimates of judgments and claims to be settled annually, but there are no cash reserves for estimated losses incurred. Settlements reached or judgments entered during FY 2023 are recorded when paid and adjusted at year-end for any additional unpaid settlements reached or judgments entered during FY 2023.

### (e) Materials and Supplies

Purchases of materials and supplies are treated as expenditures when encumbered.

### (f) Reserves

The reserves (General Reserve, Capital Stabilization Reserve, and Rainy Day Fund) provide for shortfalls in revenues and overruns in uncontrollable expenditures.

3. Capital Commitments

The reporting of actual capital commitments, as well as sources and uses of capital expenditures, are based upon the accounting period of the transaction.

C. Pension Plans

The City maintains five actuarial pension systems, providing benefits for its employees and employees of various independent agencies (including certain Covered Organizations). Such systems consist of the New York City Employees' Retirement System, the Teachers' Retirement System of the City of New York, the New York City Board of Education Retirement System, the New York City Police Pension Fund and the New York City Fire Department Pension Fund. Members of these actuarial pension systems are categorized into Tiers depending on date of membership. The systems combine features of defined benefit pension plans with those of defined contribution pension plans. Three of the five actuarial pension systems are cost-sharing multiple employer systems that include public employees who are not City employees. Each public employer in these multiple employer systems has primary responsibility for funding and reporting in the employer's financial statements on its share of the systems' liabilities.

The City also contributed to other actuarial systems and sponsors non-actuarial retirements' systems for certain employees, retirees and beneficiaries not covered by any of the major actuarial systems.

## NOTES TO REPORTS NO. 4 AND 4A

The actuals and projections in the forecasts are based on the best information available to the City at the date of preparation and certain assumptions and methods of estimation, which are considered reasonable and appropriate for purposes of the report as of such date. In some instances, prior year charges are reflected in FY 2023 year-to-date expenses and these charges will be journaled back to prior years at a later date.

**Police:** The \$(113) million year-to-date variance is primarily due to:

- \$(17) million in accelerated encumbrances, including \$(12) million for other services and charges and \$(5) million for supplies and materials, that was planned to be obligated later in the fiscal year.
- \$23 million in delayed encumbrances, including \$14 million for contractual services and \$9 million for property and equipment, that will be obligated later in the fiscal year.
- \$(119) million in personal services, including \$(214) million for overtime and \$(18) million for prior year charges, offset by \$96 million for full-time normal gross, \$7 million for fringe benefits, \$6 million for other salaried positions and \$5 million for differentials.

**Fire:** The \$38 million year-to-date variance is primarily due to:

- \$55 million in delayed encumbrances, including \$27 million for other services and charges, \$20 million for contractual services and \$7 million for supplies and materials, that will be obligated later in the fiscal year.
- \$(17) million in personal services, including \$(24) million for all other, \$(8) million for prior year charges, \$(8) million for full-time normal gross and \$(7) million for differentials, offset by \$26 million for overtime and \$2 million for terminal leave.

**Correction:** The \$(31) million year-to-date variance is primarily due to:

- \$(24) million in accelerated encumbrances, including \$(12) million for supplies and materials and \$(12) million for contractual services, that was planned to be obligated later in the fiscal year.
- \$31 million in delayed encumbrances, primarily for other services and charges, that will be obligated later in the fiscal year.
- \$(38) million in personal services, including \$(86) million for overtime and \$(4) million for prior year charges, offset by \$37 million for full-time normal gross, \$12 million for differentials and \$4 million for fringe benefits.

**Sanitation:** The \$62 million year-to-date variance is primarily due to:

- \$40 million in delayed encumbrances, including \$22 million for other services and charges, \$10 million for contractual services and \$7 million for supplies and materials, that will be obligated later in the fiscal year.
- \$22 million in personal services, including \$15 million for overtime and \$8 million for full-time normal gross.

**Administration for Children's Services:** The \$(131) million year-to-date variance is primarily due to:

- \$(140) million in accelerated encumbrances, primarily for contractual services, that was planned to be obligated later in the fiscal year.
- \$27 million in delayed encumbrances, including \$13 million for other services and charges, \$8 million for social services and \$5 million for fixed and miscellaneous charges, that will be obligated later in the fiscal year.
- \$(18) million in personal services, including \$(12) million for full-time normal gross and \$(4) million for overtime.

**Social Services:** The \$59 million year-to-date variance is primarily due to:

- \$(117) million in accelerated encumbrances, primarily for public assistance, that was planned to be obligated later in the fiscal year.
- \$128 million in delayed encumbrances, including \$42 million for social services, \$31 million for medical assistance, \$21 million for supplies and materials, \$20 million for other services and charges and \$13 million for contractual services, that will be obligated later in the fiscal year.
- \$48 million in personal services, including \$(14) million for overtime, \$(9) million for differentials, \$(9) million for prior year charges, \$(4) million for other salaried positions and \$(4) million for holiday pay, offset by \$88 million for full-time normal gross.

**Homeless Services:** The \$10 million year-to-date variance is primarily due to:

- \$(3) million in accelerated encumbrances, primarily for supplies and materials, that was planned to be obligated later in the fiscal year.
- \$4 million in delayed encumbrances, including \$2 million for contractual services and \$2 million for other services and charges, that will be obligated later in the fiscal year.
- \$9 million in personal services.

**Health and Mental Hygiene:** The \$85 million year-to-date variance is primarily due to:

- \$(14) million in accelerated encumbrances, primarily for social services, that was planned to be obligated later in the fiscal year.
- \$82 million in delayed encumbrances, including \$39 million for contractual services, \$24 million for other services and charges, \$16 million for supplies and materials and \$3 million for property and equipment, that will be obligated later in the fiscal year.
- \$17 million in personal services, including \$(5) million for differentials, \$(3) million for overtime, \$(3) million for holiday pay and \$(3) million for prior year charges, offset by \$29 million for full-time normal gross and \$3 million for other salaried positions.

**Environmental Protection:** The \$95 million year-to-date variance is primarily due to:

- \$59 million in delayed encumbrances, including \$27 million for other services and charges, \$14 million for fixed and miscellaneous charges, \$12 million for supplies and materials and \$6 million for contractual services, that will be obligated later in the fiscal year.
- \$36 million in personal services, including \$(7) million for overtime and \$(2) million for prior year charges, offset by \$45 million for full-time normal gross and \$2 million for fringe benefits.

**Transportation:** The \$73 million year-to-date variance is primarily due to:

- \$(3) million in accelerated encumbrances, primarily for property and equipment, that was planned to be obligated later in the fiscal year.
- \$47 million in delayed encumbrances, including \$20 million for contractual services, \$19 million for other services and charges and \$8 million for supplies and materials, that will be obligated later in the fiscal year.
- \$29 million in personal services, including \$(6) million for differentials, \$(4) million for overtime, \$(3) million for prior year charges, \$(2) million for terminal leave, \$(2) million for other salaried positions and \$(2) million for holiday pay, offset by \$48 million for full-time normal gross.

**Parks and Recreation:** The \$51 million year-to-date variance is primarily due to:

- \$43 million in delayed encumbrances, including \$17 million for contractual services, \$14 million for supplies and materials and \$12 million for other services and charges, that will be obligated later in the fiscal year.
- \$8 million in personal services.

**Citywide Administrative Services:** The \$115 million year-to-date variance is primarily due to:

- \$109 million in delayed encumbrances, including \$82 million for other services and charges, \$17 million for contractual services and \$7 million for supplies and materials, that will be obligated later in the fiscal year.
- \$6 million in personal services.

**City University:** The \$83 million year-to-date variance is primarily due to:

- \$(14) million in accelerated encumbrances, including \$(11) million for other services and charges and \$(3) million for property and equipment, that was planned to be obligated later in the fiscal year.
- \$81 million in delayed encumbrances, including \$67 million for fixed and miscellaneous charges and \$14 million for supplies and materials, that will be obligated later in the fiscal year.
- \$16 million in personal services, primarily for fringe benefits.

**Health + Hospitals:** The \$(26) million year-to-date variance is primarily due to:

- \$(26) million in accelerated encumbrances, primarily for fixed and miscellaneous charges, that was planned to be obligated later in the fiscal year.

**Miscellaneous:** The \$(144) million year-to-date variance is primarily due to:

- \$17 million in fringe benefits reflecting delayed encumbrances, that will be obligated later in the fiscal year.
- \$(84) million in transit subsidies reflecting accelerated encumbrances, that was planned to be obligated later in the fiscal year.
- \$(188) million in judgments and claims reflecting accelerated encumbrances, that was planned to be obligated later in the fiscal year.
- \$111 million in other reflecting delayed encumbrances, that will be obligated later in the fiscal year.

**Pensions:** The \$12 million year-to-date variance is primarily due to:

- \$12 million in delayed encumbrances in pension contributions, that will be obligated later in the fiscal year.

**Debt Service:** The \$(76) million year-to-date variance is primarily due to:

## NOTES TO REPORT #5

1. Capital Commitments: Commitments are defined as awarded contracts registered with the City Comptroller except for Waterway and Highway Bridge projects performed jointly with the State. Certain non-City commitments for Bridge projects are not registered with the City Comptroller. These commitments are reported when the State advertises the work. Beginning in Fiscal Year 2000, reported education commitments have been changed to represent master contract registrations with the Comptroller. Previously, reported education commitments represented Construction Authority contract registrations.

2. Variances in year-to-date commitments of City funds through January are primarily due to timing differences.

## NOTES TO REPORT #6

1. **Beginning Balance**

The July 2022 beginning balance is consistent with the FY 2022 audited Annual Comprehensive Financial Report (ACFR).

2. **Ending Balances**

The actual monthly ending cash balances are subject to restatement after the completion of bank reconciliations. The June 2023 ending balance includes deferred revenue from FY 2024 prepaid Real Estate Taxes.

3. **Long Term Borrowings**

Long Term Borrowings are comprised of proceeds of City general obligation bonds, NYC TFA debt and Water Authority revenue bonds, exclusive of bonds issued for refunding.

4. **Restricted Cash Bond Proceeds**

In certain instances a portion of the proceeds from each bond issuance is for capital expenditures to be made in succeeding months. Restricted cash bond proceeds accounts have been set up for this purpose. Balances in these accounts are excluded from the cash balances that are reflected in Report #6.

5. **Cash Flow Realignment**

Taxes reflect revenue net of refunds which may result in a negative cash flow in certain months. For Federal, State and Other Categorical Grants, a negative cash flow may result from corrections to certain grants that occur after the monthly accounting close in which cash is moved between grants and/or between current year/prior year classification. These negative cash flow transactions are accounting transactions reflected in the City's Financial Management System.
