### APPROVED PAPERS

*Approved Papers for the week ending May 3, 1890.*

Resolved, That permission be and the same is hereby given to Collins Brothers to place and keep a watering-trough in front of their premises, at a point on Eighth avenue, twenty-six feet north of the northwest corner of Seventeenth street and Eighth avenue, the water to be supplied and the work to be done at their own expense, under the direction of the Commissioner of Public Works; such permission to continue only during the pleasure of the Common Council.

Adopted by the Board of Aldermen, April 15, 1890.

Received from his Honor the Mayor, April 29, 1890, without his approval or objections thereto; therefore, as provided in section 75, chapter 410, Laws of 1882, the same became adopted.

Resolved, That permission be and the same is hereby given to Carl H. Schultz, with the consent of the Department of Docks, to connect his premises, No. 402 East Twenty-sixth street, with the waters of the East river at the foot of East Twenty-sixth street, by a five-inch iron pipe, for the purpose of supplying salt water to be used on said premises for cleansing purposes and in case of fire; provided the said Carl H. Schultz shall stipulate with the Commissioner of Public Works to save the city harmless from loss or damage to any gas or water pipe or sewer or from any other cause that may occur during the progress or subsequent to the laying of such pipe that may be caused by the use of the privilege hereby given, the work to be done at his own expense, under the direction of the Commissioner of Public Works; such permission to continue only during the pleasure of the Common Council.

Adopted by the Board of Aldermen, April 15, 1890.

Received from his Honor the Mayor, April 29, 1890, without his approval or objections thereto; therefore, as provided in section 75, chapter 410, Laws of 1882, the same became adopted.

Resolved, That the 22d day of May, 1890, at 1 o'clock P. M., and the Chamber of the Board of Aldermen, Room No. 16, City Hall, be and hereby are designated as the time and place when and where the application of the "Harlem, Mott Haven and Morris Avenue Railroad Company" to the Common Council of the City of New York, for its consent and permission for the construction, maintenance and operation of the street surface railroad described in the petition of said company for such consent will be first considered by the Railroad Committee of this Board, and that public notice thereof be given by the Clerk of this Board by publishing the same for fourteen days, exclusive of Sundays, in two newspapers published in this city, to be designated therefor by his Honor the Mayor, according to the provisions of chapter 252 of the Laws of 1884, such advertising to be at the expense of the petitioner.

### COMMISSIONERS OF THE SINKING FUND OF THE CITY OF NEW YORK.

*Proceedings of the Commissioners of the Sinking Fund, at a Meeting held at the Mayor's Office, pursuant to adjournment, at 1 o'clock P. M., on Wednesday, April 30, 1890.*

Present—Hugh J. Grant, Mayor; Frederick Smythe, Recorder; Theodore W. Myers, Comptroller; Thomas C. T. Crain, Chamberlain, and Walton Storm, Chairman of the Committee on Finance, Board of Aldermen.

The minutes of the meeting held on April 23 was read and approved.

The Mayor said that as the Commissioners of Emigration and Mr. Weber, the Superintendent of Immigration, were then present, the subject of leasing Castle Garden to the Government for a short period would be considered.

The letters relating to this subject, which were presented to the Commissioners of the Sinking Fund at a meeting held on April 2, were then read.

Mr. Weber was asked by the Mayor if he had any proposition to make to the Board. He replied that he had appeared upon the receipt of a notice of the meeting to consider the matter of leasing Castle Garden to the Secretary of the Treasury, for an indefinite period, say from sixty to ninety days, until other arrangements could be made for a permanent emigrant station, as had been proposed when his letter, just read, was written, but that he was not authorized to make any new proposition, and would be glad to receive any proposal the Board might make and forward it to the Secretary of the Treasury.

The Recorder said that the proposition for leasing Castle Garden should come from the Government before it could be considered by the Commissioners of the Sinking Fund.

The President of the Board of Commissioners of Emigration said that they had prepared a protest against leasing Castle Garden to the Government, which he desired to present to the Board; they were using the premises daily, and they would be needed for two or three months yet to finish up their business.

After some discussion of the subject, the Recorder moved that, as there was no application before the Board, the matter be laid over.

The Comptroller stated that the Barge Office was overcrowded, and that relief for the immigrants now received there was immediately necessary, and moved, as a substitute for the Recorder's motion, that a lease of Castle Garden for a limited period be tendered to the Government on the same terms as the lease to the Commissioners of Emigration; which motion, being put, was lost by the following vote:

Affirmative—The Comptroller—1.

Negative—The Mayor, the Recorder, the Chamberlain and the Chairman of the Committee on Finance of the Board of Aldermen—4.

The motion to lay over was then put and carried by the following vote:

Affirmative—The Mayor, the Recorder, the Chamberlain and the Chairman of the Committee on Finance of the Board of Aldermen—4.

Negative—The Comptroller—1.

The Mayor stated that the matter was laid over, and informed Mr. Weber that if he had any further communication to make in regard to the leasing of Castle Garden the Board would receive and consider it.

The Comptroller presented the following report on several applications for refrigerating the New West Washington Market:

*To the Commissioners of the Sinking Fund:*

GENTLEMEN—The Comptroller, to whom was referred, on the 9th instant, the application of the Greenwich Refrigerating Company, for the right to refrigerate the new West Washington Market, under a proposed contract with the City, begs leave to report as follows:

From the investigation made by me, it would appear that the company in question has been organized for the purpose of obtaining the right to refrigerate the market named, but is not in operation as yet. The report of the Engineer of this Department, which is subjoined, refers to the working of the refrigerating process which it proposes to use.

In this connection I desire to call the attention of the Board to the applications from several other companies, which are herewith submitted, all having in view the same object, the refrigeration of the new West Washington Market. Under date of November 11, 1889, the Markets Refrigerating Company, which had previously applied, under a misapprehension, to the Department of Public Works, applied for permission to supply their system of cold-air refrigeration to such of the standholders of the new West Washington Market as might desire the same. In spite of the fact that the company, as evidenced by its agreement, previously entered into with the Department of Public Works, had shown its willingness to subscribe to such terms as the City might exact, and had, under a permit, obtained through the misapprehension already stated, entered upon the work of introducing its system into the market, the application was laid over, and no action whatever has since been taken upon it.

This company, the Markets Refrigerating Company, now renews its former application. The communication of its president, James T. Sparkman, as well as an appended application from Messrs. Jacob Rupert, George Ehret and John C. De La Vergne, three stockholders of the De La Vergne Company, whose system of refrigerating is used by the Markets Company, are herewith presented.

It would appear that by virtue of having been the first company to make application for permission to refrigerate the market in question, supported, as it was, by a petition of standholders, desirous of availing themselves of the company's services, and in view of the fact that the good faith of the company was proven by their acceptance of the terms prescribed by the Department of Public Works, when it was thought erroneously that that Department had the power to grant the permission desired, this company, if any, should be granted the franchise requested, upon the merits of its application alone. To this matter, however, I shall subsequently refer.

There is also presented herewith the joint application of the Consolidated Refrigerating Company, representing a capital of \$5,000,000, and the New York Refrigerating Construction Company, the latter operating under the franchise and patents of the former. The system and operations of these companies have been investigated by the Engineer of this Department, and are treated of in his subjoined report. Accompanying the application are also submitted testimonials from numerous firms in Denver, Colorado, where the companies do an extensive business, as also a petition from standholders in the new West Washington Market.

An application has also been received by me and is presented from the New York Refrigerating and Cold Storage Company. This company's system is at present in operation in the Washington Market, where it was introduced during last summer; a contract, which accompanies the application, having been duly entered into by the officers of the company and myself acting for the City, by which the franchise for supplying cold-air service to such of the standholders of the market as desired the same, was granted for a period of six years from May 24, 1889. In the report of the Engineer subjoined, the practical workings of the system employed by this company are described.

An application is also submitted from Mr. Moritz Davidson. The system proposed to be used by him is that under which the New York Refrigerating and Cold Storage Company is operating in the Washington Market; and the plans which accompany his petition receive due consideration in the Engineer's report.

It appears from the foregoing that in addition to the Greenwich Refrigerating Company three other regularly incorporated companies and one private individual have signified their desire to obtain, under such conditions as this Board shall prescribe, the privilege of refrigerating the new West Washington Market; and that of all the applicants the Markets Refrigerating Company stands in the position of having made primal application and at one time of having held a permit for the privilege sought, although granted under a misapprehension by a department having no requisite authority.

Any comparison by me at this time of the merits of the relative systems employed by the various companies would seem out of place. As before stated, all the information I have been able to obtain in relation to the Greenwich Refrigerating Company has consisted of the statements of its president, the company not being in active operation; and as to the Markets Refrigerating Company, I have already reported at length, on October 21, 1889. The applications of the other companies have yet to be received and referred by the Board.

Recognizing, however, that the privilege applied for constitutes a valuable franchise, for which the City should receive the largest possible return, I beg to report that, in my opinion, should the Board decline to recognize what I cannot but regard as the very strong claims of the Markets Refrigerating Company, based upon its priority of application, the fullest competition should be invited; and to recommend that, to that end, the franchise should be offered at public auction, after due advertising, to the highest bidder of an annual payment in excess of an upset price of five per cent. of the gross receipts; and a resolution embodying this recommendation has accordingly been prepared by me, and is submitted for adoption.

In this wise all the companies which have already applied, as well as all other companies desiring to apply, will be placed upon an equal footing, and the City very properly be insured the fullest remuneration for the privilege it is solicited to grant.

REPORT OF THE ENGINEER OF THE FINANCE DEPARTMENT.

CITY OF NEW YORK—FINANCE DEPARTMENT,

*Hon. THEODORE W. MYERS, Comptroller:*

SIR—Under your instructions I have examined into the system of cold air supply now in operation at Washington Market.

The work is being done under a contract made with "The New York Refrigerating and Cold Storage Company," bearing date May 24, 1889.



Under the contract the company is required to pay into the City Treasury, for the privileges granted therein, five per cent. of its gross receipts, but not less than \$1,000 for the first year, and \$1,500 for each year thereafter.

The works of the company are located in Fulton street, between Church and Greenwich streets.

The system consists in bringing salt water to as low a temperature as may be required, by placing it in contact with the pipes of the freezing apparatus in the works, and then keeping it in circulation, by pumps and pipes, throughout the market, the communication from the works being by an eight-inch pipe. There is no ammonia in the water.

From this eight-inch main, branch pipes are run, overhead, throughout the market, from which connections are made to the boxes of the customers by smaller pipes.

The temperature required is usually about 30° Fahr.; though the system is capable of giving a temperature of 16° or 18°, required by some of the customers.

The rates of charge are from 1 cent to 1 3/4 cents per square foot, floor measure, of the ice boxes, per day. The 1 cent charge is for small low boxes; higher boxes pay 1 1/4 cents and 1 1/2 cents, and the highest charge is for the very low temperature.

The company also supplies artificially made ice, to a limited extent, at 25 cents per 100 pounds until the 1st of May; and, later on, at 35 cents per 100 pounds. The present capacity for making ice is 25 tons per day; arrangements are being made for increasing the amount to 50 tons per day.

The company has at present sixty-five customers, but contracts have been partially made, carrying the number to one hundred and five.

The present receipts of the company are about \$260 per week from the market.

The system has been in operation only a short time, less than two months.

The matter of furnishing cold air on so large a scale was an experiment, but I consider the result an entire success. I communicated with a number of the prominent men of the market, who all express themselves emphatically in terms of praise of the practical working of the system.

The saving of expense is considerable. The only defect I could find was the dripping from the pipes overhead, on account of imperfect insulation. This defect is being remedied, partly by improved insulation, which will be permanently effectual, and partly by drip-pans and gutters, as a temporary measure.

I estimate the value of the plant necessary for such a system, as carried out at Washington Market, at \$125,000.

There are on file the following applications for introducing mechanical refrigeration into the New West Washington Market, viz.:

#### 1. THE MARKETS REFRIGERATING COMPANY.

This company had a permit from the Department of Public Works, under date of January 26, 1889, to introduce its system into the market, but, it having been decided that the authority to grant such permit rested with the Commissioners of the Sinking Fund, and not with the Department of Public Works, the permit was practically suspended. Another application was made to the Commissioners of the Sinking Fund November 11, 1889, and this application is a renewal of that of the last-mentioned date.

The company proposes to use the De la Vergne system, with brine circulation. This system is in successful operation in many large establishments, in the city and elsewhere, where it gives entire satisfaction. Its merits are beyond all question.

The company proposes ninety days for the completion of its work. I think it would require, at least, one month longer.

The company will agree to pay for the privilege, five per cent. of its gross receipts, not to be less than \$1,500 for the first year, and \$2,000 for each year thereafter.

#### 2. THE NEW YORK REFRIGERATING AND COLD STORAGE COMPANY.

The system proposed by this company is the same as that I have already described as completely successful in the Washington Market.

The same conditions are proposed as in the existing contract for Washington Market, viz.: five per cent. of gross receipts, not to be less than \$1,000 for the first year, or \$1,500 for each year thereafter.

#### 3. THE GREENWICH REFRIGERATING COMPANY.

This company has been formed for the express purpose of refrigeration in the New West Washington Market.

The system proposed to be used is what is called the "Pontifex," which is in successful operation at the corner of West and Horatio streets, within one block of West Washington Market, by a company known as the "Gansevoort Freezing and Cold Storage Company." The machine was made, as I was informed by the President, by Thomas F. Rowland, Continental Works, Greenpoint, under an American patent, dated April 12, 1881. I understand from the same source, that the system has been in operation at the above locality for two years, and in Philadelphia, by a large firm of meat packers, for over five years, also, at the Soldiers' Home, Fortress Monroe.

The refrigeration is done by brine circulation. The capacity of the Gansevoort Freezing and Cold Storage Company is two twenty-ton machines. If the permit is given to the Greenwich Refrigerating Company, I understand the work is to be done at this locality, where the company expects to enlarge its capacity to two fifty-ton machines, for which it has ample space.

The machinery of this company is very complete, and certainly its work, as shown in the storage room, is well done.

The petition of one hundred standholders in the West Washington Market, to have the system introduced into the market is based, as I understand, on their experience, as gained in the storage of their goods in the establishment of the Gansevoort Freezing and Cold Storage Company, and is strong evidence in its favor.

The company does not propose any terms.

#### 4. APPLICATION OF MORITZ DAVIDSON.

The system proposed by Mr. Davidson is the same as that now in successful operation at Washington Market, with improvements suggested by experience.

He proposes to pay for the privilege, after the first year, six per cent. of the gross receipts, with guaranty that the amount shall not be less than \$2,500 per annum.

He states that he can probably commence refrigerating during the month of July. I think the time is short.

#### 5. THE CONSOLIDATED REFRIGERATING COMPANY, AND THE NEW YORK REFRIGERATING CONSTRUCTION COMPANY.

The system of these companies is altogether different from those above enumerated, the refrigeration being accomplished by the circulation of the ammonia, or refrigerating material, directly through the pipes, instead of the cold brine. It is, apparently, a very simple and beautiful system, and is in successful operation, on a comparatively small scale, at the company's establishment, on West street, near Gansevoort street, within two hundred feet of West Washington Market. This system appears to have proved successful in Denver, Colorado, where it has been introduced on a large scale, as shown by a great many approving letters, submitted with the application.

As very small pipes are used, it has the advantage of quick and economical construction, and the automatic arrangements, by means of the thermostat, for regulating the supply of the refrigerating material, presents a novel and interesting feature.

I examined a considerable number of the storage rooms in the establishment at West street, where large amounts of all sorts of produce, requiring such refrigeration, were kept, and found them at the different temperatures required. The air seemed perfectly dry, as shown by the wood work of the rooms, the hand detecting no moisture.

On the comparatively small scale of this establishment, the system appears successful.

The companies propose to pay for the privilege six per cent. of the gross receipts per annum.

The representatives of the several refrigerating companies were present, and after a general discussion of the resolution submitted by the Comptroller, it was amended and unanimously adopted, as follows:

Resolved, That the Comptroller be and is hereby authorized and directed to sell at public auction on Wednesday, May 7, 1890, at the Comptroller's office, at 12 o'clock, M., to the highest bidder among those whose applications were reported upon by the Comptroller, April 30, 1890, the right or privilege of introducing suitable and approved refrigerating apparatus into the New West Washington Market, for the term of ten years, to supply the standholders therein with cold air for preserving meats, etc.; the work to be done under the direction of the Commissioner of Public Works, and subject to such conditions as shall be prescribed by the Comptroller; the expense of introducing and maintaining all necessary pipes, connections and fixtures to be borne by the successful bidder; the compensation to be paid to the City for such right or privilege, to be five per cent. of the gross receipts for supplying cold air to the standholders, payable quarterly, and the bid for such right or privilege to be an additional amount per annum, payable quarterly, for which service of supply of cold air to standholders, the charges shall be fair and reasonable, and not to exceed three (3) cents per cubic foot per month, of space refrigerated, under an agreement with the City to be executed by the successful bidder, with a bond of ten thousand dollars (\$10,000) to be executed by two sureties approved by the Comptroller; and the work to be completed and ready for operation in ninety (90) days from date of agreement.

The Comptroller presented the following resolution exempting certain city bonds from taxation:

Whereas, The Board of Estimate and Apportionment adopted a resolution on April 24, 1890, authorizing the issue of \$178,300 Consolidated Stock of the City of New York, for the purchase of lands adjacent to the Washington Bridge, acquired by the Harlem Bridge Commissioners, and on the same date adopted a resolution authorizing the issue of \$14,000 Additional School-house Bonds to be known as Consolidated Stock of the City of New York, for grading and excavating school site northwest corner of Fifty-first street and First avenue; and on April 30, 1890, adopted a resolution authorizing the issue of \$199,700 Additional School-house Bonds, to be known as Consolidated Stock of the City of New York, for the purpose of erecting a new school building in East One Hundred and Fifty-seventh street, near Cortlandt avenue, in the Twenty-third Ward, pursuant to the provisions of chapter 136 of the Laws of 1888.

Resolved, That the said stock is hereby exempted from taxation by the City and County of New York, pursuant to an ordinance of the Common Council, approved by the Mayor, October 2, 1880, and the provisions of section 137 of the New York City Consolidation Act of 1882.

Which was unanimously adopted.

The Comptroller presented the following resolution to pay amount due W. H. Simonson for rent of premises used by the Department of Public Works:

Whereas, The Department of Public Works occupied and used for storage purposes two vacant lots on One Hundredth street, east of First avenue, during the year 1888, at a yearly rent of \$250, which has not been paid;

Resolved, That the Comptroller be and is hereby authorized to pay W. H. Simonson the sum of two hundred and fifty dollars (\$250) for rent of two vacant lots occupied by the Department of Public Works as a storage yard in the year 1888, as certified by the Commissioner of Public Works.

Which was unanimously adopted.

The Comptroller presented the following resolution amending a resolution adopted April 16, authorizing the sale of a lease of ferry to Jersey City from the foot of West Thirteenth street, North river:

Whereas, The resolution adopted by this Board on April 16, authorizing a lease of the ferry from a point near the foot of West Thirteenth street, North river, to Jersey City, requires amendment to render the language more precise in its meaning;

Resolved, That the resolution, as printed in the CITY RECORD of April 19, be amended as follows:

1. Strike out the words "and only" at the end of the fifteenth line of the resolution and insert in place thereof the word "but."

2. After the words "Sinking Fund" on the sixteenth line of the resolution, add the words "and then only."

3. Strike out the words "boats, buildings and other property of the lessee," on the twenty-first line of the resolution and insert in place thereof the words "ferry structures in New York."

So that the resolution shall read as follows:

Resolved, That the Comptroller be and he is hereby authorized and directed to sell at public auction to the highest bidder, after due public notice thereof, a lease of the franchise of the ferry established by the Common Council between a point south of and at or near the foot of West Thirteenth street, North river, and Jersey City, in the State of New Jersey, and along therewith the wharf property and water-front belonging to the City required to be used for the purposes of such ferry, to wit: The southerly side of the pier at the foot of West Thirteenth street and the northerly side of the pier at the foot of Little West Twelfth street, and the slip between said piers, with the right to place ferry-houses and racks and platforms therein and against the same for the term of ten years from May 1, 1890, to be subject to such terms and conditions and such regulations and restrictions as are provided by law and the ordinances of the Common Council and the Comptroller may deem necessary or advisable for promoting the interests of the City; provided that no structures herein authorized shall be erected outside of the present pier-head line to remain permanently, but during the pleasure of the Commissioners of the Sinking Fund, and then only to be removed when required for the improvement of the water-front in said locality, at the expense of the lessee, when duly notified by the Commissioners of the Sinking Fund, without liability of the City of New York for any loss or damage whatever on account of such removal.

The lease shall contain a covenant providing for the purchase, at a fair appraised valuation of the ferry structures in New York, used in and actually necessary for the operation of said ferry, upon the termination of the lease and the surrender and yielding up of the premises by the lessee, if the lessee shall not become the purchaser of the franchise for another term, which appraisal shall be made in the usual way before advertising a lease for a new term of the franchise, at least four months prior to the termination of the lease.

The minimum rental or upset price of said ferry lease is hereby appraised and fixed at the sum of \$2,500 per annum. The rates for ferriage of foot passengers, vehicles, cattle, freight, etc., to be subject to approval by the Mayor and Comptroller.

Which was referred to the Chairman of the Committee on Finance of the Board of Aldermen.

The Comptroller presented the following report of sale of lease of Old Harlem Market Square property:

Hughes, the highest bidder, at a rental of \$8,325 per annum, viz.: The lots and buildings known as street Nos. 2212, 2214, 2216, 2218, 2220, 2222, 2224 and 2226 Third avenue, between One Hundred and Twentieth and One Hundred and Twenty-first streets, and vacant lot, Block No. 411, known as Ward No. 32, on One Hundred and Twentieth street.

## BOARD OF CITY RECORD.

The Hons. Hugh J. Grant, Mayor; William H. Clark, Counsel to the Corporation, and Thomas F. Gilroy, Commissioner of Public Works, the officers designated by section 66 of the New York City Consolidation Act, met this day.

Those entitled to exemption are: Clergymen, lawyers, physicians, surgeons, surgeon-dentists, professors or teachers in a college, academy or public school, licensed pharmacists or pharmacists, actually engaged in their respective professions and not following any other calling; militiamen, policemen, and firemen; election officers, jury non-residents, and city employees, and United States employees; officers of vessels making regular trips; licensed pilots, actually following that calling; superintendents, conductors and engineers of a railroad company other than a street railroad company; telegraph operators actually doing duty as such; Grand, Sheriff's, and Civil Court jurors; stationary engineers; and persons physically incapable of performing jury duty by reason of severe sickness, deafness, or other physical disorder.

Those who have not answered as to their liability, or proved permanent exemption, will receive a "jury enrollment notice," requiring them to appear before me this year. Whether liable or not, such notices must be answered (in person, if possible), and at this office only, under severe penalties. If exempt, the party must bring proof of exemption; if liable, he must also answer in person, giving full and correct name, residence, etc., etc. No attention paid to letters.

Persons "enrolled" as liable must serve when called or pay their fines. No mere excuse will be allowed or interference permitted. The fines, if unpaid, will be entered as judgments upon the property of the delinquents.

All good citizens will aid the course of justice, and secure reliable and respectable juries, and equalize their duty by serving promptly when summoned, allowing their clerks or subordinates to serve reporting to me any attempt at bribery or evasion, and suggesting names for enrollment. Persons between sixty and seventy years of age, summer absentees, persons temporarily ill, and United States jurors, are not exempt.

## TO OWNERS OF LANDS ORIGINALLY ACQUIRED BY WATER GRANTS.

ATTENTION IS CALLED TO THE RECENT act of the Legislature (chapter 449, Laws of 1889), which provides that whenever any streets or avenues in the city, described in any grant of land under water, from the Mayor, Aldermen and Commonalty, containing covenants requiring the grantees and their successors to pave, repave, keep in repair or maintain such streets, shall be in need of repairs, pavement or repavement, the Common Council may, by ordinance, require the same to be paved, repaved or repaired, and the expense thereof to be assessed on the property benefited; and whenever the owner of a lot so assessed shall have paid the assessment levied for such paving, repaving or repairing, such payment shall release and discharge such owner from any and every covenant and obligation as to paving, repaving and repairing, contained in the water grant under which the premises are held, and no further assessment shall be imposed on such lot for paving, repaving or repairing such street or avenue, unless it shall be petitioned for by a majority of the owners of the property (who shall also be the owners of a majority of the property in frontage) on the line of the proposed improvement.

The act further provides that the owner of any such lot may notify the Commissioner of Public Works, in writing, specifying the ward number and street number of the lot, that he desires, for himself, his heirs and assigns, to be released from the obligation of such covenants, and elects and agrees that said lot shall be thereafter liable to be assessed as above provided, and thereupon the owner of such lot, his heirs and assigns shall thenceforth be relieved from any obligation to pave, repair, uphold or maintain said street, and the lot in respect of which such notice was given shall be liable to assessment accordingly.

The Commissioner of Public Works desires to give the following explanation of the operation of this act: When notice, as above described, is given to the Commissioner of Public Works, the owner of the lot or lots therein described, and his heirs and assigns, are forever released from all obligation under the grant in respect to paving, repaving or repairing the street in front of or adjacent to said lot or lots, except one assessment for such paving, repaving or repairs, as the Common Council may, by ordinance, direct to be made thereafter.

No street or avenue within the limits of such grants can be paved, repaved or repaired until said work is authorized by ordinance of the Common Council, and when the owners of such lots desire their streets to be paved, repaved or repaired, they should state their desire and make their application to the Board of Aldermen and not to the Commissioner of Public Works, who has no authority in the matter until directed by ordinance of the Common Council to proceed with the pavement, repavement or repairs.

## PUBLIC NOTICE AS TO WATER RATES.

PUBLIC NOTICE IS HEREBY GIVEN THAT in compliance with the provisions of chapter 559, Laws of 1887, amending sections 350 and 921 of the New York City Consolidation Act of 1882, passed June 9, 1887, the following changes are made in charging and collecting water rents:

1st. All extra charges for water incurred from and after June 9, 1887, shall be treated, collected and returned in arrears in the same manner as regular rents have heretofore been treated.

2d. In every building where a water meter or meters are now, or shall hereafter be in use, the charge for water by meter measurement shall be the only charge against such building, or such part thereof as is supplied through meter.

3d. The returns of arrears of water rents, including the year 1887, shall be made as heretofore on the confirmation of the tax levy by the Board of Aldermen, and shall include all charges and penalties of every nature.

4th. A penalty of five dollars (\$5) is hereby established, and will be imposed in each and every case where the rules and regulations of the Department prohibiting the use of water through hose, or in any other wasteful manner, are violated, and such penalties will be entered on the books of the Bureau against the respective buildings or property, and, if not collected, be returned in arrears in like manner as other charges for water.

5th. Charges for so-called extra water rents of every nature, imposed or incurred prior to June 9, 1887, will be canceled of record on the books of the Department.
